The General Committee of the Christian Conference of Asia (CCA), at its meeting on December 1-3, 2000, in Hongkong SAR, elected Dr. Ahn Jae Woong of Korea, as its new General Secretary. Dr. Ahn is elected for a regular term of five years, with effect from January 1, 2001.

Dr. Ahn is known in the ecumenical movement, A member of the Presbyterian Church in Korea, he has had wide experience in various levels of the ecumenical movement in Asia and worldwide. He served as Secretary for Asia and the Pacific of the World Student Christian Federation (WSCF) and as Executive Secretary for Urban Rural Mission (URM) of the CCA.

Dr. Ahn holds an M. Div. degree from Harvard University, and an L.H.D. (honoris causa) from Mary Holmes College. He is a candidate for a Ph.D at the University of Utrecht.

C. S. I. Youth Festival 2000.

The CSI Youth rally was conducted at Kasan Agricultural Institute, Vellore from the 2nd to 5th November 2000. It was a combined activity of the Pastoral aid department and the Youth department of the CSI. "Lord make us channels of your peace" was the theme of this youth conference.

From the Jaffna diocese the assistant pastor of Colombo Rev. Daniel Ranjit Thanarajasingam and five other youth leaders participated. Rt. Rev. Dr. James Srinivasan the bishop of Trichy, made the necessary arrangements. Accomodation was arranged at St. John's Vestry School, The chairman of the synod department Rt. Rev. Dr. George Issac expressed his happiness over the presence of the Jaffna diocese delegates. The proceedings started with the bible study conducted by Rev. G. Dyvaseervatham and Rt. Rev. Dr. J. W. Gladstone. The singing was led by Rt. Rev. Dr. George Issac.

The youth who came for the conference were divided into forty different commissions based on Social, Religious and Economic issues. It was decided to release a manifesto at the end of the group discussions and the plenery sessions. Opportunity was given to Sri Lankan delegates to express the problems caused by the ongoing civil war. We spoke about the need for a lasting solution by a third party mediation. We also expressed our feeling that the CSI should play a vital role in bringing about peace in our war-torn country. The General Secretary of the Synod, the Director of the pastoral aid department and the director of the youth department said that they would do whatever possible in this matter. The youth also said that they would pray to God to solve the problem in Sri Lanka. We participated in the Holy Communion Service on Sunday the 5th of November. Our Programme in Madras was arranged by Revd. Vinoth Victor, Paul Francis, and Rev. G. Dyvaseervatham. On the 10th November we flew back to Colomno with pleasant memories of the conference and South India tour.

CIVIL RIGHTS MOVEMENT OF SRI LANKA

THE KILLING OF DETAINEES AND SURRENDEES

massacre at the Bindunuwewa rehabilitation centre

Once again persons held in a place of detention authorised by the state have been brutally put to death. The victims are some 28 inmates of the Youth Rehabilitation Centre at Bindunuwewa. The Civil Rights Movement (CRM) expresses its shock and deep concern at this appailing event, It urges the government to ensure that the facts will be properly ascertained and revealed to the public and that all those responsible are identified and brought to book.

At the present stage many aspects are unclear, CRM nevertheless makes the following observations.

- 1. It is clear that the victims were held in the custody of the state and therefore entitled to its special protection.
- 2. An immediate priority must be ensuring the safety of the survivors, reportedly 13 in number who are injured and in hospital. There is reason to believe that the second massacre at the Welikade jall (on 27th July 1983) was an attempt to destroy the survivors of the first massacre (on 25th July 1983) thus eliminating crucial eyewitnesses.
- 3. It is a shocking fact that in 1983 not only were Tamil political prisoners but chered in quick succession on two separate occasions in the same jail, but also that not a single prosecution was instituted against anyone in this connection, nor was public inquiry held. (The inquests brought in a verdict of homicide and the police ordered to be seen other affacts on prisoners at Welikade, at Mahara, at Kalutara. A relevant factor to be considered in examining the horrific events at Bindunuwewa must be the impunity enjoyed by the perpetrators of custodial killings in particular, and the general climate of impunity that has characterised human rights violations in Sri Lanka.
- 4. In the present instance the victims were being held in a camp established by the commissiner General of Rehabilitation and inquests were held under the normal law. If, however, they had been in police or military custody, then the normal law would be by-passed and a much less satisfactory inquiry held. This is due to a change in the emergency regulations in May this year. It is essential that the normal law relating to inquests be restored in respect of all deaths that occur while in the custody of the state or its agencies.
- 5. The Bindunuwewa Centre in Bandarawelais one of the Centres established under emergency regulations. These regulations provide for rehabilitation of detainees and persons who surrender. Most if not all persons under rehabilitation are neither convicted nor under trial for any offence. Some may not be even suspected. For this reason being held in such a centre constitutes a form of detention without trial. These emergency regulations, which have several other unsatisfactory features, need to be reviewed and amended in the light of international human rights standards as a matter of urgency.
- 6. It is essential that this crime be inquired into thoroughly and efficiently by an independent body. Justice must not only be done but must manifestly be seen to be done. In this regard, it is crucial that the investgation be such as to command the confidence of the public, with special consideration to the ethnic dimensions involved.

Tribute to Sivaguru Aunty

Last night Indra called me to pay a tribute to her mother; and I gladly consented because all that need to be said was going to be pleasant and true. This pleasant lady deserved a good tribute.

As far as I know her, she never fretted or fumed or worried her poor head over something she thought was unsurmountable. She was always as happy as a lark.

I do not know anything about her early days, but her children used to say that she was always with her friends. The friendly person that she was, was able to have friends because of her wonderful husband. She boasted about him saying that he took upon himself all the serious work-load of the family and gave her all the freedom she wanted.

Her boast was not about his achievement (although he was a successful and popular lawyer from Chavakachcheri) but about who he was.

One could see her wonderful traits in her son Bala. who is always there to extend a helping hand when one needs help. He must have inherited this quality from her. It was this helpful attitude of hers that attracted her to people.

It is only with the help of God that we can discover the extent of our responsibility and that of our brothers and sisters in all that we do. Very often people devote time, energy, intelligence and money to entertain themselves. Sivaguru Aunty entertained herself in seeing others happy. She lived the abundant life and was always full of joy.

Every time I visited her, we would have the usual exchange of greetings, and after that she would take me by the hand and say "Kitchie, come and see what I have done", and she would spread out her handwork of pillow cases, table centres, and lases of varying sizes and lengths. Then she would say "Choose something for yourself", and would insist that I take at least two of her items. She took great delight in not only making them, but also giving them to her friends and relations.

She was childlike in many ways and had great pleasure in playing the piano. She would say, "Shall I play a hymn for you?", and when I replied in the affirmative, she would sit on the piano stool with a beaming smile on herface, and play and sing, and enjoy every minute of it.

She was very proud of her children, grand children and great grand children. One could have a light hearted conversation with her. She never spoke a hard word about anybody, nor was there a trace of malice in her conversation. She always seemed to be seeing the best in everybody. Her vision filtered all the bad and evil, and only made the good and beautiful visible to her. I always thought of her as one in whom there was no guile. Old age can be a severe trial. Even though life is often difficult, many of us hold on it, when it begins to slip away. The worst suffering is to feel that one is useless, and putting other people into trouble, when one would like to be a service to others.

Though she was old, she was young at heart, and in her own simple way, until she fell really ill, demonstrated that all surpassing gift of God's love, is with us always, and our suffering though not a good thing in itself, can help through Jesus Christ. to make us awareof His saving love.

Her chair is empty, her room is vacant, her voice stilled, but the memory of her will live on! in the hearts of her loved ones.

OUR RAILWAY

Since the prospects of a Railway from Jaffna to the South seemed to be so blighted by the unfavourable Report of the Commissioners, there has been much talk of an Indo-Ceylon railway across Adams Bridge, with a branch to Jaffna, and perhaps Trincomalie, Such a railway would suit the people of Jaffna even better than the other. It would furnish easy communication with South India, which in many respects would be a great boon. The Tamils of North Ceylon have naturally more interests in common with the Tamils of South India, then with the Sinhalese of South Ceylon. Language and Religion being the same in one case and different in the other, they naturally go to the celeberated sacred places of South India for festivals. Also nearly half of the staple food of the people comes from the adjoining continent, while a good part of their chief product, tobacco is sent there. All the cart cattle come from there and many ploughing cattle are exported thither. If there were equally convenient communication there is no doubt that there would be quiet as much intercourse with India as with the South.

A Mr. Shelford with others has been active for some months past in developing public interest in an Indo-Ceylon railway, with the object of forming a company for the purpose of constructing such a road. He has had on exhibition in London a model of Adam's Bridge, some six feet in length giving all the islands, channels, etc. in proportion, also indicating sand bars, depths of water etc. A new survey has also been made in part, of the approaches to the place both by land and water. The Indian Government has expressed itself as favourable to the project and ready to help it on. Mr. Shelford himself was planning to come out in a few months and settle everything definitely. Meanwhile the answer of the Ceylon Government has been anxiously awaited with the hope that substantial concessions would be granted in addition to the requisite permission. Now that answer has been received and it is unfavourable. This is quite a disappointment to many, and many are the surmises as to the reasons for such a refusal. We may add our surmises.

We believe that the Ceylon Government does not favour the Indo-Ceylon railway for two reasons, the first being that it is prepared to proceed itself with the railway to Jaffna without further delay. Our Governor has said almost as much as this on several occasions. We believe that there is a strong sentiment throughout the Island in favor of this railway's being built especially for the purpose of developing the uninhabited portions. The Ceylon railway's being in a handsome revenue to Government, and the profits in other parts might well go towards the deficit in a part where so much benefit would follow. But the private railway would make that deficit greater. Further more a few years of railway to Colombo would bind Jaffna more closely to the South and do much to unify the colony, whereas the other railway would undoubtedly bind Jaffna more to India than to South Ceylon. The other reason, which we think acts as a deterrent, is the liability of introduction of cholora. Over and over again every year the dreaded scourge is introduced from the continent, and sometimes only stamped out after it has claimed its thousands of victims. While the only communication is by ships, quarantine can be imposed and thus the dread plague stayed. But with the railway no quarantine would be possible, and Ceylon would be equally liable to the pestilence with all the places of South India. In time the Indo-Ceylon railway must come, but if our Government will give us the other road at once, we shall rejoice, and wait patiently. Some have recommended a steam tramway on the central road. as sufficient to answer the purpose, but it would not be nearly as effective for opening up the country. It would practically spoil the road, and be but a little better than the horse coach, and would attract but little traffic. It would postpone indefinitely the railroad, while giving a very inadequate substitute. We ask for, and expect, arailway to Jaffna, begun within our present progressive Governor's regime.
