WORLD COUNCIL OF CHURCHES MUST PRESSURIZE SRI LANKAN GOVERNMENT TO STOP WAR AND RESUME PEACE TALKS

Peace and Goodwill Committee urges Dr Konrad Raiser

nembers of the Peace and Goodw'll Committee of Jaffna [former Citizen's Committee] made their plea to Dr Konrad Raiser. General Secretary of the World Curreil of Chusches [WCC] that the WCC should use its good offices to pressurize the Sri Lankan Government to stop the war at once and to begin the peace talks without any sielay, the othe latter visited Jaffina on March 15, 2001.



This as Dr Raiser's first visit to Sri Lanka since he assumed his position with the WCC some years ago. Dr Raiser made this trip after he made a historic visit to Bangaladesh. He was accompanied by Dr Clement John, Executive Secretary for International Affairs of the WCC and Revd Ebenezer Joseph, General Secretary of the National Christian Council of Sri Lanka. Dr Mathews George Chunnakara, A sia Secretary of the WCC joined the visitors in their visits in the other parts of Sri Lanka.

The isitors were received at Palaly airport by a group beaded by the Rt. Revd Dr S. Jebanesan, Bishop in Jaffna of the Jaff. a Diocese of the Church of South India. They were then taken to Jaffna for various engagements. Dr Raiser declared open a new block at ST. John's College, Jaffna and visited Chundikuli College and Nuffield School for the Deaf and the Bir. 182 re he proceeded to Vaddukoddas for a special unity service, organized by the Jaffna Christian Union and the Jaffna Dideese of the CSI. The visitors proceeded to Uduvil Cirls' College and ine Christian Theological Seminary before they departed. Dr Raiser was able to see a stassess the damages the war had caused, especially the damages caused to the churches and the temples.

EDITORIAL

PAYING BACK ONE'S OWN DUE

"It was not devolution nor sharing of power that the Tamils in the North and East sought. They only sought the restoration of their rights which had been snatched away from them." These were the words of Justice C.V. Wigneswaran in his ceremonial address as the new Supreme Court Judge at the veremonial sitting held at the Superior Court Complex on March 7, 2001.

At a time when much is being discussed about 'Peace,' the words of Justice Wigneswaran echoes the sentiments of the Tamil community. He has, in other words, given the true definition of justice. Aristotle defined 'Justice' as "paying back one's own due." The Biblical understanding of zedek or zedekah, the word that denotes justice is also similar. In other words, it is "giving back or "returning" that which legitimately due to the other."

People are looking forward to the settling down of events in Sri Lanka for the betterment of the Tamil community. In the last issue, I commented on the launch of a new Decade by the World Council of Churches, "Decade to Overcome Violence," I did mention that cultivating the culture of peace is vital to overcome violence. How can this culture be cultivated? Peace is not the absence of war. It is, rather, establishment of justice. Bible says, "Justice and Peace shall kiss each other." Justice is a prerequisite for the establishment of justice. To put it the other way, rectification of injustice is peace. What Justice Wigneswaran has said is of perimence in today's context. These words of wisdom have come from none other than a Supreme Court Judge in Sri Lanka.

Justice Wigneswaran said, "My stint as \(\epsi\) judicial officer in the Northern and Eastern Provinces enlightened me as to the feelings and appirations of the vast majority of the denizens of those two provinces. It is not devolution nor sharing of powers they seek. They seek the restoration of their rights. Rights which were snatched from them by virtue of mathematical innovation where the majority in two provinces were added to the majority of seven provinces and thus made into the minority in nine provinces. This was sought to be corrected when laws pertaining to the reasonable use of Tamil were formulated in 1958 and 1966. But even these were given up without understanding the implications involved." Some further extracts from Justice Wigneswaran's speech may be worth quoting in this column.

"Singapore and Ceylon in the old days had the same problem. One country decided to give equal recognition to all four languages right from the beginning and that country flowers and flourishes. The other forced one language in preference to the others on all and that country is in precarious political turnoil. While such turnoil goes around in this country, Globalization goes on and Mother Earth is becoming a smaller place to live on, with technological advances ensuring instant correspondence, intermingling of races and indorsing of international tongues for easy communication.

Mr. Attorney and Mr. Gunaratne, I must confess that I have had a background and conditionings, which makes me truly Sri Lankan. My parents hailed from the Northern and Eastern Provinces. I was born here in Hulfsdorp in the Western Province. My early education before joining Royal Primary School was in the North Western and North Central Provinces. My father had worked as an officer of the Government inter alia in the Central Province and Southern Province where I had occasion to mingle with the people of those areas. I have worked as a Judicial Officer in the Uva Province and I count the friendship of many from the Sabaragamuwa Province. I feel every inch a native of this country. I have always felt proud in foreign forums to be recognized as a person hailing from this blessed Isle. All three languages spoken by the denizens of this country have nourished me. I have been nurtured not only in one but also in all four major religious of this country having started comparative study of religious from an early age. I am one of the few still living among those who organized from the then Congress of Religions in 1965 or thereabouts the visit of the then Mahanayake Thera of the Malwatte Chapter to Jaffna. It was a relative of my mother, Sir Ponnampalam Ramanathan, who risked his life to travel to England to place the case of the Sinhala Buddhists before the Queen in the early part of the last century. Thanks to the education I had at my Alma Mater, I have never felt second to any human being in this country despite the disabilities decreed on my community, though I have respected and do respect most humbly the intrinsic humanity and the unique individuality of every human being. I do respect their talents and capabilities sometimes different from mine.

I respect the divinity in everyone of them. Loving kindness cannot be a mere concept. It has to be a living reality. Often today we miss the wood for the trees when we wax eloquently about the Teachings of the Great Masters in mesmerizing language forgetting the spirit of their Teachings and failing to imbibe them in our lives. Otherwise how do we account for the echoing of war drums of hatred from the portals of Love and Religion?

My stint as a Judicial Officer in the Northern and Eastern Provinces during the turbulent period from 1979 to 1986 enlightened me as to the feelings and aspirations of the vast majority of the denizens of those two Provinces. It is not devolution nor sharing of powers they seek. They seek the Restoration of their Rights. Rights which were snatched from them by virtue of a mathematical innovation where the majority in two provinces were added to the majority in seven provinces and thus made into the minority in nine provinces. This was sought to be corrected when laws pertaining to the Reasonable Use of Tamil were formulated in 1958 and 1966. But even these were given up without understanding the implications involved.

I have always referred to an incident that used to happen when we were marble playing youngsters in school. Some of our seniors who were not Prefects would pounce upon us suddenly and illegally confiscate all our marbles in order that they would themselves play with them. When we protested they would keep 90% of the marbles and offer us 10% and thereafter progressively increase it to about 20% forgetting that all the marbles were ours and the seniors had no right to confiscate in the first instance. The majority of those in the Northern and Eastern Provinces were always Tamil speaking until Independence and their Language, Religions, Culture and Customs - mainly Islamic, Christian and Hindu, and ways of life within the special topographical and climatic environment should have been allowed to blossom and flourish without interference after Independence. So too the special culture and way of life that had grown up in certain areas of the Central Province. These were not done and we face the consequences today.


Even though you Mr. Attorney and Lave today in our respective honoured positions we cannot forget that two sparrows would not make a summer. In fact there were many more sparrows in high positions due to their intrinsic worth in almost every field during the middle of the last century. But we are today progressively depleting in numbers in this part of the Island and like the Burghers we too would soon be hardly heard of in Judicial. Legal or Governmental Service or even the Private Sector. It is a sad reflection of our rubes that after me there had not been a single Tamil speaking President of the Law Students Union after 1962 at the Sri Lanka Law College.

It is because I love this country and all its people including those who hate me for what I am, that I take this opportunity to say-not for my sake, not for the sake of the Tamil people but for the sake of cordial relationship among all communities in this Island of ours, for good governance and a progressive future, that unless we recognize that the Tamil Language and its culture are to the Tamils what the Sinhala Language and culture are to the Sinhalese and therefore make Tamil the dominant language of the Northern and Eastern Provinces requiring the study of it compulsory for all in those two Provinces just as Sinhalese is recognized as the dominant language of the other seven provinces, with English as the link language between equals, the wrong done by the enthroning of one Language in 1956 could never be erased; the havoc created by the deletion of Article 29(2) of the 1947 Constitution and the doctrine of ultra vires from subsequent Constitutions could never be put right; the feelings of the Tamils wounded inter alia by the 1958, 1977 and 1983 riots cannot ever be assuaged. Whether the Tamil Language is spoken and preserved in other countries is irrelevant. The Sri Lankan Tamils need to develop their language and culture peculiar to themselves in their mother country. The sterile and impotent cosmetic provisions now appearing in our Constitution has little meaning to the Tamil speaking people of the Northern and Eastern Provinces. They need to govern themselves in their own Language with the little interference from out side.

An Original Court Judge cannot under the present system of nomination to the Higher Judiciary ever hope to occupy the highest office in the Judiciary except due to the condescending discretion of the Executive. Therefore I must feel that the acme of my career has arrived today, that I cannot aspire for anything more but only fade away with time into oblivion.

Inevertheless thank both of you for making this a memorable event for me. I thank all my well-wishers who found time to be present here today.

"Even at this age the Bishop's handwriting is excellent" remarked a University Lecturer a few months back. I said, I owe my handwriting to Mr. V.N. Aiyathurai who taught me Tamil when I was a high school student at Drieberg College Chavakachcheri.

VNA was famous for his transcription exercises. Every day we have to write four lines in an exercise book and keep it. He will call students at random to see whether we

have written those four lines that particular day. This too he would do after giving us a written work like essay writing, translation or precis writing. By writing four lines clearly every day my handwriting improved. I remember vividly the comment he wrote one day in my transcription exercise book - "You are making unnecessary curves in the formation of lines. Write without making these curves". This he wrote in English.

Mr. V.N. Aiyathurai's 20th Death Anniversary falls on the 3rd of April 2001. VNA belongs to the band of old teachers of Jaffna whose main traits were perseverance, dedication, discipline and simplicity. He started life as a trained teacher. By dint of honest perseverance he passed the Inter Arts Examination of the University of London and then the B.A Degree Examination of that University. He rose to the position of Deputy Principal and retired at the age of 55 because of the regulation brought by the then government asking all persons to retire who had reached the age

He was a very hardworking man, raising his family with utmost care. He had his own car and brought his family and other children to Drieberg College from Madduvil every day. He was a Tamil Teacher of par excellence. He was well versed in Tamil Literature and inspired us to drink more and more in the nectar of Tamilæpia and modern poems.

He will not waste a minute when he goes to the class. If it is a Kamaparamayana class, he will keep on explaining the verses till the end of the period. If it is an essay writing class, he will correct each and every exercise book. If students misbehave, he will get down the cane from the office. That order itself will make every one shiver. When the Monitor brings the cane solemnly to class he will remove his wristlet from his wrist, keep it on the table and give 6 cuts or 3 cuts according to the gravity of the mischief.

He was a Tamil To her, but the students ferred him more than the Principal or the Vice-Principal. He was able to command the respect of his tellow teachers

Mr. Aiyathurai's Tamil scholarship was natural. It was the fruition of generations of Tamil study. We used to listen to his assembly talks and sermons with much interest. There will be pin drop silence when Mr. Aiyathurai speaks, because there will be anecdotes from Tamil Literature. Even in his sermons Tamil Literature will be his main source of illustrations.

Mr. Aiyathurai was a disciplinarian and he wanted his children also to be disciplined like him. Fortunately he had a wife who was deeply religious and persevering like him.

His life was a lesson to all that any man can come up by perseverance and hard work

He put up a house at Church Lane Chavakachcheri and moved to Chavakachcheri from Madduvil and spent most part of his life at Chavakachcheri till his death in 1981.

Much has happened during the past 20 years. Familiar landmarks completely destroyed.

All the leaders of Chavakachcheri have now gone beyond the veil. But any man who lived at Chavakachcheri before the ethnic riots and migration of persons will feel sorry for the present state of the town. It consisted of a Christian Community living around Drieberg College and the CSI Church. The members were united and lived like the church of the New Testament times. As we advance in age we think of the pleasant days we had at Drieberg, the paddy fields, Sunday morning worship, Sunday Schools, Railway Station and the market. We also think of the scholars and teachers who instilled hope in life and desire for learning.

Mr. V.N. Aiyathurai is one of the fine products of Chavakachcheri. His students learned to be disciplined, persevering and religious.

We have to be thankful to God for a life such as that of Mr. V.N. Aiyathurai. It
