## Sri Lanka's political crisis continues...

While many celebrated Black Friday with bargain sales, the Black Friday of October 26 became a day of reckoning for Sri Lanka when the island nation in the Indian Ocean was plunged into a state of constitutional and political crisis becoming a troubled nation with two persons claiming to be the Prime Minister of the same country. The current turbulence followed when the country's President Maithripala Sirisena decided to sack the sitting Prime Minister Ranil Wickremesinghe and appoint strongman from the opposition Mahinda Rajapakse who was President of Sri Lanka twice in his political career.

The change in political leadership in the country has brought about several responses and chained reactions hurting the country's economy, sliding the value of its currency, a drop-in tourist arrivals and turbulence in political affiliations with party switch overs and changing alignments. The changed political scenario is also against the background of a series of petitions filed in the supreme court, the country's highest court, against the Parliament's prorogation, firing the sitting Prime Minister and the appointment of a new Prime Minister, parliament dissolution and fixing of general elections etc. Both, the nation's people and the political parties involved in the tussle are eagerly awaiting the court verdict for the next move. Meanwhile, Parliament has passed motions expressing

no-confidence on the newly appointed government and Prime Minister since the opposition holds a majority as the Tamil National Alliance (TNA) has agreed to support the UNP led United Front to form the new government.

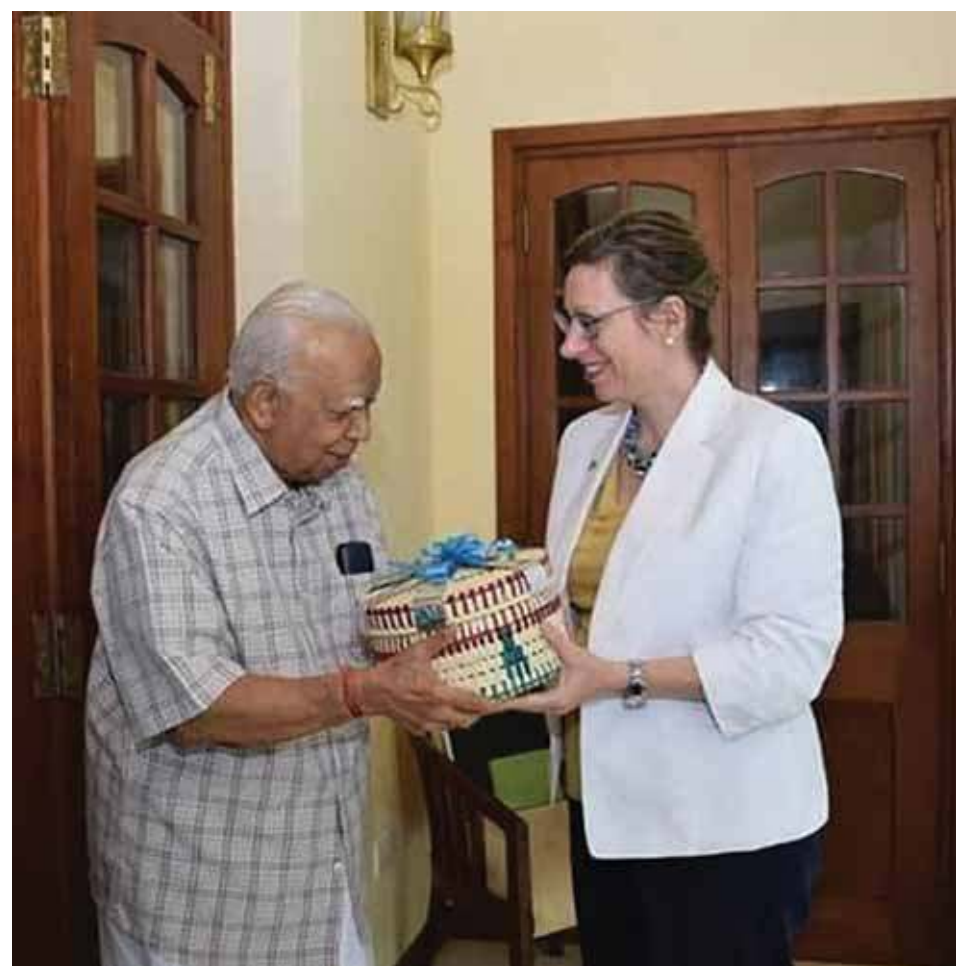
As “Monsoon Journal” goes to print, the current political scene in the country seems to be that President Sirisena might re-tract his earlier decisions and request the United Front to form the government again with UNP leadership but may suggest a new Prime Minister since he is against re-appointing Ranil Wickremesinghe as the country's Prime Minister. However, the UNP keeps insisting that Ranil Wickremesinghe is the party's choice for Premiership. He has already pledged to the political parties that he will not prorogue or dissolve Parliament again that will give way for any general elections now. But of course, Mahinda Rajapakse's faction and the UNP are confident and state that they are prepared to face the polls.

A little bird whispers that “Monsoon Journal” correctly predicted in its November issue that Tamil National Alliance will turn-out to be the game changer in the current political turbulence in Sri Lanka. ## Canada imposes sanctions on individuals linked to murder of Jamal Khashoggi

November 29, 2018 - Ottawa, Ontario: The Honourable Chrystia Freeland, Minister of Foreign Affairs, today announced targeted sanctions under the Justice for Victims of Corrupt Foreign Officials Act against 17 Saudi nationals linked to the murder of Jamal Khashoggi.

The sanctions target individuals who are, in the opinion of the Government of Canada, responsible for or complicit in the extrajudicial killing of journalist Jamal Khashoggi on October 2, 2018. These sanctions effectively freeze the assets of these individuals in Canada. Their listing also renders

them inadmissible to Canada pursuant to the Immigration and Refugee Protection Act.

While Canada has imposed sanctions on these 17 Saudi nationals, we continue to call for a transparent and rigorous accounting of the circumstances surrounding Mr. Khashoggi's murder. The explanations offered to date by Saudi Arabia lack consistency and credibility.

Canada is committed to supporting human rights defenders and will continue to promote freedom of the press around the world.

## Canada signs new trade agreement with United States and Mexico

November 30, 2018: The Honourable Chrystia Freeland, Minister of Foreign Affairs, today welcomed the signing of a new agreement to modernize the North American Free Trade Agreement between Canada, the United States and Mexico. The new agreement will support good, middle class jobs in Canada; strengthen economic ties between the three countries; and contribute to North America's global competitiveness.

The modernized agreement preserves Canada's preferential access to the U.S. and Mexican markets, ensuring that the vast majority of trilateral trade remains duty-free—something that is vital to the continuing prosperity of Canadians. The agreement includes an exemption for a significant quantity of Canadian automobiles and auto parts from potential future U.S. 232 tariff measures. In addition, Canada succeeded in preserving key elements of the original NAFTA, includ-



ing the cultural exemption and the use of binational panels to resolve disputes on duties.

Canada maintained a constructive approach throughout these negotiations to modernize NAFTA. Canada's objectives remained clear: defend Canadians' interests, fight for Canadian jobs and living standards, and uphold Canadian values within an agreement that is mutually beneficial for all three countries.

Canada, the United States and Mexico will now move forward with their respective domestic procedures toward the ratification and implementation of the new trade agreement.

## International Day for the Elimination of Violence against Women

Ottawa, Ontario - November 25, 2018: The Prime Minister, Justin Trudeau, today issued the following statement on the International Day for the Elimination of Violence against Women:

"Gender-based violence harms us all. It affects families, schools, and workplaces – and holds back whole communities from reaching their full potential.

"Today, on the International Day for the Elimination of Violence against Women, we come together to stand up and speak out against violence against women and people of diverse gender identities. We reflect on what each of us can do, in our daily lives, to combat violence and create change.

"Trans women and gender-diverse people experience violence at staggering rates worldwide. Displaced, migrant, and refugee women are both particularly vulnerable and face greater obstacles to seeking safety and justice. The epidemic of missing and murdered Indigenous women and girls in Canada is an ongoing tragedy and our collective shame.

"As we reflect on this unacceptable reality, we also honour the activists who are on the frontlines of helping survivors reclaim their voices, autonomy, and lives. Their advocacy benefits all of us, because an attack on women's rights is a threat to all our human rights.

"The Government of Canada has taken important steps to help end gender-based violence. Last year, we launched It's Time: Canada's Strategy to Prevent and Address Gender-Based Violence. The Strategy focuses on preventing gender-based violence, providing stronger support for survivors and their families, and improving the response of our justice systems.

"This year, we made gender equality and women's empowerment the guiding theme of Canada's G7 Presidency. During the Summit, leaders recognized

the urgent need to protect the rights of women and girls around the world – especially those in conflict situations – and signed the G7 Charlevoix Commitment to End Sexual and Gender-Based Violence, Abuse and Harassment in Digital Contexts. This commitment will help us build better prevention and crisis response strategies and better support for survivors of gender-based violence.

"Building on these achievements, Canada put forward a resolution at the United Nations Human Rights Council aimed at preventing and responding to violence against women and girls in digital contexts. Countries around the world adopted the resolution and committed to be part of the solution.

"But we can do more. Together, we need to change the culture that allows discrimination, harassment, and violence against women to continue in our communities. When women and girls come forward to tell their stories of survival, we cannot dismiss or ignore them. Their courage creates change that benefits all of us. We need to listen to women, respect them, value them, and protect their human rights.

"As we mark the beginning of the 16 Days of Activism against Gender-Based Violence, I ask all Canadians to do their part to protect the rights of women and take action to bring an end to gender-based violence. We all benefit when women and girls are safe and free to live their lives to the fullest."

## International Day of Commemoration and Dignity of the Victims of the Crime of Genocide and of the Prevention of this Crime: A Better Society for All

We are now a month away from the new year of 2019, and it will be a time for both reflection on this past year as well as a roadmap for the year ahead. In that lead up to the new year of 2019 with the onset of December and holiday season, it is appropriate to reflect on the victims of genocide and the prevention of crime. The United Nations marks December 9 as International Day of Commemoration and Dignity of the Victims of the Crime of Genocide and of the Prevention of this Crime. This was accomplished by the United Nations General Assembly in consideration that it is the anniversary of the adoption of the 1948 Convention on the Prevention and Punishment of the Crime of Genocide, also known as the "Genocide Convention."

Current UN Secretary-General, Antonio Guterres, notes that "at a time of rising anti-Semitism, anti-Muslim bigotry and other forms of hatred, racism and xenophobia, let us reaffirm our commitment to upholding the equality and dignity of all." This day of observance aims to raise awareness about the Genocide Convention and its function in combating and preventing the crime of genocide, according to Convention definitions, and to commemorate and honour its victims.

No vote was cast in the adoption of this resolution as the 193-member Assembly reiterated the responsibility of each individual State to protect its populations from genocide, which entails the prevention of such a crime, including incitement to it.

The Genocide Convention (article 2) defines genocide as "any of the following acts committed with intent to destroy, in whole or in part, a national, ethnical, racial or religious group ...", including:

- Killing members of the group;
- Causing serious bodily or mental harm to members of the group;
- Deliberately inflicting on the group conditions of life calculated to bring about its physical destruction in whole or in part;
- Imposing measures intended to prevent births

within the group;

- Forcibly transferring children of the group to another group.

The Convention confirms that genocide, whether committed in time of peace or war, is a crime under international law which parties to the Convention undertake "to prevent and to punish" (article 1). The primary responsibility to prevent and stop genocide lies with the State.

One of the events that the United Nations will hold is a 70th commemoration on at the UN Headquarters in New York City, New York. For individuals unable to arrive in person there is the live webcast coverage can be found at <http://webtv.un.org>.

UN Special Advisers on the Prevention of Genocide and on the Responsibility to Protect work together in advancing national and international efforts to protect populations from genocide, war crimes, ethnic cleansing and crimes against humanity, including their incitement. One critical task is fact finding where in areas at risk of genocide war crimes, ethnic cleansing and crimes against humanity with the criteria outlined in the Framework of Analysis for Atrocity Crimes.

An event dominating many international headlines would be the crises in Syria and Myanmar. Accordingly, one of the UN Special Advisors has signalled the plight of the Rohingya as "one of the most serious humanitarian crises we have ever faced," as an appeal for an urgent response by Canada and the rest of the international community. Citing genocides that have taken place over the course of history, he stresses that "dealing with the past is dealing with the present, it is dealing with the future."

It is important that readers like yourselves reflect on this major issue that continues to this day among many countries and how we can ensure a better society for all.

## Statement by Minister of Foreign Affairs condemning Russia's actions in the Kerch Strait



November 26, 2018 - Ottawa, Ontario: The Honourable Chrystia Freeland, Minister of Foreign Affairs, today issued the following statement:

"Canada strongly condemns Russia's actions against Ukraine in the Sea of Azov and Kerch Strait.

"We call on Russia to immediately de-escalate, release the captured crew and vessels and not impede passage through the Kerch Strait.

"Yesterday, I spoke with Pavlo Klimkin, Ukraine's Foreign Minister, and assured him of Canada's unwaver-

ing support for Ukraine's sovereignty. Canada is also in contact with its G7 and NATO allies on this matter.

"The Government of Canada is unequivocal in its support for Ukraine and in its condemnation of Russia's illegal invasion and annexation of Crimea. Canada will always be a steadfast partner of the people of Ukraine, and we will continue to work with our allies to hold Russia to account for its unacceptable behaviour."

## Why should Sri Lankans expect any less at home than the democratic places they are drawn to internationally? tweets Canadian High Commissioner in Sri Lanka

Canadian High commissioner David McKinnon tweeted the following tweets recently, in response to calls from sections of Sri Lanka activists characterizing as 'Western interference' in Sri Lanka's "internal affairs":

"A lot of energy, both in rhetoric and in the media, is being used to criticize the strong international interest in the current situation in #SriLanka. In my view, that is a diversion from the real issue.

#Lka is Asia's oldest democracy. Lankans share the desire of people around the world to live in a society where they are able to have a say through the ballot box, consistent with the agreed rules (ie the constitution) in how they are governed.

The peaceful and constitutional change of government in 2015 was a significant accomplishment, one in which @MaithripalaS, @RW\_UNP and @PresRajapaksa all played important roles. That legacy is at risk.

The driver of international interest is a desire to see democracy and constitutional government preserved and strengthened in #lka. It is not about particular individuals and who may or

may not be in office.

The countries that have expressed a desire for a constitutional and democratic solution—#Canada among them—are places with deep and long-standing links with #lka, in part because they are the places Lankans would most like to visit, whether for study, work, holiday or to live.

#SriLankans are clearly drawn to studying in or living in places that are open, democratic and inclusive as well as prosperous. Why should they expect any less at home?"

# Number of Sri Lankans enrolled in graduate programs in the United States continues to grow

“The number of Sri Lankan students in the United States continues to grow, according to the 2018 Open Doors Report on International Educational Exchange. Currently, 3,309 Sri Lankans are enrolled in higher education institutions in the United States, which remains the top host of international students globally. The number of Sri Lankans enrolled in graduate programs in the United States grew by more than seven percent last year.

“Sri Lankan students receive a world class education in the United States, building critical skills needed in Sri Lanka’s economy and helping expand the 70-year relationship between our two countries,” said U.S. Ambassador to Sri Lanka Alaina B. Teplitz.

Ashrifa Ali, who attended the University of North Dakota, commented, “I had the opportunity to be mentored by some amazing professors who believed in creating individuals who could face the challenges ahead in our scientific careers. My U.S. education has broadened my horizons and given me the confidence to embark on a scientific career in this competitive global climate.”

EducationUSA offers free advising services and a resource library for those students interested in studying in the United States. Located at the U.S.-Sri Lanka Fulbright Commis-



sion at 55 Abdul Caffoor Mawatha in Colombo, students can explore educational opportunities with the help of a knowledgeable advisor. There are no fees for these services. The American Corners in Kandy, Jaffna, and Matara also provide virtual advising sessions.

As for U.S. students, study abroad numbers grew by 2.3 percent to 332,727 Americans studying abroad for academic credit in 2016/17. Approximately one in 10 U.S. students study abroad during their undergraduate career.

For eight nights, Jewish families and friends will come together to engage in the lighting of the menorah. # ‘Make healthy choices’ urges UN agency, to prevent and manage chronic diabetes

November 14: Diabetes is a chronic disease that occurs when the pancreas does not produce enough insulin, or when the body cannot effectively use the insulin it produces, which leads to an increased concentration of glucose in the blood. Around 1.6 million deaths can be directly attributed to diabetes each year.

“Diabetes is a major cause of blindness, kidney failure, heart attack, stroke and lower limb amputation,” said WHO, noting that about 422 million adults have the disease – a number that has been increasing steadily over the last three decades.

WHO Spokesperson Fadela Chaib said that was largely due to changes in lifestyle: “We are eating more heavy foods, full of fat and sugar; we are less physically active; and we have a more sedentary way of living.”

As one of the leading causes of death globally, diabetes is a major public health problem, one of four priority non-communicable diseases targeted for action by world leaders, according to WHO. Even when blood glucose levels are not high enough to warrant a diagnosis of diabetes, damage can oc-

cur to the body, elevating the risk of cardiovascular disease.

In 2012 diabetes took 1.5 million lives and higher-than-optimal levels of blood glucose another 2.2 million. Of the 3.7 million people who died, 43 per cent occurred before the age of 70.

“The percentage of deaths attributable to high blood glucose or diabetes that occurs prior to age 70 is higher in low- and middle-income countries than in high-income countries,” cited WHO in its Global Report on Diabetes.

Type 1 diabetes, previously known as childhood-onset diabetes, is characterized by a lack of insulin production and requires daily insulin to regulate blood glucose. The cause of type 1 diabetes is not known.

However, the majority of people are affected by type 2 diabetes, which results from the body’s ineffective use of insulin. Healthy diet, physical activity and avoiding tobacco use can prevent or delay its onset. Additionally, medication, regular screening and treatment for complications are also available.

“An accurate diagnosis is the first step to getting effective treatment,” WHO Director-General Tedros Ad-

hanom Ghebreyesus said earlier this year.

In its report, WHO called on governments to “ensure that people are able to make healthy choices and that health systems are able to diagnose, treat and care for people with diabetes,” and encouraged everyone to “eat healthily, be physically active, and avoid excessive

weight gain.”

The UN General Assembly designated 14 November as World Diabetes Day back in 2007, recognizing “the urgent need to pursue multilateral efforts to promote and improve human health, and provide access to treatment and health-care education.”

# Presidential Proclamation Announcing the Death of George H.W. Bush

It is my sorrowful duty to announce officially the death of George Herbert Walker Bush, the forty-first President of the United States, on November 30, 2018.

On the day he turned 18, 6 months after the attack on Pearl Harbor, George H.W. Bush volunteered for combat duty in the Second World War. The youngest aviator in United States naval history at the time, he flew 58 combat missions, including one in which, after taking enemy fire, he parachuted from his burning plane into the Pacific Ocean. After the war, he returned home and started a business. In his words, "the big thing" he learned from this endeavor was "the satisfaction of creating jobs."

The same unselfish spirit that motivated his business pursuits later inspired him to resume the public service he began as a young man. First, as a member of Congress, then as Ambassador to the United Nations, Chief of the United States Liaison Office in China, Director of Central Intelligence, Vice President, and finally President of the United States, George H.W. Bush guided our Nation through the Cold War, to its peaceful and victorious end, and into the decades of prosperity that have followed. Through sound judgment, practical wisdom, and steady leadership, President Bush made safer the second half of a tumultuous and dangerous century.

Even with all he accomplished in service to our Nation, President Bush

I hereby order that suitable honors be rendered by units of the Armed Forces under orders of the Secretary of Defense.

I do further appoint December 5, 2018, as a National Day of Mourning throughout the United States. I call on the American people to assemble on that day in their respective places of worship, there to pay homage to the memory of President George H.W. Bush. I invite the people of the world who share our grief to join us in this solemn observance.

IN WITNESS WHEREOF, I have hereunto set my hand this first day of December, in the year of our Lord two thousand eighteen, and of the Independence of the United States of America the two hundred and forty-third.

# DELIVERING GENIES UNDER SMOKESCREENS IS NOT A FACET OF DEMOCRACY

The idea of democracy was spearheaded in ancient Greece, one of the cradles of early civilisation. While the world at large lived under monarchies, presuming the divine rights of some individuals over others, the ancient Greeks and Romans held their leaders accountable to the people, carefully curtailing such leaders' powers with power invested in the people too. This was why Julius Caesar, one of the most popular leaders of Rome, was assassinated. He

sought to turn his elected prowess into a dictatorship.

Rome, at that time, was not a democracy though; it was known of as a republic – a system of governance in which assembled nobles held power but not the common people at the grassroots. The meaning of "republic" has evolved since then – it currently means that certain inalienable rights of the people are enshrined in the constitution. This is to curtail the flaw in a pure democracy,

where the majority of people can take decisions, which could impinge on minority rights. Enshrining basic human rights in the constitution that a majority may not overrule to their advantage is the premise of a modern republic.

We live in the Democratic Socialist Republic of Sri Lanka as per our Constitution ratified in 1978. A long name for a small country. A name that promises the surety of basic human rights – for majority and minority communities

alike. What actually happens here on the ground though is a different story.

When we gained our independence in 1948, we seemingly gained a democratic system of government. I use the word "seemingly" because most of our leaders since then never got the memo not to rule like autocrats. They also, apparently, didn't get the memo not to form dynasties akin to monarchies, because their offspring are not intended to inherit leadership positions in a democratic system of government. The offspring didn't get the memo they are not princes and princesses either.

Sometimes, one wonders if our own people even understand the basic concept of a democracy, much less a republic. Why else would we sit back and watch our rights get repealed continuously? It's not the rule of the sword; or at least it ought not to be. The people's voices matter – even the minority segments' voices and views.

The last so called Yahapalana Government was voted into power in no small measure due to the bloc voting of the minorities in this country, who had been extremely sidelined by the rampant Sinhalese nationalism under the previous regime.

President Maithri, after coming to power on the promise of ousting the excesses of the old regime, has now backstabbed the voters by delivering – via a smokescreen, the ogre they ousted.

A popular meme, making the rounds on the internet within the country currently, has a protestor carrying a placard proclaiming "I am not here for Ranil. I am here for democracy and good governance", which she had also tweeted – to which Ranil Wickremesinghe apparently tweeted back, "and that's OK. That is what democracy is about".

It brings to mind the attitude of many voters in January, 2015. I heard from the lips of more than one person, mostly minority folks: "I am not voting for Maithri. I am voting against Mahinda."

It is through the powers vested in him by that anti-Mahinda vote that the current President has chosen to arbitrarily sack the Prime Minister to bring back

the very person who was voted out. Everything that has been unfolding over the last few days dictates absolute disregard for the people's rights, the people's views, and most importantly the people's votes.

While the average Sri Lankan struggles to make ends meet, day-to-day, parliamentarians are being bought over for unbelievable sums of money – totalling millions of dollars. Is this a democracy? Is this a republic? Is this socialism? We might as well ditch the idealistic name and christen ourselves the “Banana Republic of Sri Lanka.” That's what we long have been in essence anyway.

It hurts to think the likes of imperialists like Rudyard Kipling might have been right after all when they said we natives in the colonies were not fit to rule ourselves, no matter how educated we became. Our rulers, since independence, have done precious little to prove such imperialists wrong. Please do not mistake me. I am not hankering to get back under colonial rule. I am just wondering what it is about us that makes us go so badly off the rails when it comes to our governments, repeatedly.

I have no patience either with the internet memes that blame the common people who voted in the respective governments. The people almost never vote for corruption and mismanagement. They vote in good faith for good

governance – as we did en masse for the last one.

If those promising “good governance” failed to deliver, stop blaming the voters. We are constantly between a rock and a hard place when it comes to our elected leaders.

It's deeply bewildering and hurtful as a population to see our elected representatives in Parliament constantly crossing over for bribes. While a few people will become mega rich from this fiasco, the rest of us are still left scrambling for our daily bread – bread which few of us can afford to literally buy these days.

Worryingly, matters seem set to worsen regarding the economy in the coming days, with the falling rupee and resultant crisis. At the end of the day, can the voters be blamed for all this? Simply because we are unfortunate enough to exist in name at least in a democracy? The democracy, the socialism, and the republic are on paper only. The people clearly have little to no say in this current unfolding crisis.

What is happening before our eyes is worthy of a Shakespearean tragedy. Since we have little choice in the matter, many Sri Lankans have chosen to deal with it as a tragicomedy, where they use liberal doses of humour to counter the pain of the blatant violation of our rights in broad daylight.

A large number of hilarious memes are currently floating around in the Sri

Lankan cybersphere. The cartoons in daily and weekly newspapers likewise are just as hilarious. We are good at laughing at ourselves be it said. We'll go down laughing.

Meanwhile, the tragedy (I refuse to call it a tragicomedy) continues to unfold. The last time I checked the news, a middle-aged man had been named as the State Minister of Youth, Women and Child Affairs. And just like that, progress made in the last few years in finally getting a woman to head that Ministry had been undone.

Not only is a new Cabinet being hastily put together, but the women's rights activists' hard work in getting a female minister at last for that one important portfolio has been undone as well. We are the banana republic where a former male minister of Women's and Child Affairs just a few years ago, famously said that women should never be given leadership positions, even over matters directly pertaining to us.

Thus, in a country where we women are 52 % of the population, where we form the backbone of the economy by being the main employment force in the tea, garment, and migrant worker sectors, we not only have extremely few women parliamentarians to represent us, we also again have a man heading the one ministry allocated to us. Interesting (or should I say obnoxious?) days are ahead of us, that's for certain.

Baby steps in progress regarding

not just democracy, but also minority rights and women's rights over the last few years have been undone in a matter of days. And the male leaders will of course say we women are not fit to rule, to be in positions of leadership at any level because we are too hormonal, too emotional, too irrational.

They themselves, currently scurrying about akin to rats deserting one ship for another, are of course the epitome of good sense, not to mention good governance. They'll make speeches of loyalty and allegiance to one party and revoke it within a matter of hours to join the other, all under the public spotlight of the media, and still retain their right to rule. Their hormones, their rationality, their emotions will remain unquestioned. God help us all.

Democracy has not failed us. Our elected representatives have failed us. It is in the nature of a true democracy though to have checks and balances to ensure the elected leaders do not have arbitrary powers with which they can make themselves even more powerful. That is where we have failed.

We need to move on from memes laughing at ourselves, and even more insidiously, memes blaming ourselves as the voters. We need to put all that creativity, good humour, and good sense to use in reworking a constitution wherein we the people can no longer be hoodwinked. Let us learn our lesson.

# Indian Politicians Spar Over Dodgy Economic Data as Election Nears

November 30, 2018.

NEW DELHI — It may be the world's sixth largest, but most other things about India's economy are up for debate.

The ruling Bharatiya Janata Party (BJP) is under fire for the release of new historical GDP figures that significantly downgraded growth during the years the opposition Congress party was in power, replacing old government estimates and those prepared by an independent committee.

The figures, released by the government's Central Statistics Office (CSO), showed growth in the 10 years of Congress rule to 2014 averaged 6.7 percent, below an average of 7.4 percent under the current government. A previous government estimate had growth under Congress at 7.8 percent.

P. Chidambaram, a former Congress finance minister, called the release "a joke". In response India's current finance minister, the BJP's Arun Jaitley, said the CSO was a credible organization.

The fallout comes at a critical time for Prime Minister Narendra Modi.

India's economy grew a weaker-than-expected 7.1 percent in the July-

September quarter, from a more than two-year high of 8.2 percent in the previous quarter, government data showed on Friday.

Modi faces a general election next year, when the performance of the economy under his pro-business administration compared with the Congress era is likely to dominate campaigning.

The spat has also alarmed India's top statisticians, who have long faced the difficult task of estimating growth and unemployment in an economy with hundreds of millions of informal workers, and dominated its financial press and political cartoons in recent days.

"The entire episode threatens to bring disrepute to India's statistical services," said an editorial in Mint, one of the country's leading business newspapers, on Friday.

A joke widely circulated on WhatsApp said the government would soon be reinterpreting the last cricket World Cup, in which India crashed out in the semi-finals, to say the country won based on a new methodology.

## COMPETING INTERESTS

Unlike many major economies, India lacks an independent statistical body.



An organization called the National Statistics Commission (NSC) was formed in 2005 with that intention, though it is yet to be recognized as the official body for generating statistics.

Last year the NSC set up a committee, chaired by economist Sudipto Mundle, to come up with a new set of historical GDP figures.

Its report, published in July, showed growth averaged 8.1 percent in the decade before the BJP took power.

After the figures were cheered by the Congress, the government issued a clarification saying the report "had not yet been finalised and various alternative methods are being explored". Shortly after, the report was pulled from the government's website.

"The whole thing has unfortunately become very political," said Mundle, on the battle between the two parties. "It is very troubling."

Attempts to formalize the NSC's role have been successively stonewalled by both Congress and the BJP, said N R Bhanumurthy, who sat on the committee chaired by Mundle.

"They have not shown much interest in making it independent from our government," he said.

The debate over India's true level of growth is the latest to frustrate economists looking to measure the performance of the country of 1.3 billion people.

India has not published its official employment survey since 2015, while a smaller quarterly survey on companies employing more than 10 workers has not been released since March while the government comes up with new methodology.

India's large informal sector made calculating employment "almost impossible", Bhanumurthy said, leading to a vacuum that was filled with competing political interests.

# Indian Police Halt Efforts to Retrieve Body of American Killed by Secluded Tribe

November 27, NEW DELHI —

Police in India have put on hold efforts to retrieve the body of an American missionary who was presumably killed by a secluded tribe on an island off the Indian mainland.

The move came after anthropologists, researchers and an international rights group had urged authorities to call off the search, saying it posed a risk to the hunter-gatherer tribe.

John Allen Chau went to the prohibited North Sentinel Island on a mission to convert the tribe to Christianity. Tribe members reportedly shot him dead with arrows. Fishermen said they spotted tribe members dragging and burying the body in the sand.

Since then, police grappled with the challenge of recovering the 27-year-old's body from an island that has been off limits for centuries and whose inhabitants have defied all attempts by outsiders for contact.

The latest attempt to get close to the island was abandoned Saturday after police, who had stopped their boat about 400 meters from the shore, spot-

ted the Sentinelese standing armed with bows and arrows.

In a statement, Survivor International called the search "incredibly dangerous" for both the tribe and officials, and said, "Mr Chau's body should be left alone, as should the Sentinelese."

"Such efforts in similar cases in the past have ended with the Sentinelese attempting to defend their island by force," said Survival director Stephen Corry. The group, which campaigns to protect threatened tribes, also stressed the risk of exposure to outside diseases for the tribe with every contact. Isolation from the outside world is considered essential to their survival as they have no immunity to modern-day diseases.

A group of anthropologists, researchers and authors has also expressed concern that attempts to retrieve the body could escalate tensions as the tribe clearly finds these "incursions" unwelcome.

"Continuing with the efforts could well lead to further violence and completely unwarranted loss of life," they said in a joint statement. "The rights

and the desires of the Sentinelese need to be respected."

One of the signatories, anthropologist Visvajit Pandya, told VOA "When we have a rule that nobody should go to the island, why should we pursue efforts to get the body?"

Going to the island, which is part of India's Andaman and Nicobar archipelago, is illegal and all efforts to study the Sentinelese have been made from a distance.

The police chief of the Andaman and Nicobar, Dendendra Pathak, has called the case the "most challenging ever." The police also said that it is taking

care to ensure that this "particularly vulnerable tribal group" is not disturbed or distressed.

The tribe, estimated to number about 50 to 150 people, has fended off all efforts by anthropologists and others to get close to them.

Chau went to the island in mid-November after paying fishermen to take him there. Despite being shot at with arrows, he returned there the next day

# A NEW DAY FOR PSORIATIC ARTHRITIS (PSA)

On Friday October 19, 2018, Canada held its inaugural National Psoriatic Arthritis Day to raise awareness and encourage discussion around Psoriatic Arthritis (PsA).

This chronic, inflammatory arthritis is not well known among Canadians. In fact, many of us may be more familiar with the skin condition psoriasis – an inflammatory disease that can lead to psoriatic arthritis.

This is why individuals living with psoriatic arthritis often feel left behind and overlooked as other types of arthritis get more attention, such as osteoarthritis and rheumatoid arthritis.

Initiatives like National Psoriatic Arthritis Day will help generate more awareness and understanding about the disease, but there is still a long way to go.

We caught up with Dr. Thanu Ruban, a Rheumatologist from Markham Stouffville Hospital, to give us a better understanding of this disease and its impact:

**Q: Thanks for speaking with us Dr. Ruban. What are the common symptoms of PsA? What do your patients complain about the most?**

**A:** Psoriatic arthritis presents in a number of ways. The majority of patients with psoriatic arthritis will develop joint pain and swelling. This will tend to progress to involve multiple joints over several weeks to months. In some patients, this arthritis may develop quickly and can cause permanent joint deformities. Joints that are often involved in psoriatic arthritis include hands, feet, ankles and knees. Patients with psoriatic arthritis can have back pain that causes prolonged morning stiffness as well as nighttime awakening. Psoriatic arthritis can also affect the tendons and ligaments that are attached to bone (often called tendinitis or enthesitis). This can cause people to have pain around the back of

the heel, underneath the heel, on the sides of the elbows as well as hips.

**Q: Does this PsA affect primarily younger people or older people?**

**A:** Psoriatic arthritis usually appears in patients between the ages of 20 to 50 years.

**Q: How common is PsA?**

**A:** Psoriatic arthritis is reportedly seen in 1 in 400 to 1 in 500 people from the general population. However, this number may be higher as we know that this disease is under recognized. The risk of psoriatic arthritis is higher in patients with psoriasis. Up to 30 per cent of patients with psoriasis may develop psoriatic arthritis. More severe psoriasis as well as nail disease associated with psoriasis can increase the risk of psoriatic arthritis. Family history of psoriasis in a first-degree family member (mother, father, siblings, children) may also increase the risk of psoriatic arthritis.

**Q: As they are at risk of developing PsA, what should people with psoriasis be looking out for?**

**A:** Individuals with psoriasis should work with their healthcare provider to obtain treatment for their skin disease. They should also speak with their doctors if they have joint pain, as this may be a symptom of psoriatic arthritis.

**Q: Is there anything people with psoriasis can do to prevent getting PsA?**

**A:** There are no specific interventions that are known to prevent psoriatic arthritis. Controlling psoriasis – the skin disease – may help reduce the risk of psoriatic arthritis.

**Q: How do you treat PsA?**

**A:** Psoriatic arthritis is an autoimmune disease that occurs when the immune system attacks the skin and joints. Treatment of psoriatic arthritis does include oral anti-inflammatories as well as medications that suppress the immune system. These medications are highly effective for treatment of psoriatic arthritis.

Psoriatic arthritis is a disease that can cause permanent deformities and significant disability in patients. We know that with early recognition of the disease and treatment, we are able to prevent joint damage and disability.

**Q: What should people do if they think they are suffering from PsA?**

**A:** These individuals should speak with their healthcare providers about their joint symptoms. It is also important to let your healthcare provider know if you or a close family member has been affected by psoriasis in the past. This may alert your healthcare provider to assess for psoriatic arthritis.

**Q: What resources and support are available to Canadians who have been diagnosed with PsA?**

**A:** There are number of useful resources for patients with psoriatic arthritis. The Arthritis Society provides reliable information and support for patients living with arthritis in Canada

# Mannar's Mighty Women of the Sea

Widowed or badly affected during the decades of conflict, the fisher community in Anthoniarpuram, Mannar in North Sri Lanka has new heroes. Groups of women have formed fisheries cooperative societies, and often spend the night at sea, diving for sea cucumbers and crustaceans in the waters of the Lagoon to keep their families alive and reconstruct lives torn apart by War

As dawn breaks over the village of Anthoniarpuram, Mannar, we could see a tiny footpath leading down to the lagoon. Unlike before, the little village is at peace now; morning sunbeams make dancing patterns on the sand, and the stately palmyrah palms sway in the soft breeze. A decade ago, this was a region marked by violence and loss. Residents fled the civil war, returning years later to find their homes entirely looted. Their lives were altered too – some of them had lost loved ones, others were missing limbs, while homes and livelihoods had been wiped out. Returning families had to start from scratch and in most cases, the women were left to do it.

The footpath wound down to the lagoon, and female silhouettes appeared in the distance. Many of them were holding implements of some kind.

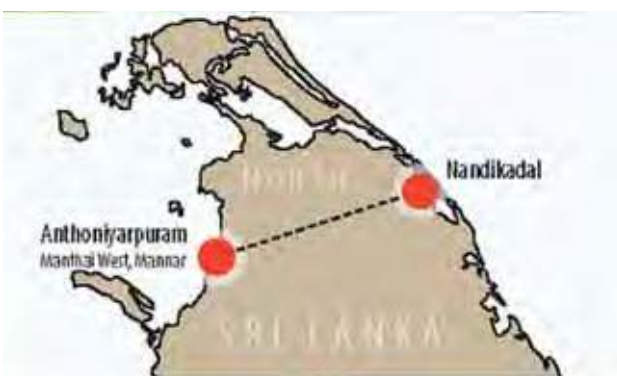
When the strangers approached, their faces broke out in smiles in the early morning light. The fisher community, now bereft of men – many who perished during the war – have leaned on women like Elizabeth Paththinathar, Jayanthi Muller and Mary Matilda to eke out a living in the way they know best. Now the sole breadwinners in their families, the three women go out to sea every day, diving in the lagoon to catch a bounty of shrimp, crabs and reef fish.

Elizabeth Paththinathan, 53, is the President of the Anthoniarpuram Fisheries Cooperative Society. Many women have been widowed in the war, she explains, and others are still struggling to rebuild, a decade after the guns fell silent. “The women in these areas have formed small groups and we go out to sea together. This is how we make a living,” Elizabeth said. Non Governmental Organisations have supplied this resilient community of women with the necessary fishing and diving equipment.

Anthoniarpuram residents have always lived off the bounty of the seas, said the Fisheries Cooperative Society leader. “But before the war, the women would only assist the men who went out to sea. It’s different now – we must do the bulk of the fishing,” she explains with a smile.

When the weather is good, the women go out fishing in the evenings. They use the small islets scattered in the lagoon to take breaks from diving for fish. “We take tea and coffee and something to munch. In the little islands we drink tea and rest a while before going out fishing again,” says Mary Matilda. “We fish all night and return to shore in the morning.”

Jayanthi Muller says, on and off the Navy stops the women from going out to sea, fearing for their safety. “It must be because we are women, and they worry there would be an accident. But, we are all good swimmers,” Muller laughs. She says, the women enjoy fishing because it allows them to spend time

together and eke out a decent living.

An elderly woman in a long dress approaches, her long hair still wet, hanging loosely around her shoulders. Nachchatthiram Lurdumuller is 75 years. She and a group of fisherwomen had come to shore at dawn, after fishing all night. She explains that several older women engage in dive-fishing in the waters of the lagoon. “I have only a daughter. She is married now. So this helps me to earn a living,” Lurdumuller explains.

Behind the camaraderie and the broad smiles, each of these women is heir to a tragic war-afflicted past. “We were displaced during the war. My husband, daughter and I went from place to place to escape the fighting. In front of our very eyes, shells fell on people and they were torn apart. We would run to a bunker then. As the fighting flared on all sides, we were stuck in between,” Lurdumuller recalls. The 75-year-old woman was widowed when an artillery

shell fell on her husband while he was on his way to the shop, killing him instantly. “We were alone then, my daughter and I. We followed the rest of the displaced from place to place.”

Lurdumuller says, finally they crossed the Nandikadal Lagoon, and into Government-held territory during the final stages of the war. “At 3 a.m. the military put us all in a bus and brought us to the Ramanathan Displacement camp. Ultimately, we returned to our village. It’s a miracle that we are alive today – God must have saved us,” she says, her eyes brimming with tears and memory.

Elizabeth is the mother of six daughters and she recalls, as they were displaced from location to location, people warned her about the safety of her girls. “But, what could we do. One day we were in one place, the next day in another,” she says, explaining that they were beaten further and further into the Wanni by the vicious fighting.

At the end however, Elizabeth’s family had made the journey to Mullivaikkal by foot and the final stage of the war was upon them. “The LTTE said no one was to leave. They told us to stay inside the bunkers,” Elizabeth recalled. Her husband would put them all inside the bunker and sit outside keeping watch. It was during one such vigil that a stray shell fragment fell on him and his leg was wounded. People from other bunkers had come to his aid and taken him to the Mullivaikkal make-shift hospital for treatment. Disregarding the pleas of those around her, Elizabeth went secretly to visit her husband in the hospital. She finds it hard to tell the rest of the story.

“I never found him there, but outside there were hundreds of wounded people lined up close together, blood spilling everywhere,” she remembers. Once Elizabeth and her children found their way back to Government controlled area, they were reunited with her husband who was receiving treatment at the Vavuniya Hospital.

“This is only one of our stories,” she says wistfully. “We have so many more.” Elizabeth says, she considers herself lucky to be able to engage in a livelihood that keeps her family going, after all that they suffered.

Lurdumuller walks off, eager for some rest after her long night of fishing and having shared their stories, the other women walk slowly towards the water.

As they approach the still waters of the lagoon, the women put on scuba masks and wade in, going slowly until they find the right depth. Putting their faces in, the women begin diving for the prized catch in these lagoon waters – sea cucumbers, for which there is a big demand in the export market.

These fish are not purchased locally, but each day, fish traders arrive to purchase the precious ocean bounty, a delicacy in some East Asian nations.

Wading deeper and deeper, the women dive to the seabed to bring up the flat cylindrical sea creatures with the leathery skin.

Sustainability is a big priority, the ladies say, as they wade in to the lagoon. “Some of the men use nets and catch even the baby fish. We are totally opposed to this.

It would eventually wipe out our livelihood when the ocean resources dry up,” they explain, swimming deeper and deeper into the ocean and disappearing underwater.

# Was Jesus born on Dec.25?

## A historical review

We are now in the midst of Christmas, a festive period concerning the birth of a child that altered the course of history of mankind. We rejoice, the birth of infant Jesus, the saviour of mankind and remember a heavenly host joining the angel of the Lord singing "Glory to God in the highest heaven and on earth peace among those whom he favours".



Many historians and Christian scholars have by their diligent effort and meticulous research has been able to compile some useful information relating to the time of birth of Jesus. Some of these information comes from the cherished stories of the birth and early life of Jesus described in the Gospels of Mathew and Luke.

However to this day, it has not been possible to determine the exact year and date of birth of Jesus born in Bethlehem over 2000 years ago.

### 1. Gospel of Mathew

According to Mathew's Gospel it is stated that "Now when Jesus was born in Bethlehem of Judea in the days of Herod .The King Herod the Great who became King in 37 B.C. (Before Christ) died in the year 4 B.C. Mathew therefore places Nativity prior to the year 4 B.C. In the 6th century Pope John 1 assigned a Roman monk named Dionysius Exiguus to prepare a standardized calendar for the Western church .Dionysius made the birth date of Jesus the basis for his chart of Easter dates. Dionysius labeled the years after Jesus' birth "AD" (which stands for Anno Domini, meaning "in the year of the Lord" in Latin), a system later supplemented by the term "BC" (which stands for Before Christ) In his calculations, Dionysius miscalculated the death of Herod by four years, resulting in the awkward situation that Jesus' birth is usually dated into the years "BC" (Before Christ).

### 2. Census in Syria. & Gospel of Luke

Meanwhile Luke tells us that the birth of Jesus occurred at the time when Emperor Augustus Caesar ordered a census. That census took place when Quirinius was the Governor of Syria (Luke 2:2).

According to historical records, Augustus Caesar dispatched Governor Quirinius to Syria in AD.6.During the same period Coponius was the first Governor of Judea. As such, Quirinius and Coponius jointly conducted a census at that time.

However if Jesus was born prior to

4 BC , at this time of the A.D 6 census Jesus would have had to be at least 10 years old by that date. Therefore, the birth of Jesus could not have occurred prior to 4 B.C.

Meanwhile, some scholars have pointed out that Quirinius served an earlier term in Syria (from 10 B.C. to 7 B.C). This probably could be the period to which Luke refers in his gospel.

### 3. Star of Bethlehem.

A third Clue to the date of Nativity is the Star of Bethlehem

- In 12 B.C. Chinese astronomers recorded a comet named Hailleys.

- They also mentioned about a stellar explosion (or Nova) in 5 B.C.

Either of the above two events could have been the celestial guide to Three wise Men seeking the place of birth of Jesus.

Meanwhile in early 17th Century, German Astronomer and Mathematician Johannes Kepler proposed another explanation. Kepler observed conjunction of the two planets Saturn and Jupiter within the constellation Pisces, in 7 B.C. He remembered an ancient Hebrew tradition that the Messiah would appear when the two planets moved so close to one another, that they appeared to be a single large star. On checking the ancient astronomical charts, Kepler found that in year 7 B.C. The planets Saturn and Jupiter had three such Rendezvous – on May 29, Sept. 29 and Dec.4.

Out of these three dates, it is possible that the "Three wise men from the East" – possibly astrologers in Babylonia chose the September date to start out along the caravan route to Judea. Based on the geography of the travel, such a Journey would have brought them to Bethlehem area towards the time when there still could have been, as Luke writes "Shepherds out in the Field, keeping watch over their flock by Night".

### 4. Month of Birth

#### - November/ January

Mediterranean climates such as Judea's have mild winters reaching their coolest in late February. Thus December nights can be quite balmy and warm enough to graze sheep. Moreover, December/January would have been an ideal time to graze sheep to take advantage of the winter rains.

During the hot months, conditions can be quite barren and the grasses dry. But the end of December was the time when the perennial grasses began to turn green again and the annual grasses had sprouted anew. Thus, climatically the ecclesiastical practice of placing Christ's birth between December 25 and January 6 is possible.



**Today in the city of David (Bethlehem), there has been born for you a saviour, who is Christ the Lord (Luke 2:11)**

Controversy over whether Christmas ought to be celebrated on December 25 or January 6 underscores the perceived importance of the day of Christ's birth and the determination of church fathers to be accurate.

Based on the above evidences and reasoning from Keplers Hypothesis, it is at least a possibility that Jesus was born in Late Autumn in the year 7 B.C. though we may never know for certain.

### Declaration by Pope John 1

However in order to bring an end to the dispute among the Historians and

Scholars regarding the year and date of the Birth of Jesus, Pope John.1 in AD.525 declared that December 25th should be celebrated as the date of Birth of Jesus.

Irrespective of the exact dates and year on which Jesus was born, what is more important is that His Birth as well as His Teachings about the kingdom of God continues to be a spiritual guiding factor and of immense benefit to mankind.

## Amazing Grace! How sweet the Sound.

A praise song that appreciate the grace that has been made available to humans. It is the grace of God that can help weaklings to face the dangers, snares and toils and lead us safely home. God's calling is the best thing that ever happened to us. His word secures our hope. We were once lost but now found. We are recipients of the blessings of God-not through our purity or goods but merely through his abundant grace. A very inspiring song that is sung very often in churches. It was written by John Newton.

## Oh! for a thousand Tongues to Sing

The hymn enlists the glories of God and states that even thousand tongues are not adequate to sing of the triumphs of his grace. The love of God is music to the sinner's heart. We need the help of God to spread through all the earth the honours of his name. The song is in the words of Charles Wesley, one of the stewards of the Methodist Church. His faith and practice of the living words of God influenced a large number of human souls and brought them to the feet of Jesus.

## What a friend we have in Jesus?!

The hymn underlines the need to seek God daily to hand over our worries and fears. Our burdens will be eased and our souls are cleansed with the fellowship with God. It is a praise song that should be sung daily to take us on a closer walk with God. It was written by Joseph Scrover of Ireland in 1820. It is said that he faced several tragedies in his life. He used his depths of sorrow to empathize with the elderly and the poor. The lines were written in a simple and personal tone that makes it an essential praise song to prepare our minds for worship and fellowship with God. "What a privilege to everything to God in prayer. Can we find a friend so faithful, who will all our sorrows share?"

## Jehovah, thou hast promised- A hymn for Ceylon by Rev. W.S.Senior.

This is a hymn written by Rev. W.S. Senior who once served at Trinity College, Kandy. The hymn was based on the hymn-Oh! Jesus, I have promised'. The song mentions about the natural landscape of Sri Lanka and seeks the blessings of God to preserve the peace and prosperity of Sri Lanka. 'On every soaring mountain, 'over every spreading plain', Give peace within her borders, Twixt man and man goodwill, the love all unsuspecting, the love that works no ill.' 'In loyal lowly service, let each from other learn, the guardian and the guarded, till Christ himself return.'- are some of the lines in the hymn that makes it a memorable song with great thought and captivating music.

## When I survey the wondrous cross

This is reckoned as the greatest hymn in the English language. It was written by Isacc Watts, a pioneer song writer in 1707. It was based on the text: Galatians: 6-verse 14. It is a deeply moving solemn song. It focuses on the cross of Christ and calls us to devoted discipleship in response to Christ's love. "Love so amazing, so divine, demands my soul, my life, my all".

## Blessed Assurance, Jesus is Mine

This hymn was written in 1873 by a blind man named Fanny Crosby. This one of the most beloved hymn of all time. It inspires a closer walk with God according to the idea given in Philippians: 1:21: 'For me to live is Christ and to die is gain'. The hymn looks like a personal testimony of faith in Jesus. 'This is my story, this is my song; praising my saviour all the day long'. It inspires us to love Jesus and be faithful to him at all times.

This is a popular Christmas carol written by Isaac Watts. It is the most published Christian hymn in North America. It is based on Psalm 98:11-12. It celebrates Christ's rule over the

## My Jesus, I love Thee, I know thou art mine.

This is an inspiring and meticulous spiritual Pentecostal hymn written by Bethel Sharon. It spells out the importance one's faith in keeping touch with God. Faith gives the strength to keep closer to God in our daily lives. When Jesus is beside us, we can face all the trials and tribulations that confront us. The refrain of this hymn gives a dynamic energy fueled with the grace of God to direct us in the paths of righteousness.

*I am walking with Jesus,  
There is nothing now to fear,  
I am walking with Jesus,

He wipeth every tear,  
I am walking in the steps of Jesus.'*

# THE 2018 NOBEL PRIZE IN PHYSICS FOR TRIO LASER PIONEERS

The Light Manipulation Includes the Third-Ever Canadian Female Professor

2018 Nobel Prize winners have now all been declared. The prestigious Nobel Prize awards are bestowed upon scientists and thinkers for their pioneering and exceptional work that “bestows the numerous benefit to humankind.” It is the ultimate accolade for any academic or intellectual. This year, Trio scientists won the Nobel Prize for Physics for breakthroughs in laser technology that have turned light beams into precision tools for everything from eye surgery to micro-machining.

They include the first Canadian female physics prize winner in 55 years. Professor Donna Strickland, of the University of Waterloo, becomes only the third woman to win a Nobel for physics. The award marks only the third time a woman has been awarded the physics Nobel. Previous female winners were Marie Curie in 1903 and Maria Goeppert Mayer in 1963. Arthur Ashkin of Bell Laboratories in the USA won half of the 2018 prize for inventing “optical tweezers,” while Strickland shared the remainder with Frenchman Gérard Mourou, who also has U.S. citizenship, for work on high-intensity lasers.

Swedish Academy of Sciences hailed Nobel winners as crafting “tools made of light.”

## WHAT THEY ACHIEVED?

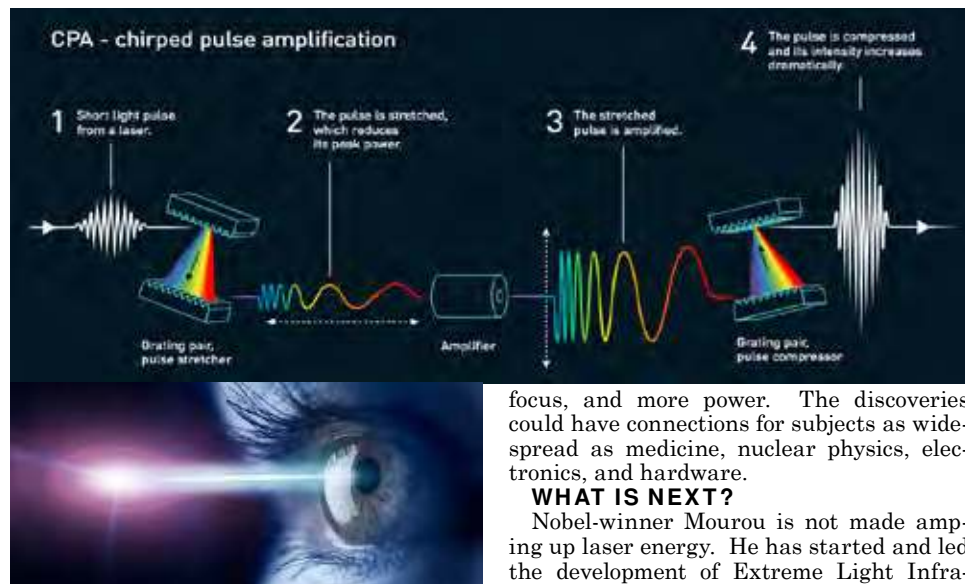
The inventions by the trio scientists date back to the mid-1980s. They have revolutionized laser physics over the years. “Advanced accuracy instruments are initiating unexplored areas of research and many medical and industrial applications,” the academy said on awarding the 1 million dollars.

The Nobel prize was divided between two significant discoveries in laser technology. Laser devices create and amplify a single source of light. The light from a laser is one color, or one wavelength, and does not spread out or weaken the way a torchlight would.

## WHAT IS OPTICAL TWEezer?

Arthur Ashkin used the radiation pressure of a tiny, focused beam of light to catch small gadgets. The tweezers grab, cut, and move around a little object without touching them. It has resulted in many applications across many fields of science and medicine. For example, they have been used to trap a water droplet to study how they behave when they are a cloud, or grab droplets from an asthma inhaler to find out how it can be better dispersed inside lungs.

Ashkin started working to manipulate objects with light immediately after the invention of lasers in the 1960s. He found that small translucent particles could be pushed using the force from a laser beam. Ashkin's work was based on the understanding that the strength of a beam of light could force tiny articles and catch them in place. In 1987, a discovery came when he used the new optical tweezers to grab living bacte-



focus, and more power. The discoveries could have connections for subjects as wide-spread as medicine, nuclear physics, electronics, and hardware.

## WHAT IS NEXT?

Nobel-winner Mourou is not made amplifying up laser energy. He has started and led the development of Extreme Light Infrastructure. He has three sites across Europe and is assumed to be accomplished in fewer years.

The peak strength of its laser is planned to be ten petawatts—equivalent to an amazingly short-flash from over thousand billion light bulbs. Some foretell a future laser of a hundred more than 100 petawatts or as fast

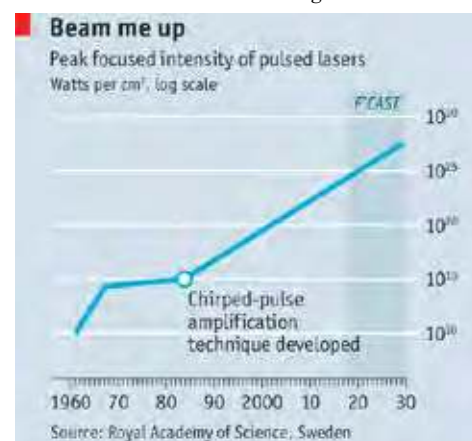


as zeptoseconds (a trillionth of a billionth of a second).

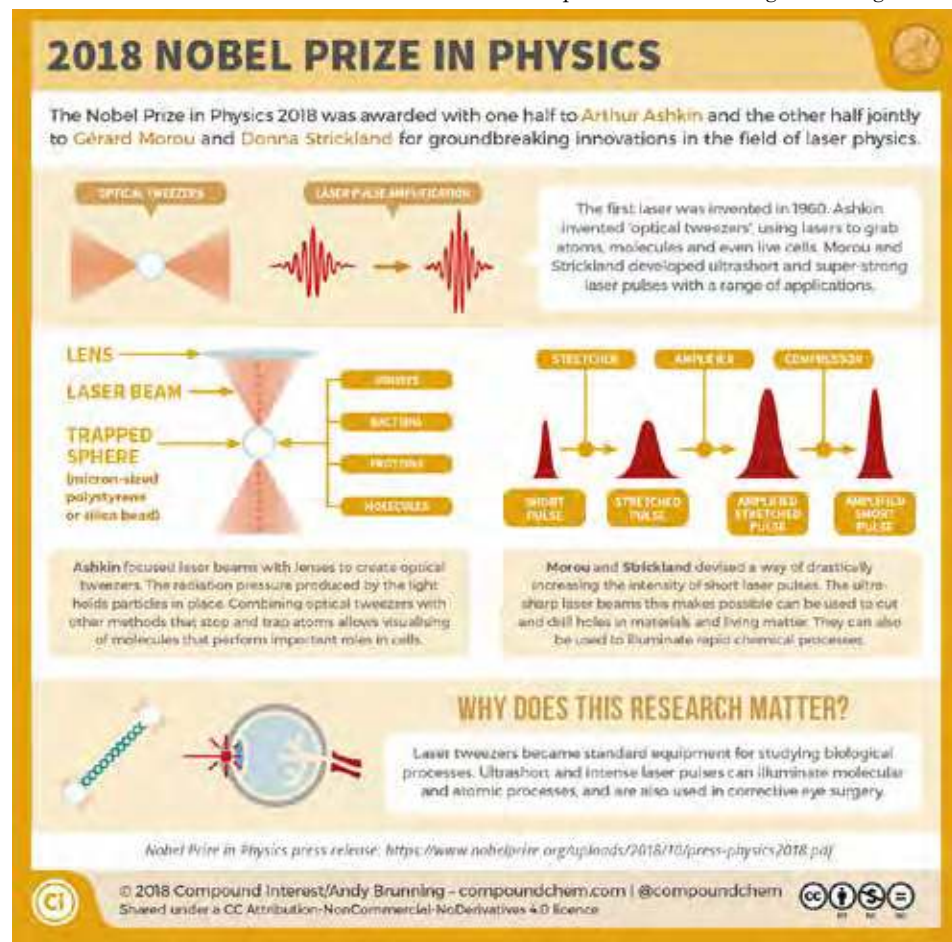
It is difficult to foretell how it can be used. Scientists believe that they will help destroy cancer cells, nuclear waste, clear debris from space, unravel quantum physics and even be a new clean energy source.

The prizes for accomplishments in science, literature, and peace have been awarded since 1901 by the Swedish business industrialist Alfred Nobel, whose discovery of dynamite generated a vast fortune used to fund the prize. The Royal Swedish Academy of Sciences is an independent organization and was found in 1739. Its overall objective is to promote the sciences and strengthen their influence in society. The Academy takes responsibility for the natural sciences and mathematics, but endeavors to encourage the exchange of ideas between various disciplines.

The inventions are being honored this

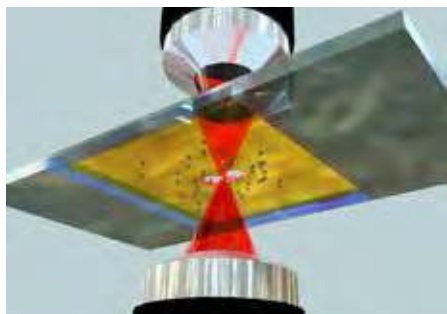


year have revolutionized laser physics. It is exceedingly small objects, and incredibly rapid processes are now observed in a new light. Advanced precision instruments are opening up unexplored areas of research and a multitude of industrial and medical applications.



## WHAT IS A LASER?

The ground-breaking discoveries to harness the power of lasers provide a few basic facts about their findings. Lasers are a light source, just like flashlights, but with unique properties. When light leaves a flashlight, it expands out. A laser concentrates the light. The difference comes from the hollow used to catch and guide the light before it is emitted. This why the Royal



ria without harming them. The Particles first were confined in the middle of a beam, and then fastened in position applying another laser aimed from the opposite direction. These visible tweezers could then be used to control and manage different cells, viruses, proteins, and even atoms. Ashkin (96) is still busy with fresh research and the oldest ever Nobel prize winner. “I am surprised about winning the prize, and he is now writing an extraordinary article on solar energy,” he told Reuters.

# Managing investment risk actively

In the investment world, the term “investment risk” relates to the fluctuations in the value of a stock, bond or a mutual fund assets. Investors generally want to avoid excessive investment risk. It stems from the rationale that investors feel a great deal more displeasure when the value of their investment declines, than the pleasure they experience when their investment increases.

Therefore, it stands to reason if investors are going to invest in risky assets such as stocks and bonds they would prefer to do so in such a way that the potential rewards outweigh the potential risks. Given a choice between two investments with the same amount of risk, a rational investor would always take the security with the higher return. Given two investments with the same expected return, the investor would always choose the security with the lower risk.

Achieving your investment goals requires patience and a keen understanding of how you would like to achieve those goals. Designing your investment portfolio should not only consider the rate of return you wish to achieve but also the investment risk you may encounter. Generally, the desire for a specific investment return should be secondary. The primary focus should be on identifying your comfort level with risk and then, through proper analysis, determine an appropriate mix of assets that will potentially provide the highest return that corresponds to the desired amount of risk you are willing to withstand.

The objective to reduce investment

risk is critical, as it is far easier to lose money than it is to earn it. What is often overlooked is that it takes a greater effort to recover a loss than it did to incur that loss in the first place. Market declines have been known to be even more extreme which places an even greater emphasis on obtaining higher returns to recover investment losses. Proper care must be taken to avoid excessive market volatility and insulate yourself as much as possible from such occurrences. The easiest way to reduce risk is by investing in assets that offer a guaranteed rate of return. The problem is that the investment return of a guaranteed investment is relatively low.

This means that over time the effects of inflation will likely ravage the value of the investment. Quite often investing in risky assets such as stocks and bonds tends to be the most appropriate means for achieving an investment goal. To that end, the best way to invest in stocks and bonds without incurring an excessive amount of risk is by diversifying your assets. Proper diversification and asset allocation is essential, as it will reduce risk without sacrificing a whole lot of return. Investing always involves an element of risk, and no matter how careful an investor is, losses will occasionally occur. That is why an appropriate investment strategy must be in place to help minimize risk.

As a seasoned investor, you know the value of effective asset allocation – but you can also unlock additional opportunities by taking traditional asset allocation one step further via an in-

vestment strategy known as dynamic asset allocation.

As you may already know, asset allocation is the practice of allocating investments across various asset classes, such as equity and fixed income, to best balance risk and reward for each investor. You have your own unique risk tolerance, which differs from that of other investors. You also have your own asset allocation strategy based on your tolerance for risk, your financial goals and your investment timeline.

Dynamic asset allocation takes asset allocation to another level. Through ongoing analysis of the global financial market, investment managers can uncover opportunities that still fit within the parameters of an appropriate predetermined range of risk tolerance. The primary aim of such an investment is to reduce the impact of shorter-term market fluctuations, thus providing a smoother ride towards achieving your long-term financial goals.

As the appetite for a potentially higher return increases, so does the corresponding investment risks. That is because obtaining a higher return usually involves a greater emphasis on equity type investments that are char-

acteristically more volatile in terms of price fluctuation. For the more aggressive investor, a portion of their equity investments may focus on emerging markets or a particular industrial sector. Through a strategic asset allocation approach, it is possible to combine a series of fixed-income securities and equities together in a portfolio that will exhibit less volatility than most of the individual constituents — provided every security included complements the diversity of the portfolio’s content. Using this approach and resisting the temptation to “time” the market by temporarily concentrating holdings in any one area will not completely remove the risk of financial loss, but it can help you to build personal wealth without taking undue risk.

# IMPORTANCE OF PREPARING A LASTWILL

During the life time, everyone accumulates wealth in the form of properties, investments and personal belongings not only for themselves and also for their family to have a secured life. In this process, you will also get a thought of what will happen to your hard earned wealth after your death. Naturally, you want your closest family to handle the wealth in a way, you have planned and wished. All you need to do is to get your Last Will done.

## What is a LAST WILL and why it is required?

A Will is a legal document by which a person expresses his/her wishes as to how their real property and personal properties are to be distributed at death and names one or more persons, the Executor, to manage the estate until its final distribution. Sometimes people don't want to have wills because they think that they have nothing. Some people don't want to have a will because they think it's taboo to talk about death. Some people are just downright irresponsible and lazy because they talked about getting a will but never got around to it. Some people just don't see the need for a will and so they die and leave their families in complete shambles.

When a person dies without a will, a complicated legal process ensues that can be costly and could attract claims from those who may not typically be included in the will.

Family members then find themselves saddled with a burden they may not be prepared or willing to take on and are reluctant to take on the role. If there has been discord among the family members before the death, it's difficult to find anybody who would like to accept that responsibility after the death.

If there is a family member willing to represent the estate by acting as the estate trustee or executor, they must apply to the court for a certificate of appointment of estate trustee without a will to get the authority to act on behalf of the estate. If there is not an obvious executor, the statute does lay it out, depending upon the personal situation and status of the deceased. The result may end up surprising the individual who ends up falling into the role if there was never a conversation about what would happen.

Family members could hire a fi-

nancial institution or trust company to take it on, and those costs would be paid for through the estate. It makes it difficult and costly when the person died intestate to find someone to take up the responsibility.

The complications continue when there are children under the age of 18. If a person die without a will and have minor children, then they will lose the ability to appoint the guardian. This will lead to losing the power to the state to take care of the kids. The state gets the power and, with the involvement of the Officer of the Children's lawyer, determines what happens to the children.

The absence of a will mean there's no ability to provide specific instructions on how any money should be distributed and when. This leads to losing the ability to decide how the assets will be held for children and how they will be distributed because no 18 year old would ever be responsible enough to

the will is followed. When there is no will, however the survivor's assets are essentially in the court's hand.

The law imposed process, however, may not be what the deceased person had intended, and it means they have forfeited an important right. An additional detrimental aspect is that if there is no will, there is likely no estate planning and that means the individual did not take advantage of any tax-saving opportunities, likely leaving less for beneficiaries. People should be entitled to deal with their assets in death as they are in life, basically however they want. But if they don't have a will, they are not taking advantage of that right. That means someone else is going to make that decision for them.

It is believed that 51 percent of Canadians don't have a will. Those aged 55 and older are nearly four times more likely to have wills than those aged between 18 and 34 and twice as likely as

of an estate when there is no will cannot be varied. This means losing the ability for any of their intended wishes.

If someone dies without a will and there is a spouse as well as children, the first \$200,000 goes to the spouse. If the estate is worth more than \$200,000 the rest goes to the children, but the spouse is entitled to one third of the remainder.

If someone dies without a will and there is no spouse and only children, the legislation determines that it is all divided equally among the children.

If someone dies without a will and there is no spouse and no children, the estate is divided between the parents, the siblings, nephews, nieces and next of kin. If someone dies without a will and there are no survivors, everything goes to the government.

If the spousal relationship is a common-law one, however, that spouse gets nothing and everything goes to



manage money like that. And people don't usually manage money if they have not earned it. It just causes confusion for the people they leave behind.

By leaving control of who gets what to someone else, the deceased individual has given up an important right that may impact his family members in ways that were never intended. When there is a will, it is stamped by the court as being the officially certified copy, and then the instruction within

those aged between 35 and 54. Higher earners are more likely to have a will than lower earners.

## Consequences of not having a WILL:

If someone dies without a will and there is a spouse but no children, everything goes to the spouse. There's absolutely no option about how the estate is to be divided. It all falls within the Succession Law Reform Act. The statutory formula for distributing the assets

children. This common-law spouse will then have to bring a dependent's support claim against the estate and they will have to make a case that they were supported before death and then demonstrate how much money they would need. But that is dependent on there being enough money in the estate to allocate funds to the common-law spouse and also to continue to provide a bequest to the children.

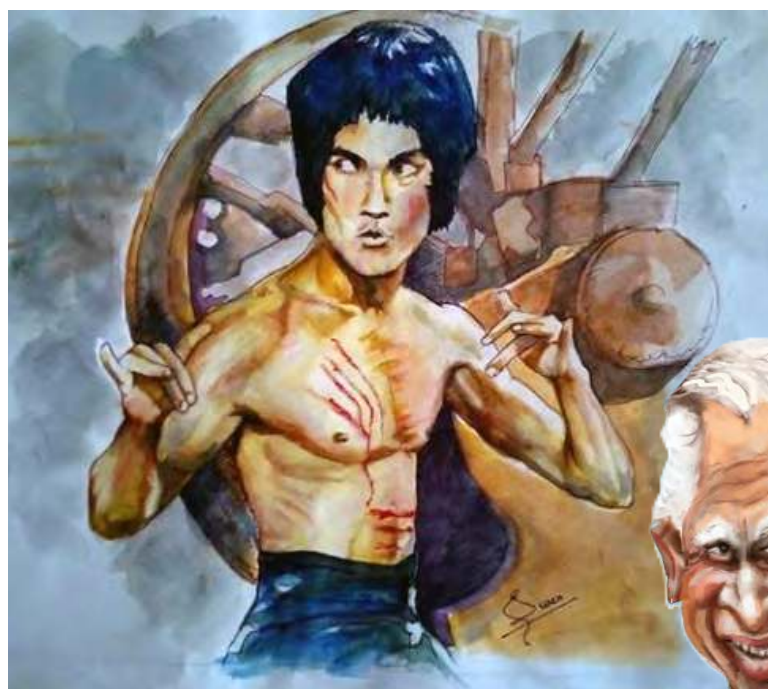

# Around \$100,000 raised at Isaiyarangam music event for University of Toronto Tamil Chair

## The Tamil Chair will promote Tamil language, Research, Studies and culture

She recalled her trip to Jaffna sometime back and remarked that she was impressed by the culture and traditions of the Tamil community. She humorously remarked that the saree she was wearing was also purchased in Jaffna too. Georgette is providing invaluable enthusiasm and support to the Toronto Chair project and helping the fund-raising team to achieve their goals.

Many more future events are being planned by the University of Toronto Tamil Chair team to raise the balance funds required for the establishment of the Tamil Chair. The Toronto fund raising team consists of Messrs. A. Muttulingam, Sivan Ilangko, Dr. V. Raghuraman and others. Tamil is the language of over 80 million people across the world and is rich in content and abundant in literature.

# Jessica Jude brightens the future of preschool children, widows in East Sri Lanka

The funds contributed by Canadian Tamils who spontaneously responded to the joint appeal made by Super singer Jessica Jude and Canadian Tamils' Humanitarian Association (CTHA) at a musical show held in August 2018 has already been invested in some of the projects in Batticaloa district, Jessica's dad Soosaitheasan Jude said during a recent interview with Monsoon Journal.

Jude added that though initially it was expected to raise around 30,000 dollars, the great generosity of Toronto Tamils had resulted in exceeding that amount by another 10,000 dollars being collected at the musical event. At the close of the show a cheque for \$40,000 was handed over to the officials of CTHA amidst repeated rounds of applause from the audience.

Meanwhile, the project partners in Batticaloa working under Adopt-a-Village program of CTHA had begun some of the previously planned projects. The construction of a Pre School has been



Not resting on their laurels, the dedicated partners of this noble project have already begun the construction of a Vocational Training Centre at Pavatkodichchenai, a village in Manmunai District, Batticaloa. A soft opening ceremony of this newly built community centre was held Friday Oct 26th 2018. A part of the building has been named Jessica's Vocational Centre in honour of her dedicated efforts. Jessica is funding the vocational centre training course as well as computer classes. An official of CTHA has already confirmed

rural villages lack the financial means and opportunities to participate in vocational training programs and they are bound to benefit greatly from this training centre and it could lead to economic advancement for them, their families and their communities.

Yet another project that is in the pipeline is Cataract Surgery to be performed on patients from this area. 30 people have been already selected and according to informed sources, the organizers of this treatment program are waiting for the availability of the operation theatre and most probably the surgeries will be done in January 2019.

Meanwhile, due to additional funds collected in Toronto one more project



already completed in the village of Kathiraveli and was officially opened on October 10th, named Kalaimagal Preschool; it will initially serve the needs of at least 50 children from this area. The Pre-school building includes a kitchen as well as a playground, according to a statement released by CTHA.

the receipt of six sewing machines and said that they are waiting to receive 6 computers and the rest of the equipment by latter part of November. The training for the women of this village is scheduled to begin early 2019 and the computer classes are to be launched soon.

Women and girls from the nearby



has been under taken by CTHA. According to CTHA officials this project is scheduled to begin in Mulangavil village in Northern Province during November 2018 and is to be completed by May 2019. Under this project, a production centre administered by Holy Family Convent nuns for the women in Mulangavil is to be renovated due to an appeal made by the Mother Superior in charge of the Convent at Iranaimatha Nagar, Mulankavil.

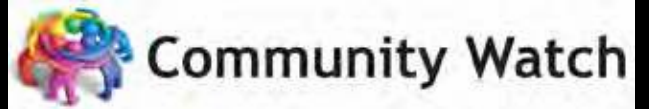

### What is Aarupadai Veedu:

One of the Hindu Gods most widely worshipped in South India and Sri Lanka is Lord Murugan. He is called by several names like, Shanmugan, Subramania, Kanda, Guhan, Karthikeya, Arumugan to mention a few. The six most blessed abodes (Veedu) of Lord Murugan are known as *Aarupadai Veedu*. These are extensively mentioned in the Tamil literatures *Thiruppugazh* and *Thirumurugarthrupadai* are written by the great Tamil poets *Arunagirinathar* and *Nakkeeranaar* respectively. These six places are all situated in the Indian State of Tamil Nadu. These six places are: Palani, Thirupparankundram, Thiruthani, Swamimalai, Thiruchendur and Pazhamudhircholai.

#### THIRUPPARANKUNDRAM TEMPLE:

Thirupparankundram Murugan Temple is situated about 8 km on the outskirts of Madurai City in Tamil Nadu and is mainly known for the Deity Lord Murugan. This place is the *first* among the six abodes (*Aarupadai Veedu*) of Lord Murugan. This is the place which is associated with the divine wedding of Lord

Murugan with Goddess Deivanai, the divine daughter of the King of Heaven, Indra and so is considered as a sacred place for marriages. The architectural style of this temple is of the 7<sup>th</sup> or 8<sup>th</sup> century. The mandapams are lined with elaborately carved pillars. There are a few caves and of these the three main ones have Subramanyar, Deivanai and Naradar. Soora Samharam, Chariot festival and Lakshaarchana are famous at this temple.

#### THIRUCHENDUR TEMPLE:

The famous Thiruchendur Temple is located in the Thootthukkudi (Tuticorin) district of Tamil Nadu. This temple is the *second* among the six abodes of Lord Murugan. This is the only temple among all the six which is located on the sea shore (Indian Ocean). It is here that Lord Murugan fought with the Asura King Surapadman. This place is known for the Oonjal Sevai Festival, where Lord Murugan swings with His Consort in a highly tranquil surroundings.

#### PALANI TEMPLE:

The Murugan Temple located in the town of Palani, at the foot hills of Kodaikanal in the Dindukkal district. It is about 150 feet above the sea level. This temple is the *third* among the six abodes of Lord Murugan. The

Deity at this temple is called as *Lord Dandaayudhapani*, as He is having a staff in His hand. The idol of this deity is made out of amalgam of nine minerals known as *Navabhashana*. This temple is famous for Kavadi and head-tonsuring by devotees to show their devotion to the Lord. Also, the Golden image of the Lord is taken around the temple in a Gold-plated Chariot, and appropriately called the Golden Chariot Festival.

#### SWAMIMALAI TEMPLE:

Swamimalai temple is about 8 km. west of Kumbakonam in the Tanjavur Dist. of Tamil Nadu. Swamimalai is the *fourth* of the six abodes of Lord Murugan. This is where Lord Murugan expounded the godly knowledge about the Sacred Pranava Mantra *Om* to His father, Lord Siva and so, was given the title *Swaminatha* (Lord of Lords).

This temple is built on an artificial hill, known in Tamil as *Kattu Malai*. Another name for this place is *Thiruveragam*. The famous festival at this temple is called *Soora Vaahana*.

#### THIRUTHANI TEMPLE:

Thiruthani Murugan Temple is situated on the hill of Thiruthani, a town about 84 km from Chennai in Tamil Nadu. Thiruthani is

considered the fifth of the six abodes of Lord Murugan. It is said that this is the place that Lord Murugan stayed after defeating the asuran King Surapadman. This is the place, it is said that Lord Subramanya married Valli. This hill has 365 steps symbolizing the 365 days in a year. Thiruthani is well known for Saravana Poikai, Sapta Rishi Theerthan and Aadi Krittikai. The most famous festival of this place is the Mirror Festival (Kannaadi Sevai), where the Lord's six faces are exposed through a mirror and worshipped.

#### PAZHAMUDHIRCHOLAI TEMPLE:

Pazhamudhircholai temple is situated about 20 km. from the Madurai City in Tamil Nadu. This temple is the *sixth* of Lord Murugan's *Aarupadai Veedu* Temples.

Lord Murugan is known to have appeared for the great Tamil Poet Avvaiyar. In this temple, Lord Murugan stands with a posture of Single face Goddesses Valli and Deivanai, one on each of His sides. The most famous festival is the Holy bathing (Abhishekham), where Lord Murugan is bathed with Holy waters from all over, amidst the chanting of Vedas.

## SKANDA SASHTI

Nov. 08 – Nov. 13, 2018

*Muruga vanquishing Narakasura***Skanda Sashti Celebrations:**

It is a six-day Vratam and celebration and commences on *Prathamai* (the 1st day of the 15-day cycle according to Hindu Calendar) immediately after *Amavasya* and ending on *Sashti* (6th day) in the Tamil month of *Aippasi* (October-November) with *Surasamhara*. This year the celebrations are from Thursday November 8th to Tuesday, November 13th.

**The Deity, this celebration is dedicated to:**

These are dedicated to the second son of Lord Shiva, Lord Muruga, also known as Subramanya, Shanmuga, Kartikeya to mention a few. On the Sashti day, it is believed that Lord Muruga to have killed the mythical demon, Taraka. This is one of the important festivals in all Saivite and Muruga temples in South India, Sri Lanka, Canada, USA, Malaysia and other countries where there are Tamil speaking Hindus.

**How is it celebrated:**

During the six days devotees pray and chant inspiring hymns on Lord Muruga. The inspiring and devotional hymns of Sri Arunagirinathar in the popular religious works called *Thiruppugazh* is chanted by devotees. In addition, the hymns from *Kavadichindu* and *Skanda Sashti*

*kavacham* are also recited by devotees on this occasion.

Corresponding to six days of the war over evil forces, devotees under take fast (*Vrata*), pray sing devotional songs in praise of Lord Muruga. In places like Tiruchendur and Tiruparankundram in South India events leading to the annihilation of the Asuras are dramatized and enacted. The Offerings of *Kavadi* on Skanda Sashti is also a very popular form of worship.

These six places are considered to be the battle camps of Lord Muruga (Skanda). The term "*padai Veedu*" in Tamil means "*Battle Camp*" and so *Aarupadai* means six battle camps.

**Legend about Skanda Sashti:**

It is said that Skanda Sashti is the story of the birth of Skanda (Kumara) and the fulfilment of the purpose of His divine incarnation. Demon (Asura) Narakasura had been oppressing and tormenting the celestials and drove them out of heaven. All the Gods went to Brahma and appealed for help. Brahma said that he cannot destroy the demon Narakasura, since the demon had obtained his grace through severe penance. Brahma suggested that they should get the help of a cupid, the God of love and induce him to tempt Lord Siva who remained absorbed in His Yoga Samadhi. Let Lord Siva unite

with Goddess Parvati. A powerful son, Lord Muruga (Kartikeya) will be born to them and that Boy will destroy the demon Narakasura who has been tormenting you all.

*Indra*, the chief of gods, asked Cupid to ho with his wife, Rati and his companion Vasanta (the season of spring) to Mount Kailas the abode of Lord Siva. Cupid carried out the instruction and standing behind a tree shot his arrow of passion towards Lord Siva while Parvati was placing flowers in His hands. The moment their hands met, Siva experienced a distracting feeling. He wondered what disturbed His Yoga. He looked around and saw Cupid crouching behind the tree. The Lord opened His "*third eye*", the inner eye of intuition and Cupid was burnt to ashes by the fire that emanated from it. That is why the god of love is also called "*Ananga*", which means bodiless.

After burning the Cupid, Lord Siva ascertained by His Yogic vision that the birth of Lord Muruga was absolutely necessary to destroy the demon, Narakasura. Siva's seed was thrown into the fire, which was unable to retain it and so it was thrown into the Ganges, which in turn threw it into a reed forest. This is where Lord Muruga was born and hence He is called "*Saravanabhava*" (born in reed forest). He was also Skanda, Siva's power chastity preserved

through penance. Skanda was raised by six mothers of the divine constellation of *Krithigai*. *Karthikeya* divided himself into six babies to be nursed by six mothers. When Parvati came and gathered all six babies, He became *Shanmukha*, the one with Six faces and One body.

*Shanmukha* became *Kumara*, the powerful verile adolescent who was also beautiful and the handsome (*Muruga*). He was named the General, **Deva Senapathy** of God's army. In fact in *Bhagawad Gita* Lord Krishna says, "Of the army generals I am Skanda". Skanda received from His mother *Parasakthi* an all-powerful *Vel* (lance). That is why He is called *Sakthi Velan*. He engaged the armies of *Simhamukha*, *Surapadman* and *Narakasura* on a six day battle and vanquished them all on the sixth day. That is why the sixth day (*Sashti*) of Skanda Sashti is celebrated with devotion. It is the true victory of Good over Evil.

According to Swami Sivananda "the Lord spent His childhood in Tiruchendur and took *Mahasamadhi* at Kathirgamam in Sri Lanka. If anyone goes to Kathirgamam with faith, devotion and piety and stays in the temple for two or three days, the Lord Himself grants His vision to the devotee".
