New Parent and Grandparent Super Visa implemented

Applications for the Parent and Grandparent Super Visa is being accepted from Dec 1, 2011, Citizenship, Immigration and Multiculturalism Minister Jason Kenney has announced.

Statement from Ministry:

The Parent Grandparent Super Visa is one element of Phase I of the Action Plan for Faster Family Reunification, announced in November. The Super Visa will allow applicants to remain in Canada for up to 24 months at a time without having to renew their status.

To be eligible, the applicant must:

-Be a parent or grandparent of a Canadian citizen or permanent resident;


- Provide a written commitment of financial support from their child or grandchild in Canada, including proof that the child or grandchild meets minimum necessary income (Low Income Cut-Off);

-Undergo the Immigration Medical Examination;

-Submit proof that they have purchased comprehensive Canadian medical insurance, valid for at least one year; and - Satisfy the visa officer that they meet all other standard admissibility criteria.

Current processing times through the Family Class indicate that many parents and grandparents could wait for eight years or more to be accepted to Canada. With the Super Visa, they could be enjoying the company of their family in about eight weeks.







Rathika Sitsabaieson protests cuts in govt funding for Ontario Immigration Settlement Services

(Scarborough—Rouge River, NDP):

Mr. Speaker, on Friday we learned that the government plans to slash \$31.5 million from immigration settlement services in Ontario. Community organizations are already struggling because of similar cuts last year and the year before.

Ontario remains the number one destination for immigration in Canada. Why is the government making it harder for newcomers to access the services that they need?

Hon. Jason Kenney (Minister of Citizenship, Immigration and Multiculturalism, CPC):

To the contrary, Mr. Speaker. We are now providing three times more in funding for immigrant settlement services in Ontario than was the case under the previous Liberal government. Next year, Ontario newcomers will receive more than was the case in 2005. It is true, however, that the number of immigrants settling in Ontario has declined quite significantly, from 64% to 52% of newcomers. They are going to other provinces; it is only fair that the settlement dollars follow the newcomers and that we have fair funding across the country.

Ms. Rathika Sitsabaiesan (Scarborough—Rouge River, NDP):

Mr. Speaker, the minister says he is doing better than bad. I guess that is the level that the government has set for itself.

With this shuffling of funds, we are still looking at an overall cut of \$6 million and \$45 million in cuts from two years ago, but the number of newcomers is at an all-time high. Pitting province against province is not going to solve the deficit.

This decision to cut services in Ontario was done without planning and with no warning. New Canadians are huge contributors to prosperity in this country. Will the minister maintain the key supports and services they need to

thrive in this country?

Hon. Jason Kenney (Minister of Citizenship, Immigration and Multiculturalism, CPC):

Mr. Speaker, the premise of the question is completely inaccurate. There has been a great deal of planning by my officials over the course of two years to ensure that the adjustment in funding from Ontario to provinces with growing immigration numbers happens in an orderly fashion.

In terms of giving people notice, we just gave notice this week to the small number of organizations in Ontario that will be affected at the beginning of the next fiscal year. We have given them several months' notice.

The question is, why does the member think that newcomers to Ontario should be receiving \$4,000 per capita in settlement services but that those in the rest of the country should receive only \$3,000? We believe that newcomers all across Canada deserve the same support.





Jayalalithaa opposes foreign direct investment in Tamil Nadu retail sector

Flaying the Centre's decision to allow Foreign Direct Investment in retail, Tamil Nadu Chief Minister Jayalalithaa on Sunday, Nov 27th alleged it was taken under pressure from a few retail giants and asserted her government would not allow multi-brand global players to set up their markets in the state.

Strongly opposing the decision to open up retail trade to FDI, Ms. Jayalalithaa demanded that the Congress-led UPA government reverse the 'ill-advised' move as it would not serve to bring down inflation or improve market efficiency.

Rather, the domestic manufacturing and services sector would take a serious hit and the retail trade completely taken over by the MNC dominated big retail giants, which is not good for the country, she said in a strongly-worded statement.

"While Parliament is in session, this move of the Government of India..without even consulting the state governments is unprecedented and indicates the overweening arrogance of the UPA government," she said.

The FDI policy in the retail sector was a "sensitive issue and by making this sudden announcement ignoring the sentiments of the people, the Central government has stirred the "proverbial Hornet's Nest," she said.

Ms. Jayalalithaa described the Centre's move as a "wrong decision, taken under pressure from a few retail giants starved for capital infusion for their future survival."

Justifying her stand, she said her government "will not allow the multi brand global players as permitted under the new policy to set up their hyper markets in Tamil Nadu."

While the government talked about creation of jobs for 10 million in the next three years, "it will lead to 40 million people being uprooted and thrown out from their business, she said.

Ms. Jayalalithaa said the purported intention behind the move seemed to be bringing more foreign investment to India and to bring down double digit inflation which was mainly "due to the series of policy blunders" made by the Congress-led UPA.

The Centre "should realise that constraints on farm products on the supply side, cannot be addressed through the FDI route, but only by squarely addressing the infrastructural constraints through appropriate policy support." Elaborating on her contention, Ms. Jayalalithaa mentioned the cases of the UK and Thailand where retail chains reportedly controlled the major share of the market. She said the MNC experience in many countries showed that the "price mark up by such MNCs is much higher than what is being charged by the small vendors." Holding that "any amount of safeguards will not be any use in protecting the interests of the domestic sector," Ms. Jayalalithaa demanded that the Centre's deci-

sion be reversed.

"The Centre's announcement has come as a thunderbolt and shocked millions of small vendors who have been completely taken off guard," she said.

As the decision would affect the livelihood of millions of small departmental store owners and "completely destroy the unorganised retail sector within the next couple of years," Ms. Jayalalithaa said she strongly opposed the move to open up the retail trade to Foreign Direct Investment.

India Opens Up to Foreign Retailers Despite Concerns Over Job Losses

In India, the government hopes that its decision to allow foreign retailers into the country will bring in billions of dollars of investment, create millions of jobs and modernize India's retail sector.

India's Commerce Minister Anand Sharma says the government has built in safeguards to protect farmers and small shopkeepers while allowing the entry of foreign retailers like Walmart and Tesco into the country.

Foreign retailers have been given the green signal to invest up to 51 percent in multi brand retail, such as supermarkets. Foreign companies can now invest up to 100 percent in single brand retailers.

The new foreign superstores will be allowed to set up shop in cities with a population of at least one million. They must invest at least \$100 million and half of this would have to be invested in rural infrastructure and refrigerated transport and storage. Thirty percent of their produce would also have to come from small and medium enterprises.

Global retail giants have waited for years for India to open its \$ 450 billion domestic retail market, which is still largely dominated by mom and pop stores. But the government hesitated due to fears that the entry of foreign supermarkets will wipe out local livelihoods.

A day after allowing foreign direct investment or FDI in retail, Commerce Minister Anand Sharma tried to calm such concerns.

"This step which we have taken is an investment in the present and the future of this country," he said. "This will help immensely India's farmers. It will help in creating jobs both in manufacturing as well as in the agro and food processing sectors. It will bring in enormous amounts of FDI into this country to build the infrastructure."

Over the next three years, Sharma said foreign retailers could help create up to 10 million jobs, many of them in rural

areas. He says the establishment of cold storage facilities by these retail chains will improve India's decrepit infrastructure which results in up to 50 percent losses of fresh produce.

He also says farmers will benefit immensely by getting higher prices. At present they get a fraction of the price paid by consumers due to the presence of several middle men in India's antiquated retail supply chain.


But the main opposition Bharatiya Janata Party remains unconvinced. A senior BJP leader, Yashwant Sinha says the party will lead a nationwide movement to oppose the entry of global retail giants. Foreign retailers will wipe out small shopkeepers in the country and only the big players will survive, Sinha argues, warning that unemployment will rise in a big way. India's retail sector is the second biggest employer after agriculture. The Communist Party of India also has misgivings, says its senior leader Sitarm Yechury.

Yechury says the influx of foreign capital in retail trade will be a huge threat to local jobs. It will not increase employment, it will take away livelihoods.

There are also concerns that although the federal government has approved the move, several state governments, ruled by opposition parties, could block the entry of foreign retailers into their states.

Sri Lanka expropriations will hurt economy: EIU

A Venezuela-style law in Sri Lanka to expropriate dozens of private enterprises will hurt the economy, undermine policy predictability and scare investors despite state assurances that it will be a 'one off', UK-based Economist Intelligence Unit has said, according to a report in Sri Lanka's premier business web portal lankabusinessonline.com. The report further states.

"The Sri Lankan authorities have repeatedly tried to assure investors that this is a "one-off" measure which will not be repeated," Economist Intelligence Unit - EIU said in a risk analysis.

"Unavoidably, however, the move undermines the predictability of policymaking and increases uncertainty for foreign investors.

Though Sri Lanka's ruling coalition's two thirds majority or political stability has been cited as a factor favoring investors unpredictable policy, especially relating to property rights, from a stable regime has the same effect as unpredictable policy from different regimes.

Robert Higgs a US economist described the phenomenon as the likelihood of state action that will either undermine private property rights or return and yields on investments.

"Such attenuations can arise from many sources, ranging from simple taxrate increases, to the imposition of new kinds of taxes, to outright confiscation of private property," Higgs wrote in a 1997

"In any event, the security of private property rights rests not so much on the letter of the law as on the character of the government that enforces, or threatens, presumptive rights."

EIU said the law which deemed some 37 firms as 'under-utilized' or 'under-performing' also resembled similar asset seizures in other populist countries.

"It also raises uncomfortable echoes of the actions of populist Latin American governments, notably Venezuela, which has repeatedly used similar excuses to nationalise foreign-owned land and companies," EIU said.

"As this comparison suggests, Sri Lanka's expropriation law is likely to be economically counter-productive."

All the firms had either received state

received tax breaks.

EIU said the asset seizures will be "particularly counter-productive at a time when Sri Lanka is keenly seeking foreign investment for development following the end of the civil war."

The legislative process that was used to pass the law was also a concern, EIU

Critics have said that the law is deeply flawed in that it trespassed on a constitutional separation of powers, and amounted ad hominem law, which targeted specific citizens.

"Firstly, the passage of a law which specifically lists assets to be expropriated, rather than a general set of principles to be applied, appears to conflate the roles of the executive and the judiciary with that of the legislature," EIU said.

"Secondly, the speed with which the legislation was pushed through will add to the political opposition's concerns that the government is using its two-thirds majority to consolidate its grip on power.

"Sri Lanka's main opposition United National Party and the Marxist Janatha

land grants, were privatized or had Vimukthi Peramuna party have alleged that the government is targeting businesses linked to opposition parties, a charge the government denies."

> EIU said Sri Lanka had recently made gains in a World Bank doing business ranking.

> "However, the passage of an expropriation law with scarcely any public scrutiny or debate is likely to undo at least some of this progress in the eyes of foreign firms."

> Among the firms listed for expropriations was a Singapore based firm and another with an Indian connection.

> Sri Lanka had a history of violating property rights with international oil companies, foreign owned tea plantations, the EIU said. A new constitution in 1978 had sought to allay such fears giving strong guarantees.

> Sri Lanka's supreme court however had reportedly given a determination saying the expropriation law was not inconsistent with the constitution, lankabusinessonline.com said in the report.

Sri Lanka rupee adjustment in right direction: IMF

Sri Lanka's rupee devaluation announced on the budget presentation on Nov 21st was a step in the right direction, and a planned narrower budget deficit would reduce the country debt burden, an International Monetary Fund official has said, according to a report on business web portal Lanka Business

The report further stated:

"We think that the exchange rate adjustment was a step in the right direction and should help support Sri Lanka's export competitiveness and safeguard its reserves over the medium term," IMF resident representative Koshy Mathai

Sri Lanka has lost foreign reserves since peg defence began in mid 2011 and active sterilizations of interventions began in August.

Sri Lanka's exports grew 38 percent to August but the trade deficit has been high, driven by rising domestic spending power coming from net borrowings abroad and inward remittances from Sri Lankans resident abroad.

In the spot dollar market the rupee fell to 114.15/20 rupees on Nov 23rd after an official guidance band was dropped 30 cents. The rate was put back at 113.90 later in the day.

The rupee fell more than three percent on Nov 22nd after President



Mahinda Rajapaksa said in a budget speech that the currency should be devalued. There has been some uncertainty in announcement.

The budget planned a deficit of 6.2 percent of gross domestic product.

"Our initial impression is that the budget also seems to be broadly consistent with the authorities' earlier articulated plans, though we are continuing to study this complex document," Mathai

"The targeted reduction in the deficit, while smaller than originally envisaged, should nonetheless help keep the debt-GDP ratio on a declining path."

A few years ago, I never imagined I'd be writing a blog about being a breast cancer survivor. But here I am doing just

This December marks three years since I had my mastectomy. I sure didn't expect that, at age 45, after finding a lump in my breast, and after a mammography and ultrasound revealed that it was highly suspicious for breast cancer, that I'd soon have to have my breast removed. I had none of the typical risk factors for breast cancer, and I'm the first one in my family and among my friends to have a diagnosis.

It certainly was strange being on the receiving end of patient care at the place where I went to work every day. But I had faith in my colleagues, and I was also fortunate to be treated in my community hospital, so that I could be close to my husband, daughters, friends and colleagues.

I remember thinking before my surgery about all the equipment that I would typically point out to potential donors during hospital tours. Who knew that I would one day be using it?

When I awoke from surgery, there was a Christmas tree in my room decorated by my friends. It was a touching gesture, given how crummy it feels to be in the hospital over the holidays. When you're faced with a critical illness, you're not the only one dealing with your diagnosis and treatment. Your family and friends are affected

For the next year, I underwent my chemotherapy and radiation treatments just like the many patients who visit the chemo clinic at Rouge Valley Centenary. Having regular chemo sessions became a new, but weird, kind of normal. The chemo centre was very busy, and inevitably over the long hours of treatment, you'd strike up friendships with those sitting next to you. Some people are really outgoing and forthright about their disease. Others are more reserved. Scared, really.

This part of my treatment was rough, though. The chemo cocktail of drugs prescribed for me left me feeling weak and tired. Plus, I lost all my hair, including the hair on my head, nose hairs, eyebrows and eyelashes. Boy did I miss my eyelashes! You never think about how important they are until the soap you use to wash your face runs into your eyes and they begin to burn.

However, I'm fortunate that during that time, my fantastic colleagues were so supportive, and that my job allowed me to work from home or to come into the office when I was feeling up to it. If I was working in the office, the other staff members were careful not to come in if they weren't feeling well, and were sympathetic when I was feeling under the weather.

And let me tell you, you really think about how important hand hygiene is when simple hand washing can make a difference to your health and well-being.

Cancer is different for everyone. No two stories are the same. What I experienced three years ago may be completely different from what someone else experiences today. But know that it is possible to survive it. I'm a walking example of that.

During my treatment, I remember my two daughters looking up statistics on the internet and, after seeing the high survival rates for cancer, decided I was going to be just fine. It turns out that they were

Today, although I'm at risk for reoccurrence, I only need a follow-up MRI once

I'm hesitant to say that things always happen for a reason, but maybe it's true to some degree. Three years after my mastectomy, we now have a brand new, stateof-the-art MRI at Rouge Valley Ajax and Pickering. Having this quality of treatment available to our patients, and right in our community, is significant. It means that our patients no longer need to travel



outside of west Durham to receive this kind of care, which many of us can appre-

Waiting for a diagnosis or treatment is incredibly scary and stressful. And bringing down wait times and ensuring that life-saving equipment and services are available closer to home now are even more meaningful to me.

When I'm giving a tour to a donor of one of our hospital campuses and I pass by patients waiting in the lobby looking a little nervous, I wonder what they're thinking. Especially since I was once in their shoes. I'm so very grateful to those compassionate, warm and knowledgeable health care professionals who saved my life three Christmases ago.

This Christmas, once again, I'll be holding my breath a little. Hoping and praying that my MRI scans stay clear. And I'll also be crossing my fingers for all those worried-looking people who I see in

Save a life with CPR

York Region EMS encourages residents to learn Cardiopulmonary Resuscitation (CPR)

The Regional Municipality of York onds count. According to the Heart and Emergency Medical Services (EMS) encourages residents to take a Cardiopulmonary Resuscitation (CPR) course and possibly save the life of someone experiencing sudden cardiac arrest.

Sudden cardiac arrest happens when a person stops breathing and the heart stops beating. According to the Heart and Stroke Foundation of Ontario (HSFO), up to 45,000 sudden cardiac arrests occur each year in Canada.

CPR is a life-saving procedure involving chest compressions (pressing down on the chest) and artificial respirations (rescue breathing). It has the power to restore blood flow to someone suffering a sudden cardiac arrest, keeping them alive until paramedics or emergency service personnel arrive.

Once the heart stops pumping, sec-

Stroke Foundation, for every minute that passes without CPR, a person's chance of surviving drops by about 10 per cent. If you know how to respond to a sudden cardiac arrest, a person's odds of survival and recovery may increase.

Learning CPR is easy and inexpensive - just a few hours could make an important difference in someone's life. Since most cardiac arrests happen at home, you could be saving the life of a family member or friend.






Guests were treated to a scrumptious dinner followed by some tantalizing music and singing by the music band in attendance, Sampath and the Showcase.

TSH launches new ED geriatric mental health program

A new program at The Scarborough Hospital's Emergency Departments (EDs) will improve the care of seniors who may have mental health or addiction issues.

The ED-Geriatric Mental Health program (ED-GMH) was launched at the Birchmount and General campuses in late November. It "allows staff to use a different lens to see the geriatric population," says Shirin Vellani, a Geriatric Emergency Management Nurse Practitioner at the General

Since October, medical and clinical staff in the EDs started training on the program's e-learning module, which provides specific clinical and practical knowledge and skills. E-learning components include:

- How to recognize changes in cognition, mood, function and behaviour in seniors;
- A set of standardized assessment tools to screen for the '3Ds' – delirium, dementia and depression;
- A newly designed process and recording form to help staff understand when and how to apply the '3D' tool with a clear definition of roles and responsibilities for each
 - Culturally sensitive strategies for staff to interact

effectively with the hospital's diverse populations in the ED setting.

Santy Thomas, a Registered Nurse at the General campus ED who has completed the e-learning module, finds that she can now "more easily identify elderly patients in the ED who require this sort of care and provide them with the proper treatment.'

"These issues are very common for seniors, but can also be easily missed in the ED, so this program will be very beneficial," adds General campus Social Worker Scott Wisner.

"The training put the '3Ds' on my radar and helped me better identify the causes and know what to look for."

"The ED-GMH program has been successfully introduced in the EDs of seven academic hospitals in Toronto and has won an award for excellence

at the Ontario Hospital Association's Health Achieve conference," explains Shirin. "We're very proud to be the first hospital in the Central East Local Health Integration Network to implement it."

By the end of the year, most physicians, nurses and allied health staff in the both of the hospital's EDs will have completed the ED-GMH e-learning module. After six months of staff using the new program, changes in the diagnosis of mental health and addictions issues will be evaluated.

Ethics in Health Care:

Supports for Ethical Decision-making at TSH

Three initiatives that support ethical decision making at The Scarborough Hospital were the subject of a recent presentation at the 2011 Ethics in Health Care Conference.

TSH Clinical ethicist, Moji Adurogbangba and Debbie Driver, Nurse Practitioner and Clinic Lead, Geriatric Assessment and Intervention Network (GAIN) Clinic, shared knowledge with peers about TSH's innovative approaches and exemplary practices that have positively impacted and broadened awareness of healthcare ethics.

The first presentation focused on an initiative that addresses how TSH engages patients and/or Substitute Decision Makers in their healthcare decisions.

'This speaks to patients' and families' access to clinical ethics consultation at TSH and the opportunity to be educated about the clinical, ethical and legal framework in which the Ontario healthcare system operates," Moji says.

TSH's Community Advisory Council was engaged in the development and implementation of the brochure on 'The Role of Substitute Decision-Maker.' The Clinical Ethics program at TSH is a resource not only for staff and physicians, but also for our patients and community when they need assistance making ethical health care decisions that respect their cultural values, and those of their loved ones.

The second initiative was on how the Nurse Practitionerled Interprofessional Teams in the GAIN clinic encourage seniors to reflect on wishes by initiating discussions about Advance Care Planning and future care needs. The GAIN clinic at TSH was launched in January of 2011, proactively delivering specialized geriatric care to frail seniors, enabling them to stay in the community and avoid unnecessary

visits to the emergency department.

"Our community is interested in having these conversations with us, and with their families,' Debbie says. eagerly accept assistance and information about resources available to them. Advance Care Substitute Planning, Decision Maker identification and future care wishes discussions are initiated during the comprehensive geriatric assessments conducted in the TSH GAIN Clinic.

Over 400 seniors have attended the TSH GAIN clinic over its first ten months of operations.

A third initiative involved actively taking steps to open conversations about difficult health issues by engaging the community through the ongoing free speakers' series, 'It's Time to Talk.' The session offered in February, 'Tough Transitions: Aging, Families and Eldercare,' promoted:

Awareness and understanding of Substitute Decision-Maker roles.

- Planning a Geriatric Future.
- Advance Care Planning.

More than 100 community members and healthcare partners attended the inaugural session.

The presentation at the Ethics in Health Care conference was well received as evidenced by the positive feedback from attendees commending TSH on efforts being made in directly impacting patients and families and engaging the community.

The conference was co-hosted by Accreditation Canada and the University of Toronto Joint Centre for Bioethics.

CENTRE ADDRESSES HEALTH, EMOTIONAL IMPACT OF SEXUAL ASSAULT ON MALE VICTIMS

When Everett was six years old, he was placed in the care of Children's Aid. By the time he was nine, he had been shuffled from group home to group home. At one of those group homes, Everett was sexually assaulted by a teenage male over an extended period of time.

Fast-forward 26 years, and Everett is in treatment for alcohol abuse, charged with domestic violence and has a six-vear old son.

"I'm tired and I really need to change things," he told Social Worker Tatjana Singer when he was first referred to The Scarborough Hospital's Sexual Assault and Domestic Violence Care Centre. After ten sessions, Everett (not his real name) feels he is getting the help he needs "to face my demons. I feel better and stronger for facing them."

"At first, reaching out was hard. I didn't know where to go and I was worried I'd be judged," Everett says. "Maybe I would have sought help sooner, but I don't know. Back then, I didn't know services for me existed. I do know that when I did reach out, I was ready."

One in four females will have experienced a sexual assault by the age of 18. The number of males who have also experienced a sexual assault is lower – one in six – but it is generally understood that sexual assaults are under-reported for both males and females.

"We offer 12 sessions of one-on-one counselling to sexual assault victims, as well as medical intervention with a clinical nurse on the team in case there are any concerns of STDs," Tatjana explains. "We connect them to other services in the community, to transition them if they need additional help."

Sexual assault victims find their way to the centre one of two ways: through the Emergency Department because they've been assaulted within the past 72 hours, or they have been referred to the Centre through the legal system, a family physician, guidance counsellor or find the information online.

"It's not only clients who have a history of sexual abuse, but also recent victims who realize that, 'hey, this doesn't just happen to me," Tatjana explains.

"Throughout the community stream referral, we see victims who have had that experience within the past two years, and may be ambivalent about counselling," explains Social Worker Rahel-Leigh Peckett. "Then something comes

on the news – the sex abuse scandal at Penn State last fall, for example – and victims think that maybe it's time to reach out. We generally see a spike in male clients after such an event. There is that window of opportunity for them."

Once they engage in counselling, the Centre – which serves both men and women 12 years and older – provides therapeutic intervention that includes psycho-education to highlight they are not alone. While the therapy approach is similar for both genders, male clients have a tougher time dealing with it.

"I think there's an extra layer of stigma for male clients in getting help and talking about it," Rahel-Leigh explains. "Anecdotally, in my own experience working with males, most have been assaulted or abused by other males, so there's that extra question: how does this affect my sexuality? What does it mean about my sexual orientation?"

"And due to male socialization

they're raised not to cry and should be able to protect themselves – our approach in providing therapy differs,"
 Tatjana adds. "We have these hurdles to address early on.
 I also noticed male clients tend to 'act out' more. They're not just dealing with the impact of sexual assault, but many are dealing with an addiction issue or a mental health issue.
 Those cases tend to be more complex."

Indeed, depression, alcoholism and drug addiction are common side effects of sexual assault. And since males are less likely to come forward or take longer to come forward, "there's time for a greater impact on other areas of their health and functioning."

"If someone comes to Emerg, we can immediately prevent symptoms from developing into other illnesses like posttraumatic stress disorder, or before it gets to depression,

before the anxiety gets too great," Rahel-Leigh says. "Since it's harder for men to come forward sooner, it may take years for them to get counselling and by then, alcohol might be their way to cope, high blood pressure sets in or maybe their anger comes out leading to relationship dysfunction and trouble with the law."

The Centre tries to create a safe environment regardless of who walks through their door, "and part of that safety comes from us having a real understanding of what it means for someone to be sexually assaulted," Tatjana says.

"We do a lot of education in the schools, talking to young people about how to protect themselves, where to go for help," Rahel-Leigh says. "Our hope is that this boy sitting in the audience can feel safe and come forward."

For Everett, the Centre has set him back on the long road to recovery and healing. "My advice to others is, 'don't let the abuse control your life anymore," Everett says.

TSH WINS AWARD FOR 'GREEN' INITIATIVES IN THE OR

The Scarborough Hospital is being lauded as a leader in demonstrating a serious commitment to going green and using reusable textiles in the operating room.

Last October, TSH was one of five hospitals in Ontario to be awarded a Booth Centennial Green Award for its increased use of reusable OR products and willingness to participate in innovative green OR solutions.

"We are striving to find the right balance between reusable and disposable products, and we have introduced textile OR gowns to reduce waste," explains Nurallah Rahim, Patient Care Director, Surgical Services, Ortho & Rehab at TSH. "When we became aware of just how much garbage the OR produces, we took a serious look at how to reduce waste and become more environmentally conscious."

The first step was to introduce reusable textile surgical gowns that provide less static and less strike-through of fluids. Newer textile weaves and blends now available are far more efficient barriers to fluids than the old cotton and linen gowns of decades ago.

"Disposable paper gowns were introduced several years ago to replace cotton and linen, but it's almost a 360 degree turn back to textile," Nurallah explains. "The modern textiles are far more efficient, though, and will help us reduce what we send to the landfills."

The cost of textile gowns is comparable to disposable paper gowns, and once you take into consideration a cost analysis of how much TSH will save in garbage removal/disposal, the scales tip even further in favour of reusable textiles.

"As we move more towards endoscopic surgeries, where there is less blood and fluids, textile gowns will become increasingly cost-effective," Nurallah explains. "While surgeons may need to wear a disposable gown as they're right next to the patient, a scrub nurse can wear a textile gown. The used gowns are cleaned and sterilized and put back into the system, saving considerable waste. "Being recognized by Booth Centennial makes us feel proud that we're environmentally conscious and that TSH – one of the largest community hospitals in the GTA – is moving in the right direction," Nurallah adds. "This is a huge step forward, another recognition that TSH is a leader in integrity and accountability."

FAMILY MEDICINE RESIDENT BRINGS GLOBAL HEALTH SPECIALTY TO HIS PRACTICE

A medical degree in global health is a rare specialty, one that TSH family medicine resident Dr. Alan Goldman is finding very useful in treating Scarborough residents.

"It's amazing to have this background in international health, and especially to be able to put it to good use in such a culturally diverse community," explains Dr. Goldman, who recently started his two-year residency at TSH and has always has a "passion" for global health issues. Born and raised in the Toronto area, Dr. Goldman recalls doing a project in Grade 10 on

cardiac transplantation, "and I thought it was the coolest thing I've ever seen."

"Medicine was at the back of my mind going forward ever since. Even as I explored other career options, it always came back to medicine," he says.

While attending York University during his undergraduate years, Dr. Goldman had the opportunity to travel, teaching English in China and participating in earthquake relief in El Salvador.

"I realized I had a strong interest in various cultures, and wanted to combine that with medicine, so I finished by Undergraduate degree and went for my Masters in international health," he says.

He remained at York University where his Masters' thesis, 'Ugandan Youth: Attitudes, Knowledge and Behaviour Regarding HIV Prevention,' was followed by two published manuscripts, both of which examine vaccine preparedness in sub-Saharan Africa. He subsequently attended the Medical School for International

Helpful tips for new dialysis patients

Patients diagnosed with kidney failure – where kidney functions drop below 15 per cent – have two choices for survival: dialysis treatments or kidney transplants.

Dialysis is a process for removing waste and excess water from the blood, and is used primarily as an artificial replacement for lost kidney function in people with renal failure. The Scarborough Hospital's Chronic Kidney Disease Program is one of the largest in North America, treating more than 5,000 patients with kidney disease and another 750 dialysis patients.

Diabetes is the most common cause of kidney disease. High blood glucose levels and high blood pressure can damage the kidneys over time. But for long-time dialysis patient Terri Bradshaw, diabetes was not the diagnosis that turned her life upside down 10 years ago.

"It was glomerulonephritis, which is not diabetesrelated," Terri says. "When I was first diagnosed, I was in denial until I became so sick, I had no objections to going on dialysis because I just wanted to feel better.

"I won't deny that dialysis is very invasive, and there is pain involved," explains Terri, who is Chair of the Home Dialysis Peer Support Group at The Scarborough Hospital. "You really don't understand what it means until it happens to you, but I always tell people that it beats the alternative."

For newly diagnosed patients needing to start dialysis, Terri offers the following advice:


- 1. Gather as much information as possible provided by doctors and nurses, and review it at home with someone you trust who will help you. Go over it together in a quiet environment that's less stressful because you can't possibly absorb all that information in the doctor's office.
- 2. Write out questions for your medical appointments even if they seem silly. Quite often during appointments, your discussion with the doctor takes another track. Keep a log of your questions and answers, because when you're sick, it may be hard to remember everything. Better yet, take someone with you to your appointment.
- 3. Don't allow yourself to be intimidated by healthcare professionals. Be prepared for your appointments and be your own advocate. Be involved, be in charge, and take an interest in your treatment.
- 4. Take advantage of any non-clinical information or support, such as a peer support group, touring the facility, watching the dialysis machines in action and talking to other patients.
- 5. And the most important and probably the hardest thing is to stay positive, even when don't feel good. Without a positive outlook, it's very easy to slip into black hole of depression.

Health in Israel, a specialized medical school that incorporates global health coursework into all four years of the curriculum. As a first-year medical student, Dr. Goldman worked on a study comparing the rates of adherence to anticoagulant therapy in Bedouin and Jewish populations in the south of Israel. In his fourth year, he completed a study on 'Preventative Health Behaviours By Time-Since Immigration to Canada.'

"Global health is very important to me, and as such, I try to build it into my career," Dr. Goldman says. "Working at The Scarborough Hospital helps to fulfill that need as I have so much opportunity to interact with different cultures."

Dr. Goldman says his young family is settling into Scarborough quite nicely.

"When we moved here, we knew very little about the community," he adds. "Scarborough is amazing. We feel right at home in one of the most culturally diverse cities in the world."

Pt Jawaharlal Nehru had strong scientific temper

Science occupied a central place in Pt Jawaharlal Nehru's vision of good society. As a scholar at Cambridge, he had acquired a sensitive understanding of the intellectual matrix of science and this understanding became deeper through extensive reading of socialist literature. In many ways Pt Nehru was the greatest man of our age. His name and fame will resound throughout the world in the ages to come. His love of science was only one facet of his complex, many sided, mysterious personality, yet his depth of understanding of science was perhaps unique among world leaders. He said, "The future belongs to science and to those who make friends with science".

Science for Pt Nehru was more than just a conglomeration of disciplines dealing with the development of material resources. He was concerned with, what he described as a scientific temper which enables man to look upon himself, upon society and upon the problems facing mankind with an intellectual vigor, which combines sympathy with objectivity. To him science is an effective agent to bring social and economic transformation. It doesn't solve man's present day problems but also governs the future course of civilization also. Pt. Nehru often referred to the paradox of India being a rich country inhabited by poor and starving people and asked, "Why are we unable to convert our natural endowments into wealth meaningful to our people?" And the question was answered in the book 'Discovery of India' in these words: "It is science alone that could solve the problems of hunger and poverty, of insanitation and illiteracy, of superstition and decaying customs and tradition".

After our country achieved independence his gaze was on development since he wanted to concretize his vision on new India. As Prime Minister he wanted India to develop along modern lines and make rapid strides lest it should be left behind in the competitive world so he looked upon science and technology as the levers for this purpose and for raising the living standards of masses.

In 1950 Planning Commission was set up to devise strategy of rapid econom-

ic growth as well as of the reduction in economic disparities. Heavy industries, Machine tool factories, fertilizer plants, shipping and aeronautical industries came up with amazing speed. Towns and cities started cropping up at places which had known no habitation at all. The entire rural India was connected through a network of village development blocks and community projects.


During British period emphasis on Indian science and technology was directed towards meeting the needs and requirements of the then Government for increasing trade communication and defenses. This resulted in several important advances such as the first scientific survey of the country and a network of meteorological stations, the buildings of canals and railway system. Several academic institutions were created. The end of 19th century and the first 50 yrs. of 20th century produced some of the ablest scientist the country has known and this period is recognized as the Renaissance of science for India.

Shanti Swaroop Bhatnagar(1894-1955) an outstanding chemist in his own right, worked very closely with Pt Nehru and founded the Council of Scientific and Industrial Research (CSIR) with a chain of National Laboratories. In the later period, another person who made the greatest impact on Indian Science was Dr Homi Bhabha, the father of India's Nuclear Program. He was instrumental in establishing the Tata Institute of Fundamental Research and the Atomic Energy Establishment which was later named after him. Dr Vikram Sarabhai was another scientist whose efforts yielded in the establishment of Space Research Organization (ISRO). However, it was only after the independence and through the vision of Pt. Jawahar Lal Nehru that science and technology were developed as a major force for accelerating for social and economic change.

Nehru's involvement in the promotion of scientific activities in India was of several folds. On the eve of independence he constituted a scientific manpower committee along the lines of a similar committee of England. From 1947 to 1950 in addition to being Prime Minister, he was the Minister-in-charge of scientific Research. In this capacity and even otherwise his fervent and convincing advocacy of the importance of science on motions to grant funds punctuated the parliamentary debates and lent luster and freshness to the quite often dull deliberations, presenting and defending the budget demands for scientific research he was not tired of reminding of his colleagues, the fundamental impact of science on the modern world and its implications for the Indian science. He laid the foundation for the establishment of a chain of national laboratories and continued as the chairman of the Governing Council of Scientific and Industrial Research until his death. From the time the Department of Atomic Energy was created, it remained directly under his charge as Prime Minister. He was elected President of Indian Science Congress Association in 1942 and again in 1947. Since that time he attended its annual sessions regularly.

1n 1950, three laboratories, namely the National Physical Laboratory in New Delhi, the National Chemical Laboratory in Poona and Central Technical Research Institute in Mysore were established. Pt. Nehru diverted his attention to the villagers in 1952 in a new effort to galvanize the national economy. He gave a call that "Everything can wait but not agriculture". This statement became a landmark in the history of India for the formulation of future policies towards agricultural development. It was for the first time that Government of India showed determination to tackle major rural problems. Research institutes on crops, animals, fisheries and other related sciences were started. Agricultural Universities, colleges and research institutes were sprung up in every part of the country. It was the vision of Pt Nehru that gave us the "Green Revolution" and placed our country on strong footing to take up any challenge on the food requirements of one billion people by the turn of 20th century.

Today, India can be proud of having the third largest manpower in the field of science and technology because of the structure which Pt Nehru laid down for higher education in fifties. It was the N.R.Sarkar Committee which reported in 1946 with regard to the post war landscape of technical education that led to the founding of an innovative technological institute at Kharagpur, afterwards it was raised to level of an institute of technology. Within four years, four others MIT's were established on the same pattern. This coincided in its own way with Pt. Nehru's vision of future India in which science and technology would play a considerable role in the development of the country. From the day these technical institutes were established, it was visualized that these institutes would compete with the best of the kind in the world. The model taken was from that from MIT at Boston. US helped directly for the establishment of MIT at Kanpur. Russian and German influence was



strong in Bombay and Madras MITs. All these institutes were developed in fifties.

The mineral raw materials constitute the backbone of industrial production. It was Pt Nehru's time that mineral exploration and mining development was given the pride of the place and its exploration made India totally self sufficient in the filed of planning, engineering and construction of mines. Presently India is in a position to extend technical knowhow in setting up, integrating and mining steel plants to other countries. The credit for all this goes to Jawaharlal Nehru, whose vision is being transmitted into reality. India's atomic energy program owns its beginning and development to the encouragement that Nehru gave during 17 years of his Prime Ministership. The creation of the Department of Atomic Energy in 1954 as an independent Ministry with Pt Nehru as its in charge was a radical departure from the normal methodologies of the working of the Government Ministries. It was Pt. Nehru who started the space Program in 1963 and its first centre at Thumba started functioning. Later on India undertook many complex projects and accomplished them. As President of the Council of Scientific and Industri Research, on 23rd May 1964, Pt Nehru approved for the setting of National Laboratory devoted to the study of the Ocean. This decision led to the establishment of the National Institute of Oceanography and Research soon after

Pt. Nehru had strong scientific temper which dispels difference between myths and logics. From the foregoing account it is ample clear that our impressive achievements in the field of science and technology during the post independence period own a great deal to the interest, support and patronage of Pt. Jawaharlal Nehru.



A Relationship with Life

"Life," says Maharaji, "is offering you something. Do you have a relationship with it?"

Indian by birth, but now, after decades of travel, a citizen of the world, Maharaji speaks to audiences of every size about personal fulfillment. He talks about a peace within the heart that brings contentment to those who seek it. He has spoken to millions of people around the world, in situations ranging from international convocations of professors and diplomats to groups of villagers. His words have been translated into hundreds of languages and are available in a variety of media.

"In this world," Maharaji says, "you have different relationships. They don't always work out. Sometimes they are a source of incredible amounts of pain. I am not talking about those relationships; I am talking about your relationship with the power of life within you."

The power keeping us alive, Maharaji says, sustains all living things. "Look at a bee and a flower," he says. "Over hundreds of thousands of years, they have established a relationship. Whether the flower knows this, I don't know; whether the bee knows this, I don't know—but there is a relationship.

"The relationship is that the flower offers a sweet nectar the bees like, and so they come looking for that nectar. Every time they land on that flower, they get a little pollen on them. Then the bees fly away. They land on another flower, and they pollinate that flower.

"So the flower gets to do something



that it couldn't normally do. It can't fly around. It doesn't have wings. It can't go very far, but the bees can. The flower offers the nectar, and the bees do the pollinating. What a beautiful relationship!"

How does that example relate to our lives?

"This is where it becomes very beautiful," Maharaji says, "because life, like that flower, is offering something. I'm not talking about this world. I'm talking about the power of life itself. It's offering something. The sky, the air, water, this Earth, this body—these are not our ideas. We couldn't come up with all this, but here we are.

"The question is what our relationship is to that power. Do we know how to accept it? The bees know how to accept the nectar. There are flowers in many places that have evolved such a specific relationship with hummingbirds that the shape of the bird's beak will only let it get nectar from that type of flower. It's specialized.

"Have we specialized to receive the gift being offered to us? No. Instead, what do people do? They try to oblige this world. In doing so, all of a sudden they find that a lifetime is not enough. How can someone make a master happy who doesn't know how to be happy? Yet the world is just such a master. It doesn't know how to be happy.

"Only one thing can make us truly happy, and that's the power that gives us life. Nothing can be happier than that. That's as happy as anyone or anything can be. What if the opportunity of being alive and the purpose of being alive is in fact an invitation from that power? 'Feel me. Experience me.' What if the purpose

of being alive is simply that?"


Maharaji offers to help people get in touch with that power within themselves.

"If you agree that we should have that relationship with the power of life," he says, "and you agree that we should be specialized to be able to take full advantage of what it is offering, then how can you do that? 

Flexing Out of Bondages

The complexities that one encounters on the spiritual path are not because of the path. The complexities are only there because of the mess that is your mind.

During the practice of yoga asanas1 you realize how rigid you are physically. It takes a little more awareness for you to know the rigidity in your mind and emotions. Somebody who is very rigid in his thoughts and emotions believes that he is perfect because he does not allow room for any other way of looking, thinking or feeling. When you meet this man, you think he is pig-headed, but he thinks he is perfect. Similarly, there can be rigidity on the energy level. For someone whose energy is very fluid, on the very first day of the simplest yoga kriya2, the energy will start moving and transforming, whereas for another person, even after practicing it for a long time, nothing seems to happen. This simply depends on how malleable the energies are. The rigidity in all these dimensions isn't really separate, they are all interconnected. The rigidity in one dimension manifests itself into the others.

On Patanjali's path, yoga is a system where it doesn't matter what kind of a fool you are, what level of unawareness you're in, what kind of karmic bondages you have; there is still a way for you. If you are willing to at least bend your body, you have already broken one karma. If your forehead touches your knee, then you have broken a physical karma. This is not a joke; it's quite an achievement for a person who has never done it before. This simple limitation

would have increased with the passage of time. Even the little flexibility that's there in you today will become less as time goes by. A day will come when you're totally rigid, both physically and

This is happening to everybody. Look at your own life; see how flexible you were at the age of ten or twelve, both physically and mentally. At the age of twenty, the flexibility is considerably less and at the age of thirty, most of it is gone. Not only physically, mental rigidity has also set in very severely as you progress on this path; it's not progression, rather it is regression. Life is just a regression for most people. They are not growing; they are going backwards. Even with what little assets they have come, they don't grow; they just go backwards, unfortunately. 



Pandemonium in Sri Lanka parliament as MPs clash during budget speech

Pandemonium erupted in the Sri Lankan Parliament on Monday November 21st 2011 as MP's belonging to the ruling United Peoples Freedom Alliance(UPFA) and opposition United National Party(UNP)clashed openly in the presence of Sri Lankan President Mahinda Rajapaksa during the presentation of the budget for the forthcoming year.

In what was a shameful spectacle viewed by several diplomats ,high ranking govt officials, media personnel and eminent citizens ,there were fisticuffs, scuffles, manhandling, hurling of water bottles,books,files,papers, abuse, threats and tugging of sarees worn by some woman MP's.

Although the majority of MP's on either side remained passive, the antics of a few Parliamentarians brought great disrepute to the August assembly despite the presence of Sri Lanka's head of state in the House by the Diyawanna Oya.

The opposition MP's from the Democratic National Alliance(DNA)and Tamil National Alliance(TNA) as well as Govt MP"s from other political parties were not part of the furore. Only MP's from the UPFA and UNP were actively involved in the fracas.

It all began with the dawning of budget day on Nov 21st. President Mahinda Rajapaksa who is also the Finance minister was scheduled to attend Parliament and deliver the Budget speech.

INTELLIGENCE

The Govt received intelligence reports that the UNP planned to stage demonstrations brandishing placards and posters with slogans against the President during Parliamentary proceedings. The Speaker Chamal Rajapaksa was informed.

In a controversial , preemptive move the speaker instructed the sergeant at arms to authorize Police to search the premises for placards and posters and to prevent MP's from bringing such material into the Lobby

The Police following orders conducted a search and then wanted to go into the Opposition leaders office for an intensive search. UNP parliamentarians vehemently protested at this breach of Parliamentary etiquette and stopped it.

Police however prevented UNP MP's from bringing in documents or files on the basis that posters could be hidden inside. Police forcibly took away files in the possession of UNP Parliamentarians Dr.Jayalath Jayewardena and Tissa Attanayake.

This high handed action by the Police was a grave infringement of the Parliamentary privileges of MP's complained the UNP which stated the Police had no right to seize material from an MP inside Parliament or prevent an MP from carrying documents and files into the lobby.

After Parliamentary proceedings began, President Rajapaksa entered and commenced the Budget speech at the auspicious time of 1.53 pm. At this time the UNP's Dr.Jayalath Jayewardena stood up and tried to raise a ponit of order about his rights and privileges as an MP being infringed upon by the Police.

OVERRULED

The Speaker overruled him saying that he would not allow it as the second reading of the appropriation bill had commenced. A smiling President continued with his address amidst thundering cheers and applause from the Treasury benches.

The President prefaced his speech with the remark about how happy he was to present his seventh budget before Parliament with his elder brother presiding as speaker. As the speech progressed opposition MP's began interrupting heckling and booing. Govt MP's began retorting. The President also made a few remarks and continued reading the speech.

At one stage some of the UNP MP's raised placards and posters with the slogan "Budget or Bucket" and "Shame" written in Sinhala, Tamil ad English. Many of these posters were improvised ones with "Shame" being written on A-4 size paper.

This led to much shouting and cross talk between UNP and UPFA Parliamentarians. At one point President Rajapaksa lost his cool and told Dr.Jayalath Jayewardena that he would dissolve Parliament if necessary to teach opposition MP's a lesson." only God can save you all then" he stated.

Unfazed the UNP Parliamentarians continued to wave their posters and handle-less placards .They also shouted "shame, shame" and "bucket budget" loudly.

It was then that Lohan Ratwatte, UPFA Kandy district MP and son of former cabinet minister Anuruddha Ratwatte went up to UNP's chief whip John Amaratunga and snatched away the poster in his hands.

When the taller Amaratunga tried to wrest the poster back, the UPFA's Polonnaruwe district MP Roshan Ranasinghe went up to both and pushed Amaratunga back. Lohan Ratwatte then sprinted back to his seat with his prize.

HARIN FERNANDO

But when Roshan Ranasinghe walked back triumphantly he found his way blocked by the UNP's "fiery particle" from Badulla district Harin Fernando. Both came to blows after a heated inter-play of words. This saw UPFA Badulla district MP Chamika Buddhadasa rush to the aid of Roshan Ranasinghe and confront his UNP rival Harin Fernando. This in turn saw UNP Moneragala district MP Ranjith Madduma Bandara join the scuffle to help his colleague Harin Fernando. This in turn saw former speaker WJM Lokubandara's son and Badulla district MP Udith Lokubandara also joining in the "frolics".

At this point of time the "combat" seemed to be a home and home fight between the "merry men of Uva" as Buddhadasa, Lokubandara, Madduma Bandara and Harin Fernando were all MP's representing the Uva province. But the conflict soon escalated.

The floodgates were now open and a number of MP's from the Govt side got up from the back rows and moved up to the front to join in the fracas. These included some backbenchers and a few holding ministerial and deputy ministerial portfolios.

The Govt Parliamentarian combatants were led by Gampaha district MP and minister of Public relations and Public affairs "Doctor"Mervyn Silva. True to form the self-styled descendant of Dutugemuu fearlessly led his knights at arms into the foray asking and giving no quarter.

PUGILISTS

Among other portfolio wielding pugilists risking dignity and self-respect in the line of duty were Sports Minister and Kandy district MP Mahindananda Aluthgamage, Civil aviation minister and Puttalam district MP Priyankara Jayaratne and Deputy minister of Health and Kegalle district MP Lalith Dissanayake

Among the noteworthy champions from MP Parliamentarian ranks in the fray for President and party were two from Sabaragamuwa, T.Ranjith de Soysa (Ratnapura) and Kanaka Herath (Kegalle)

It was like a rugby scrum sans the oval ball with the Parliamentarians engaging in a free-wheeling scuffle trading blows and exchanging in the choicest language, threats and insults.

Interestingly the combatants on both sides were from the Majority community with minority ethnicity MP's being conspicuously absent from the fracas.It was thus a Pan-Sinhala "event".

While this was going on there was a loud outcry from both sides with Parliamentarians shouting slogans and hurling insults at each other. Govt MP's also began throwing water bottles, books, files and papers at the opposition.

One book landed right in front of UNP senior deputy leader and Gampaha district MP Karu Jayasuriya. A water bottle hit the leg of opposition and UNP leader Ranil Wickremesinghe.

Excelling in this type of sport was the UPFA's 74 year old national list MP Kamala Ranathunga whose unerring markswomanship in striking bulls-eye was astoundingly remarkable.

WATER BOTTLE

One of the water bottles thrown from the govt back row at the opposition fell short of its mark and hit the floor very close to President Rajapaksa who stopped reading the speech and started entreating the MP's to stop.

At one point an exasperated President shouted in Sinhala saying "MPs from the Govt. At least you all return to your seats". A few obliged but the rest continued with the "satana".

Meanwhile the speaker Chamal Rajapaksa called upon Sergeant- at -Arms Anil.P.Samarasekara to restore order. The Sgt at arms and his staff tried to restrain the pugilistic MP's and make them cease combat. The squabbling however continued.

Deputy minister of Education and Moneragala district MP Wijayamuni de Zoysa in a burst of frenzy rushed up to the opposition benches and began to sweep everything on their tables to the floor. He also seized books and documents and threw them away.

Not to be outdone Kalutara district MP and deputy minister of Ports and Highways Rohitha Abeygunawardana went up to Matara district MP and former cabinet minister Mangala Samaraweera and

grabbed him by the collar trying to assault him. Samaraweera resisted and other UNP Parliamentarians gathered around and restrained Abeygunawardana.

Some of the woman MP's in UNP ranks like Rosy Senanayake and Anoma Gamage also found themselves targets of sorts and had hands tugging at their sarees.

Education minister and Colombo district MP Bandula Gunawardena strove diligently to cool tempers and instill a modicum of discipline and decorum into his "warrior" colleagues. The Education minister deserved a bouquet for his ennobling efforts.

WALKED OUT

Gradually the melee subsided and commotion ceased. President Rajapaksa resumed his star-crossed budget address.But an aggrieved UNP would have none of it.Refusing to remain in Parliament after what they termed was "a murderous attack by govt members" the UNP led by Ranil Wickremesinghe walked out of Parliament.


The Opposition leader then held a press conference where Mr. Wickremesinghe charged that key UNP Parliamentarians such as Karu Jayasuriya, John Amaratunga, Joseph Michael Perera, Jayalath Jayawardena, Rosy Senanayake, Mangala Samaraweera, Anoma Gamage and Harin Fernando were assaulted and threatened by government MPs in Parliament. He added that some of them will have to undergo medical check-ups as a result of what he termed a a 'brutal attack.'

The UNP leader said government Ministers and MPs such as Roshan Ranasinghe, Lohan Ratwatte, Udith Lokubandara, Mervyn Silva, Lalith Dissanayake, Rohitha Abeygunawardena, Wijithamuni Zoysa, Piyankara Jayarathne and Kamala Ranatunge were responsible for attacks and threats on Opposition MPs

Even as the UNP was accusing the government MP's of attacking them in Parliament President Mahinda Rajapaksa winding up his udget speech requested the UNP to unite and support the Government for the betterment of the country

Thus ended an ugly chapter in the Parliamentary history of the Island nation where Government and opposition MP's fought each other in an exhibition of rowdyism despite the Executive President being present and his elder brother the speaker presiding over proceedings. 'War tourism,' in an environment where survivors worry about next meal and still haunted by violent past

ELEPHANT PASS, Sri Lanka (AlertNet) – The packed buses hurtle along the once forbidden, dusty A9 highway from the Sri Lankan capital across the former frontline to the "liberated" north – a region held by the defeated Tamil Tiger separatists for the best part of a quarter of a century.

Along the way, the buses stop and passengers descend into the hot afternoon sun, taking out their phones to photograph displays of blown-up water tanks, captured boats, armoured vehicles and monuments dedicated to the army. In some places, they buy a cool refreshment and a souvenir t-shirt.

More than two years after the Indian Ocean island's 25-year-old civil war ended, an entire generation of Sri Lankans is finally getting the opportunity to see a part of their country which was off limits. A place they had heard about, but never imagined visiting. A place now healing from the ravages of war

"It's really interesting to see all this," says accountant Gayan, 33, from the capital Colombo, as he holds up his BlackBerry to snap a picture of his brother and father posing in front of a captured truck. It's on display at an armyrun roadside "tourist spot" at Elephant Pass, a strategic military base fought over repeatedly during the 25-year civil war

"Growing up, we would hear about the Tigers and were scared of attacks in Colombo, so it's good to have peace and see the north," he said, sipping some ice-cold Coke at the cafe and examining the other war relics on display — a tractor and wooden boat once owned by the Tigers.

Sri Lanka's army retook Elephant Pass, under Tiger control since 2000, as part of its 34-month offensive to end one of Asia's longest modern conflicts once and for all – retaking nearly a third of the island's land mass which the Tigers controlled, until a cataclysmic final battle defeated the separatists in May 2009.

In the nation's south, including Colombo, the victory brought an end to the constant fear of suicide bombings and other attacks that killed thousands of civilians – a hallmark of the Tigers, who were on the terrorism lists of more than 30 nations.

Now, as communities return to find their homes destroyed, possessions lost and little means of making an income, some aid workers and residents question this "war tourism" in an environment where survivors worry about their next meal and are still haunted by their violent past.

"It's wonderful that the war has ended," said a foreign aid worker based in the northern Kilinochchi district, who spoke on condition of anonymity for fear of upsetting the government.

"But given it was a horrible finish and that war-affected people are still struggling financially and emotionally to pick up the pieces and rebuild their lives, it's too soon and insensitive to be making even a small business out of it or erecting memorials to those partly responsible for civilian deaths."

The government rejects allegations that it intentionally killed civilians during the final offensive, when some 300,000 were held hostage by the retreating Tigers.

It has ratcheted down the presence of foreign aid workers, especially in the north, where by necessity they worked with the separatists and often had their organisations infiltrated by Tiger operatives

T-SHIRTS AND ARMY NOTE-BOOKS

Most of the Tamil civilians were forced to flee with the Tigers, until army operations allowed hundreds of thousands of them to pour out. They were sent to crowded displacement camps lacking proper sanitation.

There is no conclusive figure on how many civilians were killed in the fighting in the final months.

A U.N.-sponsored report, criticised by the government as being filled with unfounded accusations that initially emerged from Tiger propaganda outlets, says there was "credible evidence" thousands and perhaps tens of thousands killed in shelling and fighting.

Yet no one who gets off the buses mentions the bloody end of the war or the struggle survivors are going through, despite the pick-up trucks laden with



World Food Programme sacks of grain and large white lorries with the familiar blue "U.N." lettering – a telling sign that aid is still needed here.

Along the A9 Highway, which runs through the centre of Kilinochchi town, a massive concrete water tank lies fallen on its side, blown up by Tigers retreating from a place they unilaterally declared the capital of Tamil Eelam, the country they wanted to carve out as a Tamil-only preserve.

The destroyed tank is enclosed within a wall, together with a plaque and a "Souvenir Galore" shop run by the army. Visitors take a few snaps, have a cold drink and buy a black t-shirt or baseball cap with "Kilinochochi Re-awakening" emblazoned across it, or opt for the smart Sri Lanka military field notebooks on offer for a just few hundred Sri Lankan

"During the week, there are many buses and people stopping. At weekends, we get the most amount of visitors – around 600 or so," says Nalaka Vijaypala, 24, a Sri Lankan army soldier in civilian clothes, the left side of his head scarred from sniper fire during the

war. "The army runs this place ... It's popular."

Other monuments are also on display along the route – a giant cuboid with a bullet lodged inside it and a lotus flower and the gold, red and green Sri Lanka flag emerging from the top of it – in memory of the Sri Lankan army "in the gallant operation to annihilate savage and brutal terrorism which has terrified this land," reads the plaque.

The government has quickly repurposed its military assets and personnel for civilian purposes, in part to help President Mahinda Rajapaksa's post-war development drive and also to keep the roughly 100,000 troops in the north gainfully engaged after the war. But for some war survivors, it is just too early.

A few hundred metres down from the imposing cuboid, 35-year-old war widow Subendine, who sells vegetables by the roadside, says the visitors bring discomfort.

"They come and go ... they take their pictures. They don't ask us or even want to know what happened," she said.

Sri Lanka tourist arrivals hit new record high in 2011

Sri Lanka's tourist arrivals in the first 10 months of the year has surpassed 2010's record as visitors to the island nation has continued to rise every month on a year-on-year basis since May 2009, according to a Reuters report.

The report states,

Tourist arrivals in the first ten months of 2011 jumped 34.2 percent to 667,569 from a year earlier, higher than Sri Lanka's record annual tourist arrivals of 654,476 reached last year.

The arrivals rose 32.8 percent in October from a year earlier to 69,563.

The government is targeting annual revenue of \$2.75 billion by 2016 from 2.5 million expected visitors attracted by Sri Lanka's beaches, hills and religious and historic sites, while aiming for \$3 billion in foreign direct investment.


Sri Lanka has forecast 20 percent growth in visitor arrivals this year to more than 780,000 people. Last year, the industry grew at 46 percent. The island's tourism industry drew \$1.2 billion for investment in the first half of 2011.

Tourism revenue, which jumped 64.8 percent in 2010 to a record \$575.9 million, has risen 48.1 percent in the first nine months of this year from a year earlier to \$580.1 million, central bank data shows.

-Sri Lanka aims to attract \$2.7 billion in investment to upgrade its post-war tourism capacity.

-The hotel and travel index on the Colombo Stock Exchange has risen nearly fourfold since the end of the war.

-Tourism is one of the main foreign exchange earners for Sri Lanka's \$50 billion economy along with remittances from expatriate workers, garments and tea.



Bangladesh Begins 1971 War Crimes Trial

Four decades after Bangladesh's violent struggle for independence from Pakistan, the country has begun the first trial of those accused of war crimes. But observers have long raised concerns about how authorities are conducting the trial and whether the prosecutions are politicized.

On Nov 20th, senior leader of the opposition Jamaat-e-Islami party, Delawar Hossain Sayedee, became the first to stand trial for the 1971 crimes. A prosecutor charged him with crimes against humanity, such as genocide, murder and rape.

Sayedee is among seven senior Bangladeshi politicians charged with war crimes during the violent ninemonth struggle that led to the country's independence from Pakistan.

In addition to Sayedee, four other suspects belong to the top rungs of the opposition Jamaat-e-Islami party - Bangladesh's largest Islamic party. Two belong to the main opposition Bangladesh Nationalist Party. They are accused of collaborating with Pakistani forces and committing atrocities during the conflict that killed an estimated three million people.

All of them maintain their innocence and accuse the government of Prime Minister Sheikh Hasina of carrying out a political vendetta against them.

Professor of politics at Dhaka University, Ataur Rahman, says there is wide acceptance that those guilty of war crimes should be brought to justice. But he says there are growing concerns about how the trials are being conducted and the credibility of those involved in meting out justice.

"They have some misgiving about the fairness of the trial, in terms of the process and whether that process is conforming to the international standard or

not," Rahman said. "I think the government should take much more care than they did particularly in drafting some of the laws, in recruiting some of the prosecutors and in recruiting particularly the judges and the chairman of the tribunal."

The tribunal was set up last year without United Nations involvement. Human Rights Watch has said that legal procedures fall short of international standards. There have been reports of defense lawyers and witnesses being harassed. Critics also say the rules on what evidence is permissible are at variance with international law.

British lawyer John Cammegh, whose help was sought by Sayedee's defense team, has said that he was not allowed to participate in the trial or enter the country while it is happening.

The prosecutor has said the trials would be fair and are not aimed at "political axe-grinding." The government also says its legal structure is competent enough to handle the trials.

Political analysts say, unless the trials are seen as absolutely fair, they could further heighten tensions in a country with an already divisive political culture.

plumb to 58 against US dollar

The rupee can slide further and touch a level of Rs 58 a dollar in the near-term if the economic condition deteriorates in the Eurozone economies, top banking officials of HSBC Bank said on Nov 24th.

"The rupee is likely to depreciate further and touch a level of Rs 58 against the US dollar in the near-term if the Eurozone nations don't find a credible solution to their debt woes," HSBC Bank India and ASEAN chief economist Leif Eskensen based in Mumbai said. He also said the domestic currency would slide also due to high inflationary environ-

ment, and a possible slowdown in the GDP growth. "This will happen despite intervention by the Reserve Bank of India (RBI)," he said without giving any specific timeframe.

The rupee, which touched an all-time low of Rs 52.73 against the dollar on November 22, has plunged around 15 percent in 2011 as investors seek safe haven option in the US treasury papers and its currency. RBI has intervened in the forex market by selling dollars to check this volatility. As per a Citibank estimate, RBI is believed to have pumped

India, Pakistan Work Toward Normalizing Trade

Efforts by South Asian rivals India and Pakistan to normalize trade ties have received further momentum, with Pakistan agreeing to open most commerce with India. The thaw in India-Pakistan trade ties is expected to bolster economic integration of the South Asian region.

At a meeting in New Delhi recently, Pakistan pledged to open its market to 7,000 goods from India over the next three months - up from the fewer than 2,000 items allowed at present. Top commerce officials from both countries also decided to open more trading posts and ease visa rules that restrict travel.

The steps follow Pakistan's decision last month to grant "most favored nation" status to India. That means the two countries are on track to trade on equal terms by removing tariffs that restricted commerce for decades.

Trade analyst Nita Taneja at the Indian Council for Research on International Economic Relations warns that favorable trade accords alone are insufficient to boost commerce. She says infrastructure improvements are needed to overcome the two countries' limited transportation links.

"Look at rail movement. You don't get wagons to transport goods across the border. There could be a wait of 45 days," Taneja said. "For instance, a lot of iron ore is getting exported from India from the eastern side and that is all going via Colombo, and then to Karachi and then coming back to Lahore."

Some steps are being taken. A new freight handling facility will be opened in the coming months at Wagah - the main land crossing between the two countries.

The business potential between India and Pakistan is underscored by the flourishing illegal trade that goes via the Middle East and is estimated at \$3 billion - higher than the official bilateral trade of about \$2.5 billion.

Economists say the benefits of normalizing trade ties between the two rivals will also help boost trade in all of

South Asia - one of the world's least economically integrated regions. Regional trade is \$5 billion or just five percent of South Asia's total trade.

The head of the Federation of Indian Chambers of Commerce and Industry, Rajiv Kumar, says the potential to increase regional trade is huge.

"One of the major impediments in the greater trade relations within the region was [the] India-Pakistan standoff," Kumar said. "Now that is beginning to get resolved, I think you will see a burst of trading activity and commercial activity all across the region."

At a regional conference last week, India made another push to engage in commerce with its neighbors. Kumar says this is important because India accounts for a large part of the region's economy.

"India has also taken an amazing step by announcing that all imports from less developed neighbors - Nepal, Bhutan, Bangladesh - will have zero tariff duty treatment," Kumar said. "That measure also will allow greater access to the Indian market.... India is the 1,000 pound gorilla in the room."

The World Bank estimates that trade within South Asia could rise to \$20 billion if restrictions are removed. Indian leaders say boosting trade ties will also make the region more politically stable.



in around USD 3 billion on Nov 23. The officials from the bank also said inflation and slipping fiscal deficit numbers could prove tricky for the domestic economy in the wake of ongoing sovereign debt crisis in Eurozone.

"Inflation is a much serious problem for the domestic economy in comparison to other emerging countries and it is still not under check despite monetary squeezing," Eskesen said. The HSBC officials, however, said that India is a domestic consumption driven growth story and would not be impacted as much as the export driven economies of the world.

Cold war in the tropics: China, India vie for Maldives

ADDU CITY, Maldives (Reuters) -On the pristine equatorial shores of the Maldives, an archipelago best known for luxurious resort hideaways swathed in coral reefs and cerulean seas, India and China's regional cold war is warming up.

Stretched across 90,000 sq km (35,000 sq m) of the Indian Ocean southwest of India, the Sunni Muslim nation of 1,192 islands finds itself sandwiched between the two Asian rivals, and both flexed their muscles at a meeting of South Asian nations hosted by the Maldives recently.

China preceded the heads-of-state meeting of the eight-nation South Asian Association for Regional Cooperation (SAARC) by opening its first embassy in the Maldives, a ceremony attended by Vice Foreign Minister Zhang Zhijun.

Two Maldivian officials said China had hurriedly rented a space to open the embassy in time for the summit, while the actual embassy is being built. Officials with the Chinese delegation declined repeated requests by Reuters for comment.

"The bureaucrat in me says the timing is right. You want to open something like that when there is a big official around. But opening it right before SAARC is a way to tweak India," an Asian diplomat told Reuters on condition of anonymity.

China joins India, Sri Lanka, Pakistan and Bangladesh as the only countries with full embassies in the Maldives and, at the SAARC meeting, Beijing pushed to have its observer status raised to dialogue partner, an elevated standing it has with the Association of Southeast Asian Nations (ASEAN).

"There was no hurry or further discussion to make China a dialogue partner," Maldivian President Mohamed Nasheed told reporters after the meeting.

"INDIA'S NEIGHBOURHOOD"

India's response to China's diplomatic display included a show of military force and political largesse.

Navy frigates patrolled off the Gan

atoll, where the summit was held, to protect VIP visitors including Afghan President Hamid Karzai, and Indian Prime Minister Manmohan Singh held a one-day state visit to the capital island, Male.

"This is our extended neighborhood. We wish to work with the Maldives and other like-minded countries to ensure peace and prosperity in the Indian Ocean region," Singh told the Maldivian parlia-

India extended a \$100 million credit line, inked pacts on maritime and counterterrorism cooperation, and both nations agreed "their respective territories would not be allowed for any activity inimical to the other and by any quarter."

New Delhi has long been concerned by any moves China makes to boost its presence in neighboring countries, and is worried about the so-called "string of pearls" ambition to expand Chinese maritime influence in the Indian Ocean and

"China has made a lot of surge in the Indian Ocean rim countries. Maldives is of particular interest because it can help China gain access to the main regional forum, SAARC," Bhaskar Roy, a strategic affairs expert at the Chennai Center for China Studies, said.

China made its present felt throughout the SAARC summit. The post-summit giveaway bag included porcelain pens and diaries from the Chinese Foreign Affairs Ministry detailing "Five Years of China-SAARC Cooperation." A box for a new 40-inch TV in the media center bore a sticker: "China Aid."

CHINA'S TOURIST TAP

While India may have the edge in terms of political clout and military cooperation, China has a softer but no less powerful lever over the Maldives' \$1.5 billion economy.

It is the top provider of visitors to the tourism industry, which earns 28 percent of gross domestic product and 90 percent of foreign exchange, with stays costing up to \$1,000 a night at paradise resorts on desert islands of pure-white beaches,

palm trees and incomparably hued condition of anonymity. waters. Chinese tourist arrivals doubled year-on-year in 2010, according to the Maldives Ministry of Tourism, Arts and Culture. By September, this year's 146,668 visitors from China were well past 2010?s total of 118,961.

"The Chinese can buy their way into this country. All they have to do is put out a travel advisory saying too many people are drowning and that's it, they will turn those tourists off like a tap," a senior Maldivian official said on condition of anonymity.

The China surge has been a godsend for tourism operators who traditionally rely on Europe and other Western countries for the bulk of visitors, but have seen those numbers fall with the downturn in developed-world economies and European debt crisis.

The Maldivian government wants "to maintain an appropriate balance between Maldives and India and other investors and not have any one country dominate them and exercise inordinate influence over them," a senior U.S. administration official told Reuters on

The United States remains concerned, as does India, about China's plans in the Indian Ocean, the official

"I think it is important to try to continue to engage them, to stress opportunities for working together, and to stress the importance of them being as transparent as possible about what their economic and military intentions are," the official said

The president, Nasheed, unequivocal when asked how the Maldives would avoid becoming a pawn between Asia's giant rivals.

"We've made it very clear that India is our best friend and neighbor and we will continue along those lines," he told reporters, prompting immediate questions from journalists present from China's state media.

"There won't be any issue because of the Maldives' friendship with any other country," Nasheed said, smiling. (Additional reporting by Krittivas Mukherjee; Editing by John Chalmers and Alex Richardson)

Myanmar engagement "not - " TT C about China, U.S. says

The U.S. decision to engage Myanmar should not be seen as an attempt to encircle or contain China and is a development that should be welcomed by Beijing, U.S. officials said.

After President Barack Obama announced he would send U.S. Secretary of State Hillary Clinton to Myanmar, U.S. officials emphasised that they would consult closely with China on the engagement with Myanmar.

Secretary Clinton is the first US secretary of state to visit Myanmar in more than 50 years.

One U.S. official, who spoke on condition of anonymity, said it is in China's interests to see Myanmar both stable and better integrated into the international community.

"It's about Burma (Myanmar), not about China," the official said.

Many analysts say Beijing is increasingly uneasy with what it sees as U.S. efforts to try to exert influence over countries around China. (Reporting by Caren Bohan, Editing by Jonathan Thatcher-Alertnet)

Church of Mary Magdalene

The Church of Mary Magdalene is a Russian Orthodox Church located on the Mount of Olives in the vicinity of the Garden of Gethsemane in Jerusalem, Israel.

This elegantly constructed church is dedicated to Mary Magdalene, a follower of Jesus. According to the sixteenth chapter of the gospel of Mark, Mary Magdalene was the first to see Christ after his resurrection. (Mark 16:9) She is considered a crucial and important disciple of Jesus. The church was built in 1886 by Tsar Alexander III to honour his mother, Empress Maria Alexandrovna of Russia. It includes seven distinctive, gilded onion shaped domes.

Dominus Flevit church (Lord Wept Church)

Dominus Flevit is a Roman Catholic Church located on the Mount of Olives immediately facing the Old City of Jerusalem.

Dominus Flevit, which translates from Latin as "The Lord Wept", was fashioned in the shape of a teardrop to symbolize the tears of Christ. Here, according to the 19th chapter of the Gospel of Luke, Jesus, while walking toward the city of Jerusalem, becomes overwhelmed by the beauty of the Second Temple and predicting its future destruction, and the Diaspora of the Jewish people, weeps openly. (Luke 19:37-42)

Garden of Gethsemane

Gethsemane Garden located at the foot of the Mount of Olives in Jerusalem most famous as the place where, according to Biblical texts, Jesus and his disciples are said to have prayed the night before Jesus' crucifixion.

It was a very moving experience for us to stand so close to the very spot where Jesus Christ is said to have been arrested before being crucified.

Gethsemane is mentioned in the Greek of the Gospel of Matthew and the Gospel of Mark. The name is derived from the Aramaic word Gat-Šmānê, meaning "oil press".

Apostles Matthew (26:36) and Mark (14:32) call it a place or estate. The Gospel of John says Jesus entered a garden with his disciples.

According to the New Testament it was a place that Jesus and his disciples customarily visited, which allowed Judas to find him on the night of his arrest

According to Luke 22:43–44, Jesus' anguish in Gethsemane was so deep that "his sweat was as it were great drops of blood falling down to the ground." According to the Eastern Orthodox Church tradition, Gethsemane is the garden where the Virgin Mary was buried and was assumed into heaven.



For the first time ever, devotees of Sri Sathya Sai Baba celebrated the birthday anniversary of their guru without his physical presence at Prashanti Nilayam, the ashram located in Andhra Pradesh, India. Don't cry." all the teachers were telling this to the students. We were crying for no plausible reason. May be this was a ploy to go home .This was the scene in all grade ones. Some of them were seen holding to their parents hands tightly and crying. They were adamant in going into the class.

Later on we were most of the time at school, celebrating Saraswathy pooja, preparing stage for concerts and decorating the hall for parties etc. I used to think of the first day at school and laugh to myself. I still remember that as I entered the class on the first day, I was not crying but on seeing others crying, I also started to cry. I was not worried on sitting on the ground and never thought of the shorts I was wearing then getting dirty. Later in higher forms we used to clean the chairs with our handkerchiefs before sitting, so that our pants don't get dirty.

I was holding on to my book bag tightly on the assumption, others may steal it. This was because of the instructions from my older sister, who told me to be careful of the books, pencil and the note book and all these to be brought home safely. In the same way another boy was also holding his bag tightly to his chest. His bag was also of blue color like that of mine .So I looked at him in amazement. He also looked at me. Both looked at each other and smiled .That was the beginning of our friendship. That was my first time, smiling at a stranger. I had all my relatives living down our lane. Cousins, uncles, aunts, brothers, sisters all living as neighbors. So every activity of mine was with them. Never had a chance to play with friends. Because I never had any friends to play with.

We were looking at each other and at our bags until lunch break. Our teacher told us take out the lunch packs. Inside the book bag there will be a lunch pack and a water bottle. Mostly bread and Jam or pittu and omelette. My Mum wanted me to avoid the trouble of washing the lunch pack and always gave bread with jam. That was later .But on the first day, I never took anything. Teacher was going round looking at the lunch of everyone. She asked "Ramesh, what did you bring for lunch?". I came to

and sat near him and shared my lunch with him. This strength- ened our friendship. Every morning all of us were delighted to tell good morning to teachers, as they approached the classrooms. We had a new technique in saying good morning. We waited till others finish their greeting and started after and said it loudly and showed our control of the whole situation. One day Miss. Muruguppillai put an end to our technique and made us angry. So that evening we hid our selves behind a bush

and ran away. We were playing with girls that time without showing any difference of boys and girls.

I shaved my head on the thirty first day of my father's death and went to school next day. Aiyngaran one of my class mates ridiculed me as a 'bold headed baby.' During lunch break, I started beating him assisted by Vinothan. After that he joined us, as a group member and three of us had hey days at school. We were engaged in so many tricks without being caught by the teachers or the vic-

know his name as Ramesh on that day. Since I did not bring any thing I was ready to cry as a self-defence. This was my practice even at home .When I break something or for some mischief, I used to cry before someone start beating or yelling at me. He took a box with cookies and showed it to the Teacher .When my turn came up I started crying. Teacher came to me and said not to cry and wiped my tears. She told me that boys should not cry and this made me to remember the fact that I am a male for ever. He took out a cookie from his box and held it towards me. That day I broke the rule of my mother that I should not accept any thing from strangers.

That evening I went home and demanded, that I should be given lunch everyday without fail and took it next day to school. During lunch break went

and shouted "murukkupillai" and ran away. But she saw him running and punished him the next day. He never told her that, I too was with him in shouting and saved me and showed his true friendship.

We had our lunch during lunch break, throughout the first year and after that we started eating bit by bit during class, without the teacher noticing it. During the lunch break we were playing with the tennis ball. We were playing a game called "sambol". We had two teams and aimed the ball at the other team members and if hit by the ball he was declared out and had to leave the team. We used to laugh at people who twisted their body when hit by the ball .This became a popular game and later girls also joined with us. When they sometime called us as 'boys', we used to get angry and hit them

tims never complained to the teachers. Hence we were free from any type of punishment. Also we scored good marks in the tests and were in the good books of teachers. We were the people who brought sticks to the teachers and not the people receiving beatings.

One day Rameshe's mom committed suicide and he was very much depressed. On the day of his mother's funeral he rolled on the ground and cried. It was unbearable to him. Students who ridiculed him for doing that, were well beaten up by Vinothan and myself. We found out that terrorism originates, when you are ridiculed. So violence became our weapon to defend ourselves. There were other bullies in the class, who got into difficulties daily and ended up in Principal's room. When we were in Grade



five our classmate Nayagi performed a Magician's dance at our school concert. After that I used to bully her by calling as the fearful Magician. Ramesh stopped me from doing that and later I found out he had a soft corner for her. Not that he was in love, but a special affection for her. At that age we never new what love was, except that it was a special kind of affection.

When we went on an excursion, he let me sit near the window in the bus. We were together during temple festivals tasting ice cream. On their festival day at the temple, he brought lots of bananas and vadais and we went to the field and had a feast. When we went on another temple excursion three of us took a picture with Mr. Sethupathy teacher. Later we found out that we had something common among us. That was we all had lost one of our parents. This we thought as a common bond which brought us pride. Our science teacher put zinc into sulfuric acid and produced hydrogen and filled a balloon with it. He told us to write the name of the school on a card and attach it to the balloon and allow it to fly. Secretly we wrote our names on it too.

When the army moved into our town, we were in grade eight. So we moved to Kanagarayankulam and I thought he moved with his grand-father to another place. I was not willing to join the school in that village and my mother never forced me to join. This remains still a mystery to me. Then, when the army got out of Omantahi, we moved to Mallavi. Within four years we moved to four houses and three villages. I never wanted to go to schools there. At last we came back to skanthapuram and was happy to see my school functioning but with less number of students. I was happy to see Vinothan at school. But no one knew where 'Rabbit' was. We talked about him now and then.

When we were in grade ten we heard the news that Nayagi eloped with someone and I was reminded of him. We never took anything for lunch but bought bun and tea at the school canteen. One day while eating bun I thought of him. I remember him stealing one hundred rupee note from his father's shop and got caught to the canteen Manager, when we tried to pay for the bun and tea we bought at the canteen. It is very rare to have a five rupee note at that time, when you are a student. So the Manger got suspicious and reported to our Teacher, who told him to bring his father next day. So he was upset. I devised a plan and told him to inform the teacher that your father is attending the Traders meeting and unable to come. That was a Friday and assured him that the teacher will forget about this over the week end. It worked out well and he bought me cup ice cream on Monday evening.

After some time Vinothan also left for Switzerland. I met his mother and she confirmed it. I never asked for his phone number since she may think that I may ask him for money. You can't blame her

because, once our people get their numbers, they ask them for money, thinking that they pluck money from a tree. I spent my time here and there without any proper education. We heard that we can go back to Kilinochchi. That time I started writing poems. Also met friends who were interested in literature and writing. At times, I thought of Vinothan and 'rabbit'. I have forgotten his real name.

We went back to Kilinochchi. The school's olive tree was found with only two branches and in a semi alive position. The school was filled with rubbles and was in pieces. The land and houses lost their identity. Land mines were removed from and around our houses. I became a reporter. I tried to write poems on the destruction of our place and failed .But captured the ruins in my camera. Many skeletons were displayed for identification. I went there to gather news. There was lots of crying and a tense situation prevailed. Suddenly 'are you brother Agilan?' a girl asked me. I said "Yes". 'I am Suganya, Rameshe's sister' she replied. I felt ashamed for not in apposition to identify her. I asked her, "Where are you staying? Where is Ramesh? Who accompanied you? non stop without paying attention to her tears on the eyes." We moved to our grandfather's place at Puththuvedduvan. One day grandpa got out to see our house in Kilinochchi not listening to anyone, who dissuaded from going. My brother also went with him. Both never returned home." She said.

I went to the place with her, where they had all skeletons arranged for identification. My mind was praying not to see their skeletons, expecting them to be in a prison. Suddenly she shouted "Anna (brother)". I saw a a skeleton of a fourteen year old boy and by the side was a man's skeleton. Immediately I remem-

bered his rabbit ears. She was crying and was holding my legs. I released her hands and came out of the place quickly. I was wondering what to do. Got on to my motor bicycle and came to our school

olive tree in a decaying state. The tree was standing there without any motion. I felt like crying. No one was around me. Hence unable to hold my grief any more, cried out loud.

"We have the graduation photo"


"Wonderful, the first impression is always important, you see; let me see, dashingly hansom man--- not very fair and not very tall, I assume, am I right?"


"We want you to check again the compatibility and their future"

Understanding the Registered

Disability Savings Plan

The Registered Disability Savings Plan (RDSP), which became available to Canadians in 2008, can be a very good way to accumulate tax-deferred savings (and obtain 'free' matching grants/bonds) for a disabled person. RDSP helps parents and others save for the long term financial security of a person who is eligible for the Disability Tax Credit . Contributions to RDSPs may be supplemented by a Canada Disability Savings Grant (CDSG) and a Canada Disability Savings Bond. Here's how it works:

Any Canadian resident eligible for the Disability Tax Credit can be the beneficiary of an RDSP. There is no lower age limit – an RDSP can be established for a minor and, generally, the sooner the better. The beneficiary and/or their family and friends can invest funds in an RDSP that will grow on a tax-deferred basis. Contributions are usually not tax-deductible and can be made by anyone authorized by the holder of the plan up to a maximum lifetime contribution of \$200,000 per beneficiary. There is no limit on annual contributions, other than the lifetime limit.

Contributions must cease at the end of the year in which the beneficiary reaches age 59 and the beneficiary must begin taking payments from the plan (known as Disability Assistance Payments/DAPs) at age 60, although DAPs can be taken at an earlier age in some circumstances.

The federal government1 will usually contribute quite generous Canada Disability Savings Grant (CDSG) and Canada Disability Savings Bond (CDSB) amounts to an RDSP. The amount contributed will be based on the family net income of the beneficiary, the value of the contributions each year, and any CDSG or CDSB contribution room carried forward from the preceding 10 years. However, when DAPs are made, all the CDSG and CDSB received by the plan in the preceding 10 years will be clawed back. The best RDSP strategy is to start saving early and leave money in the plan for at least 10 years.

Depending on the beneficiary's family income and contribution level, the may grant up to \$3 for every \$1 in contribution received by an RDSP in a year, to a maximum of \$3,500. The lifetime grant limit is \$70,000. A CDSG can be paid into an RDSP on a contribution made to the



beneficiary's RDSP by December 31 of the year the beneficiary turns 49 years old

A Canada Disability Savings Bond (CDSB) helps low-income families save for the long term financial security of an eligible person with disability. The bond is paid into an RDSP by the Government of Canada, even if no contributions were made to the plan. A Canada Disability Savings Bond is paid by the government of Canada directly into a registered disability savings plan. Depending on the beneficiary's family income, the government may contribute up to \$1,000 each year. The life time bond limit is \$20,000. A Canada Disability Savings Bond can be paid into an RDSP until the year in which the beneficiary turns 49 years old.

Disability assistance payments (DAP) are any payments made from the plan to the beneficiary or to the beneficiary's estate. DAPs do not affect eligibility for federal income-tested benefits or credits but may affect eligibility for certain provincial or territorial benefits or cred-

If you intend to leave substantial assets to a disabled person, it is recommended that the assets in question flow into your estate, and that in your will you direct that the disabled person's share of your estate is to be set aside in a testamentary trust known as a discretionary Henson trust, such that your trustee has the discretion to decide if, when and how much to distribute to or for the disabled person's benefit. It would be useful to specify within the will that the trustee may, if he or she thinks it appropriate, use trust funds to make contributions to

an RDSP on the disabled person's behalf, but the trustee should not be required to do so.

An RDSP can be a valuable planning tool – but there are many others to consider. Talk to your professional advisor about what's best for your situation.

GO trains coming to Kitchener Dec. 9 TRAIN COMING: Kitchener Centre MPP John Milloy announces Dec. 19 launch of GO trains service to Kitchener

Long-awaited GO train service between Kitchener and Toronto begins Monday, Dec 19.

Provincial commuter trains will leave Kitchener's Via Rail station on Victoria St. N. at 5:52 a.m. and 7:10 a.m., arriving at Union Station in Toronto two hours later.

Returning trains will leave Union Station at 4:45 p.m. and 5:45 p.m. and reach Kitchener two hours later. It's Monday to Friday, no weekend service, 11 stations, 10 cars per train and oneway fare is \$14.60. A monthly pass is \$482.

Politicians hailed the \$18-million launch as a step forward after GO buses came to the region in 2009.

"It's been on the agenda for a long, long time," said Liberal government MPP John Milloy of Kitchener Centre. "We have made some great progress."

However, the new service is half the plan proposed by GO Transit in 2009. It also falls short of the service desired by Kitchener council, which plans to use two-way commuter trains to bring employees into its downtown to help reiuvenate it

"It's not enough," Kitchener Mayor Carl Zehr said. "But we really do understand the need to progress."

"It's a great first step. However it's not enough," said Kitchener-Waterloo MPP Elizabeth Witmer, a Conservative. People want two-way service during more hours and weekends to attend cultural and sporting events and avoid Highway 401 driving, she said.

"This is the first step to connecting the Region of Waterloo to all-day, dual direction GO service and hopefully a future high-speed rail connection between Toronto and Montreal," said Tim Mollison of the pro-transit Tri-Cities Transport Action Group.

Among the shortfalls:

- The new service cuts the trains proposed in 2009 in half from four to two. It lacks a park-and-ride station proposed near Highway 7, east of Breslau. The province will not provide a date to add trains or build the park-and-ride, saying it depends partly on rider-ship
- There's no launch date for all-day, two-way service between Kitchener and

Toronto. Municipal politicians desire this to help out-of-town technology employees commute to jobs in this region. "That's a long-term goal," Milloy said

- There's no launch date for weekend service, which the province links partly to ridership. A planned station at Acton is delayed into 2012.
- Neighbours were startled to learn that trains will park overnight in central Kitchener and idle there while warming up. The province has stalled a costlier plan to park trains west of Kitchener in Baden.

Regional government plans 120 free parking spaces for passengers at King and Victoria streets when trains launch. Another 130 spaces are planned in 2012. Anyone arriving after the second train departs will pay parking rates.

Trains will eventually relocate to a transit hub at King and Victoria streets that regional government proposes to build.

Commuter trains will travel to Toronto at an average speed of about 50 km/h due to frequent stops and track constraints.




Amalamarial Vidivelly Boys' Center:

The center is concerned in rehabilitating the mentally & physically challenged boys. So far 25 have been undergoing the rehabilitation programme in the center. At present 21 are residing. Though the need and the request to accommodate more boys into the center is more, the lack space and the facilities are challenge for it.

Claret Arunothayam Girls' Center:

The center is concerned in rehabilitating the mentally & physically challenged Girls. So far 63 have been undergoing the rehabilitation programme in the center. At present 25 are residing. There are children of the mentally chal-





lenged mothers, mentally challenged and physically challenged girls/children. The girls need special care and well structured facilities for rehabilitation. 

WSPA demands Collars Not Cruelty in the fight against rabies

Global campaign launched to protect animals and communities

Every year, more than 55,000 people around the world die from rabies. Twenty million dogs are also brutally killed every year and fear of rabies is often used as the excuse. That's 38 dogs killed every minute. People think it will stop rabies. It doesn't. The World Society for the Protection of Animals (WSPA) launched the Collars Not Cruelty Campaign to ask governments worldwide to tackle rabies through the only humane and effective solution: mass vaccination of dogs. WSPA is asking Canadians to support the campaign by making a donation online at www.wspa.ca/redcollar.

"Rabies poses a serious threat to both human and animal populations in many parts of the world," said Ray Mitchell, International Campaigns Director, WSPA. "When confronted with the problem of this fast-spreading disease, national governments sometimes turn to what they believe is the only way to wipe out rabies: wipe out the dog population. However, a world without rabies does not have to mean a world without dogs."

"I think it's absolutely horrific that 20 million dogs are killed every year because of the fear of rabies when there is an alternative solution," said WSPA celebrity supporter Leona Lewis. "I really want to help WSPA spread the word worldwide and end the cruelty that is

happening at the moment. By educating people and getting vaccinations out there, we're not only helping dogs, but entire communities."

Over the past several years, WSPA has led many successful rabies control projects in Bali, Sri Lanka and several Latin American countries - all of which provided a humane and sustainable alternative to killing the dog population in response to rabies. As part of the Collars Not Cruelty campaign, the organization will work to implement similar mass vaccination projects in other areas of the world. WSPA is currently working on a new project in Bangladesh, where it is supporting the national government in implementing a large-scale vaccination campaign in the town of Cox's Bazar. The effort will save thousands of dogs in its first year alone and pave the way for a nation-wide vaccination campaign.

"We look forward to working with WSPA," said Professor Be-Nazir Ahmed, Director of Disease Control, Bangladesh Ministry of Health and Family Welfare. "We will proceed in a united way to eliminate rabies without the need to cull dogs."

WSPA strongly advocates that animal welfare agencies work in close partnership with human health, education and social welfare agencies to eradicate



rabies. It is widely accepted that the only truly effective solution for rabies control relies on a combination of dog vaccination, community education for bite prevention and accessible post-exposure treatment for bite victims. The World Health Organization (WHO) has described such vaccination campaigns as "globally, the most cost-effective strategy for preventing rabies in people."

Success in Bali: Vaccinating more than 210,000 dogs against rabies

WSPA's mass vaccination program involves teams of trained animal handlers who immunize dogs against rabies and give them a red collar. These red-collared dogs become a symbol of proactive measures being taken to protect communities from rabies - without resorting to cruelly killing dogs.

The vaccination program on the Indonesian island of Bali demonstrates the most recent success of the solution

proven by WSPA. In the first phase of the campaign, approximately 210,000 dogs (70 per cent of the total estimated population) were vaccinated. In the first six months WSPA saw dog (45 per cent) and human (48 per cent) rabies cases down by almost 50 per cent.

"Our work in Bali offered proof that a humane alternative for rabies control was both practical and effective. Other governments are beginning to recognize this success, and we are now working in several countries to design similar models for rabies control," said Ray Mitchell. "With the increasing support we are receiving from governments, international agencies and inter-governmental bodies; WSPA is confident we can create a world where we see collars – not cruelty – winning the fight against rabies."
