

Social Activist and Trauma Counselor speaks at the fourth annual Tamil Studies Conference in Toronto

The fourth annual Tamil Studies Conference couldn't have come to Toronto at a better time this year. Mr. Karunanidhi informed the M.Ps that he will do all what was possible to help in this matter.

The Indian Government gas already promised Rs.500 crores for the rehabilitation process of the displaced Tamils in the camps.

Karygiannis calls on the Harper Government to expedite Family Sponsorship Applications from Sri Lanka

Member of Parliament for Scarborough-Agincourt, called on the Harper Government to expedite Family Sponsorship Applications from Sri Lanka. As the internal situation in Sri Lanka has deteriorated, innocent civilians are suffering unspeakable hardships.

"People in the refugee camps have little or no medical assistance, clean drinking water or said Mr. Karygiannis. "There are reports of mass graves and over 20,000 people are reported missing. There are also reports of women being raped, children being separated from their parents and men been segregated separately from their wives and families."

Since the Conservative Government listed the Liberation Tigers of Tamil Eelam (LTTE) as a terrorist organization on April 8, 2006 and the World Tamil Movement (WTM) on 13 June, 2008, the Harper Government has taken an oppressive approach to immigration applications from



Tamil Sri Lankans. While innocent people are dying, immigration application processing times have increased by over three hundred percent; taking up to three years to re-unite spouses.

"Canada must make every effort to ensure that all the necessary security precautions are taken when assessing immigration applications." Mr. Karygiannis commented. "However, applicants from Sri Lanka are undergoing extraordinary background checks, which are taking an abnormal length of time. This has increased wait times significant-

Spousal Sponsorships are mandated, by the Department of Citizenship and Immigration, to be finalized within six to eight months. Spousal Applications from Sri Lanka are taking up to three years. People are undergoing two and three interviews in order to be able to emigrate to Canada and join their families."

In order to address the plight the innocent victims of the civil war, Mr. Karygiannis is calling on Harper Conservative Government to immediately enact the Protocol used by the Liberal Government after the Tsunami:

- The immediate evacuation of Canadians caught in the conflict area, who wish to leave Sri Lanka;
- The immediate expedition of Family Class Application presently in progress and new Family Class Application from the affected region (medical and background checks are finalized)
- " In order to meet the Department of Citizenship and Immigration mandated Standards of Operation, the Commission in Colombo should be provided with additional staff in order that this 'need' for increased security does not increase wait times.
- " The provision of additional CIDA funding of \$5 million to approved NGO's working in the field in order to provide and deliver humanitarian aid;



- The matching, dollar-fordollar, all monies raised by NGO's, approved by the Government of Canada, to provide assistance to the war torn area, specifically the North and the Northeast of Sri
- That should the Sri Lankan Canadian community wish to raise funds, they should be issued a one-time, special charity number by the Revenue Canada Agency in order to fulfill that requirement;
- That should Government of Sri Lanka ask for assistance or if asked by the UN, Canada should offer the DART Team, as we did after the Tsunami; and,
- " That Canada should push the UN to assign a Special Envoy to deal with the situation in Sri Lanka.

City of Toronto introduces Mobile Multi-Ethnic Food Carts

The City of Toronto has started a pilot project known as Toronto a la Cart Street Food Pilot Project. The proposed project is for vendors to market food from different ethnicities on mobile carts. This is a 3 year pilot project and there will be an annual report back to the Board of Health outlining the status of the project and making recommendations.

The city is supporting the vendors through media training, marketing materials, the creation of the "a la cart' brand etc. There is no financial support from the city to the vendors. More locations will be added in the future depending on the success of the present vendors. Food safety is the primary goal of the proposed project.

Although the city does not control or regulate the prices, vendors were requested to submit their pricing scheme as part of their application to the project. Their proposed pricing scheme was considered during the overall vendor evaluation and selection process. The city welcomed applications from all ethnicities and places of food origins. The vendor located at Nathan Philips Square offers Indian Food and the City hopes to receive food proposals from all regions of the world as the program expands.

Four of the eight vendors participating in the new Toronto a la Cart Street Food Pilot project have opened their Food Carts for business since last month.

While the horrific conditions at the "internment camps" have received attention, horrific abuses are reportedly taking place in so called" screening centres" and possibly the "rehabilitation centres" also . What are the procedures involved and who determines the outcome in these processes? The "Screening process" of the war displaced in Sri Lanka is conveniently run by the Sri Lankan government and therefore will enable them to continue to treat the Tamil populace using their own discretion.

Various reports raise fear of abuses taking place where thousands are being detained and "interrogated." There are no outside witnesses at all to prevent the human right violations from continuing in these several "screening centres." It is feared that thousands of people may be held even within the Kilinochchi area "screening cen-

It is reported that even persons from "internment camps" in Vavuniya are being taken away secretly to the "screening centres" for alleged involvement and / or sympathy to Liberation Tigers of Tamil Eelam (LTTE). Children are being separated from parents and being detained in "rehabilitation centres".

UN watchdog Inner City Press reported on June 2nd that 13,100 Tamil Internally Displaced Persons (IDPs) appear to have disappeared from Sri Lanka's internment camps between May 27th and May 30th reports by the UN's Office for Humanitarian Affairs.

Protests for the support of international humanitarian intervention have occurred all over the world in cities such as London, New York, Washington and Toronto. These awareness campaigns have gone on for several months and continue to take place as the international community remains largely dormant and inactive to the humanitarian violations that are taking place In Sri Lanka

Kashmir. Now the Pakistan Army itself accepts that terrorism originating from the Taliban, Al-Qaeda and other associated organisations must be disrupted, dismantled and defeated. If the Pakistan Army is serious about its mission against the Taliban and Al-Qaeda it cannot have anything to fear from the Indian Army deployment which is meant to counter the activities of the same terrorists only. When the Pakistan Army treats the jihadis as its strategic assets, it will have concerns on Indian Army deployment. Any continuous obsession Indian Army deployment will only raise doubts about the Pakistan Army having given up its misperceptions about the militants being its strategic assets.

Kashmir is not the origin of India-Pakistan tension but it is the outcome of Pakistan's two-nation theory which is the original clash of civilisations thesis. At the basis of it is the extremist thesis that Muslims cannot coexist with others and all Muslim-majority areas should be part of an Islamic order. No doubt, the US during the Cold War, particularly in the eighties, promoted the extremist Wahabi

A monitoring system needs to be enforced urgently so that international organizations such as the United Nations and other Human Rights groups will be permitted access to these camps to be witnesses to the actions that take place. Without any witnesses to the atrocities that are taking place in these "screening centres", "rehabilitation centres" and "internment camps" countless Tamils are continually disappearing and the numbers continue to grow.

There are discrepancies between the figures from the Sri Lankan government and independent groups for the people in the camps which pose questions of legitimacy for these camps.

Is the Sri Lankan government running these camps to show the international community that they do care about all of their people, including the Tamil people? If this is true then what will they do after the international community loses interest and they are up to their own discretion.

U.S. Senators have urged Secretary of State Hillary Clinton to deny the IMF loan to Sri Lanka that they requested. The grounds for this refusal were as the Sri Lankan government continued to ignore to address any of the concerns that were raised by Secretary of State Clinton and others, which evidently may set precedence that Sri Lanka can disregard the international community's concerns but still receive their support.

"Before receiving major financial support, the government should first take at least some steps to reassure the world that it is adjusting its policies, by allowing access to the conflict area and international monitoring of the screening process...," said Senators Patrick Leahy and Robert Casey in a letter to the Secretary of State Hillary Clinton on June 5th.

The Monsoon Journal urges Government of Canada to take similar urgent measures such as the move by U.S. Senators in suspending the IMF loan, towards getting transparency and access to all "screening centers", "rehabilitation camps" and "welfare camps" run by the Government of Sri Lanka for Internally Displaced Persons.

Two sustainable development programs of the City*s, the Toronto Green Standard (TGS) and the Better Buildings Partnership - New Construction (BBP-NC) were nationally recognized for their environmental excellence and innovation in service delivery and together received a Sustainable Community award.

I am very proud of the work we have done to raise the bar for sustainable development in this City, says Mayor David Miller. * In Toronto, buildings account for approximately 63 per cent of all greenhouse gas emissions, so it is critical that all new development adhere to a higher level of environmental performance if we are to achieve these targets*.

TGS is a set of performance meas-

ures for new buildings that promotes sustainable development. Being implemented through the planning process in September 2009, TGS is the City*s approach to greening development practices that respond to the City*s environmental concerns, which include air quality, greenhouse gas emissions, energy efficiency, water quality, solid waste and the natural environment.

The BBP-NC program provides assistance and incentives to enable energy efficiency measures throughout the design and construction phases of new buildings in Toronto. The program assists with the upfront costs of energy simulation or *modeling* during the early stages of design, as well as paying out incentives on the final *as constructed* energy savings that a new building achieves.

The Outstanding International Contribution award Volunteer acknowledges the City of Toronto*s leadership in working with internationalmunicipal governments in implementing a number of specific programs to help improve quality of life in countries such as El Salvador, Botswana, Indonesia and Sri Lanka.



International Tamil Technical Professionals' MONSOON Organization vows to rebuild Vanni Tech

San Jose nonprofit organization International Tamil Technical Professionals' Organization (ITTPO) founded the Vanni Tech in 2002. The institution hailed as a model on how Tamil diaspora could help build their homeland is now "abandoned."

In a news report recently on California - San Jose's Mercury News, Shan Nanthakumar of ITTPO said: "We will go back and start all over again, as soon as we are allowed back. Education is the key driver of survival of the Tamil community."

Full report by Lisa M. Krieger on Vanni Tech also becoming a casualty in the Sri Lanka onslaught:

Among the many casualties of Sri Lanka's bloody civil war is a Silicon Valley-built dream: an innovative technical college, built through Bay Area donations, but damaged in combat, then dismantled and moved, and finally abandoned.

The surviving faculty, staff and students of the Vanni Institute of Technology are believed to be held, against their will, in Tamil refugee camps, where the United Nations says they are in desperate need of food, water and medical care.

One recent graduate is known to be dead. Two staff members are undergoing treatment for gunshot wounds.

"It is a huge disappointment and frustration," said Shan Nanthakumar, a Wharton-trained émigré and chief financial officer for the Altierre Corp, who helped support the school with the San Jose nonprofit organization International Tamil Technical Professionals' Organization (ITTPO).

"My hope is that they are still alive, somewhere - and that we can help them get back on their feet," Nanthakumar said.

A quarter-century of conflict ended in mid-May, raising hopes that the nation, formerly known as Ceylon, could seek peace, reconciliation and reconstruction. Many had high hopes for the nation when it achieved independence from Britain in 1948. but the civil war devastated its

potential to become a regional economic power.

"We will go back and start all over again, as soon as we are allowed back," Nanthakumar vowed. "Education is the key driver of survival of the Tamil community."

Built in 2002 during several years of cease-fire, VanniTech was a high-tech oasis at the end of a dusty alley, past abandoned bicycles and wandering chickens.

In clean and air-conditioned classrooms, it educated hundreds of the region's top students in electronics, software development, database management and other computer-related skills - all desperately needed by the poor and isolated Tamil-held part of the nation, in the northeast.

Politically neutral, VanniTech earned the official blessing of both the Sri Lankan government and the Tamil Tiger separatists.

On a green and manicured campus, its software lab was filled with Pentium 4 computers. Its library held more than 15,000 books and CDs such as "Getting Ahead: A Business Course in English." The school had intranet service with e-mail, database servers and wireless connectivity. There were labs, dormitories, an employment center, cafeteria and a gym.

Its most advanced students studied university-level subjects like logic design, circuit analysis and wireless communications. By graduation, they could write business letters and give short speeches in English.

Its estimated 200 graduates have taken jobs with businesses, nongovernmental agencies or outsourced projects, such as Computer Zone Consulting of Minneapolis, Minn.

"It was a beacon of hope to so many young people that a selfsustaining university was in their midst," said Stanford University professor pathology Natkunam, who visited the campus in 2006. "It was an assurance of what could be achieved and a chance to build for a better

VanniTech was conceived by Cisco Systems software engineer Jey Surier of San Jose, who left

the region in 1982 but recognized that many of its top students remained trapped and unable to study due to the war and battered economy. Within six months, ITTPO donated \$100,000. In the Tamil village of Kilinochchi, Surier found a suitable site to renovate.

"It was a broken-down building with bullet holes," Surier said. "There was damage from a shell blast on the second floor. It had a leaking roof and no ceiling."

To rebuild, he arranged for tools and materials to go through two military checkpoints along the nation's badly damaged two-lane Highway A9.

For four consecutive years, students graduated and found well-paying jobs. Among them was Singam Theepan, who had lost his leg due to shrapnel lacerations - but gained enough computer expertise to support himself and his parents.

"I thought I would always have to rely on my parents. Now I'll be able to take care of them," said Theepan, interviewed at the school in 2005. "This gave me the only opportunity to progress in this life."

The renewal of combat in January 2008 was devastating to the school.

"There was air force bombings that shattered the windows. After that, there was more indiscriminate shelling," Surier said.

Students and staff dismantled the campus and moved it, in pieces, to a "safety zone" in the town of Vavuniya about 20 miles

"They moved everything - all the computers, furniture, doors, the generator, even the tiles on the roof," Surier said. "They wanted to continue the school's operation."

But even that location grew dangerous. Since the end of January, the United Nations estimates that more than 6,000 people died, many from exhaustion, starvation and dehydration. An additional 14,000 were wounded. "The safety zone was redefined as they moved, so they kept moving," Nanthakumar said. "We lost

all contact with them."

On May 20, as army troops closed in on the dwindling band of Tamil Tigers, the terrified civilians

One school staffer, who telephoned San Jose with a borrowed cell phone, told Surier that he escaped the region by wading through a lagoon. "He got shot in the stomach, and started bleeding in the water, but kept walking," Surier said.

Worried about their fate, Silicon Valley's Tamil community is urging the Sri Lankan government to grant access by international aid workers to the refugee camps that house hundreds of thousands of displaced refugees. And they pray for a political settlement, granting rights to the marginalized Tamils, so that violence does not reignite.

Most important, they want the scholars to be released from the camps, so they can return to what remains of their school.

"Our graduates can help rebuild the country. These are local people - top-notch people with technical skills and knowhow," Surier said.

Said Nanthakumar: "Education is the fastest way to self-reliance-and it's been taken away from them."

"The current restrictions on access to the camps is limiting and slowing are ability to respond to the medical needs of the internally displaced persons," said Severine Ramon, MSF coordinator in the MSF field hospital.

Over the last few weeks, while tens of thousands of people have emerged from the Vanni, the former conflict zone in northern Sri Lanka, MSF teams have been working alongside Sri Lankan Ministry of Health staff providing surgical and medical care to people who were caught up in the fighting. The situation remains extremely worrying inside the hospitals and among the 269,000 displaced people in Vavuniya District.

More than 500 wounded patients are receiving daily medical care in the three hospitals where MSF teams are working together with the Ministry of Health staff.

MSF opened a field hospital close to the Menik Farm camps on May 22. It is the closest referral hospital for the 226,000 displaced people living in Menik Farm. The temporary structure will provide 24 hour surgical and medical care during the current emergency phase. Surgical activities began on Tuesday, May 26. The surgical team is carrying out between six and 10 procedures per day, main- dures. ly wound debridements.

"Patients are mainly referred to our hospital by the Ministry of Health medical facilities in Menik Farm camp", explained Severine Ramon, MSF coordinator for the field hospital. "We received more than 100 patients during the first week, mostly with wound infections, severe respiratory infections among children and dehydration because of diarrhea. But the current restrictions on access to the camps is limiting and slowing are ability to respond to the medical needs of the internally displaced persons."

MSF continues to support the Ministry of Health surgical and medical activities in Vavuniya Hospital where the number of patients remains at least three times more than the 450-bed capacity. MSF has set up a dressing clinic close to the wards and the team is applying and changing approximately 60 dressings per day. There are 100 care takers who tend to the patients in the hospital, feeding and assisting

Dozens of people have been referred from Vavuniya Hospital to the nearby Pampaimadu Ayurvedic Hospital to receive post-operative care, including physiotherapy. A small operating theatre has been set up in the

Two LTTE leaders killed as they marched to surrender

LTTE's political wing leaders B Nadesan and S Puleedevan were gunned down by the Sri Lankan army as they came out holding white flags to surrender, according to a media report.

Balasingham Nadesan was the head of the political wing of LTTE, while Seevaratnam Puleedevan was the chief of the Tigers' peace secretariat. "For several days I had been the intermediary between the Tiger leadership and the United Nations as the army pressed in on the last enclave at

the end of a successful military campaign to defeat the rebellion," Marie Colvin, correspondent of Sunday Times (UK) wrote.

Marie Colvin, recognized as Best Foreign Correspondent in many of the British Press Awards, was wounded when she was fired upon in Vavuniya by the Sri Lankan Army in April 2001. Due to shrapnel injury she lost sight in one of her eyes.

Marie Colvin quoted a Tamil, who was in a group that managed to escape the war zone, to describe what happened on the morning of May 18 when the two

leaders were killed.

This source, who later spoke to an aid worker, said Nadesan and Puleedevan walked towards the Sri Lankan army lines with a white flag in a group of about a dozen men and women. He said the army started firing machine guns at them.

Nadesan's wife, a Sinhalese, yelled in Sinhala at the soldiers: "He is trying to surrender and you are shooting him." She was also shot down.

According to the source, who is now in hiding fearful for his life, all in the group were killed.

Aid workers forced to leave Sri Lanka to purge criticism

Foreign aid workers are being forced to leave Sri Lanka as the government considers some of them of being sympathetic to the Tamil Tigers, which could hamper international relief efforts, a media report said.

The government is forcing dozens of British and other foreign aid workers to leave the island country. The policy is costing Sri Lanka tens of thousands of pounds of donors' money as they struggle to help 280,000 Tamil civilians in internment camps, 'The Times' said on June 3 quoting aid organisations.

Sri Lanka claims new visa rules introduced last year was an effort to "weed out Tiger sympathizers". But aid workers said the rules were being used to purge foreign critics and to limit the ability of NGOs to operate and lobby the government, the report said.

According to an unnamed senior staff in an international aid group, the NGOs are extremely scared. "If you raise your voice you'll be the next one thrown out," they are warned.

The Sri Lankan government deported the Norwegian head of Forut, an Oslo-based NGO, on Saturday and stopped a British employee of Forut from re-entering the country last month, citing new rules that prevent them from



staying in the country for more than three years.



We are told that celebrations have broken out in the Sinhala community in Colombo. That is understandable, but it should be a celebration marked with sadness as well. "The war is over", the crowds will shout. But there is a difference between a war ended by agreement and a war ended by death and destruction.

The tens of thousands of deaths, towns and villages destroyed and hundreds of thou-

stone wall of resistance. What had been a parliamentary issue turned violent in the 1970's, with the Tamil Tigers emerging as the most powerful guerrilla force after that time. The Tigers were ruthless at killing their opponents and insisting that they and they alone would represent the Tamil people. Their goal was an independent Tamil state in the north and northeast controlled by the Tamil Tigers.

We are always looking for "good guys and bad guys" in a dispute. The Sri Lankan government, for example, insists that the only way to understand what is happening is that the Tigers are thugs and terrorists and so have to be eliminated. The Tigers and their apologists will point to the evil of a corrupt government that they say wants to eliminate the

on both sides won out. In recent months, we witnessed an escalation of the violence as the Sri Lankan government defeated their opponents once and for all. Hundreds of thousands have been affected by this conflict, with thousands still remaining in internal displacement camps at the hands of their Sri Lankan adversaries. While the fighting seems to have stopped for now, the hard work only begins.

The north of the country has been devastated by this war there will be no pictures on state controlled television of the dead and wounded, the villages destroyed and the lives shattered. I can remember some years ago a senior government official expressing shock at the physical destruction in and around Jaffna when he paid a visit after the

sands of people made homeless in this long conflict have not, until recently, dominated the airwaves and televisions of the Western world. Seven years ago there was a window in this terrible tragedy, a ceasefire brokered by Norway in the wake of unprecedented bombings in the South and a dramatic toughening of world opinion after 9/11. As Chairman of the Forum of Federations, I attended most of the negotiating sessions of the so-called peace talks, and met with the leaders of government, opposition, civil society and the LTTE, known as the Tamil Tigers. I have been back many times since. I think of the possibilities of peace in the years after 2000 and I weep at the lost opportunity, the lost lives. So many dead now that were once alive, debating the possibilities and prospects for peace.

It is impossible to say anything about what is happening without enraging opinion on

both sides. But some things must be said. The Sinhala community - the majority population took power after the departure of the British in 1949 and over a long period made a series of disastrous decisions: imposing their language and religion (Buddhism) as the only official expression of the country, limiting access to universities and the civil service by the Tamil community, and refusing to broaden the country's politics to allow an effective expression of Tamil opinion. Repeated attempts by moderate Tamils to effect change were met by a



Tamils entirely.

The Tigers are ruthless and have never made the transition from a guerrilla army to a democratic force. They use suicide bombers against civilians and recruit children into their army. But their support around the world is partly based on the sense of the Tamil people that they have never been able to find justice inside a failed state. The Tigers appear as the only public voice for the many grievances of the Tamil population inside Sri Lanka. That does not justify or excuse suicide bombings and the recruitment of children. But it does mean that the narrative of "they're terrorists and that explains everything" is simply inadequate.

The collapse of the peace talks in 2003, the tsunami, the escalation of killings and assassinations, and the official termination of the ceasefire by the government in 2008 meant that the advocates of a "military solution"

ceasefire. "I had no idea it was that bad". I expressed deep surprise that he didn't know, the hospitals and schools destroyed, the homes wiped out, the sheer scale of the physical destruction. The same holds true today.

These hundreds of thousands are not terrorists. The world cannot stand by and do nothing while they attempt to rebuild their lives. The international community can't allow the Sri Lankan government to say "it's an internal matter" and stay away. Nor can Canada, with its long history of engagement in this issue and it hosting the largest population of Tamils outside of South Asia, stay silent any longer. Political accommodation and reconciliation must emerge if this conflict is to be resolved. The Tamil community of Sri Lanka cannot be ignored, but must be brought into the fold if the Sri Lanka has any chance of securing long term peace and stability.

The many and widely attended demonstrations over the past several weeks throughout the world have proven just how powerful these grievances remain in the Tamil community both within and outside Sri Lanka. A military victory is not enough.

If there is no magnanimity in victory, there is no victory. I shall go back to the Vanni, because the effort must still be made. But it is hard not to cry at what has been lost, how much life has been destroyed. And what must still be done to bring justice to the peace that is being proclaimed so loudly.

While panels discussing the Pallava period, Sangam literature, Missionaries in Tamil Nadu during the colonial era, or the case of Buddhism among Tamils were intriguing, particularly to the young Tamil scholars who seek knowledge and greater understanding of their heritage and history, it was the discussions on the current conflict in Sri Lanka and the Tamil Diaspora that drew more participation and interest - A biased and unconscious interest indeed. The participants could not refrain from engaging the panelists on the current conflict and seeking their perspectives on issues of terrorism, genocide, armed conflict, protests and civil disobedience. One of the most engaging panels at the Conference was "Activist Practices and the Materialization of Political Community in Tamil Nadu and Toronto", chaired by Glynis George and presented by Kiruthiha Kulendiren, Regini David, Lucy Pirapakaran, and Preethy Sivakumar. It was a panel of strong female presence and feminist perspectives.

Among these vivacious pre-Kiruthiha senters was Kuldendiren, a community advocate, activist, Trauma Counselor and an eco-feminist. Her presentation dealt with the impact of displacement and transmigration on social activism in Canada - a topic certainly in need of further exploration and discussion. Kulendiren explains "social activism is international action to bring social, economic, political or environmental change, justice and wellbeing." As a child survivor of the war, Kulendiren understands the sentiments of the Tamil community. She herself triggered on the Gardiner Expressway on May 10. 2009. "This is how I chose to celebrate Mother's Day" she told a group of fifty or so participants. For Canadian Tamils, Kulendiren explains, "the experiences of trauma, oppression and loss in their past, combined with barriers and oppression they face here are stressors that contribute to these social activist practices." As we have seen in recent weeks, thousands of Tamils participated in series of protests, demonstrations, rallies and vigils. This was an extraordinary outpouring of first and second generation Canadians, who took to the streets to bring about social, political and economic change and justice. This is also a form of expression and coping mechanism for Tamils who have survived the war and who continue to relive the trauma through the current conflict.

When asked from the audience whether the current controversial protests by the Tamil community have undermined the cause, Kulendiren replied "Tamil Canadians cannot express themselves without being labeled". She accepts that there has been negative coverage on the matter but further explains that this is the media's intent to demonize a community. She also points out that despite the great number of support from members and organizations in the non-Tamil community; the media chose to show this as an exclusively "Tamil" issue; undermining this as a humanitarian crisis requiring international intervention.

For those who question why the Tamils are unable to leave behind the baggage they bring to their host country, Kulendiren has this to say: "survivor guilt". As survivors of war, oppression, displacement and torture, Tamil Canadians feel extremely privileged to have escaped the horror but feel immensely guilty of what they have left behind; their families, their friends, and their loved ones. This has emotional and psychological effects on Tamils. They feel helpless but feel they must do something - anything.

Kulendiren attempts to see social activism through the lens of experience and trauma and argues that the first step in the healing journey is a sense of empowerment. Thus, for Tamil Canadians social activism is more than just about bringing change but an empowering experience in an attempt to heal.

Sri Lankan Tamil National Alliance Members of Parliament Sampanthan, Senathirajah, Adaikalanathan and Surech Premachandran met Tamil Nadu Chief Minister Karunanidhi recently to get his support for the rehabilitation of the Vanni Civilians and also to press for a political solution for the Tamil problem in Sri Lanka. Chief Minister Karunanidhi promised all he could do to help them on this.

A Journey of Loss

A week ago today I drove to the hospital to visit my grandfather. A week has now gone by and I lost a man who I loved dearly. I will remember my grandfather for his caustic wit, his devotion to my grandmother and the endless hours he spent at his manual typewriter. He loved and cared for his family, adored his wife for over sixty years and helped so many. He was funny, jovial, occasionally cranky and always loving. He was a very practical realistic man and his death, like his life, was relatively simple, uncomplicated and yet As he took his last breaths, he wasn't in pain and he was surrounded by the people he

In death, just as in his life, my grandfather taught me a few lessons. Today I share these lessons and thoughts with you, hoping that they will help. It isn't easy to lose someone you love and the process of death and dying can be traumatic, painful and difficult. The subject is never seen as appropriate dinner conversation; it is often taboo to talk about death or dving. However, it makes such a difference when you've had open discussions

about the process, choices and values. Thankfully, many such discussions were had with my grandfather and family, mostly with humor and his definite practicality. Even in his last moments of consciousness, he was able to express his needs and choose the level of medical care that he

As well as discussing your values with your family, it is important to realize that there are always choices to be made. You can document your choices for yourself by preparing a "living will", which consists of all your instructions about what level of medical treatment you want

should you be unable to express vourself. For instance, you may want all possible measures taken to keep you alive - or you could instruct that nothing be done. Depending on what medical condition you may have, you can also be specific about what treatments you want. If you or your family members have been admitted to the hospital, ask the medical staff questions and options, to allow you to make decisions based on your values. Waiting in emergency rooms, and being surrounded by wires, tubes and machines is traumatic enough. Nominate one consistent person in the family to coordinate the discussion between medical staff and the family. Have that person ask about treatment options and the consequence of that action. This is relevant with the use of life-saving measures like feeding tubes and ventilators, which mechanically provides air and oxygen. How long will it be needed? Can it be removed? What is the quality of life? Ask the necessary questions, remembering that ultimately you are being true to the individual's values.

Certainly, the reality is hard and painful. Once you are emotionally ready to let go of the person and realize that you are losing them, you then have to wait for the physical process to continue. For some, it can be sudden and others, it is a slow process of waiting. There will be physical changes that occur. The body temperature and blood pressure may lower; the temperature of the extremities may become cool-The process of breathing changes and becomes more labored and erratic. The loved one usually becomes unrespon-



sive. It is widely believed that the sense of hearing is the last one to go and therefore, it is recommended to sit and talk to the person. It is the perfect opportunity to share your feelings and in turn, helps you with the grieving

This week I was able to share this journey with my grandfather. While it was painful and sad, I feel reassured that it was dignified and was true to his value system. Having seen so many people come to pay tribute to him, I also realize the importance of how you live your life and how you touch the people around you. I am truly grateful for the memories of joy, laughter and love he left behind.



In the ancient Indian epic Ramayana the Aryan Prince Rama goes all the way from north India to vanquish Ravana, the King of Lanka. Following a massive battle in which thousands are slaughtered Rama, with the help of the monkey god Hanuman, finally rescues his kidnapped wife Sita in a grand victory of 'good' over 'evil'.

The Ramayana of the 21 st Century may need a little modification

In the modern version the Indian Rama and the Lankan Ravana, who turn out to be long lost brothers, together stage the abduction of Sita and accuse the 'terrorist' Hanuman of the crime. Finally with international support they use every means possible to kill him along with thousands of innocent bystanders.

Adding insult to injury the council of Gods supposed to safeguard the world's conscience not only absolves Rama and Ravana but perversely even applauds them for 'saving' Sita and winning the 'War on Terror'.

Alas, if this were really the only wonky myth about Sri Lanka in our times! The truth is that over the years and decades dozens of myths have been floated about this island nation's history, politics and conflict.

Many of these myths were created by colonial administrators and 'scholars' in the period when the British ruled the island. Many more were created by the chauvinist Sinhala elite- of different shadeswho have run Sri Lanka for the past sixty years. Some others were born in the fertile minds of the armchair warriors who sit in New Delhi and a few created by the various champions of the Sri Lankan Tamils themselves.

Given below is a list of the top ten myths (in my opinion) about contemporary Sri Lanka, the dispelling of each of which is indispensable to finding a lasting solution to the seemingly perpetual tragedy of its diverse population.

Myth One - The Sri Lankan government is/ was at war with the LTTE:

This has been the single biggest myth about the Sri Lankan conflict in our time and used as an excuse by many outside to keep quiet about what has been happening all these years in this island country. The LTTE is/was after all a 'terrorist' organisation banned by the international community and so what as wrong if the Sri Lankan government went to war against them?

The Ten Great Myths of Modern Sri Lanka

The simple truth is that the Sri Lankan conflict is much older than the LTTE itself, which emerged as a force only in the early eighties. The systematic conversion of Sri Lankan Tamils into second-class citizens in their own country or state-sponsored violence against them however dates back to the time of Sri Lankan independence in the late-forties itself.

The recent offensive in the north of Sri Lanka was just a new and more brutal phase of the war that Sri Lankan Sinhala elite have been waging for a long time against Sri Lankan Tamils and indeed all the minorities in the country. And I must add that these minorities are not just linguistic or religious ones but also political as over the decades successive Sri Lankan regimes have also killed - and continue to kill- a very large number of Sinhala people opposed to their policies.

In their quest for power there has been no human norm left unviolated by the Sri Lankan elite, which has managed to murder over 20,000 or more of the country's Tamil citizens in its final assault on the LTTE in May this year. If the LTTE has used terrorist methods to further its cause there is no doubt that the Sri Lankan government has used genocidal methods to put them down.

Myth Two - The Mahinda Rajapakse government has 'won' the 'civil war' and successfully prevented the division of Sri Lanka:

There is of course nothing 'civil' about any war but this term implies that the conflict in Sri Lanka is between two groups that belong to the same nation. Maybe this was true upon a time long ago but is certainly not the case any longer.

How many countries around the world do you have governments bombing their own citizens using air power, mobilising tanks, heavy artillery, thousands of ground forces, sophisticated military equipment supplied by foreign governments? How many governments herd all citizens of a linguistic minority into concentration camps to be treated as terrorists simply because of their identity? And after doing all this what right do they have to call themselves 'one nation'?

What we are today witnessing in Sri Lanka is indeed a war between two separate nations. Whether the regime in Colombo realizes this or not by their own actions over the years they have made Tamil Eelam a reality today. The defeat of the LTTE is not the defeat of the Tamil people of Sri Lanka. Nor is it the end of their quest for dignity, against racist discrimination and the right to self-determination.



There comes a point in every relationship when divorce becomes inevitable and the only alternative to separation is gross murder. That time has arrived in Sri Lanka today. The future of the Tamil people should be urgently decided by a internationally monitored referendum on whether or not they want to be part of a united Sri Lanka.

Myth Three - The creation of a Tamil Eelam will damage the interests of the rest of Sri lanks:

In fact the opposite is likely to happen if Sri Lanka 's Tamils are given the right to self-determination and form their own country. Either they will fail miserably and clamour to become part of a future Sri Lankan federation on their own accord or succeed brilliantly and create a prosperous neighbourhood that benefits everyone. If a group of Tamil guerillas could make fighter aircraft while hiding in the forests of Vanni imagine what they can achieve in peacetime.

At the same time the proponents of Tamil Eelam will also have to remember that independence does not mean all their problems will be solved automatically. They will have to deal with the divisions of caste, religion, class within the Tamil population and also demonstrate to the world that they treat all minorities in their midst as equal citizens unlike the Sri Lankan state they have opposed so bitterly all these years.

Also any Tamil Eelam will geographically forever remain on the same island- after all Eelam can't be physically carried away to Australia or Canada. In the long run the Tamil and Sinhala people, along with every other community on the island of what is currently called 'Sri Lanka' today will have to come to terms with each other and live in harmony - as perpetual war can only mean collective suicide.

Myth Four - The Sri Lankan Tamils will gang up with Indian Tamils and create a 'Greater Tamil' nation:

For all the light and sound produced in the Indian province of Tamil Nadu about the fate of their 'Tamil brothers and sisters' in Sri Lanka the fact remains - beyond the usual rhetoric- they have not really done much for them. Over the past twenty years there are thousands of Sri Lankan Tamil refugees languishing in Tamil Nadu without proper shelters, livelihood, education for their children or even safety from arbitrary arrest by local police. The Indian government has repeatedly turned down calls to sign international treaties on rights of refugees and the politicians of Tamil Nadu busy bargaining for their place in the Indian cabinet- don't care a

Similarly, soon after independence from British rule when the then Sri Lankan government, in one of its first vile acts, disenfranchised over a million Indian Tamils working in the country's tea plantations there was not a murmur of protest from the then leaders of the Sri Lanka 's Tamils. They were 'Indian Tamils' after all and that too poor workers to boot.

The point I am trying to make is that Sri Lankan and Indian Tamils have different histories, outlooks and priorities and cannot be simplistically conflated into one phrase 'Tamil people'. The fact is that the problem of the Sri Lankan Tamils is not a 'Tamil' issue at all- it is a problem common to many linguistic, ethnic, religious and other minorities around the world. While indeed the people who are suffering today in Sri Lanka are the Tamil speaking population of that country their primary identity is that of an

oppressed people fighting for their rightful place under the sun and not as Tamil speakers alone.

In that sense what is being murdered in Sri Lanka is not just the Tamil population but the very concept of humanity itself, an issue that should agitate the entire world. To make my stand clear I would say that if the Sinhala people had been a minority in Sri Lanka and the Tamils had been the racist oppressors I would have appealed to the world to fight for the rights of the Sinhalase

Myth Five - Sri Lanka has a special place in world Buddhism and its territorial integrity needs to be protected by the Sinhala people:

From whatever little I know, the Buddha became what he did only by giving up his entire kingdom in the search for truth and the salvation of humankind. In the process he in fact conquered the entire world. What the current day proponents of religious nationalism in Sri Lanka are promoting is a crude kind of 'landlordism' and certainly not 'Buddhism', which has nothing to do with ownership of property.

The idea of the Sinhala elite being champions of Buddhism - a religion of compassion, peace and tolerance - is also simply laughable given their historical record of taking so many lives. Ultimately you are a Buddhist only by what you do in practice and not by wearing saffron robes, chanting a few mantras in Pali or Sanskrit or building large and expensive monuments to the Buddha.

Two thousand years ago the great Emperor Ashoka became a

Canadian Tamils protest attack on Canadian High Commission in Sri Lanka

Hundreds of Tamils protested near the Sri Lankan consulate in Toronto on Friday May 29th against the attack on the Canadian high commission in Colombo on May 27th.

Scores of Sri Lankan protesters had ransacked the Canadian mission to protest against what they called Canadian "support" for Tamil Tigers. Media reports suggested the protesters belonged to hard line Sri Lanka's Sinhala Patriotic Movement.

However, many of the protesters in Toronto said the attack on Canadian High Commission in Colombo was carried out with the cooperation of senior Sri Lanka Defence officials. They pointed out that such a protest is not possible without government sanction in the security fortified capital. Shouting slogans against Sri Lanka for the ransacking of the mission, Tamil protesters said the attack on the mission exposed the true fascist nature of the Sri Lankan government.

"We condemn the vandalism.

Canada is a symbol of hope, peace and equality for millions around the world and we, Tamil Canadians, see this as an attack on these principles," said Canadian Tamil Congress leader and spokesman David Poopalapillai.

"If the Canadian mission can be attacked with this impunity, imagine what happens to the ordinary Tamil civilians (in Sri Lanka) who have no protection at all," he added. Poopalapillai said the Canadian government must pressure Sri Lankan government to bring the culprits to justice.

Government of Canada has accused Sri Lankan police of failing to guard the Canadian High Commission in Colombo when it was targeted by stone-throwing protestors, and demanded a full inquiry.

Earlier British High Commission in Colombo too was attacked in a similar manner. Sri Lankan Government did not take any police action during or after that organized ransacking either.

Buddhist when he repented for the massacres he committed in the war on the Kingdom of Kalinga. Today the Sinahala chauvinists, many of whom claim their ancestry back to the very same Kalinga, are exiting from Buddhism through the genocide they have committed against the Tamil people. These champions of Buddhism have no doubt become its greatest destroyers.

Myth Six - Sri Lanka is a sovereign country and outsiders should not interfere:

Sri Lanka used to be a sovereign country once upon a time when they were not at war with their own people. The fact is that whenever the Sri Lankan regimes have been in deep trouble they have always violated their own sovereignty to seek help from other countries to help prop up their rule. island over the decades has sent thousands of Tamil citizens fleeing the country into exile all over the globe. So for all the touchiness of its leaders against 'foreign interference' what is happening in Sri Lanka is really an international conflict and the people of the world have as much right to interfere there as their governments.

Myth Seven - A majority of the Sinhalese people are racists and chauvinists:

Sinhala chauvinism was inevitable in a country where the Sinhala population is in a majority and every politician has to stoke nationalist, ethnic or religious passions to win his/her election. So whether you were a practicing Buddhist or not or knew even how to speak Sinhala properly or really loved your motherland you had to be a 'Sinhala Buddhist nationalist' in order to succeed in politics.

There is no real history of Sinhala-Tamil conflict before the formation of the Sri Lankan 'nation' artificially carved out of their 'Raj' by the hastily departing British colonialists in 1948. For most ordinary Sinhalese, like ordinary folk every-

In 1971 the Sirimavo Bandaranaike government sought and obtained the help of the Indian navy together with the Pakistani air force to put down the JVP rebellionmainly consisting of Sinhala youth fighting for revolutionary change in their country. where, the main concern is livelihood or love and the quest for a better life denied to them by their own elites.

But so venal have been the feudal Sri Lankan families that inherited power from the British that they chose to divide and destroy their motherland rather than give up power- political, economic or social to the ordinary men and women of their land.

If one looks at the results of the 2005 presidential election in Sri Lanka the hawkish Mahinda Rajapakse won only by a slender margin of 50.29% of the overall votes against 48.43% for former

Prime Minister Ranil Wickramasinghe, who had signed a peace deal with the LTTE in 2002. Since the Tamil population largely boycotted the election what this clearly shows that close to half the Sinhala voters preferred peace over war when they voted for Ranil.

Today most of these Sinhala people are also being held hostage by the fascist Rajapakse regime, which has turned Sri Lankan nationalism into a family-run dictatorship guarded by guns purchased with the people's own hard earned money. The fact that there are still enough Sri Lankan journalists and human rights activists willing to die to preserve democracy in their country is evidence that human decency is still not dead everywhere on this troubled island. The entire world should come to the support of these brave people fighting one of the most murderous regimes in recent history.

Myth Eight- The Tamil and Sinhala people have always been pitted against each historically and always will be:

Projecting the very idea of a 'Tamil' or 'Sinhala' race or people back to ancient times is problematic as the consciousness of such an identity is modern and can be traced back to the nineteenth or eighteenth century at the very earliest. Before that there were really no 'Tamil' or 'Sinhala' Kings - they were simply 'Kings' who used anyone from anywhere who suited their quest for control and power.

The earliest people to inhabit Sri Lanka were neither the Tamils or the Sinhalas but the ancient Veddas, of whom just a few thousand families now remain. The rest of the population of this island came from different parts of India in different periods and intermixed freely with the Veddas as also each other and so it is difficult to talk of any 'pure' race anymore. It is well established that the royal families of past- both Tamil and Sinhala- freely intermarried with royalty across southern India in what are today the provinces of Kerala, Andhra Pradesh and Tamil Nadu. There are cultural, linguistic and other differences between Tamils and Sinhalese today of course but not 'racial' differences.

Much of the modern conflict in Sri Lanka has to do with the rigid framework of the unitary 'nation state' imposed on the fluid realities of the island's people by European colonialists - particularly the British. This together with the notion of 'separate histories' of each linguistic or religious group - as if such separation into neat identities is possible at all- has hardened attitudes on both sides unfortunately.

Even then I remember clearly despite years of conflict- when the Asian tsunami wrought untold tragedy on the people of Sri Lanka in December 2004 both ordinary Tamils and Sinhalese showed phenomenal solidarity and compassion to each other. There were Tamils involved deeply in the rescue of tsunami survivors in southern Sri Lanka while the people of the south rushed aid voluntarily to those affected in the north and northeast. All this of course lasted for a fortnight or more till international donors got together to pledge over US\$3 billion towards 'rehabilitation' and sparked off a fresh round of intrigue and bad blood between Colombo and Jaffna- the latter still under LTTE control at that time as part of the peace accord.

Today- after all that has happened in the past few months- all this talk of solidarity between Tamils and Sinhalese may sound needless detail, but it is important to remember this to disprove the notion that there is something 'permanent' about their antagonism and also to remind ourselves that many conflicts around identity around the world are part of real conspiracies by power elites to keep ordinary folk slaughtering each other so that they don't turn against their real enemies.

Myth Nine - The Indian government, once supportive of the Sri Lankan Tamils, has turned against them:

The truth is that the Indian government does not really care for either the Sri Lankan Tamils or the Sinhalese for that matter. Like in most countries of South Asia successive Indian regimes too have only been bothered about preserving the power of the corporate or feudal elites and care little for their ordinary citizens.

New Delhi in that sense is not the capital of India but the seat of the Indian Empire inherited from the Mughals and the British by the 'Brown Sahibs' of today. And among the nefarious things these Johnnies have been up to all these years is bullying neighbouring governments and playing games with the lives of their people - especially those that don't 'stand up and obey'.

So the Indian regimes in the past supported the Tamil struggle, including through military assistance and training, when they wanted to put the then Sri Lankan government in 'its place'. Later on when their priorities changed - for various reasons chief among which was the assassination of former Prime Minister Rajiv Gandhi- they dumped the Tamils and started cultivating the Sinhala elite.

The lip sympathy for Tamils across the Palk Straits that still emanates now and then from New Delhi is solely because of the compulsions of electoral politics in Tamil Nadu- where politicians routinely play political football with the hopes and aspirations of the Sri Lankan Tamils. Once elections are over it is back to the usual indifference to the fate of thousands of people being pulverised by the genocidal Sri Lankan state.

Myth Ten - Governments around the world do not care what happens to the Sri Lankan Tamils:

Many of them actually they care so much that they will not do anything to help the Tamils form their own nation. For many governments - from India to Israel and China to Russia- Tamil Eelam becoming a reality would set a 'bad example' to their own restive minorities. Hence their all out support to the ruthless Sri Lankan government, who they believe is showing them 'the way' how to deal with dissent of all kinds within their borders.

Western nations, that themselves have the blood of innocent civilians on their hands in Iraq, Afghanistan and elsewhere, also care-but only about their own global image. Making noise about upholding human rights after the genocide has been carried out allows to them to appear to be 'civilised' without having to take any meaningful action.

After all it was quite clear that a colossal human tragedy was in the offing for the past three months. If the UK, EU and the US had put their combined might together to warn the Rajapakse government properly the Sri Lankan lion- for all its bravado- would have squeaked like a trapped mouse.

The fact is that the Sri Lankan Tamils today can expect genuine support for their cause only from other people around the world facing similar racist discrimination or fighting for autonomy and self-determination. That is not such a bad thing, as looking across the globe such people probably constitute well over half the planet's population.

There are the Palestinians, the Tibetans, the Burmese, the Kashmiris and people of the Indian North-East, the Baluchis, the Pashtuns, the Chechens, the Basques, the Puerto Ricans, the Scots-and lots more. If Sri Lanka 's Tamils can join hands with all these struggles for dignity and equality it would be a good start indeed to make a fresh bid for Tamil Eelam!



- The smell of the army boots, the gun, never our friend

I became an Internally Displaced Person (IDP) when I was just 13 years old. Our house was bombed out. We did not know where to go. We ran and ran. The stench of corpses was everywhere. They were not just dead bodies. They were my uncles, sisters, friends and neighbours.

My mother asks me to close my eyes. I keep seeing the gun that pointed at my face. I see my sister frozen with fear of being raped. I see us running into the church. I see my neighbours crawling without legs. I see people's feet, stepping over small babies. I see infants crying to awaken their dead parents. I see the pregnant mother running, to save herself and the unborn baby in her stomach. And I see her shatter in an explosion near the church. I see her two legs quivering in pieces on the soil. I see the fragments of shells, raining down to destroy me, to destroy my mother.

We are all packed in a small tiny space, our neighbourhood church. Hundreds of families, thousands seek here. There is no place to sit here. I just sit in one place for five days. I want to stretch myself and go to sleep. I am numb all over. There's nowhere to even stretch my arms. Five days, I stand or sit, circulating blood. I cried for food and water, as many other children around me did. Our mothers could only give us their tears. Our fathers were nowhere to be seen. Our brothers were taken away by the army. My sisters were hidden under their folded arms, numb with fear. My uncles went with the priest to help the wounded and take the dead bodies to the cemetery as there were dead bodies everywhere. That was the last I saw of my uncles. It was the priest whose white tunic turned red, who tried to console us saying that he had to put my uncles too in the bullock-cart, they had used to send the bodies to be buried. My uncles were killed in the shell bombing while they were helping others. I never had a chance to say goodbye. We screamed and screamed until our throats went dry. No one heard our voices.

The Sri Lankan Government told the world that my uncles are safe... The Sri Lankan government told the world that my sisters did not get raped. They told the world that it was not true. But the truth is they are all gone.

Our stories are buried in our backyards, but our nights are full of these stories.

On seeing the bloodshed of innocent people, I decided to work with the community of people who most needed it. I worked in the community at the grassroots level with women raped and affected by war in many villages around Jaffna and continued my work in the first twelve refugee camps in Colombo during the

I still recall vividly life as a community worker in the refugee camps.

I heard many voices of innocent, helpless civilians who lost their loved ones on their way to the camps. Women's silent cries at being raped on their way to the camp. Mothers crying over their lost and disappeared children. Scattered families who had to leave behind loved ones who did not want to leave their homes, neighbourhoods they grew up in, friends, schools, temples, fields and trees even when their lives were in danger. My family was one of them. I saw entire communities of Muslims being uprooted from Jaffna with unbearable sorrow in their hearts.

But after all this struggle to reach the "safety" of the refugee camps, more struggle awaited us.

The refugee camps were packed to explode. People just had space only to lie down in the vast open halls of former schools and community centers.

People were lining for washrooms. When people had diarrhea, the last piece of cloth they had were most of the time soiled. And they had to keep wearing them until or if some help arrives. There were many contagious diseases such as rashes, dysentery, and malaria in these refugee camps which kept recurring again and again.

Armed Tamil groups who were given responsibility over the camps by the government misused their power over the innocent helpless civilians. I saw old men who went to get fresh air, escaping the fetid air in the camps get beaten up until they coughed up blood, by one of the main leaders of the Tamil armed groups for returning after 6 PM. When people speak out, they disappear the next day. Young women and men were watched constantly. The people in these camps were not allowed to return to their neighbourhoods or communities that they grew up in, even if the wanted to. For some people, there was no place to return because of the bombs. People were afraid to speak freely about even regular happenings. There was so much loss and sorrow they could not even think about it, as it filled them up. Many times, when I gave counselling, people were bottled up with unshed tears and pain. It took me a lot of time to build trust. The counselling had to happen inside the camps surrounded by the Tamil armed groups, which kept most of them silent. People were kept in the refugees camps for months without being allowed outside. Even children! Our future is lost in the refugee camps in our own lands.

I had to fight for months with the Tamil armed groups for permission to take the children and families out for a few hours to conduct a trauma workshop. However, I could not continue to just do my set out tasks. I went further and beyond my limitations and asked questions and challenged the authority of the Tamil armed groups. So, I was targeted and was put in jail for 12 days with my family and friends, under the Sri Lankan emergency law just because I spoke out. I was able to get out of the jail only with the support of the international aid community. If they had not come to my aid, my family and I would have lost our lives as many Tamils have.

The international community should not wait to pressure for answers from Sri-Lankan government during disasters because the Sri-Lankan government does not listen or follow international law. This is clear from how the Sri Lankan government is not even allowing the UN to send aid, or the aid agencies to provide much needed relief for the 300,000 innocent civilians caught in the camps. The Sri Lankan government is not even letting in the international media. The international community has to act now and not just send requests as it has done for months. Otherwise many more thousands of innocent lives will be destroyed forever.

Future of Tamils in Sri Lanka:

Refugee camps are not a solution as the Sri-Lankan government, other Tamil armed groups, and Tamil human rights activists would have us believe. Even the leaders and their supporters who propose all these, the question we have to ask is: would you put yourselves and your children through a refugee camp?

During the last 30 years, thousands of innocent civilians have lost their lives and homes that they keep rebuilding, along with their identities and hopes.

I can understand the feelings of this war as the 1980s, 90s and 2000s are no different. Being raped in 1990s and being raped in 2009 is not different; the agony is the same. The loss of loved ones, the hunger, the running for safety is the same then and now. Having no hands to comfort, being alone is the same in that war and this

and they can survive. Food and shelter is important, too, but that is not enough for real peace. What about their scattered families torn apart by war, the endless mourning for them, and the endless hope for a life without guns and bombs. None of this comes into the solution of a refugee

Therefore, refugee camps after the mass killings of Tamils, after the torture, after the erasure of people, the refugee camps are not a solution, especially because it is the same government who kills them and their families and then offers them refuge. Where is the guarantee of real safety inside these refugee camps? As I mentioned, when I worked in the refugee camps, what I saw was nothing less than terrifying. The threats to their lives, the torture, the violence continued even inside the camps. Therefore, this is not a permanent or democratic or diplomatic solution; it is not even a solution. It will not end the war or bring peace, and any human rights activist who works without any bias or agenda except for humanitarianism would not disagree.

It is our responsibility as a Sri Lankan, as a Canadian, as a human being to support and solve the real issue for our children in

the future. The powerful leaders carry out their campaigns with both guns and pens. These guns and pens bury the stories, the pain, the faces of women and working class people in their own backyards. Sometimes, Tamil human rights activists and intellectuals cover up our pain with their personal pain and loss. Our unheard voices were buried for years and continue to be buried.

The war will end and people will be in peace only if the real root of the problem is touched and addressed democratically. Banning the LTTE or defeating them or other Tamil armed groups is not a solution. The solution will be when Tamils are treated as equal citizens in a land that they have lived in for many decades now. The solution will be when Tamils do not have to prove their belonging or their right of place in Sri Lanka. The solution will be when we all sit down and talk with an open agenda with justice in mind. No Justice, No peace!

UN's Cover-ups of Tamil Ethnic Genocide:

United Nations and Nations United in Slaying the Surrendered and Bulldozing the Wounded

LTTE has been declared a terrorist organization by 32 countries in the world and in return these countries have 'helped' Tamils, by Sinhala Buddhist Chauvinistic Sri Lankan Government to ethnically cleanse more than 100,000 Tamils in the heart shaped heartless Sri Lanka. Now again The U.N. United Nations Under-Secretary-General Humanitarian Affairs and UN Emergency Relief Coordinator Sir John Holmes, who visited Sri Lanka met President Mahinda Rajapaksa at Temple Trees in April 2009 and had discussions in an atmosphere of cordiality and friendship has lots of things to learn from Sri Lankan leaders. UN Still Withholds **Casualty Numbers**

For Britain's Times newspaper's claim of more than 20,000 Tamils were massacred in the final days of the war Bai-Ki Moon, UN's relief coordinator John Holmes and other officials keep avoiding give their own counts, but giving a qualitative statements such as appalling number of people were killed, without giving what number it has. This is in order to keep room for making opportunistic statements in the future according to the mounting pressure level and to cover up the 'democratic' Sri Lanka. The UN and Holmes are in the midst of protesting the expulsion and layoff of half of the humanitarian workers in Darfur. But there is no humanitarian or media access at all to the conflict zone in Sri Lanka. According to Innercity press, "Holmes said the UN has "done some of our own attempt" at a count, but "cannot verify them" and therefore will not release the figures. By contrast. the UN repeatedly uses a 300,000 figure for deaths in Darfur, regarding which many questions of verifications have been raised. There were no humanitarian or media access at all to the conflict zone in Sri Lanka. What action has the UN took? They obey Sri Lanka officials' statements. Tamils for Obama reports that it has its own sources in the safety zone. These sources estimate that there were 360,000 Tamil civilians in the safety zone last January. Now, news reports say that there are about 290,000 Tamil civilians held in detention camps by the Sri Lankan military. For Tamils for Obama, the math is simple: about 70.000 Tamils civilians have vanished in the last five months.

Ms. Jan Jananayagam, an elections in London, secured over 50,000 votes, an unprecedented result, and a record for an independent candidate in an EU election. Though Ms Jananayagam did not secure a seat, her campaign team said they were delighted with the results.

Ms. Jananayagam had campaigned on a platform of getting the UK and EU to take action to stop genocide abroad and protect human rights and civil liberties, both at home and elsewhere. She is the UK representative for the pressure group Tamils Against Genocide (TAG).

Ms. Jananayagam, a Jaffnaborn British citizen, had agreed to contest a few days before voter registration closed on May 19th. The UK polls were held on June 4.

The Bank of Canada today announced that it is maintaining its target for the overnight rate at 1/4 per cent. The Bank Rate is unchanged at 1/2 per cent and the deposit rate is 1/4 per cent.

Information received since the Bank's April Monetary Policy Report (MPR) is broadly consistent with the Bank's medium-term outlook for output and inflation in Canada. The economy is undergoing major restructuring in a number of sectors. The already significant output gap will continue to widen through the third quarter, putting downward pressure on inflation. The Bank continues to expect that the global and Canadian recoveries will be more muted than usual.

In recent weeks, financial conditions and commodity prices have improved significantly, and consumer and business confidence have recovered modestly. If the unprecedentedly rapid rise in the Canadian dollar (which reflects a combination of higher commodity prices and generalized weakness in the U.S. currency) proves persistent, it could fully offset these positive factors.

Bank of Canada Rate Unchanged

Bank of Canada maintains overnight rate target at 1/4 per cent and reiterates conditional commitment to hold current policy rate until the end of the second quarter of 2010



GTA May Resale Housing Sales Higher Than Last Year

In May 2009, Greater Toronto REALTORS® reported 9,589 sales, up almost two per cent from May 2008 - the first annual increase since December 2007. The seasonally adjusted annual rate of sales in May was 81,300.

"The resale housing market in the GTA has remained resilient in the face of challenging times globally," according to TREB President Maureen O'Neill. "Many home buyers have taken advantage of extremely low mortgage rates."

The average price for May transactions was \$395,609 - down less than one per cent compared to the same month last year.

"The average resale home price has moved in line with last year's level because of tighter market conditions experienced this Spring," stated Jason Mercer, TREB's Senior Manager of Market Analysis. "Home sales have increased strongly relative to new listings, bolstering home prices."

Seasonally adjusting TREB MLS® data removes recurring seasonal trends observed each year. For example, MLS® sales are highest in late spring each year and lowest in the winter months. Removing the recurring seasonality, allows for the analysis of a meaningful trend reflecting actual changes in market conditions. By multiplying the monthly seasonally-adjusted figure by 12, creating an annual rate, we can compare how the current month relates to historical annual figures.

Median Price

In May the median price was \$337,000, from the \$338,000 recorded during May of 2008.

The outlook is subject to considerable uncertainty. While the underlying macroeconomic risks are roughly balanced, the Bank judges that, as a consequence of operating at the effective lower bound, the overall risks to its inflation projection remain tilted slightly to the downside.

Conditional on the outlook for inflation, the target overnight rate can be expected to remain at its current level until the end of the second quarter of 2010 in order to achieve the inflation target.

The Bank retains considerable

flexibility in the conduct of monetary policy at low interest rates, consistent with the framework outlined in the April MPR.

The next scheduled date for announcing the overnight rate target is 21 July 2009. A full update of the Bank's outlook for the economy and inflation, including risks to the projection, will be published in the MPR on 23 July 2009.

CONTACT LENSES CAN BE IMPLANTED IN THE EYE

By Carol Pearson

Millions of people use glasses to correct their vision. Others turn to a surgical procedure called LASIK that permanently changes the shape of the comea, the clear part of the eye over the iris. But now there is another choice for people who are nearsighted.

Tommy Hardeman cannot believe how well he can see. "Everything is so clear," he said. "I'm still not fully used to not wearing glasses or contacts." He is a 20-year-old college student who says that he did not get perfect vision with LASIK. Hardeman had contact lenses surgically implanted in his eyes.

This procedure is most often used for patients who cannot have laser surgery and whose low vision cannot be corrected any other way. Dr. Jeffery Whitman is enthusiastic about the results. "Patients are really thinking this is better than sliced bread (a vast improvement)," Dr. Whitman said.

Implanting the lenses involves minor surgery. The doctor makes one small, self-healing cut in the eye and inserts a plastic lens in front of the patent's natural lens. Patients are awake, and the procedure takes about 10 minutes per eve.

The surgery is similar to cataract surgery, except the patient's own lens is left in place.

And unlike LASIK, this technology does not permanently change the shape of the cor-

"We have a lens that we can remove if we want to do something, (if) a new technology comes out and we want to do something down the line," Dr. Whitman said, "And we haven't interfered with the structure of the

eye at all."

"It left me more options than LASIK did," Hardeman said. "For later on in life, if my eyesight had to change a little bit, I (am) still able to fix that.'

The American Academy of Ophthalmology says as eye doctors become more comfortable with this procedure, it will become more common. In some countries the procedure has been done for more than 20 years.

The U.S. Food and Drug Administration approved the lenses for use in the U.S. four years ago. New lenses are being developed that are expected to be better than those already available.

India becoming medical hub for orthopaedic surgeries



ow-cost facilities, world-class expertise ✓and almost no waiting list in Orthopaedic surgeries have made India the hub of medical tourism with more foreigners, needing joint replacements or affected with bone injuries, flocking to the country for

The market for orthopaedic implants has grown by five to six times in the last decade and a large portion of this growth has been driven by medical tourists from developed countries, as also from Africa and Middle East, experts say

The cost factor, which is almost one twentieth of what it is in the western countries, is the primary motivator for foreigners, who want to avail "world-class" facilities at affordable prices, they say.

There has been an evident change in the sector in the past few years with orthopedie implant surgeries becoming acceptable with greater number of Indians and the

inflow of foreigners also going up considerably," said O N Nagi, an orthopaedic surgeon at the Ganga Ram hospital, Delhi.

Besides providing cost-effective treatments, Indian medical centres also cut down the painful procedure of waiting for their turn in countries where the sector is congested, said Dr. Nagi, who conducts 500 surgeries annually, 30-50 among them being

for foreign patients.

"The last decade has seen the number of surgeries done, including those of foreign patients, go up by 5-6 per cent," he told

A knee surgery which costs \$40,000 in America, can be availed at \$8,000 in India, thus benefiting those opting for it even after adding up the travel costs.

Hip replacement surgery in India costs Rs 45,000 for a cement-less implant and Rs 75,000 for a cemented implant and the expenses are one-twentieth of what stands in the US or the UK.

Orthopaedic implants which include knee, hip, shoulder, elbow, among other surgeries are recommended to patients who have suffered damage to joints, sometimes by injuries but mostly by thinning away of cartilage, wasting of muscles, bone overgrowth and deformities

"As the number of people undergoing orthopedic implant surgeries has steadily gone up by 5-6 times in the last decade, knee and hip replacements are the most sought after surgeries," said C S Yadav, orthopedic surgeon and professor in the Department of Orthopedics at AIIMS.

The surgeries are sought after because they considerably improve the quality of lives of people undergoing them, and unlike people suffering from heart ailments, patients from western countries can travel long distances to avail low-cost facilities in developing countries, Dr. Yaday says.

While the medical aspects of the sector have been showing positive trends, the area of concern is the quality of implants produced in India, doctors say.

There is no innovation in the Indian market. Indian companies have no copyrights and most of the implants or their designs are imported or copied," said Yash Gulai, orthopedic surgeon, at Apollo hospital.

According to estimates, the global demand for orthopaedic implants is likely to reach \$23 billion by 2012.

As per a research by US-based consultancy firm Deloitte, India was the world's second largest destination for medical tourists after Thailand, treating an estimated 4.5 foreign patients in 2007.

Researchers Say Depression Preventable

Depression is a common mental disorder characterized by sadness and lack of energy. It is a leading cause of disability worldwide. In severe cases, it leads to 850,000 suicides around the world each year.

"[It] can affect their school, their relationships with friends, increased risk for suicide and increased problems with drugs and alcohol," explained Judy Garber, a doctor of psychology at Vanderbilt University.

She presented the results of a

study on teenagers and depression at a conference in New York. She studied teens because adults who suffer from depression say it often begins in adolescence.


"I'd like to eliminate the stigma that's associated with it because it is common, and it is treatable, and we think, preventable," she added. Garber led a study on more than 300 teens who already had one episode of depression. Half the teens were in a control group. The other half had regular group therapy that examined depression and taught coping skills, ways of solving the

problems that caused their depression.

"We focused on looking at how they were thinking about things, particularly how they deal with stress, particularly when a stressor occurs," she explained. "Do they they blame themselves,

do they think that things are going to be terrible forever? Do they think that it's all their fault? We get them to look realistically at what are the consequences of the events, consequences of their own actions, and then, what they

can do about it.' When the study ended, those in the prevention program had an 11 percent lower incidence of depression compared to the control group. Garber points out that preventing depression



has broad social implications.

Depressed teens sometimes act out and commit crimes. Preventing depression saves precious community resources.

Another thing the researchers learned: if a parent is depressed, teenagers were much more likely to feel depressed. A parent's depression was such a strong factor that she says it prevented the program from helping these teens.

The researchers says their findings have the potential to improve the lives of many teenagers and reduce lost productivity when they enter the workforce.

to see clear evidence of sustained community transmission of the virus from person to person in at least two regions of the world before it raises its alert to the Phase 6 pandemic stage. The alert level

is currently at Phase 5. Most of the swine flu cases have been reported in the United States, Mexico and Canada. about 100.

India's Parliament Chooses First Woman Speaker

India's newly-elected parliament has elected its first woman speaker - Meira Kumar. She is also a member of the country's low-caste Dalit community. Her name was put forward by the Congress Party, which won a sweeping victory in the recent general elections.

Amid applause from lawmakers across ruling and opposition benches, 64-year-old Meira Kumar was elected, unopposed, by a voice vote as speaker of the lower house of Parliament, Wednesday.

A smiling Prime Minister Manmohan Singh described it as an "historic occasion."

"For the first time, a woman member of this august house has been elected as speaker, and that, too, a woman belonging to the Dalit community. In electing you to this august office, we members of Parliament pay tribute to the womanhood of our country," he said.

Not new to Parliament

Meira Kumar is a five-term member of Parliament. She was sworn in as a Cabinet minister last week, but resigned after the Congress Party offered her the speaker's post.

She is the daughter of a former deputy prime minister, Jagjivan Ram, who was a prominent leader of the low castes.

Political analysts say the choice of Meira Kumar as speaker will enable the Congress party achieve twin objectives as it seeks to build on its decisive victory in the recent general elections.

Image boost

It will boost the Congress party's image as being a pro-women party. During its last term in office, the Congress Party was instrumental in helping Pratibha Patil become the country's first woman president.

Even more significantly, the party hopes to strengthen its base in the lowcaste Dalit community, which in recent decades has switched its loyalty to a host of regional parties headed by low-caste leaders. The Dalits belong to the lowest rung of Hindu religion's complex caste system and have faced discrimination for centuries. Congress wants to be seen as a party committed to improving their social and economic status.

A smiling Meira Kumar said she is overwhelmed and has promised to do her best in her new job.

"It would be my endeavor to run the house as well as I can and give a very fair chance to all sections of the house," she said

Not easy

The task may not be easy in a house where noisy disruptions are common and lawmakers frequently stall proceedings by shouting slogans and storming the podium.

The prime minister has already ap-

pealed to lawmakers to observe a "new beginning" and allow parliament to function smoothly.

Finance Minister Pranab Mukherjee backs the plea. "Perhaps I would like to have the indulgence of the

house that ... we would like to create a new precedent not of obstruction, but debate and discussions," said Mukherjee.

But not many people are sure that will happen in India's raucous and noisy democracy. [voa news]

Indian Students Claim Epidemic of Racist Violence in Australia

A ustralian Prime Minister Kevin Rudd has condemned as "senseless acts of violence" a series of race attacks on Indian students in Melbourne. The Indian high commissioner is demanding greater protection for Indians studying in Australia, as state authorities in the southern state of Victoria draw up new laws to crack down on hate crimes.

A series of assaults on Indian students in Australia prompted about 3,000 people to take part in a recent rally in Melbourne to demand greater protection from the authorities, who are accused of doing too little to stem the violence.

There were ugly clashes between protesters and police. More than a dozen people were arrested.

Indian High Commissioner to Australia Sujatha Singh says many young expatriates are furious that their concerns have not been properly addressed.

"Our Indian communities overseas are law abiding. They go by the rules and, if they're being provoked into this [protests], it is because they have very real concerns," said Singh.

In the past year, about 70 attacks on young Indians in Melbourne have been reported and there are claims by community groups that the vast majority have been racially motivated.

The latest victim of the violence - a 25year-old Indian student - is in a critical condition after being stabbed with a screwdriver



by intruders at a birthday party.

His friend, Srinivas Vedantam, insists the attack was carried out by racist thugs.

"When they entered the party and they started abusing - using the racial abuses, like 'You black Indians,' like that stuff. So it ended up with a racial attack," said Vedantam.

However, senior police officers doubt that the violence directed toward the Indian community in Australia is exclusively

motivated by racial prejudice.

Victoria Police Chief Simon

Overland insists that students, in
general, have become "easy targets" for opportunistic criminals.

"It's partly violence against Indian students," he said. "It's escalating robberies and we have used the term 'soft-target robberies.' Now, the Indian students have taken that as referring directly to them; it's not. What we have seen is that robberies are now happening more directed against people in the street, directed against people who are wandering around with laptop computers, mobile phones, iPods, cash. And, if they're alone, they're vulnerable."

The attacks have caused diplomatic friction between Canberra and New Delhi.

Prime Minister Kevin Rudd has publicly reassured the Indian government that Australia is not a racist country and says he was appalled by the assaults.

"These are senseless acts of violence. Those who carry out these attacks stand condemned," he said.

In response, the Rudd government has set up a special task force to deal with the violence.

The new unit will be lead by a former chief of Australia's Special Forces, Duncan Lewis, who is one of the government's most-senior national security advisers.

Officials in Victoria also want those convicted of racially-motivated offenses to be given more severe punishments.

Victoria Attorney General Rob Hulls says judges should take bigotry into account when passing sentence.

"We want to send a message that any crime that's committed purely based on hatred or prejudice against a group of people is not to be tolerated, but it ought be something that is taken into account in the sentencing principles in this state," he said.

But some Indian students, like

Jayasanker Bagiepalli, are too fearful to remain in Australia and are heading home.

"See what happens here? We are being attacked. Not once, twice. Many people, many Indians are being attacked. That's what happens here. So if this country, you know, people from India really stops coming here. My parents doesn't (sic) want me to stay here," said Bagiepalli, About 90,000 Indian students are living in Australia. They generate millions of dollars for the national economy, each year.

The Australian wave of violence has made headline news across India.

Bollywood legend Amitabh Bachchan has rejected an honorary doctorate from a university in Queensland to protest the assaults on Indian students in Australia. [voa news]

Economists Say

Immigration is Key to Ending New Zealand Recession

Some economists warn that New Zealand will suffer if it cuts immigration because of the recession. As unemployment rises, there is growing pressure on the government to reduce its intake of skilled workers, imitating decisions made across the Tasman Sea in Australia.

Unemployment in New Zealand is at a six-year high and stands at five percent. The economy slipped into recession last year, well before many other developed countries, and the chances of a speedy recovery appear slim.

The International Monetary Fund expects the New Zealand economy to shrink by two percent this year.

Unions: scale back

Trade unions argue that in such dismal economic times the government in Wellington should reduce the level of skilled migration to protect local workers, especially in hard-hit industries such as construction.

Union officials think New Zealand should follow Australia's example and scale back its immigration program. Canberra cut migration levels by almost 15 percent because of the global economic slump.

Some economists, however, think this is a short-sighted view.

British economist Philippe Legrain says New Zealand needs to prepare now for economic recovery by keeping immigration strong. He says that new migrants are a lifeline to the world economy and a "launch pad" for recovery.

"Different people, with different experience,

different ideas, different perspectives sparking off each other can create new solutions to problems, can help to innovate and it is precisely in a recession that businesses need to innovate in order to be prepared for the recovery," he said.

Some migrants complain they are being overlooked

Some well qualified migrants complain that they are being over-looked when applying for suitable positions in New Zealand.

Enoch, who arrived from Rwanda in 2002 armed with two university degrees and the ability to speak four languages, says it took him two

years to find work.
He thinks companies in New Zealand are too ready to dismiss overseas qualifications and experience.

"When you have work experience that can be transferred to businesses here is what matters and sometime some employers do not look closely to the CVs to find what is really your experience and what you can do for their businesses," he said.

PM resists calls to scale back immigration

So far, New Zealand's conservative Prime Minister John Key seems likely to resists calls to scale back immigration. Mr. Key says that skilled foreign workers will help the country of just over four million people to eventually recover from its recession.

The largest groups of migrants settling in New Zealand come from Britain, China and Australia, followed by Samoa and India.



Ethnic gaps remain a threat to peace

The bombs and the artillery have gone silent in Sri Lanka, whose 21 million people have endured a grueling civil war for the past 26 years that has killed an estimated 80,000 to 100,000 people, shaken the country's economy and deepened ethnic divisions.

Now comes the hard work of winning the peace.

There are positive signs that give rise to some hope.

The highest-ranking surviving member of the Tamil Tigers rebel group has urged supporters to "restrain from harmful acts to themselves or anyone else" and unequivocally said "we have given up violence and agreed to enter a democratic process" to achieve rights for the 18 per cent of Sri Lankans of Tamil origin.

Sri Lanka's president Mahinda Rajapaksa has made conciliatory moves, too, speaking briefly in Tamil in a speech immediately after the Tigers' defeat, and reiterating his plan to resurrect a proposed constitutional amendment to strengthen provincial administrations and give more autonomy to Tamil areas.

Such expressions of goodwill are to be welcomed, but they

must be followed -- swiftly-- with meaningful actions.

The Sinhalese majority have suffered from this war, with the uncertainty and horror of terrorist violence, from assassinations and suicide bombers to attacks in busy public places such as the financial district and the central bus depot.

But the Tamil minority has suffered far more, enduring hardship, deprivation, coercion (for some) into the rebel forces and continuing violence, culminating most recently in the deaths of some 7,000 civilians in the final offensive against the rebels.

Distrust and anguish run deep among Tamils -- Tamil Canadians are so profoundly mistrusting of the Sri Lankan government that they want aid for victims to be channeled only through international organizations.

The first priority must be to improve conditions for the 300,000 people crowded into the world's largest camps for displaced persons. The Sri Lankan government has been slow to allow aid organizations access to the massive camps. Despite its fears that the camp may house some terrorists -- an estimated 8,000 or so, by some counts -- the situation in the camps is dire and



the government should welcome all efforts to ease the suffering of those mouldering behind the barbed wire.

Next, the government must begin the long task of rebuilding an area shattered by violence. Some part of the 2.6 per cent of its GDP that Sri Lanka has until now spent on its military might be redirected there.

Reconstruction is one area where Canada and other interested nations can help, clearing landmines from the north, for instance, and helping resettle displaced people.

And lastly, the country must address the Tamils' unresolved grievances with genuine and lasting reforms. Sri Lanka's existing constitution gives primacy to the Sinhalese language and Buddhist religion.

Federalist models like Canada or Switzerland might provide inspiration for change, as will the recent experiences of Ireland and Punjab in forging a new peace.

If it fails to act, the country runs the risk of spiraling once more into violence.

UW scientist receives major award for omega-3 research contributions Centre for Education in Mathematics and Computing

A University of Waterloo nutritional scientist who pioneered a new technique to test omega-3 levels in the body will receive a major award from a leading international research society.

Ken Stark, a professor in UW's faculty of applied health sciences, has been awarded this year's young scientist award from the American Oil Chemists' Society (AOCS). It recognizes his significant and substantial research contributions to increase the intakes of omega-3 fatty acids among North Americans.

"During the past few years, Dr. Stark has become a leader in developing the tools and insights in experimental nutrition and food science research, and this award confirms his growing reputation." said Roger Mannell, dean of applied health sciences. "Omega-3 fatty acids, which are found in fish and seafood, have been associated with reduced risk of chronic diseases. The methods Dr. Stark's team has developed increase the potential for routine clinical profiling of fatty acids."

Stark, a former AOCS-honoured student, will receive the award at the society's annual meeting and exposition to be held in Orlando, Fla., May 6. He will give an address, entitled Omega-3 Fatty Acid Profiling and Dietary Forensics.

Stark, who heads UW's labora-

tory of nutritional and nutraceutical research, now is developing new biomedical tools that will help quantitate and interpret dietinduced diseases. His recent research has provided practical insights on North American intakes of omega-3 fatty acids and strategies to increase these

His research team seeks to use fatty acid profiling to assess disease risk in large clinical trials. This will lead to a routine measurement of omega-3 fatty acid levels in blood to determine cardiovascular disease risk.

The work will help revolutionize primary prevention of cardiovascular disease and many other diet-induced disorders.

Stark has published more than 20 peer-reviewed articles since 2000, serving as primary investigator on 17 of those articles. He has been often invited to speak to scientific and general audiences, as well as give interviews on television and radio.

In 2006, he received the young investigator grant from the International Society for the Study of Fatty Acids and Lipids Congress.

The AOCS is a global professional scientific society for individuals and corporations interested in the fats, oils, surfactants, detergents and related materials fields.

'Let's make shorter films'

The length of films will change. Our films will get shorter because attention spans will get shorter, actor Kamal Inasan said. Speaking at the valedictory function of Chennai International International International Workshop in Chennai onvened by Raj Kaamal Films International on Wednesday, June 3, the actor said, 'the future of cinema is bright icreenwriters need to be ready to deal with platforms which are palm-size.'

Urging the film personalities to tap very available platform to reach out of the masses, he said that they have of take to available platforms like Youable. On the concept of naach-gaana in ndian films, Kamal Haasan said, "I am gainst monoculture. Just as everyone is lifterent, films too must be different."

Predicting that the future of Indian inema is safe, noted screenplay writer nd head of the Screenwriting Departments at Film and TV Institute of India, 'une and Whistling Woods, Mumbai, unjum Rajaballi said, 'there has been a

great interest among youth for screenwriting. It means we are seeing a definite change in the quality of storytelling in Indian cinema. In fact, one can even expect a mutative change.

'An extensive survey of Hindi movies released between 1991 and 2000 revealed that over 85 per cent of movies failed to recover even the cost, the reason being they lacked effective screen-play. The greatest storytelling culture in the world has neglected screenwriting in cinema for too long,' Anjum Rajaballi said Hariharan, director of L V Prasad Film and TV Academy, said that the mutative change in cinema would arrive because filmmaking is no longer the domain of the elite.

The difference between the elite and the mass audience has collapsed,' he said. Earlier in the discussion, director Rakeysh Omprakash Mehra said 'time is ripe for us to get talent from the small towns and let them tell their stories in the universal language. People are the same everywhere in the world." 'If a Hindi movie clicks in a town like Coimbatore cutting across language barriers, it should do well in an European country too, 'he said.

Rakeysh Omprakash Mehra, who made an impact with Rang De Basanti, said, 'My Delhi 6 was a very touchy and personal movie. Unfortunately I understood after the movie's debacle that the final output was far from what I originally conceived. A screenwriter has to do movies that is convincing to him. He cannot make movies to the expectations of the audience.

I will be making minor corrections in the movie and reshooting few portions as per my original script. French writer Olivier Lorelle, film personalities including Jean Claude Carriere, Sreeram Raghavan, K Balachander, Balu Mahendra, Shekhar Kapur, Rituparno Ghosh took part in the function.

There used to be a time in Tamil cinema when even grief was projected aesthetically. Then, a young man with fire in his heart made the gut-wrenching Veyil, layered with raw grief and longing, and changed public perception forever. That film found reception even at Cannes, where it was screened to moist eyes and choking voices. Now, Vasanthabalan is back with Angadi Theru, his ode to the street and the sellers that people it.

"Usually, in cinema, the camera is always on the buyer. What about the seller? What is his life like? What drives him? These are some of the questions I seek to answer," says Vasanthabalan.

A late night pay bhaji break during the post-production of Veyil was the inspiration for this script, which took three years to perfect. "I saw people going and coming, constantly. And, I wanted to document their lives," he says.

"My film is about a particular street rife with the din and bustle of humans. Even after the whole world sleeps, this one's awake — the shops are cleaned and stocks replenished. And, it's not just things that are for sale — there are slaves, sex workers... everything is for sale, and everyone has a price," says this former assistant of Shankar. As much as 90 per cent of the film was shot at night in a Chennai market (sometimes using a hidden camera) by cinematographer Richard M. Nathan.

And, as in Veyil (a biography), there's a lot of Vasanthabalan in this too. "Well, I can't avoid that. Years ago, I came to Madras wearing torn rubber slippers in search of a life. So many people come in like that. The film will talk about their mental state, their homesickness...."

Feeling of hope

But, despite it all, what will shine through is the feeling of hope, the young director assures. "There is strife, but flowers still bloom, children are still born. There is life. And, living is important. Actually, mere existence is great joy," he philosophises.

So, will he ever be able to shoo away the ghosts of the past and make a happy film? "Never. I can see only pain. Probably, there's something wrong with me. Am I addicted to pain? Possibly," he admits.

How easy was it to move on to Angadi... after the catharsis called Veyil? "I don't carry baggage. Also, that was much easier because it was my life. Here, I'm trying to see through another being's life."

The cast of the film has been spoken about too. Mahesh, the hero, hails from a family selling pori kadalai in theatres and shops in Chinnalapatti near Dindigul. He was discovered at a volley ball match after close to 30,000 boys were screen-tested. "I wanted a rural-looking boy who oozed helplessness and fear. He was perfect. And, I have not trained him in 'cinema' acting."

The heroine is Anjali, who made a mark in the critically-acclaimed Katradhu Tamizh. "She has the perfect girl-next-door looks," he says.

How happy is he with the way the film has shaped up? "Very. It is more refined than Veyil. And, I've worked hard for it. I was hospitalised thrice during shooting. I am eagerly waiting to see people's reaction," he says.

Now, he's working on another script in Tamil. And, post-Cannes, many offers for crossover films have been coming in "They liked the raw emotions, and many scripts have been coming my way. I am waiting for the right offer, though," he says.

How comfortable will he be doing a "foreign" film? "Well," Tamil films are like my home, this will be like a neighbour's home. But, a director is a craftsperson first, and craft knows no boundaries."

The latter recently shared the Hutch-Crossword award for translated fiction. She is currently the Director of SPAR-ROW (Sound & Picture Archives for Research on Women).

The award was presented at the function by Dr R. Nagaswamy, former Director of Archeology, Tamil Nadu. In her acceptance speech Ambai said that she had not received a single award for Tamil in India. In her forty years of writing career she had crossed many oceans, conquered mountains, fought wars and destroyed countless demons to arrive at where she is today. 'Like the Zen philosopher who produced a single tune on his flute when the King asked him what he had learned in life, I too would have created a single musical note of my understanding of life. But that would not have earned a lifetime

achievement award for me. Everything needs to be built in words,' said Ambai.

The Legends of Indian Gnema - Sivaji Ganesan

The Profile of A Cinematic

Nearly Seventy years ago, a little boy seven years old and bearing the name Villupuram Chinnasamy Ganesan ran away from his home to join a Drama Company later to make his debut in South Indian Cinema for well over a half a century.

The little boy was no other than Chevalier Sivaji Ganesan, who strode the Tamil Cinema for over fifty years like a colossus and whose film career culminated with the Dada Saheb Phalke Award, the highest honour in India for an artiste for his contribution to the film industry in his country.

In his book "Sivaji Ganesan", author Theodore Baskaran has traced the meteoric rise of this legendary actor from his life on



stage, his first film Parasakthi and the final countdown of his film career. Beginning his early days in Drama, the book follows Sivaji's early essays in Cinema, his days of glory as a star, the manner in which he acquired power to control his career and his rivalry with MGR, both on and off screen. The decades of his domination on the South Indian screen and the cul-

mination of his film career with the winning of the Dada Saheb Phalke Award form part of the book. The book also takes the reader to his early days with the Dravida Munnetra Kalagham, his association with Periyar, C.N. Annathurai and present Tamil Nadu Chief Minister Karunanidhi. It also portrays his entry into politics and his failure in this field.

Sivaji was groomed to be an actor and not fitted for a politician.

Sivaji Ganesan was more than a cinematic star. He was an icon. His life portrayed and reflected the changing face of India. He exhibited this through his films. From Parasakthi to Kattabomman, from Paasamalar to Karnan, from Gauravam to Thangapathakkam Sivaji's exceptionally excellent portrayals reflected the changing times and different moods of moving India. Whereas MGR carved for himself a different role in Politics away from Cinema, Sivaji remained in the cinematic field right to the end.

When Wisdom Tree Publishers began a series of books on the Legends of Cinema, Sivaji was an obvious choice. At the ceremonial opening of his statue on the Marina Beach in Chennai, even Chief Minister Karunanidhi publicly admitted "Enathu uraihalluku uir koduththavar Sivaji" (Sivaji gave life to my dialogues") Kamalahaasan went one step further when he stated that "The Indian Tamil Cinema could be

divided into two periods - The one before Sivaji Ganesan and the other after Sivaji Ganesan." His eminence in Tamil Cinema was so electrifying that the great Cinema Music poet Kannathasan acknowledged that there was no Tamilian who had not been influenced by his screen persona. The book portrays the life of the actor from his early beginnings drowned in poverty and how he rose to the dizzying heights of glory. The book is certainly a wealth of understanding the great actor and an inside perspective of his

Theodore Baskaran's story of Sivaji is the profile of a cinematic icon and a book worth reading from the beginning to the end. The book is handy in size to handle and pictorially represented with rare photos of the highlights of Sivaji's career.

Most of the details of Mirabai's birth, parentage, matrimony, and circumstances of death are just approximate arrived at by broad consensus. Unanimity does not prevail even in regard to her name

Dr. Barthaval contends that Mira was not her actual name but the term's literal meaning being 'Consort of Ishvara -God' it emerged as Mira's popular name. Purohit Harinarayana, another scholar claims that Mira, developed from 'Mir', the title of the descendants of the family of Muhammad, was a name inspired by Shah Sufi of Ajmer, though in view of Rajputs' great dislike for Shah it is not likely that any Rajput would inherit from Shah anything, even a holy syllable, for naming his daughter. Scholars like Dr. Padmavati and Dr. Bhagwan Das Tiwari among others mention Mirata, Miram and Miran as Mira's three other names.

Mirata, divisible as Mira+ta, is linked with Merata, one of the places associated with her birth. It broadly means 'one from Merata'. In early 17th century genealogy of Munhata Nainsi Mira has been mentioned as Miran, and in one or two others, as Miram, though these are only local phonetic variations of the term Mira.

It is alike with the date of her birth which swings from 1403 to 1506. Though no conclusive evidence has so far come to light supporting it, 1500 C. E. has wider acceptance. Apart that a scholar from Mewar Devashri barrister claims it as the date of Mira's birth, the dates that scholars like Dholerava Bhat, Kunwar Sukhvira Singh Gahlot, Munshi Deviprasad, Harvilas Sarda among others fix as the date of her birth are also around 1500 C.E., that is, in between 1498 to 1506 C. E. Citing some secondary evidences Jhaveri takes the date of Mira's birth back to 1403, G. A. Grierson and W. G. Archer, to 1420, Thakur Chatur

Rathor, to 1457-58, and F. E. Keay to 1470. W. G. Archer's opinion is somewhat significant. In his 'The Loves of Krishna' he contends that Vallabhacharya was Mira's follower, and as

Vallabhacharya was born in 1478, Archer takes back the date of Mira's birth to 1420.

Vallabha's Pushtimarga had begun taking shape when he was in his thirties, approximately around 1520-30, the period when Mira, having relinquished the houses of both, Rathors and Sisodias, was passing through the prime period of her 'bhakti' life. Strangely, Vallabha's Pushtimarga immensely influenced Vaishnava devotional poets, Surdasa and others; however, nothing of it is traceable in Mira's writings, and that too when he had his seat in Mewar itself, one of the two most significant places in Mira's life. It strongly suggests

that Mira might have preceded Vallabhacharya.

Merata, a medium size town situated at Delhi-Jodhpur train route, is now widely accepted as Mira's birthplace, though some scholars yet contend, Parashurama Chaturvedi being quite firm, that her birthplace was Kukari, and a few others, that it was Chokari.

Kalyanamal Shekhavat has a far different opinion. He claims that Mira was born at Bajauli, though she lived at Kuraki for sometime. In his 'Annals and Antiquities of Rajasthan' Col. J.

Tod mentioned at two different places Rao Duda and his son Ratan Singh as the names of Mira's father. Mewar records, collected by Munshi Devi Prasad, too, confuse between Duda and Ratan Singh as her father's name. However, despite such initial confusion it is

now almost unanimously accepted that Ratan Singh was Mira's father. Similar confusion prevails in regard to her mother's name, which in some sources has been mentioned as Kusum Kunwar while in others, Virakumari. It is popularly believed that Mira's

mother died soon after Mira's birth, though some scholars contend that it was not so. In his 'Bhaktirasabodhini', the early 17th century commentary of Bhaktamal, Priyadas claims that Mire's parents, both mother and father, were alive for long.

Mira's Marriage

The event of Mira's marriage, about the date of which greater unanimity prevails, has strange undertones, and from here Mira seems to take two different directions, one, the essential or fundamental to which her essential being inclined, and the other, incidental, which as human-born she was obliged to take. It was largely at this juncture that the traditional or popular Mirabai whom accumulated faith of generations across centuries

constructed and people's memory retained, something like the spiritual Mirabai, emerges. The human-born Mirabai was married in 1516, when barely sixteen, though till recently confusion prevailed as to the name of her husband, which some sources - J. C. Omen, Colonel Tod, G. A. Grierson among others, claimed was Rana Kumbha, and other, Bhojaraj. Perhaps the historical Mira temple constructed close to Rana Kumbha's Victory tower at

Chittor, confused Col. Tod to relate Mira and Kumbha with each other. This temple dedicated to Mira enshrines Krishna, and Mira seated close to his feet, sings and plays on lyre for him in perpetuity. However, a wider consensus evolved in favour of Bhojaraj as Mira's husband.

Unlike her matrimony in human-birth, there is hardly any confusion in regard to the matrimonial status of the popular or spiritual Mirabai. This Mira was wedded to One Infinite who manifested in human, personal, beatific and joyous form of Krishna. Krishna was her Lord and to Him she was wedded with ties of love beyond fetters of this world, rigid modesty norms and chains of family life. She was married to Him in every birth, and

in every birth she yearned for him in love and was thus ever his spouse and ever his maid. This Mira, the pure soul, a part of the Supreme separated from Him, was thus ever wedded and was ever - births after births, a virgin:

'Charana Sarana ri dasi Mira, janam janam ri kwanri' -

A servant at her Lord's feet Mira was a virgin, birth after births.

Strangely, scholars jump from one date of Mira's marriage to another and from one person to the other as her husband but as for Mira, she claimed to be ever a virgin - 'Janam janam ri kwanri', and if she was dyed in colors of anyone's love, it was Krishna's -'Shyam rang ranchi' - dyed in Krishna's blue. History, a coward, does not have the courage to look into the eyes of the Mira who is both, ever wedded and ever a virgin. This eternal consort of the Supreme, and His virgin ever in sojourn till he meets her and she unites with him in inseparable union, is hardly discoverable in debris of history.

Mira Transformed

Interestingly, Mira's utmost poetic imagery and devotional idiom center on marriage, particularly its bonds that tie the two together, resulting union and its delight, and separation and its pangs. She presents herself as her Lord's virgin, bride, and humble servant, one willing to live the way He liked. Mira seems to have discovered in marriage love's essential idiom - formal and intrinsic; and, it is somewhat natural for it was an event of marriage that transformed the human-born Mirabai into the spiritual Mirabai; to some extent, the spiritual Mirabai was born out of an event of marriage. As the popular tradition has it once when yet a child, Mira saw a marriage procession reaching her neighbourhood, a curious mind, she asked her mother what for so many richly bejewelled and costumed men riding horses and palanquins had come there. When told that it was a marriage procession and that the most richly bejewelled youth riding as splendidly saddled horse walking ahead of others was the bridegroom come to marry their neighbour's daughter, Mira innocently asked her mother where was her groom. Mira's mother smiled at her innocence and to amuse her picked the idol of Krishna and giving it to her said that he was her groom. Mira's adolescent mind believed it. She



recalled how, though not in a procession, her groom had likewise

Mira's mind was so deeply influenced by this association of the Krishna's idol that in many of her songs Mira addressed Krishna as 'jogi' and herself as his 'jogin'. Mira rarely sees her Krishna beyond her own contexts. She yearns for Krishna but these are her own yearnings, not Krishna's. She does not drag him to her level of sensuous yearnings.

Mira venerated Raidasa as her 'guru' - teacher, in some of her verses, and so contended the popular tradition, though chronologically Mira and Raidasa, broadly accepted period of

Raidasa being from 1394 to 1418, weren't contemporaries. It is said that Raidasa had led her to the path of Vaishnava 'bhakti'. It seems that this might have led the common mind to link 'yogi' and Raidasa for they both led her to the path of Krishna.

Mira's Pre And Post Marriage Life

Although slightly varying is the contention that Mira's mother died early and Mira was the sole charge of a fond grandfather Rao Duda, a staunch Vaishnava. Reciprocally, Mira the child took care of her grandfather's religious activities - lighting lamp and incense, making sacred food for offering, dressing up the idol, arranging things in order, and when rites began chanting hymns along with him and herself prostrating before the idol. This Vaishnavite atmosphere was Mira's initial training and the factor that shaped her personality. Whatever her inspiration, by the time of her marriage with Bhojaraj her mind had become fully absorbed in Krishna so much so that when on her lips were the marriage-rites related hymns within her heart were thoughts of Krishna. She earnestly believed that she was being married to Krishna, not to Bhojaraj.

Most sources say Mira did not have problems with Bhojaraj but her real ordeal began with his death in 1523. Under rigid customs of 'sati', Mira, a Rajput widow, was required to immolate herself, which Mira declined. She argued that she was wedded to Krishna who was 'Avinashi' - indestructible, not to anyone other than him, she was not a widow Immolating herself would disgrace him whose consort she was. This incensed everyone's anger in the family and even beyond including her father who thought the same way. Now Mira, the bride of the house of Sisodias, was the object of everyone's disdain. Ungenerous treatment apart, she was subjected to various atrocities, mental and physical; to include even attempts on her life, to which everyone in the family was a party.

Historic misdeeds sure to breed a new Tamil politics

"Closing of this chapter in Sri Lankan history is bound to see the inauguration of an even tougher phase of challenges for the Rajapaksa oligarchy. Lack of governmental enthusiasm to correct its historic misdeeds is sure to breed a new Tamil politics this time which will lay the foundations for a new nation-state in the neighbourhood," writes Sadanand Menon in the leading Indian periodical, The Outlook.

The Eelam forecast:

So why are they bursting crackers in Colombo as if some IPL match was won? Velupillai Prabhakaran, the LTTE chief, may be dead or alive. But that's completely beside the point. What everyone should be asking is whether the Tamil question in Sri Lanka is dead. Let's make no fuzzy mistake. The answer is a resounding no.

The present triumphalism of the Sinhala government and the carousing people on the streets of Colombo is a display of a kind of political idiocy. They have learnt nothing from over sixty years of ethnic conflict and almost thirty years of armed insurgency, which has claimed an unconscionable number of dead soldiers and militants-not to speak of an unacceptably high number of civilian casualties.

The notion of a Tamil homeland is not going to perish with Prabhakaran. The militant movement, which began in the mid-1970s in Jaffna, was in response to three decades of unbridled majoritarianism by the Sinhala state, which tried to squeeze Tamil aspirations and snuff out Tamil identity. Broadly speaking,

these conditions continue to exist.

The Sri Lankan state itself will be in no mood to address any of these long-standing grievances. It's up to India and the rest of the international community to effectively persuade Colombo to pay attention to redressing this. It is apparent that before the dust settles, the Sri Lankan government will do its best to send across Sinhala settlers into the Tamil regions of the north and east, even as a large segment of internally displaced people continue to languish in ruthlessly controlled

'refugee camps'. While humanitarian aid is sure to pour in, a substantial percentage of it is bound to be diverted to settle 'outsiders' in the newly depopulated Tamil regions. The strategy of demographic disaggregation is not unknown in our times and frequently used to neutralise nationalist ambitions. Ethnic porosity over geographic stretches becomes particularly achievable in smaller countries.

But what the Sinhala state now needs to heed is the new reality of a swelled out, prosperous and extremely vocal Lankan Tamil diaspora. Thirty years of militancy-topped by at least twenty years of LTTE hegemony-has decimated the Tamil youth, crippled the Tamil intelligentsia and denuded the Tamil population of any sort of alternative leadership at the local level. It is into this space that a newly articulate, million-strong, diasporic community with international connections is poised to step in. That is where the new leadership, new resistance and new political process will come from. This segment is better equipped to continue the struggle through constitutional means, even as it encourages stray elements to carry out neat surgical strikes on a vulnerable Sri Lankan state.

The Sinhala government is reportedly preparing to divide the newly conquered Tamil territories in the north and east for obnoxious renegade elements like Douglas Devananda, Pillaiyyan and Karuna to administer. This too is only going to lead to further alienation as armed acolytes of these warlords roam the streets bullying and extorting a beleaguered population. Some of it is already happening in the east. Sri

Lanka will have no mechanism to demobilise this Falstaffian army. A quick slippage into another kind of a civil war is inevitable.

No one speaks enough about India's own wretched role in the political and social mess that contemporary Sri Lanka is in today. In the 1980s, it was India's strategic interest in keeping president Junius Jayawardene from walking into the US camp (by allowing the American Seventh Fleet use of Trincomalee harbour) which led to the Indian state's alacrity in setting up training camps for militant Tamil youth groups like LTTE, TELO, EPRLF and PLOTE. These armed insurgents were to be used as a threat against any Sinhala intransigence. Ironically, India lost the plot pretty soon as the groups became involved in the usual internecine, inter-intelligence agency rivalries and dirty tricks. Soon, by 1987, the LTTE had ruthlessly decimated all other groups claiming to represent the Tamil cause and had declared itself independent of Indian control too. Subsequently, the role of the Indian Peace Keeping Force (IPKF) in turning the guns on the Tamils in Jaffna and the recent Indian collusion with the Sri Lankan state to stomp out the rebels in the Vanni are well

Her father-in-law Rana Sanga was a little considerate, but he died in 1527 fighting against Babur and with this the reins passed into the hands of Ratan Singh, and a little after. Vikramaditya Singh, Mira's worst oppressors. The Bhaktamal, its various commentaries, and other early records evade mentioning the names of tormenters, but enumerate a number of atrocities, including a few attempts on her life, to which Mira was subjected. Mira's atrocities, especially the attempts to kill her, also feature in the 17th century poetry of Priyadasa, Dhruvadasa, Nabhadasa and Dayabai among others. However, the list of atrocities and occasions when attempts on Mira's life were made, and divine miracles which every time aborted them, is quite large in the popular tradition.

When this attempt failed, he sent a wicker-basket with a deadly cobra in it; however, when Mira opened it, it revealed just a Saligrama, a symbolic form of Vishnu. The Mira Mandir at

Vrindavana has a Saligrama icon claimed to be the same into which the cobra sent to kill Mira had transformed. As popular is the event of Rana's encounter with Krishna in Mira's apartment. It is said that Krishna often appeared in Mira's chamber and she spoke to him. Hearing her talk to someone privately Rana's sister Udaibai reported the matter to her brother. With a naked sword Rana. perhaps Vikramaditya, stormed her chamber shouting where her lover was. When he found none except Krishna's image, he left shamefaced. In slight variation, he flung his sword on one behind the curtain wherefrom a disc - Vishnu's Sudarshana Chakra, emerged and struck his sword, and in sheer horror he

left. As some sources have it, Rana passed the night almost in fearful trauma. In the morning, in complete inversion of the values that he so far venerated, the king and his wife went to Mirabai and submitted to her as her devotees.

Whatever, after the atmosphere of the royal household, where lust for power and sensuous pursuits overrode piety, became throttling Mira decided to relinquish it. As have some

sources, she first went to Merata, her father's abode. Her uncle Rao Viramdeva and

cousin Jayamala were cordial and she was allowed to have her own way but subsequent political events, reducing Merata to Jodhpur's suzerainty in 1538, and Rao Maladeva pressurizing Mira's uncle to mend Mira's ways or banish her, forced Mira to leave. She first

went to Vrindavana and then to Dwarika. Now her devotional life was in full swing. She moved in sadhus' company, danced and sang in temples and beyond breaking all barriers that rigid society and its customs imposed. In visual representations the Mira of palaces was a wanderer of roads with songs on lips and a 'vina' - stringed instrument, in hands.

When at Vrindavana. Mira heard that the known Krishnadevotee Jiva Goswami was at Vrindavana. She desired to meet him, but under a vow not to cast his eve on a woman, he refused to see Mira. Thereupon Mira sent him words that she was under the impression that in Vrindavana there was just one male and all others, His Gopis. Now she finds that there is another male parallel to Him and identifies his separate entity. Jiva Goswami did not fail to understand the underlying meaning and ashamed rushed to meet her.

Mira's Death

When in her forties, Mira came to Dwarika. Now every moment of her life was devoted to Krishna. In meantime her cousin Jayamala succeeded in wrestling Merata back and regained his supremacy. He sent messengers to Mira asking her to return. Some of the messengers stayed at Dwarika pressurizing her that they would not go back unless she accompanied them. As the tradition has it, she asked them to wait for the night, and when the night fell, all alone she entered into the temple, in some legends, into deep forest, for bidding farewell to Shri Rana chhoraji. She sang two songs; with the one, her spiritual being merged into the image of the Lord, and with the other, merged into Him her mortal form.

Those who had seen her entering the temple never saw



her coming out. Her mortal body was never found. Another tradition puts it with some difference. With her wide open eyes she looked at her Lord praying Him not to separate her from Him. It is said that thereupon the Lord stepped out of the idol, entered into her through her eyes, occupied her spiritual being, and let the discarded mortal body fall.

Mira's Popularity, Poetry And Nature Of Bhakti

Kabir, Surdasa, Tulsi, Nabhadas were 'bhakti' poets. 'Bhakti' was their poetry's essence but basically they were poets. Mira sometimes sang like Kabir:

'Jantar mantar kachhu na janunved parhi nahi Kasi'

- neither adept in cosmology or the science of syllables nor I have read Vedas or visited the holy Kashi, but still I am just an uncut naive 'bhakta'.

When she danced, in her legs revealed her surrender to her Lord and when she sang, in her words revealed her yearning to unite with Him. Neither a dancer, nor singer, Mira was 'bhakti' incarnate - surrender in love, surrender beyond questions, calculations, fear, and all thoughts of profit or loss, something that Chaitanya called Gopi-bhava - single-pointed submission as Gopis had for Krishna.

To Mira, the ties between her Lord and her were those of love, the love that looked like this world's. Not an inhabitant of this world, Mira discovers in it the frame for her Lord's picture, in the world's sensuous ways, her Lord's ways, and in its idiom, the diction to communicate with Him. Not a symbolic or elemental merger, Mira desired, with her body, soul and all faculties, that her Lord, when He met her, rushed to her, smiled and embraced her -

In love, her form of devotion and its essence, Mira sought release from the cycle of birth and death:

'Jana Mira Kun Girdhara milaya, dukha metan sukha bheri,

Ruma ruma sata bhayi ura mein, miti gayi phera pheri' -

The moment Mira met Girdhara, sorrows vanished and happiness emerged, all agitations of mind and body extinguished, and the cycle of birth and death is destroyed.





According to legends, King Ravanan set fire to Anumar's tail, while he was searching Lord Rama's beloved wife Sithathevi. Anumar was a dutiful messenger of Lord Ramar. After his tail caught fire, he came to Maamaangam, and dipped his tail into the holy river. And, it is believed that Lord Ramar worshipped the Sivalingam in Maamaangam.

Hindus travel to Batticaloa to fulfill their vows. It is also believed that many miracles happened here. Devotees believe that, the holy water in the Maamaanga Nathi has healing power, free from their sins and takes away ill evils from the human body


