## Conservative Government receives one and a half month's wait time to present New Economic Plan for current crisis

### P.M seeks Opposition advice on Economic Reforms - Will it work?

Prime Minister Stephen Harper and his Conservative Government have been given a respite with a one and a half month's wait time through a prorogation of Parliament which has saved the Government of a defeat in Parliament by a vote of no confidence by the Opposition parties who have formed a coalition. The Governor General's decision was perhaps a pragmatic approach taken in the light of the current developments.

Meanwhile, Harper's new strategy was to seek Opposition advice for economic reforms to be included in the new Budget which his Government will present in late January when the new Parliament meets. This measure was to take the heat off the Opposition's protests that the Government is not seeking proper economic reforms to meet the current economic crisis in the country.

Stephan Dion has stepped down from the leadership of the Liberal Party and Michael Ignatieff, a former Professor of Harvard is to take over the leadership of the Liberal Party.

Bob Rae, another Liberal and friend of Ignatieff who announced his candidature for the Liberal leadership, has now backed out. The dawn of the New Year will certainly seem some fire-works across the political sky. Whether the Conservative Government will continue, or whether the Coalition would take-over or whether Canadians will have another election (fourth in four years is anybody's guess!

Current economic conditions reveal that Canada is entering a recession. Last month alone, nearly 50,000 lost jobs, house sales fell by 50 % as compared with last year, House prices went down by 6% and auto-sector sales, another vital part of the economy, plummeted down. Who ever runs the Government has to come out with a viable and successful plan to avert an economic disaster.

Bringing down a Government is one thing. Running the Government is another. A mere change of Government without a proper economic plan will not be a solution. It will be like changing pillows for a headache!

**60th Anniversary of the Universal Declaration of Human Rights**

This year marks the 60th anniversary of the day - December 10th in 1948 when the General Assembly of the United Nations adopted and proclaimed the Universal Declaration of Human Rights (UDHR), under the leadership of U.S. First Lady Eleanor Roosevelt.

This is the first global articulation of any form of inherent and universal human rights, and it remains the world's most widely translated document of its kind and stands as a symbol of the highest goals society can achieve.

The Declaration has come to form the basis of much international law and has provided moral and legal backing for UN action against human rights violators.

Pope John Paul II described it as "one of the highest expressions of the human conscience of our time".

According to former South

African archbishop Desmond Tutu and former Irish president and UN high commissioner for human rights Mary Robinson, the document remains "the single most important reference point for discussion of ethical values across national, ideological and cultural divides".

Today, concerns about the rights of ethnic, racial, and religious minorities - as well as women, homosexuals, and many others - are all viewed as human rights. There are often reports of violation suspects and prisoners' rights, draconian laws for detaining political prisoners, battered women and their children facing difficulties, same-sex couples who are denied basic services, professional women and racial/visible minorities who hit the discriminatory "glass ceiling", worker abuses etc.

Many nations have hardwired

into their system of laws protections enshrined in the Declaration. And, the Declaration has inspired people the world over to advocate for an expansion of individual rights.

However, this momentous document's 30 articles seem like empty promises to many of the humanity around the globe today.

Many governments do not properly adhere to its tenants. This Declaration was written against the horrific backdrop of World War II, when human rights violations reached immense proportion. Similar levels of human rights violations have remained consistent throughout several countries around the world.

On the eve of the 60th anniversary it was announced that Genocide and other mass atrocities are underway or risk breaking out in at least 33 countries including Sri Lanka, by a new compre-

hensive watch list slated for released on Dec 9th.

So while this 60th anniversary is certainly an opportunity to recognize the worthy ideals of the UDHR, it should also be a clear reminder that our deeds must align with our promises for a grander celebration in the future, or the aspirations of the momentous document will forever remain nothing more than words.

Preventive measures to safeguard the rights and lives in countries such as Sri Lanka must be taken without delays.

The Monsoon Journal joins the world humanitarian community, in urging the public and policy-makers to learn more about UDHR and share information about it. An informed conviction on safeguarding the inalienable human rights of each person is the best way of ensuring and or working towards the human rights of everyone.

A Canadian Citizen (of Sri Lankan origin) complained to the Ontario Ombudsman of Administrative improprieties by a Ministry of the Ontario Government as provided for under the Ombudsman Act. The front-line

Officers who handled the complaint, on a one-sided and incorrect, version and response by the Respondent, unlawfully and acting in bad faith, decided to close the file, although the Complainant produced documentary evidence to rebut the Respondent's response.

In accordance with the policy and procedure available, with his Office, Complainant then complained about the improper conduct of these officers to Mr.Andre Marin, the Ombudsman personally. But Mr.Marin took no action whatsoever nor did he even care to respond to the complaint.

## Supervisor's term ends at The Scarborough Hospital

**New Board, CEO to continue focus on quality of care, patient safety and community engagement**

As of midnight December 5th, The Scarborough Hospital is no longer under supervision.

In a letter confirming the end of his term, the Minister of Health and Long-Term Care, David Caplan, thanked Rob Devitt for his dedicated efforts in addressing the challenges facing the hospital and building a stronger healthcare system.

"I've enjoyed my time at Scarborough," says Devitt. "When I arrived, there was a very long list of issues to be addressed, both on the governance front and in administration. But I've been very impressed by the way staff and the community have come together to find solutions, and the progress in 15 months has been remarkable."

Devitt's final report to the Minister, which is posted on the hospital's website ([www.tsh.to](http://www.tsh.to)), presents a frank overview of the hospital's many challenges and the intervention that was required to move the organization forward since July 2007.

These challenges included Hospital Standardized Mortality Rates (HSMR) that were among the worst in the province, back-to-back budget deficits, a poor workplace safety record, a backlog of unaddressed patient complaints and serious staff morale issues.

Significant progress has been made towards resolving many of these issues. Achievements include:

"A significant improvement in the HSMR rate;

"A budget strategy that allowed the hospital to go from a deficit position to one that

includes a small surplus;

"The development of a comprehensive workplace safety program;

"The development and implementation of a leading-edge strategy to reduce C. difficile infection rates;

"A significant reduction in unresolved patient complaints;

"Routine staff satisfaction surveying, with programs to improve rates and the creation of a staff Code of Conduct;

"Development of a strong internal communications program; and

"The recruitment of a new permanent CEO and a strong, skills-based Board of Directors who will bring stability to the organization.

"A great deal of hard work on the part of staff and physicians went into achieving these improvements, and I would like to thank everyone at The Scarborough Hospital for their efforts and their support," said Devitt. "Building on that foundation, and with the support of strong leadership at the Board and CEO level, the hospital will continue to move forward positively and productively."

"Rob has done a great job setting us up for success," explains Mike Mueller, Chair of The Scarborough Hospital Board of Directors. "There are still many challenges ahead of us, but he's given us a very solid foundation. I look forward to working with our many stakeholders to move The Scarborough Hospital forward."

"The Scarborough Hospital was truly fortunate to have Rob Devitt as a Supervisor," says Dr.



John Wright, CEO. "It would be impossible for anyone to put more time and effort into an assignment than Rob did on this one. His extensive consultations with stakeholders have resulted in innovative bylaws with checks and balances that allow the hospital to govern effectively while providing important roles and representation for the community."

A hospital supervisor reports directly to the Minister of Health and Long-Term Care, and assumes the full responsibilities of the Board that governs the hospital, the hospital corporation and its officers. With the end of supervision, The Scarborough Hospital will now be governed by its new Board of Directors, and administration will be led by President and CEO Dr. John Wright.

## Minister Kenney Addresses the Immigration and Refugee Board's Consultative Committee on Practices and Procedures



The government is committed to protecting the integrity of the refugee protection system and the immigration system, the Honourable Jason Kenney, Minister of Citizenship, Immigration and Multiculturalism, said recently.

"As the Minister of Citizenship, Immigration and Multiculturalism, I believe strongly that Canada is richer for the newcomers who come here," Minister Kenney told the Consultative Committee on Practices and Procedures of the Immigration and Refugee Board (IRB). "Each year we welcome from every corner of the world almost a quarter of a million newcomers who embrace our values of freedom, of democracy, human rights and the rule of law."

Minister Kenney acknowledged the important role that the Committee plays in working with the IRB, noting that it "allows for

a unique and valuable perspective on Canada's immigration and refugee system."

The Minister's address also highlighted recent important improvements that are a part of the Action Plan for Faster Immigration, including the changes that will improve the immigration program's responsiveness to Canada's labour market, reduce wait times for new applicants and reduce the size of the application backlog.

The government is also upholding its commitment to reunite families and maintain its humanitarian obligations to refugees by granting between 26,300 to 27,200 refugees and their family members permanent residence in 2009. "This builds on a longstanding humanitarian tradition of welcoming refugees and displaced persons," added Minister Kenney.

Left with no alternative Complainant then sued the two Officers Angela Aljbertis and Tim Arkell in the Toronto Small Claims Court in action Nos; SC-08-64426-00 and SC08-64427-00 respectively personally, for acting in "bad faith" and also failing to provide even proof of their delegation by Ombudsman to investigate the complaint as expressly provided for and mandated under section 24(1), though they were duly requested in writing by Complainant, and 26(5) respectively of the Ombudsman Act.

Then Amanjit S.Brar, Lawyer with the Ombudsman, who had no authority to represent the Defendants as they were sued personally for what they did illegally

and not qua office, appeared for the them and without any legal basis moved Court to have the claims of the Complainant struck off even without a hearing.

The Complainant filed objection to this and the motion was dismissed by Provincial Court Judge His Honour Godfrey.

Prior to this Andre Marin had unilaterally dispensed with "Community Open Houses" that were regularly held by his predecessor to enable the public to have transparency and discuss matters openly. When Complainant personally asked Andre Marin why he had done this and requested him to restore it, he never responded to it.

## Senior Chinese Official Warns of Economic Downturn

A senior Chinese official warns the country's economy is slowing at an "accelerated" rate and could lead to social unrest.

National Development and Reform Commission chairman Zhang Ping said on Nov 27th that data gathered this month shows China's economic downturn is deepening as the impact of the global financial crisis spreads.

He says an increase in bankruptcies and production cuts by major manufacturers would likely cause large-scale unemployment, and trigger social instability.

The Bank of China cut the country's benchmark lending rate by more than a full percentage

point Wednesday in an attempt to help the economy.

Earlier this month, officials unveiled an almost \$590-billion plan aimed at spurring economic growth.

Still, tensions have been rising. Hundreds of laid-off workers trashed the offices of the Kaida toy factory in southern China recently following a pay dispute. Last month, 7,000 people marched in protest after losing their jobs at another toy company.

Also, the Hong Kong firm that owns the Kaida toy factory agreed to improve compensation packages for its laid off workers. [voa]

With extreme politicization, no planning, personal agendas and the unqualified at the helm of administration - sports in Sri Lanka is presently witnessing its darkest period, said Former Test cricketer of Sri Lanka team, Hashan Tilakaratne.

He was speaking at a media briefing organized by 'Development Watch' at Sri Jayewardenepura Kotte, on Nov 28th.

"Big names in athletics like Susanthika Jayasinghe, Dama-yanthi Darsha, Sugath Tilakaratne and Sriyani Kularatne are all who had brought glory to our country. But, there is no system in place for youngsters to learn from their international exposure. They can

make invaluable contributions towards upliftment of sport. We also do not have any system to identify rural talent. Therefore, how can the country's sport can go forward or develop?" he asked.

## India is our friend, we are not against any country, remove the hindrance of ban: Prabakaran

While conveying his love and gratitude to the people and leaders of Tamil Nadu and leaders of India who have grasped the heartbeat of Eelam Tamils and have come forward with timely support, the Liberation Tigers of Tamil Eelam (LTTE) leader V. Prabakaran in his Hero's Day speech on Thursday November 27th requested them to voice firmly for Tamil Eelam and to undertake conducive measures to remove the ban, a great hindrance to amicable relationship between India and the LTTE.

"At no stage did we ever consider India as an enemy force. Our people always consider India as our friend. They have great expectations that the Indian super power will take a positive stand on our national question", he said.

The LTTE leader also requested the world powers to remove the ban on it, citing that the LTTE never schemed any act against any country and the Tamil struggle is not against the geopolitical, national or economic interests of any country.

## Financial Crisis Threatens World's Most Vulnerable

As the humanitarian crisis worsens in the Democratic Republic of Congo, aid workers are warning that the global financial crisis will hurt the world's most vulnerable people. Some are now predicting that death rates for the world's poorest could increase rapidly as the global recession bites.

Flipping through his photo album, Buka Mwanza looks back on his last trip to Congo. He says he was kept busy visiting family.

"We're an old-fashioned African family so we have quite a large extensive family," he said.

But it is not just the recent fighting in his homeland that worries him. He is also concerned that humanitarian aid to Congo will be reduced following warnings by aid agencies that the global economic crisis will lead to cut backs by governments and private donors.

"It is human lives that we are talking about. Money is something that comes and goes but a human can't be replaced," added Mwanza.

Peter Kessler, a spokesman for the United Nations refugee agency, UNHCR, says the agency relies on donations. If it gets less, it must spend less.

"The UNHCR is almost entirely funded by voluntary contribution so every contribution, from individuals on the street to governments in their capitals, is vital. Obviously when governments are devoting huge amounts of money into stabilizing their economies, those have an effect on the humanitarian programs like UNHCR and our partners," said Kessler.

The UNHCR has refugee camps all over the world, from Afghanistan, to southern Africa and even in the Darfur region of Sudan. Kessler warns that the impact of cutting programs could be devastating.

"People shouldn't forget the fact that there are tens of millions of people who rely upon the UN refugee agency and our partners for food, water assistance, protection and without these programs there will not be the care available, that people will indeed suffer and could indeed die," said Kessler.

It is not just UNHCR that's concerned. The International Red Cross and Red Crescent held a conference in South Africa recently to discuss the issue of dwindling aid.

And there is another danger to the financial crisis - rising global unemployment. The International Labor Organization is warning that as many as 20 million people worldwide might lose their jobs as a result of the financial crisis.

Claire Melamed with Action Aid, an international anti-poverty group, says this is a serious concern for developing countries.

"This is the flip side of the growth that we have seen in China and India which have been based on exporting things to rich countries. This is the downside in a sense, when demand dries up then jobs disappear," said Melamed.

A vicious cycle, aid officials and humanitarian workers warn - and one that could see the world's most vulnerable pushed precariously closer to the edge.

## US Secretary of State spotlights Rights violations in Sri Lanka

United States Secretary of State, Condoleezza Rice, on Monday Dec 8th, awarded the 2008 Human Rights and Democracy Achievement Award to Michael De Tar, the chief of the Political Section of our Embassy in Colombo, Sri Lanka, for engaging "constructively with Sri Lanka while underscoring our [U.S.'s] human rights," and for proposing the roadmap adopted by the Sri Lankan Government" to induce a paramilitary aligned with the government to begin to release its child soldiers [in the east]."

Rice said that De Tar was "a key actor in the international effort to monitor an official

Commission of Inquiry investigating high-profile cases of human rights abuse, and he has responded quickly and effectively when journalists and other activists have been threatened or arrested."

Human Rights Watch (HRW), the New York based rights advocacy group few weeks ago pointed out, the situation in the Eastern province of Sri Lanka continues to rapidly deteriorate. HRW said the Sri Lanka-backed paramilitaries there were responsible for thirty murders and thirty abductions during September and October.

## Canada's BMO Capital to set shop in India

Notwithstanding the financial crisis ravaging the world markets, Canadian investment banking major BMO Capital Markets sees opportunities in India and is planning to launch its operations in the country.

"We will mainly concentrate in the advisory business in India and launch our operations as soon as we receive all regulatory approvals which could take another 45 days," BMO Capital Markets India Head Ashutosh Sharma said.

Asked whether it was the appropriate time to launch their business in India amid the ongoing global financial crisis, Sharma said, "We believe in the growth

story of emerging markets and the crisis has made valuations of American firms quite attractive and make the right acquisition targets for outbound deals from Indian companies."

The investment and corporate banking arm of BMO Financial Group completed a tour of global investors in India recently which included a number of enterprises in Mumbai, Bangalore and Delhi.

"Our group of investors, who in aggregate manage assets worth \$1.5 trillion, were impressed by India's growth trajectory and entrepreneurship which would be driven largely by sustainable domestic demand," BMO Capital Markets Managing

Director Investment and Corporate Banking Ashi Mathur said.

BMO sees opportunities that India present over near and long term and has recently enhanced its commitment to Indian market with the appointment of Ashutosh Sharma," Mathur added.

Further, BMO believes that for global economy to recover from a potentially devastating recession, the key is leading emerging market economies.

"Next year, the world will be looking at India's economic performance with more interest than any time in the nation's history," Group's Global Portfolio Strategist Donald Coxe said. [PTI]

## Mumbai has most active online shoppers: Report

Mumbai has the most active online shoppers followed by Delhi and Hyderabad, as a recent report says that eCommerce has picked up fastest in the megapolis.

According to the eBay India Census 2008, India's top five eCommerce hubs are Mumbai, Delhi, Hyderabad, Bangalore and Chennai.

"Over 2,427 cities had online transactions in 2007. The IT hubs of Andhra Pradesh, Kerala, Maharashtra, Tamil Nadu and Karnataka were the most wired states of India with the maximum number of towns where eCommerce originates," eBay India Director (Category Management) B Murali-

krishnan told reporters here.

Muralikrishnan said eCommerce was helping bridge the demand and supply gap.

"Over a third of all products bought by eBayers in the hilly areas (North East, Jammu and Kashmir and Himachal Pradesh) are tech gadgets (Mobile Phones, Digital Cameras and USB Drives). While women from metros are buying a lot of sarees, the sellers are spread across various cities and towns like Devanagere (Karnataka), Chittaurgarh (Rajas-than); Lucknow, Kunnamkulam (Kerala)," he said.

The most bought and sold items on the shopping portal are diamonds, value handsets, MP4 play-

ers, USB MP3 players and Indian stamps.

"The census includes data only from shoppers on eBay India but can be used to get some idea of the market as 42 per cent of shoppers prefer eBay over other portals according to a survey by Juxt consulting," he said.

Similar reports have been brought out for the US and Canada operations of the company, which has a presence in 39 countries.

eBay India, formerly known as Baze.com, is the wholly owned subsidiary of the US-based eBay Inc.

## Gale force winds, heavy rain lash Jaffna

A 195.5 mm rainfall was recorded from Monday Nov 24th to Tuesday 25th evening alone by the Sri Lanka Meteorological Department in Thirunelveli in Jaffna peninsula. Two feet high sea water has entered Karaiyoor, Paasaiyoor, Kaakkaitheevu and Naavanthu'rai areas along the coast of Jaffna lagoon forcing residents to seek shelter in nearby churches and schools. Electricity supply, transport services and telecommunication have been cutoff due to the collapse of electricity posts, overflowing culverts and trees falling across the roads and electric wires. Jaffna peninsula is plunged in darkness as its people keep indoors unable to face the monsoon torrents that continue to lash for the fourth

day, sources in Jaffna said.

Though Jaffna Secretariat sources said that nearly 500 families consisting of 2,500 people have been displaced due to the incessant rain and intermittent hurricanes the number of persons displaced is said to be more than 4,000.

Sri Lanka Transport Service (SLTB) Koandaavil depot tried to run a few buses Tuesday morning but the attempt was suspended as the main streets were blocked by uprooted trees and culverts overflowing, making them impassable.

The SLTB officials said that it would be impossible to resume bus services until the roads are cleared of the obstacles.

Sri Lanka Electricity Board

(SLEB) in Chunnaakam has completely cutoff electricity supply to the peninsula as electric posts have fallen and supply wires snapped by falling trees.

Almost all residents of the coastal areas in Vadamaradchi North and East have been driven from their huts seeking shelter in nearby churches, schools and other public buildings.

Many of their dwellings and the roof on them have been ripped off and cast into the sea by the strong gales accompanying the pouring rain.

The people of Jaffna peninsula may have to face more hardships and suffering should the monsoon rain and storms continue to lash, civil society sources said. [TN]

## Floods, Fighting, Food Shortages Hit Trapped Tamils

Incessant rains and flooding in the Vanni, the Tamil rebel stronghold in northern Sri Lanka, are adding to the woes of at least 200,000 people stranded in intensified fighting between the Liberation Tigers of Tamil Eelam (LTTE) and the Sri Lankan army since mid-September.

On Tuesday Nov 25th, TamilNet reported that floods were "flowing over most of the roads and civilians who had sought refuge in open lands and in temporary huts in low-lying areas were forced to seek shelter in schools, temples, churches and public buildings in Vanni."

There are now conflicting estimates as to how many people are affected by the floods, fighting

and food shortages. Foreign Secretary Palitha Kohona put the figure of the entire Vanni population at 200,000, while the United Nations puts the number of internally displaced persons (IDPs) at 230,000.

On Nov 19th, Amnesty International (AI) assessed that "more than 300,000 people face the next few months crowded together in temporary shelters, surrounded by mud, with no promise of regular access to food or adequate sanitation."

"The Sri Lankan government must immediately end its policy of blocking humanitarian aid needed to reach an estimated 300,000 displaced people in the Vanni region of northern Sri Lanka,"



Sam Zarifi, AI's Asia-Pacific director, said in a statement.

"The Sri Lankan government states that it is distributing aid to displaced families, but AI believes that the government lacks the capacity to uphold international human rights standards and ensure the support is provided to protect the lives of thousands of people," Zarifi said.

## Protest against Sri Lanka army restrictions on essentials

The people in Vanni marched in thousands towards two Government Agents' offices and two Divisional Secretariat offices in four locations on Friday Nov 21st, protesting against Sri Lanka Government's restrictions on food and essential supplies, blaming Colombo for using humanitarian supplies as a tool of war to force civilians to flee against their will into the hands of Sri Lanka Army (SLA).

Velamalikithan, a representative of Vanni Peoples Welfare Organisation (VPWO), addressing more than 5,000 protesters in front of Kilinochchi Government

Agent's office at Tharmapuram described how the supplies were reduced from 600 lorries per month in 2007 to 250 lorries per month in 2008, but only 54 have allowed to cross into Vanni in the recent days.

On Nov 20th, Amnesty International has appealed to Sri Lanka's government to allow aid to reach more than 300,000 people displaced by fighting in the north. The human rights group urged both the government and Tamil Tiger rebels to allow international monitors into the embattled northern Vanni region.

## Eat healthy for a happy heart

Research has shown that persons of South Asian descent are prone to developing heart disease and stroke at a younger age, often before the age of 40. And, South Asians have a 3 to 5 fold increased risk of heart attack and death due to cardiovascular disease compared to other groups.

Being aware of your risk factors for heart disease and stroke as well as healthy eating and being physically active can help you prevent these conditions.

It is important to eat a healthy diet that is lower in fat, especially saturated and trans fat. The quantity and quality of the fats are both important factors in a healthy diet. It is also important to watch the amount of salt you are eating in prepared foods.

Limit your intake of saturated fat, which is found primarily in red meat and high-fat dairy products. Choose lower-fat dairy products such as milk, yogurt and paneer.

Include a small amount (30 to

45 ml or 2 to 3 tablespoons) of healthy oils in your meals each day for cooking and salad dressings. Healthy fats can be found in vegetable oils (such as canola, olive and soybeans) and soft margarines low in saturated and trans fats. Limit the use of butter, hard margarine, lard, coconut oil, shortening, ghee and vegetable ghee.

It is important to eat fewer foods that are cooked in fat, such as puris, samosas, pakora, French fries and fried snacks such as gathia, chevdo and chips. Choose lower-fat foods such as plain roti, dhokla, and plain popcorn.

Often a lot of fat is added when preparing South Asian foods such as dhals, sabzis and breads such as roti, chapatis or naan. You can dramatically reduce the fat in these foods by slightly adjusting how you cook and prepare them. When serving vegetables, try preparing them without oil or using only small


amounts of vegetable oil. Remember a vegetarian diet is only low in fat when the vegetables aren't cooked with a lot of extra fat.

Make at least half of your serving of grains whole grain each day by choosing brown basmati rice as well as whole grain flours when making or buying bread such as chapattis, naan or roti.

Also be aware of high sodium levels. The following foods may be high in sodium. Read the Nutrition Facts Table on food containers before selecting these foods: ketchup, chutneys, chaat massala, pickles (achar), papad, canned or bottled foods and other packaged convenience foods, salted nuts, salted crackers, chips, popcorn, biscuits, pretzels, namkeens and other fried snacks.

If you watch what you eat, your heart will be healthier for it.







## Sri Lanka court decision might damage country's credibility in international financial markets

Sri Lanka's supreme court has ordered the state-owned oil refiner, Ceylon Petroleum Corporation (CPC), to suspend hedge payments to banks until a central bank probe into the matter is over.

A report by Reuters on Nov 28th says the decision may have far reaching implications, with possible increase of risk premium for any deals and agreements Sri Lankan entities considering in the future.

Reuters report further says,

Opposition politicians have questioned the hedging arrangements by the state-owned Ceylon Petroleum Corporation (CPC), with Citi Bank, Standard Chartered Bank, Deutsche Bank and two local banks, which were made in expectation that the oil prices would hit \$200 per barrel.

Prices have dropped instead and the hedges mean the country will not benefit while the banks do.

"The Supreme Court granted interim relief suspending all the hedging payments to the banks until the final hearing," said lawyer Uditha Egalahewa, who appeared on behalf of the peti-

tioners seeking to cancel all hedging payments.

Lawyers said the court had suspended A.H.M Fowzie, the minister of petroleum and petroleum resources development, and Ashantha de Mell, chairman of the Ceylon Petroleum Corporation.

The court has yet to issue formal notifications of its ruling.

Asked to comment, Fowzie said he had heard of the court's decision.

"I do not know what the final outcome will be, until the final judgement," he told Reuters.

A spokesman for Standard Chartered in London said: "As the matter is now sub-judice it would not be appropriate for us to comment on the interim ruling."

He said in a statement the bank was not directly affected.

Deutsche Bank declined to comment.

Representatives of the CPC and the other banks involved could not immediately be reached for comment.

Hedging analysts said the island nation would have to pay at least \$300 million during the next seven months if global oil prices remained at current levels around

\$50 per barrel.

They have fallen from a record above \$147 in July.

An analyst said the court decision might damage Sri Lanka's credibility in international financial markets.

"Future agreements with any party are at risk and will have serious financial repercussions with possible increase of risk premium," said the analyst, who did not want to be named.

"This might make it very difficult for Sri Lanka to borrow commercial loans in future as investors will be concerned over termination of contracts on those borrowings as well."

Hedging analysts said the deal, designed to protect oil importer Sri Lanka against large movements in prices, had been done in such a way that CPC had to pay to the banks when the oil price fell below \$100 per barrel.

Financial analysts said the deal could impose a major burden on the \$32 billion economy when Sri Lanka's foreign exchange reserves have declined more than a quarter since mid-September because of the need to protect the rupee.

## CM, Maran Patch up

The bitter feud that fractured the first family of Tamil Nadu has come to an end. Shunned by M. Karunanidhi, his family and the DMK party after their Tamil daily Dinakaran in May last year carried a provocative public survey that gave only two per cent votes to Azhagiri, the Maran brothers finally made it back for a happy family reunion on Monday.

The head honchos of the massive Sun TV network, Kalanidhi and younger brother Dayanidhi, were received with great warmth by Karunanidhi at his Gopalapuram residence. The septuagenarian had only last Friday scolded his grandnephews restating his accusation that they had 'stabbed' him in the back even though he had brought them up, literally on his shoulders, for he loved dearly their father, the late Murasoli Maran, his elder sister's son.

The entire Kalaingar family was there for the grand occasion. Well, almost the entire family; for, his daughter Kanimozhi, born to second wife Rajathiammal, was not invited. The Rajya Sabha member has never been a Maran favourite. "Anything that makes my father happy makes me happy too," she later said.

The architect of the reunion was Mr Karunanidhi's daughter Selvi, married to the late Maran's brother Selvam. And sources say the foundation for the patch-up was made at the bedside of Mr Karunanidhi's first wife Dayalu Amma, when she was admitted at the Apollo a few days ago. Daughter Selvi was taking care of

her, so also her niece and Azhagiri's daughter Kayalvizhi. It is said that Selvi was able to break the wall between the Marans and Azhagiri through his daughter.

"Azhagiri and Stalin worked for this happy reunion. This has made everyone happy," Mr Karunanidhi told a crowded press conference later at his party headquarters. He had driven there straight from the Gopalapuram 'festival'. He did not want reporters to rake up the bitterness witnessed in the frequent sparring between the Marans' Sun TV and his own columns in DMK organ Murasoli.

What had led to this change of hearts, a scribe asked. "There was a mind, so the change happened," shot back the chief minister, with a broad grin, perhaps the first time he showed happiness about a Maran issue all these 18 months.

Would Dayanidhi now get back into the Union cabinet? "I do not want to talk about it now," was the quick retort. But now that the families have patched up, Dayanidhi will be part of the DMK team in the MPs' delegation to meet Prime Minister Manmohan Singh on the Lanka issue on Tuesday. Sources insist that the 42-year-old former IT and Communication minister has been promised his Central Chennai ticket when the Lok Sabha poll is next held. In return, apart from 'other' things, the DMK government would get better coverage in Sun TV.

## Ex-Indian premier VP Singh, champion of the poor, dies

Former Prime Minister of India, Vishwanath Pratap Singh, passed away in New Delhi at the age of 77 on Thursday, Nov 27th. He was Prime Minister of India between December 1989 to November 1990.

In his condolence message, Prime Minister Manmohan Singh said the country had lost a great patriot and nation-builder whose empathy for the weaker sections would always be etched in national consciousness.

"As Chief Minister of Uttar Pradesh and later as Finance Minister and Prime Minister, he consistently strove to translate his convictions into public policy.

Even after being afflicted with a debilitating disease, he continued to be at the forefront of the struggle for social justice."

Mr. Singh earned name as "Mr. Clean" while he was finance minister in mid-80's and took on industrialists by launching tax investigations. At the height of his campaign against fraud, he was shifted from Finance to Defence in 1987. He resigned as Defence Minister and left the party to strengthen the Janata Dal coalition and became Prime Minister of India in 1989.

V.P. Singh withdrew the Indian forces that were engaged in a war with the Liberation Tigers of

Tamillelam (LTTE) in 1989 when he came to power.

## United States Mint Releases Designs for Native American \$1 Coin on Native American Heritage Day

The United States Mint released the designs for the new 2009 Native American \$1 Coin, on Nov 28th, 2008 - on Native American Heritage Day.

Public Law 110-82 directs the Secretary of the Treasury to mint and issue the new \$1 coin to recognize Native Americans for their contributions to the history and development of our Nation. The new coin, slated to be released into circulation in January 2009, will circulate along with the United States Mint's Presidential \$1 Coins.

"We are proud to produce the Native American \$1 Coin," said United States Mint Director Ed Moy. "When Americans use this coin, we hope they reflect on the tremendous contributions Native Americans have made, and continue to make, to our Nation."

Like the Presidential \$1 Coins, the Native American \$1 Coins will be minted in the distinctive gold-colored alloy. The coin's obverse (heads side) will feature the Golden Dollar's striking image of Sacagawea-the young Shoshone woman who accompanied

Meriwether Lewis and William Clark on their historic expedition by sculptor Glenna Goodacre. Inscriptions on the obverse are LIBERTY and IN GOD WE TRUST. The year, mint mark and E PLURIBUS UNUM are incused on the coin's edge.

The reverse (tails side) of the Native American \$1 Coin will bear a new design each year. The featured design for 2009, by United States Mint Sculptor-Engraver Norman E. Nemeeth, is based on an agricultural theme, a significant part of Native American culture. This design depicts a Native American woman planting seeds in a field of corn, beans and squash, representing the Three Sisters method of planting. Inscriptions on the reverse are UNITED STATES OF AMERICA and \$1.

Throughout the Presidential \$1 Coin Program, the Native American \$1 Coins will be issued in chronological order, to the greatest extent possible, of the events or persons featured. The Secretary of the Treasury approves the designs after con-



sulting with the Senate Committee on Indian Affairs, the Congressional Native American Caucus of the House of Representatives, the National Congress of American Indians, the Citizens Coinage Advisory Committee, and the Commission of Fine Arts.

The total quantity of Presidential \$1 Coins and Native American \$1 Coins minted and issued into circulation by the United States Mint will be sufficient to meet the Nation's needs. As required by law, at least 20 percent of all \$1 coins minted and issued in any year will be Native American \$1 Coins.

## Coalition Government - Patriotism or Power Grab?

It was a pleasant afternoon on Friday, November 28th 2008, at the conference room of the Citizenship and Immigration Canada office on 5343 Dundas Street East in Mississauga. Journalists from many ethnic backgrounds arrived for the first news conference in Toronto attended by the Minister of Citizenship and Immigration. Jason Kenny was briefing us on the new immigration policy that was presented in parliament. It was an impressive and well planned policy. With high hopes, I returned home and wrote almost half an article about it and went to bed. The following morning, I switched on the TV and read the newspapers in my office. That is when I received the news about the three major opposition parties' intention to bring down the Harper government and form a coalition government. My mind instantly went back to the election campaign and the overly ambitious speeches of Jack Layton saying that Harper would be out of the Prime Minister's chair and that he would occupy it. When I think of it now, I realize that some of the polluted election campaign air circulated through the political atmosphere and brought on this cyclone. Though Mr. Stephane Dion, the leader of the main opposition party very carefully and from the bottom of his heart made his statement to the press saying that "We are ready to form a new government that will address the best interest of the people," he was far from sincere and I believe that most Canadians could see that.

I will venture to say that it is not right time to play political games when the global economy is facing an attack the size of a Tsunami. Creating instability in the government will be adding fat to the fire and will worsen the entire economy. It is the first time in Canadian history that both the effects of the economic Tsunami on the ground and political cyclone have hit with both

barrels at the same time. I do not care about who does or does not care about the state of the nation, but I do care about the actions which should be taken in the best interest of this nation, not at the expense of the nation or what suits the whims of a particular party.

It is crystal clear that the idea of forming a coalition government was made not because of the measures taken by the Harper Government to stimulate the economy were insufficient, as it was said. Rather, other more hidden reasons contributed to this idea such as bringing down Harpers government at any cost, grabbing power, and making use of this opportunity to reestablish their parties.

The two partners of the coalition and its active supporter, the Bloc have one thing in common. Making use of the old adage "The enemy of my enemy is my friend" they are putting all available resources together and are trying hard to achieve their goal. Who cares that the fundamental values and beliefs of the parties are different? In face of acquiring power, these things are immaterial; the end will justify the means. The vision and core intent of the coalition is to bring down the government by taking advantage of the current economic state without any regard for the Canadian people. The NDP had been badly criticized during the federal election campaign by both the Conservatives and the Liberals, insinuating that the NDP was taking the country down the wrong path. The NDP is famous in wanting to bring down the government and that is what they did during Paul Martin's minority government. I do not think they have a balanced interest between national and international political policy to govern this great nation. Their focus is more of distribution rather than the stable increase in production. The basic principle of Socialism centers on the fair distribution of wealth among the contributors of production, land,

labour, capital and workers as well as advocating for a centralized monopoly of the government. Right now Canada has four main economic problems. The workers have to be protected and reassured about the safety of the investments of the entrepreneur. Maintaining employment, creating more employment opportunities and improving social amenities all depend on a stable and sound production level of the diversified Canadian economy. The second problem is the foreign market for Canadian products against the well protected European Union and the fast increasing economic power status of India and China. The third area of concern is the threat of terrorism and the means to defend ourselves if we are attacked. This is an international issue, and if we do not act wisely in collaborating with our neighbours, what kind of right do we have in asking for help? The last problem is that consecutive minority governments weaken national development at a rate that has not encouraged foreign investment into Canada. This is not an issue the rest of the developed world has faced; this is a peculiar problem that Canada has encountered recently.

Who is responsible for this situation? Neither the voters nor the politicians shoulder the responsibility alone. Let us consider the voter first. They do not want to have a minority government that will fall at any time. They do not want to spend their valuable time listening to the politicians explain their plans and policies over and over again. The voters do not want to spend endless hours making their calculations, comparing the leadership of each party with the rest, assessing the capability, reliability and personality of each, examining the policies and finally casting their votes. This is a very grueling exercise. If the voters are not convinced, the tendency is to have a minority government. Those who do not feel obliged to cast their vote believe at times,




that none of the politicians is going to do what they say so why should they bother? A few people also have a preconceived notion about politicians and a few of them told me while I was canvassing in my provincial election that all politicians are liars. Of course, this is a very exceptional circumstance, but I do not underestimate its expression. On the other side of the coin, I being a politician do not know what to say but, there is a room for us to do better. If there is going to be another election, that one should have an absolute majority. "Until someone some day achieves a majority, the fight is not won or lost" said Mr. Steven Harper on the evening of June 28th, 2004. It now appears that the fight will be over and the end is near.

The opposition parties proclaim that Harper's government has lost the confidence of the House of Commons. But the opposition parties have lost the confidence of the voters and have more confidence in the Conservative Party and its leader. In the system of indirect democracy where multiple parties exist, the verdict of the voters could be interpreted conveniently. The naked truth is that Canadians did not vote for a coalition of the opposition parties and the opposition party leaders advocated and revealed their hidden agenda to the voters to whom they must be true and loyal. I do not think that

the idea of a coalition dropped from the sky in the middle of the summer, and Harper did not take any "U" turn from what had been said during the election campaign. From the beginning until now, he was prioritizing the economic issues but, at the initial stage, almost all of the opposition parties picked other issues and all of a sudden, they woke up and cried loudly around economic issues. I appreciate that at least they realized what Harper was planning to do. They may not have liked it but it is good for the country.

To the average person, it may appear that Harper was not panicking as one of the opposition leaders was saying during the middle of the last election, or the respective governments of the USA, Germany and Great Britain. If Harper wanted to ride on people's emotions, he would have brought in rescue measures and ensured a place in the good books of everyone. It does not mean that Harper did not understand the current economic situation of Canada; On the contrary, he is one of the rare people who understands both the present and future economic situations and develops sensible solutions. The financial institutions in the USA, Germany and Great Britain were on the verge of collapsing and sought governmental help.

But in Canada, the Finance Minister met with the financial institutions and determined that they could stand on their own at this point in time and in the future, if it is required, extend help. He is a strong finance minister for a strong economy and does not take certain actions merely for the sake of doing them. When the G20 nations met in the USA, some of those nations pinpointed Canada as a role model in handling the current economic situation. Would the Opposition parties want to handle the finances in the manner that Bob Rae did in Ontario? Would they spend more money, not pay back government loans adequately; pay more of the tax payer's money as interest; Would they increase government debt by borrowing more money and passing it on to the next generation, increase taxes such as the GST to 7% and make the consumer suffer more, decrease social services to the masses, build more schools, bridges, hospitals and pass the burden to the next government and future tax payers.

If anything, this coalition is a marriage of convenience. When the honeymoon is over, one hopes the marriage will not end or reach the stage of divorce. Usually coalition governments do not perform well and after their regime, they meet with political disaster. There are two examples that I can give to illustrate this point. In 1873, Sir John A MacDonalld resigned after being censured in the House of Commons. The Governor General asked the opposition leader Alexander Mackenzie to form a government without an election. Mackenzie governed for three months, and then called an election, which he won. The second example is in 1926, Prime Minister William Lyon Mackenzie King realized that his minority government was going to be defeated on a non-confidence motion. He asked the Governor General to dissolve parliament and call for an election. But the Governor General refused the dissolution request and called on Opposition Leader Arthur Meighan to form a government without an election. He was able to govern for three months before being defeated in Parliament.

The role of opposition parties in the parliamentary system is to help the ruling party be balanced, unbiased and be more productive to the nation and the people who voted for and against them. Though they have an interest in becoming the ruling party in the future and make use of every opportunity to pinpoint the weaknesses of the government and their

strength to the people, it is understandable. But when an unusual situation arises, they should put the interest of the country first and all others second. I can cite two examples, when the Liberals federalist provincial counterparts to the sovereignist's were not as they expected, the federal leader of the Conservatives was brought to Quebec's provincial leader of the Liberals and safeguarded federalism in Canada. When the Israeli government once planned to attack the Iraqi government under Saddam Hussein, the Prime Minister consulted with the opposition party leader, even before it was revealed to some cabinet ministers. Such a mutual trust is made by working beyond party interest. Why is this happening in Canada? It appears to some of us, if not many, that even before the 40th parliamentary session began, a prominent politician wanted to bring down Harper's government without considering the consequences that the nation will face at this critical time.

At this stage, regardless of the acceptance or non-acceptance of Mr. Harper, the tax payers, the voter, the masses, the public, whatever the term we use will have a big say. This will not be done through a formal referendum but through lobbying, writing, gathering, emailing, and contacting the media as individuals and collectively. Public opinion will have a great influence in resolving the current constitutional crisis. It is a very sensitive issue because when the voters cast their ballots in the last election, they were not given any indication that there could be a plan for a coalition government, though Harper predicted that a minority government would be formed again by the Liberals or Conservatives. If the voters were aware of this, their voting patterns would have been different. We cannot take it for granted that the verdict of the people in the last election had given the green light to an alternative form of government.

Thanks to Governor General M. Jean for considering all of her options and for the time being accepting the points made by Mr. Harper and proroguing Parliament until the 26th of January, 2009 when the Federal Budget will be presented on the following day. Whatever the outcome, it should be in the best interest of our Nation as a whole. Whoever tries to gain at the expense of the people, will have to give it all a second thought.

## Housing Market Continues to Reflect Economic Times

The erosion of consumer confidence that began with rising fuel prices earlier this year is continuing as the global financial crisis and volatile equity markets have many Canadian households concerned about their own finances. This is clearly reflected in the slowdown of the housing market.

ONTARIO - GTA resale housing market continues to reflect economic times

(November 2008, Toronto, Ontario) The Greater Toronto Area resale housing market reported 5,155 sales in October, Toronto Real Estate Board President Maureen O'Neill announced today. This represents a 35% decline from the 7,915 sales reported in October 2007 and a 25% decrease from the 6,876 transactions that took place during the same period two years ago.

In the City of Toronto, there were 2,136 sales, with sales activity down 38% from the 3,455 transactions recorded last October. In the 905 Region 3,019 sales were recorded, with sales activity down 32% from a year ago when 4,460 homes changed hands. With 68,570 transactions to date this year, sales are within 16% of the 81,563 transactions noted a year

ago. The 2007 market referred to was a record breaking year with each month breaking records for the entire year. Putting this into perspective, 2008 figures are indicative of a return to a more balanced market.

In the City of Toronto, the current average price of a home was \$376,896, down 13% from last October's average of \$434,022 and within 3% of the October 2006 average of \$386,807.

In the 905 Region homes are selling for an average price of \$336,049, a decline of 8% from October 2007's average of \$364,142. Prices in this area however, remain one per cent higher than the October 2006 average of \$332,822.

OTTAWA – Prime Minister Stephen Harper issued the following statement today:



Realizing that the blazing pillar is a manifestation of Sivan, who has neither root nor crown, Vishnu conceded defeat and surfaced. In the meantime Brahma had flown upward for many eons without finding a hint of a top. When they met again Sivan stepped out of the fiery lingam and put an end to the squabbling.

Vishnu and Brahma prayed to Sivan to withdraw the Efulgence form and to abide as an immovable Lingam. Sivan in His grace took the lustrous forms of a mountain, and a small Lingam. The small Lingam was to enable the devotees to perform abhisheka, aradhana and puja. The mountain is the eternal, immovable Arunagiri (red hill), the most potent manifestation of the Supreme. The small Lingam is enshrined at the Arunasaleswarar temple, at the foot of the mountain. The name Aruna signifies the total annihilation of accumulated sins of the worlds merely at the sight of the holy mountain.

The mount reveals for the sake of the welfare of the world its true Efulgence once a year in the month of Kartikai (November-December) on the evening of the full moon when the star Krithika is on the ascendant (December 11, 2008). Karthigai Deepam commemorates the appearance of the Lord as a Jothi Shambam, an infinite pillar of light at Arunachala (Thiruvannamalai).

About a million devotees throng Tiruvannamalai to witness the lighting of the Maha Deepam atop the Annamalai Hills on the last day of the 10-day Karthigai Deepam festival of the Sri Arunachaleswara temple.

The flame is lit in a kopparai (cauldron) atop the hill. The cauldron is initially filled with about thousand kilograms of ghee and a 350 meter wick. When lit, the flame shoots up to seven feet and could be seen as a point of light from a 35 km radius. The flame, a spiritual beacon, burns for a week. Devotees trek to the top of the hill, which rises to a height of 2668 feet, to make personal offerings of ghee.

After the flame is lit, about a million devotees walk around the hill, a distance of 14 km. This is the immensely popular girivalam. Girivalam is the most important ritual that a devotee is expected to perform at Thiruvannamalai. The Arunaleswarar temple is one of the largest temples of Tamilnadu and is closely associated with many great lives.

One of the earliest references to Karthigai Deepam festival is found in the Ahananuru, a book of poems, which dates back to the Sangam Age (200 B.C. to 300 A.D.). The Ahananuru clearly states that Karthigai is celebrated on the full moon day (pournami) of the Tamil month of Karthigai. It was one of the most important festivals (peruvizha) of the ancient.

The Lingodbhava sculpture is usually installed in a niche in the back wall of the sanctum sanctorium of Sivan temples. It represents Vishnu in the form of a boar trying to find the bottom of the lingam, and Brahma in the form of a bird trying to find the top. When they fail, the lingam splits open and the full image of Sivan is seen.





## Global Financial Crisis: A Strategic Approach Needed

Current global financial crisis were created in the macroeconomic perspective, a prolonged period of excess global liquidity that boosted domestic demands, and other microeconomic factors such as deregulation of financial markets that led to financial engineering products and industry practices that played crucial roles in the build up of the bubble. 'Originate-and-distribute' lending model was mostly adopted by many financial firms in creating the MBS (Mortgage Backed Securities). Risks inherent in the mortgages were mispriced and transferred to unregulated segments of the markets. When the original mortgage borrowers failed the risk bearing assets holders in this markets segment suffered the loss.

### House prices continue to fall in most countries

Housing markets look grim all over the world. In the third quarter of 2008, house prices fell in 11 of 16 countries measured by The Economist's house-price indicators. The worst fall was in Britain, where prices tumbled a whopping 5.5% in the three months to September, following a 2.7% drop in the previous quarter. America's housing bubble was the first to burst in 2006, and it has been deflating rapidly since. Many places that recorded gains in the first quarter, such as Hong Kong and China, are now seeing declines. Only in Sweden and Switzerland did house prices grow by more than 1% in the third quarter. Germany, France and South Africa saw tiny rises. Global house prices are expected to fall by 15% in the next two years.

### Now Canada Heading for a

### Recession

In November alone this year 71,000 jobs have been lost in the Canadian Job Market, a largest monthly net loss figure in 26 years. This has pushed Canada's unemployment rate to 6.3%, and a strong indicator of Canada has finally moved towards a recession. Out of this number 66,000 losses were from Canada's leading manufacturing province Ontario, where the unemployment rate has now been pushed to 7.1%, Ontario is the epicenter of direct impact of the U.S. crisis in Canada. In the U.S. the figure for November 2008 was even worse, a loss of more than half a million (533,000) jobs a largest monthly net loss figure in 35 years and the unemployment rate was moved to 6.7%. There is a fear among economists that another 100,000 jobs may be lost in the coming months and the national unemployment rate to could further be pushed up to 7%. The ruling minority Conservative government in Canada is more interested in safeguarding political power, rather than realizing and addressing the weakening economy. Much criticized budget proposal has not even been submitted in the parliament as it has been prorogued by the Governor General. Actions that should have been taken three months before, has now been postponed by another two months. Similar situation is prevailing in the economic malaise engulfed U.S. as the presidential transition period between election and inauguration, almost three months is unavoidably a long period to be carried with a high cost on the economy.

### Central Bankers Commitments

While fiscal expansionary policy can play considerable role in addressing the recessionary situation, monetary policies by central bankers are widely expected in this time of financial catastrophe. At this time of liquidity and solvency problem central bankers worldwide, mainly from western world already have announced slashing down interest rates and provide liquidity support to illiquid bankers. Fed has drastically cut down its key federal funding rate to 1%. Bank of England has brought down its official rate to 3%, and another 1% slash is widely expected. Bank of Canada is expected act fast to remedy the situation, and there is an expectation that key interest rate to be cut down by 1.75% in December 2008. Bank of Japan is keeping its rate to the lowest of 0.3% now. Switzerland central bank has cut its benchmark rate in half to 1% last month. European Central Bank has brought it down to 3.25%.

### Valuable Monetary Policy Tool has no Impact on Recovery

Although such commitments by the central bankers some analysts question the effectiveness of this measure since the financial crisis is so huge, and no much improvement even though using this valuable tool. Some rates are already at very low levels. No much room to cut further. Fed rate is further expected to slash down to 0.5%. If no signs of recovery of global economy, what's next? Japan's rate at the very lowest level, it suggests, traditional monetary policy tool doesn't necessarily have miraculous powers to prevent a recession. Another option for the central banks is to buy bonds and channel funds in



order to bring long-term interest rates down. More liquidity may cause inflation as well. Some economists caution deflation is a real possibility as economies around the world contract. Deflation, a persistent, general decline in prices that can cause consumers to delay purchases in the hope that prices would further go down, and that can prompt businesses to cut production and lay-off staff, making demand fall even further.

### Bold Strategies Needed

Should taxpayers bail out distressed banks, investment giants or automakers? There should be a more comprehensive approach to resolve the crisis rather than bailouts. New government bodies have to be setup to recapitalize those failing banks and take over their troubled assets and manage it. Rather than a firm wise ad hoc bailout, the body should make a thorough study from the origination, evaluation and remedial action to recover the economy from the mess. Using tactical approach the Federal Reserve and the Treasury have put plenty of taxpayers' money through the central bank's liquidity facilities, loan to Bear Stearns, or the government takeover of Fannie Mae and Freddie Mac, the mortgage giants, insurer

AIG and now the auto makers. This is focused on staving off catastrophe one bail-out at a time. Barney Frank, the leading Democrat on financial matters in the House of Representatives, Paul Volcker, a former chairman of the Federal Reserve have suggested that Congress may need to create a new agency to deal with the mess, similar to Resolution Trust Corporation (RTC), a government body set up in 1989 to deal with the fallout of the savings and loan (S&L) bankruptcies. But the current crisis is much larger and such a body needs wider power to address it.

### IMF Study

Results of new study 'Systematic Banking Crisis' by Luc Laeven and Fabian Valencia the IMF economists suggest that 'tactical crisis containment' is expensive and frequently inadequate. In most financial meltdowns a comprehensive solution was required, and the sooner it was provided the better.' The study looks at 42 crises in all, spanning 37 countries. The economists conclude, "central banks privilege stability over cost in the heat of the containment phase." The economists say 'for the moment, the bail-out tacticians are in overdrive. But the strategists' moment is approaching.'

## How to Repair Your Credit and Improve Your Score

Credit Score is the method used by financial institutes to measure your financial health at a specific point in time. It indicates the risk you represent for lenders, compared with other consumers. In Canada, credit history is recorded in files maintained by at least one of Canada's three major credit-reporting bureaus (Equifax, TransUnion and Northern Credit Bureaus Inc.). These files are called credit reports - a "snapshot" of your credit history.

There is a rising tide of spam offering "credit repair" for a fee. Beware of these companies; their ability to change the information that appears in your credit file is no different than anyone else's! Only your creditors are able to alter this information. Therefore you do not need to pay a third party to obtain, review or make changes to your credit report. You have the right to access your information and make changes to your file if there is an inaccuracy.

What should you do if you have bad credit?

Before you pay someone to

advise you how to fix your credit, check out these simple steps to help you build a better credit rating:

1. Request a copy of your credit report from the three credit-reporting agencies at least once a year to verify that your personal information is up to date and your financial information is correct, and to ensure that you have not been the victim of identity fraud. Because your credit information can be kept by more than one credit-reporting agency, and because those agencies do not necessarily share information, it's important to check all three credit reports carefully. You can get a copy of your credit history from the above agencies websites for a small fee.

2. Check your credit history thoroughly. Look for errors and make sure the information in the report is correct and up to date. If you believe that the information in your credit report is incorrect, contact the financial institution that reported the information to see if an error was made. You

could also file a dispute with the three credit-reporting bureaus explaining your situation.

3. Analyse your finances. Make a list of everything you owe, the interest rate each debt carries, and the minimum payment due each month. Then, prioritize your debt: mortgage, real estate taxes, credit cards and bills should be paid in that order.

4. Negotiate with your creditors for a lower interest rate.

5. Pay your bills on time. Although the payment of your utility bills, such as phone, cable and electricity, is not recorded in your credit report, some companies may report late payments to the credit-reporting agencies, which could affect your score. Try to pay your bills in full by the due date. If you aren't able to do this, pay at least the required minimum amount shown on your monthly credit card statement.

6. Try to pay your debts as quickly as possible. The faster you pay your loans the less interest you will pay in the long run which means more available money to

pay other bills.

7. Don't go over the credit limit on your credit card. Try to keep your balance below 25% of the limit. The higher your balance, the more impact it has on your credit score. You're better off spreading out your debt between three or four different cards than having it all piled on one card.

8. Reduce the number of credit applications you make. If too many potential lenders ask about your credit in a short period of time, this may have a negative effect on your score. However, your score does not change when you ask for information about your own credit report.

9. Make sure you have a credit history. You may have a low score because you do not have a record of owing money and paying it back. You can build a credit history by using a credit card.

10. Don't share credit (except with a spouse). Think carefully before you agree to co-sign a loan. It is easy to wind up in a situation where that friend or relative stops paying his or her bills



(for whatever reason) and your credit will take a big hit. Once you're a co-signer for a loan, you're legally obligated to make those payments, whether or not you can afford them.

Show the credit system that you are a responsible money manager. A bad mark on your credit report will remain on your credit record for a maximum of 7 years. Pay your bills on time. Don't bounce any cheques. Don't overdraw your account at the bank (even if you have overdraft protection). You should only borrow money because you want to, not because you have to. In this way you will repair your credit and avoid a bad credit report in the future.

# Absolute Zero

The concept of zero, says Maharaji, an internationally recognized voice for peace, "is fascinating. When we're feeling perfectly healthy, what do we feel? Your pants aren't too tight or too loose. Your shoes are comfortable. You don't have a headache, your arms don't ache, and you don't have pain anywhere else. What do you feel? You feel nothing."

It's only when something isn't right that people feel pain, Maharaji says, and that hints at the value of zero, which could be used as a metaphor for the absolute.

"It's everything," he says, "without being anything. Its potential is infinite: it will just go on and on. If zero is taken from something, nothing changes, but when something is given to a zero, it changes."

For example, he says, if zero is placed in front of a one, then the value of one doesn't change; but every zero added after that one increases its value.

"One explanation for the infinite can be that it's zero," Maharaji says. "It is not an entity, and yet it is an incredible entity."

"How can you feel this thing called zero? Well, I offer something that works very well when it comes to letting you feel zero. It lets you feel it very beautifully."

For most of his life, Maharaji has traveled from country to country urging people to look within themselves for the answer to the question of what life is all about. He says he can offer the key to finding a lasting peace within the heart that, when experienced, can fulfill a life.

"People try to figure out, 'How do I get fulfillment? How can I be fulfilled?'" he says. "They're told, 'Read this book and you will be fulfilled.' 'Follow this path, and you will be fulfilled.' 'Go to this holy place, and you will be fulfilled.' 'Renounce everything, and then you will be fulfilled.'"

"That's one kind of concept. Other people say that the more money you have, the more fulfilled you will be, or that if you have a good job, the more fulfilled you will



be. The trouble is neither of those two trains of thought has been proven.

"Now, what about you? Do you think what I talk about is another path? Is it a bunch of rituals? No, it's about experiencing fulfillment."

Maharaji frequently makes himself available to answer questions from those who are interested in finding out more about what he offers.

Q: What do you mean by experiencing the absolute?

A: Let me share my perspective. In this body, in this shell made of dust, resides the infinite. What is infinite? It's what was, is, and always will be.

Something within us has the ability to make this dust dance, talk,

walk, and--most importantly--want. When this process is taking place, it's called life. As long as this union is intact, we're alive. As long as we're alive, we can feel. Breath comes into me. I'm conscious. I see, I feel, I understand, and I want to feel fulfilled.

Why do we want to feel fulfilled? Does anybody have to explain to us why we want to feel fulfilled? It's because it is the best feeling. The issue isn't fulfillment. The issue is how to get it--and this is where speculation comes in, because nobody can tell you, "Now you are fulfilled." Either you feel it or you don't.

Q: What if I just want to be happy?

A: It doesn't matter what you call it. What would you like to feel? Some say happiness; some say bliss; some say love. We can feel all of these--and much more. We can feel content. Not only can we feel contentment, but we can feel joy and happiness. Not only can we feel happiness and bliss, but we can feel the infinite within us--and that's everything.



## Out of the goodness of her heart

Some donate their time volunteering at their neighbourhood soup kitchen or helping the less fortunate. Others make generous contributions to charitable organizations. But, University of Windsor student, Shikha Chandok, took philanthropy one step further. She decided to give a part of her.

Chandok, now 22, shocked her parents, Ashwani and Kusum Chandok, last fall when she informed them of her decision to donate part of her liver to Sunila Sharma, a friend of the family.

"I was so scared. She's a girl. She has to have her own kids one day, her own life. She wasn't listening to me. She wanted to do it. I do a lot of meditation and I just prayed that everything would be okay," said Mississauga resident, Kusum Chandok.

The idea was born when Chandok eavesdropped on a conversation between her mom and a friend. "My mom mentioned that she [Sharma] was just coming out of the hospital again and her condition was getting worse. It had something to do with bad genes; a genetic condition," said Chandok.

Eight years ago, Sharma was diagnosed with primary biliary cirrhosis (PBC), a chronic liver disease that affects women between the ages of 40 and 60. PBC is not considered to be hereditary,

although it may develop in siblings.

Sharma, who has type O-positive blood, had been on a waiting list for a donor for over four years. Those with O-positive blood can donate to their blood to anyone, however they can only receive blood from each other.

With the odds against her, Sharma's chances of finding a suitable match were slim.

Thus, enters Shikha Chandok.

Hearing the news, Chandok, also an O-positive blood type, and a blood donor for many years, immediately contacted her family doctor to confirm whether she could be a suitable candidate for Sharma.

After withdrawing 16 vials of blood and undergoing numerous tests, doctors at University Health Network Toronto General division confirmed Chandok as a match. "When I found out, it was the hardest week of my life. I had three midterms, I had just quit my job, talked to my professors, and had to pack up my apartment and head back home," said Chandok.

The transplant was set for December 10, 2007. After eight and a half hours of intense surgery and the hard work of a team of eight doctors, psychologists, social workers, psychiatrists, and surgeons the transplant was completed successfully. For Chandok, it was a life goal accomplished.

"I've always wanted to make a difference. Donating blood was just a start for me doing the surgery was a completely random chance that I got."

But the worst was yet to come. A week later Chandok was released from the hospital. "The first three days I have no memory of at all. Thursday is when I started remembering everything. It was so painful. I couldn't walk. I couldn't get out of bed. I needed help going to the bathroom. I couldn't do anything," says Chandok.

Chandok's recovery from the surgery was neither simple nor speedy. She endured a 10 inch incision to her stomach, which resembled a hockey stick, continuous vomiting, daily shots of Herpin (an anti-coagulant), low attention span, breathing difficulties, a lack of energy, headaches and the daily consumption of medications, including morphine, stool softeners, antibiotics and immunosuppressant agents.

But the gruelling recovery process did not quell Chandok's indomitable spirit. "As much pain as I was going through, not for a second did I regret my decision, thinking to myself that, why did I do this?"

When asked how this experience had changed her life, Chandok replied, "It was a turning point for me. It changed my perspective on things. I figured out



who my true friends were, which was probably the hardest for me to deal with. It's a good reality check, and I needed it. I never thought this surgery would blow up to this proportion. It's caused a lot of awareness, and I'm really proud of that."

To her surprise, Chandok soon became a cause célèbre in her community. Her act of generosity was featured in local newspapers and on radio stations. To many, she became an inspiration and role model. "We all are proud of her, not many people would be able to do this, including me. I think if I couldn't do this then at least one person in my family has done a great job," said her father Ashwani Chandok.

In Canada, more than 300 liver transplants are performed each year. Unfortunately, patients may have to wait anywhere from

24 hours to three years for a suitable donor. In 2004, 68 patients died waiting for a transplant.

"We're all capable of making a difference, giving back," said Chandok. "We take so much and never think to give back until something negative happens. We can take simple steps like donating blood. People need that out there. You are saving someone's life. Some day your family member could need it. We can help so many people by doing a selfless act. We're giving someone a chance the hope to live."

When the ambitious Shikha Chandok is not busy saving lives, she continues to pursue her bachelor's degree in sociology and psychology at the University of Windsor, and volunteers at a school for students with special needs.

Manja songs have a few lyrics, which can be six or seven lines, and they are repeated. The songs are about love, nature, sea, birds and animals. Kaffirs also sing devotional songs. They say that, they follow the footsteps of the ancestors, and

## 'Tamils Still Want Safety, Security and A Future In This Country'

Excerpts from the speech delivered by R. Sambandan, Member of Parliament, Trincomalee District and Parliamentary Group Leader, Illankai Tamil Arasu Kadchi (TNA), during the 2009 Budget Debate at the Sri Lanka Parliament on Nov 17th, 2008:

The Tamil people have since 1956, through their democratic verdicts overwhelmingly supported the right to internal self-determination in the areas of their historical habitation. Initially, even several Muslim leaders were elected from the Eastern Province on the Federal Party ticket. If the demand of the Federal Party for a federal arrangement was accommodated, many more members of the Muslim community would have been returned on the Federal Party ticket. The government should realize that not merely did it not accommodate the legitimate aspirations of the Tamil people in keeping with their democratic verdicts, you subjected them to several pogroms over several decades when there was no violence whatever on the Tamil side. That was your answer to our legitimate aspirations and our democratic verdicts, to the non-violent Satyagraha campaigns that we engaged in.

Several decades later after the armed struggle commenced, some areas in the North-East went out of government control and when elections were held you did not want to locate polling booths in such areas. You did not want the electoral process to take place in areas not under your control. You clustered such polling booths and located them in government controlled territory, some considerable distance away from the residence of the voters. But, it is true that the LTTE discouraged voters living in areas under their control from voting in clustered booths located in areas under government control. The losers were Tamil candidates, such as myself and several others like me-nobody else- certainly not any one of you.

Nevertheless, the Tamils who were returned at those elections were returned on the basis of the same policy - the right to internal self-determination in the areas of their historical habitation.

At the 2001 Parliamentary Elections, when the peace process had virtually commenced and the Norwegian facilitators were functioning in the country,

the Tamil people in large numbers in the uncleared areas attempted to come through the army checkpoints and vote at the clustered booths in the government-controlled territory. They were prevented by the armed forces from crossing the checkpoints and voting. Several of these persons filed fundamental rights applications in the Supreme Court and I believe about five or six of them, from both the North and the East, were awarded damages by Justice Mark Fernando, then a senior judge of the Supreme Court. Who subverted democracy by preventing these Tamil people from voting? Was it not the government of which you were a member? And you have the impudence to talk about restoring democracy to the Tamil people.

At the 2004 Parliamentary Elections these Tamil people in the LTTE controlled areas who were able to cross the checkpoints voted liberally. There may have been some irregularities-but these people were voting for the first time after several decades. There was however, not the slightest doubt about whom the people wanted to elect. Twenty out of twenty-one Tamil members elected from the North and the East were from the Illankai Tamil Arasu Kadchi. The Illankai Tamil Arasu Kadchi also obtained two seats on the National List on the strength of the vote they polled in the North-East. The twenty-two of us in parliament are unquestionably the representatives of the Tamil people of the North-East, which unfortunately, your government does not want to acknowledge in view of the agenda that you have.

Having conducted a disgrace-

ful and shameful election in the Eastern Province, you have the temerity to talk about the election of the Illankai Tamil Arasu Kadchi Members in 2004. We know what happened at the Eastern Provincial Council Election. On my recent visit to Trincomalee, I met with some people from the North of my district where several booths had been clustered during the Provincial Council Elections.

Many voters had left the villages and had gone away to other parts of the country or had left the country. At 5 o'clock in the morning, on election day, I was told that a bus and 25 other vehicles arrived in that particular village where the booths of several villages had been clustered and that about 150 people alighted from these vehicles. Then they had gone into several houses in that village, used their toilets and their water facilities to freshen themselves and set about stuffing the ballot boxes.

Still, you could not win a single seat. Not one Tamil Member from your party was elected in Trincomalee. That was the way you got about conducting elections; that was the way you conducted the Eastern Provincial Council Election. In fact, there have been certain actions filed in court and I believe, when those hearings take place more facts in regard to the manner in which you conducted the Eastern Provincial Council Election will come to light and it will be proved in court how young fellows, members of a paramilitary group were moving around with weapons and having their own way.

All these matters will come to light. And you have the impudence to say that you conducted

a proper election.

Before I deal with development and devolution, the other two concepts of this government towards the resolution of this national question, I should place on record the government's multifaceted position on the people who inhabit this country, their status in this country, their rights in this country, and other relevant issues.

When I last spoke in Parliament during the Second Reading of the Budget, I placed on record details of several events that have occurred in the Wanni after the special envoy, Basil Rajapaksa went to New Delhi and gave an assurance to the Central Government in New Delhi that Tamil civilians will not be harmed. I also placed on record pictures of several events to prove that people had been killed; non-combatant civilians had been killed; had been injured; houses destroyed or damaged; temples damaged and even the Kilinochchi Hospital had been damaged.

Despite the assurance of the President, all these things have happened. I placed on record in this House, in the course of an Adjournment Debate in September, 2007, the names of 261 Tamil persons who were killed in the Eastern Province during the course of your military activities in the Eastern Province. Have you paid compensation to any one person?

I called upon your government to appoint a commission of inquiry comprising three retired members of the higher judiciary, a Sinhalese, a Tamil and a Muslim with the Muslim as the Chairman to go into that question and ascertain the truth. Have you done that? You see, you say one thing but you never act accordingly. This has been your history.

We know of the 'Mahinda Chintana.' We know of the two pacts the President signed with the JVP and the JHU before the presidential election. The 'Mahinda Chintana' and the pacts signed with the JVP and the JHU are only for a unitary state and no ISGA, no P-TOMS arrangement, nothing whatever. They are all at complete variance with the position that the President has taken in an interview to the 'Hindu' where he talks of a political solution and the equality, liberty, fraternity and all that type of thing. The positions taken up by him when he contested the presidential election are in complete vari-

ance with the concepts he has defined.

Of course his main military man, and I would say his main political man have enunciated their positions.

You are merely trying to assuage the international community who are constantly, whether it be India, the USA, the co-chairs, the European Union or any other country, wanting you to come to a political solution, emphasizing the need for political proposals that can lead to a solution. In fact, I quoted when I spoke in Parliament last during the Second Reading debate, Mangala Samaraweera's press interview where he said that the President had assured the Prime Minister of India that the final political proposals will be made public before the end of August 2006-two years ago. Of course, the President cannot defy the international community. He has got to keep on saying something. I saw the Prime Minister speaking on TV last evening. He was also striking a slightly different note.

You are hoping that you can show the world that the Tamil people have come to your side and that by political conviction, they have embraced the 'Mahinda Chintana.' Then you can tell the whole world "we are doing development, we do not need devolution, and everything is in our hands."

We urge the government to rethink this whole question. I knew this problem would arise and that is probably one of the reasons why I called for a division, to make sure who was where, and what the government's reaction to that would be. We are not 'koti'; I am not a 'kotiya.'

Of course, I negotiated with Chandrika Bandaranaike Kumaratunga. There is no question about it. I did not hide that. The whole world knew about it. The whole world knew that I was very seriously involved. The Prime Minister knew. So, sir, we are interested in the cause of our people. We are interested in this problem being resolved in a manner where our people will be secure, safe and will have a future in this country.

We still want that.

But, if you cannot give us the right to internal self-determination in our areas of historical habitation, then, international law says that we shall be entitled to the right of external self-determination. Please remember that! And, do not think that you can shout down reason, that you can shout down justice and that you can suppress us. That will be a mistake.

## Baked Whole Wheat Samosas (Pastry stuffed with curried potatoes, peas, and spices) Serves 12

### Ingredients

#### For the dough:

2 cups (500 mL) whole wheat flour

1/8 tsp (0.5 mL) salt

1 cup (250 mL) plain, non-fat yogurt

#### For the filling:

2 cups (500 mL) mini new potatoes, skin on, cubed

1 cup (250 mL) onion, chopped

1 tbsp (15 mL) canola oil

1 clove of garlic, chopped

1 inch cube of ginger root, peeled and grated

1 tsp (5 mL) cumin seed

2 tsp (10 mL) curry powder

1/4 tsp (1 mL) salt

1 cup (250 mL) frozen green peas

Cayenne pepper (optional)

Canola oil for brushing

### Directions –

**1. Dough:** Mix flour, salt in bowl. Add yogurt. Form into a ball. Knead adding more flour as needed. Wrap tightly. Place in the fridge until ready.

**2. Filling:** Boil the potatoes 15 minutes or until tender but not mushy. Drain. Set aside. In the same pot, heat oil over medium heat, add onion, oil, garlic, ginger, cumin, curry powder and salt. Cook until the onion starts to soften. Add peas and cook until heated. Remove and add the potatoes. Toss to blend.

**3. Assemble and bake:** Preheat oven to 425° F (220° C). On floured surface, roll dough into a long rope. Divide it evenly into 12 pieces. One by one roll each piece into a circle. Place about 2 tbsp (25 mL) of filling on each circle and fold over. Dampen inside edge with finger dipped in water and crimp edges with a fork. Brush sparingly with oil. Place the samosas on greased baking sheet and cook 15 minutes. Remove them from the oven. Reduce the oven temperature to 350° F (180° C). Flip the samosas over and bake for an additional 5-10 minutes. Serve with your favourite dipping sauce.





## Think Positive to be Positive



If the Christ child in the crib was not both God and man, then the man who underwent so much agony and died on the cross 33 years later could not have been both God and man and none of us would not have been redeemed. If we have not been redeemed, then we can never get into Heaven



Christmas is not just the vague commemoration of a single event that took place 2000 years in a remote village in Bethlehem. Paul said that "in the fullness of time God sent his son, born of a woman, to redeem us and to make us His adopted sons".

We are still living in the fullness of time, being redeemed by the precious blood of Jesus. The angel said to Joseph, "She will give birth to child and you must call his name Jesus, for He will save people from their sins." Mathew 1:21

In the Acts, St. Peter says "There is no other name under Heaven by which we can be saved"

This then is the wonderful exchange of form that took place at the Incarnation. God assumed human nature so that He may communicate to us a share in his divine nature or sanctifying grace. Without that grace, we could not enter Heaven and without the death of Christ, we could not have won back for ourselves the grace which Adam had lost.

Without the crib we could not have had the cross. Christ had to be born that He might die. We all die, but we are born for life. Christ on the other hand was born into this world so that He may die for us. Our salvation is not an automatic process but it was won for us by Christ.

If we are to benefit from the salvation which Jesus Christ won for us, we must live in such a way that we are worthy of it. That is the significance of life of Christ between the crib and the cross. He opened the gates of Heaven and showed us the way to get there. He did that by living according to the values of God. In His life, we can find every value.

He was detached from things of this world.

Perhaps it might be worth while dwelling on this fact

Paul tells us that whilst He was rich before He became poor for our sakes. The King of Kings chose to be born in the manger. Christ could have come into the world as a rich man, a man of immense power and worldly influence but He chose not to. It certainly teaches us a very valuable lesson. Today the world society in general has become so materially minded that men measure success in terms of making money. Yet when God came down into this world to show us what He considered a perfect and successful life, he came as a relatively poor man though he had all the necessities in life. He was born in a stable; He worked at a trade: He died almost naked on a cross and He said: "I have given you an example that as I have done so also you should do"

He never attended any institution of higher education. Yet all the scholars and philosophers are to this very day trying to comprehend his teachings.

He was not a business magnate. Yet even the wealthiest and the powerful in the world shudder at the mere mention of his Holy name. Yes the name of Jesus has made such a profound impact.

Let us remember the innocent baby born in an occupied and troubled land for the purpose of dying. It was a great paradox of history. A birth that found ultimate purpose of death. God who came to the earth in the most vulnerable form - Victory in defeat. Glory in humiliation.

The silent babe in the manger has so much to say to us, if only we will listen. If we have still have not listened let us make an effort to do so and transform our lives.

In a separate phone call, another gunman invoked the oppression of Muslims by Hindu nationalists and the destruction of the Babri Mosque in Ayodhya in 1992. Such calls were the only occasions on which the militants, whom initial reports have tied to the Pakistani jihadist group Lashkar-e-Taiba, offered a likely motive for their indiscriminate slaughter. Their rhetoric seems all too familiar. Nevertheless, it shows how older political conflicts in South Asia have been rendered more noxious by the fallout from the "war on terror" and the rise of international jihadism.

Pakistan, a nation-state founded on Islam, has long claimed Muslim-majority Kashmir, and has fought three wars with India over it since 1947. In the early 1990s, as an anti-India insurgency in Kashmir intensified, groups like Lashkar-e-Taiba became the Pakistani government's proxies in its war of attrition with its neighbor.

American pressure after 9/11 forced Pakistan's president, Pervez Musharraf, to ban Lashkar-e-Taiba, which had developed links with the Taliban and Al Qaeda. With General Musharraf's departure from office in September, it would be no surprise if this turned out to be the Muslim group's first major atrocity since 2001.

Pakistan's new civilian government is too weak to control either the extremist groups within the country or the various rogue elements within its military and intelligence. The American military was reported to have started bombing supposed terrorist hideouts inside Pakistan's borders even as General Musharraf stumbled to the exit. As its increasingly desperate pleas to the Bush administration to stop the attacks go unheeded, Pakistan's government appears pathetically helpless to its own citizens.

The sense of humiliation and impotence that this loss of sovereignty creates in Pakistan, a country with a strong tradition of populist nationalism, cannot be underestimated.

Meanwhile, India's influence in Afghanistan has grown as it pours reconstruction money into the country, as have its military ties with Israel. Add to this the Bush administration's decision to reward India with an extraordinarily generous nuclear deal and to more or less ignore Kashmir, where in August Indian security forces brutally suppressed the biggest nonviolent demonstrations in the valley's history, and recent attacks against the Indian Embassy in Kabul, the Marriott Hotel in Islamabad, and now in Mumbai begin to appear to be connected by more than chronology.

Meanwhile, Indian intelligence experts and others suspect that jihadists and disaffected members of Pakistan's armed forces and intelligence agencies have forged closer links and, as the string of recent bomb attacks on Indian cities reveals, are rapidly making new allies among the 13 percent of Indians who are Muslim.

It is very likely that Barack Obama will take a different tack from the Bush administration in antiterrorism efforts in South Asia. In an interview with MSNBC last month, he said that his administration would encourage India to solve the Kashmir dispute with Pakistan, so that Islamabad can cooperate with the United States in Afghanistan.

The idea that the road to stability in South Asia goes through Kashmir is as persuasive as the notion that the path to peace in the Middle East goes through Jerusalem. It is also equally hard to realize. Mr. Obama could act

quickly to stem growing extremism in Pakistan and strengthen civilian authority by ending American missile attacks within its borders and shifting the allied strategy in Afghanistan away from military force and toward political nation-building and economic reconstruction. At the same time, he will have to find a solution in Kashmir that endows its Muslims with a measure of autonomy while pacifying extremists in both India and Pakistan.

The new president's moral and intellectual authority will be vital in negotiations with India, which, like China regarding Tibet, adamantly rejects third-party mediation in Kashmir. Mr. Obama could point out the obvious to Indian leaders: they have paid a huge price for their intransigence over Kashmir, with an estimated 80,000 dead in the valley in the last two decades and a resultant rise in terrorist attacks across India.

Indeed, the outrage in Mumbai is the latest and clearest sign that the price of India's uncompromising stance on Kashmir has become too high, imperiling its economy as well as its security. Indian anger over the fumbling response to the brazen attacks disguises the panicky realization that there can be no effective defense against terrorists in a country with a long coastline and densely populated cities. The best India can hope for is to improve what Ratan Tata - the country's leading industrialist and the owner of last week's main terrorist target, Mumbai's Taj hotel - calls "crisis management."

As the economy falters (Mumbai's stock market has lost nearly 60 percent of its value this year), India can barely cope with homegrown violent movements like the Maoist insurgency in its central states, which Prime Minister Manmohan Singh has described as the biggest internal security threat to India since independence.

Pointing to the Bush administration's vigorous response to 9/11, Indian commentators lament that India is a "soft state," unable to defend itself from internal and external enemies. But India cannot turn into a "hard" state without swiftly undermining its secular, multicultural democracy.

The government has already experimented with draconian laws like the Prevention of Terrorist Activities Act of 2002, which among other measures allowed the police to hold suspects without charge for six months. It was repealed in 2004 after many abuses against Muslims were revealed. While these attacks may lead to calls for more tough measures, Indians cannot lose sight of the peril that 150 million Muslims would lose their faith in India's political and legal system. And it is obviously dangerous to threaten Pakistan, a nuclear-armed state, with war.

As president, Mr. Obama could conceivably persuade India and Pakistan to see the virtue of a political solution to Kashmir. But he would first have to set an example by rejecting the false assumptions of a global war on terrorism based primarily on military force - assumptions that the elites of powerful countries with restive minorities like India, China and Russia have eagerly embraced since 9/11.

"The people of India deeply love you," Prime Minister Singh said to President Bush in September while thanking him for the nuclear deal. Yet it is President-elect Obama who has the opportunity to create deeper and more enduring alliances for the United States in South Asia - and he should start with Kashmir.

Growing up in a small Sri Lankan fishing town, cricket changed Sanath Jayasuriya's life. But his association with the game and humanitarian work has also helped transform the lives of many others, says a CNN.com report.

The report further said:

"Without cricket I would have a small job in my home town. My mother is happy to say my name," Sanath Jayasuriya says.

His mother's pride in his success has an extra poignancy as Jayasuriya's fame in some part helped his mother survive the south Asian tsunami on December 26, 2004.

She was swept away by the first wave and only by calling out to get attention, saying she was Jayasuriya's mother, did a rescuer manage to spot her among the debris and destruction and pull her to safety.

Thousands of others, including many of Jayasuriya's friends and neighbors, were not so fortunate, and the impact that the disaster had on Jayasuriya's home-

town of Matara and many other parts of Sri Lanka is still felt today.

"Even now when many people hear the word (tsunami), they are still scared. When my mother hears it, she still can't run," he said.

After nearly 20 years of international cricket, the 39-years-old is now just as happy to put bowling attacks to the sword as well as working as a UN Goodwill Ambassador.

"Coming from Sri Lanka you need to do a lot of charity work and help in anyway you can. People love cricket and they look to cricketers, so as a team Sri Lanka also does a lot for charity. It's a personal commitment," Sanath Jayasuriya said.

On the pitch he has always been just as committed to helping his team. Making his international Test match debut in 1991 he retired from the five-day version of the game in 2007 having captained the Sri Lankan team for four years until 2003 and hit memorable centuries against every other Test side, bar the

West Indies and New Zealand.

However it was in the one day game that the all-rounder has really made his mark.

As part of the Sri Lankan team that won the World Cup in 1996 he played an explosive innings of aggressive shot-making that has been credited with revolutionizing the way in which batsman play the game.

In 2005 he became only the fourth batsman to reach 10,000 runs in one-day matches and his current stats stand at 12785 runs from 421 one-day internationals.

Having made his name in the 50-over version of the game he's still involved in cricket's latest revolution; the even shorter Twenty20 game that is being touted as the future of popularizing the sport.

"Cricket has changed all over the world. For the public to watch this game we need for it to change. You can now enjoy all that in around 3 hours (with Twenty20). The Indian Premier League (IPL) is good for cricket and good for cricketers. The one-

day game will be phased down."

Throughout his career he's shown his own resilience adapting to changing circumstances on the cricket pitch as well as off it. Before the 2003 World Cup he took the decision not to sign a contract with the Sri Lankan cricket board, citing the loss of potential earnings it would mean for him and fellow players.

Despite not being a confrontational personality, the tension between himself and the Sri Lankan cricket board led to his resignation from the captaincy in 2003.

With no Test cricket to play this year, Jayasuriya found himself omitted from the Sri Lanka squad for 2008 series one-day series against the West Indies.

However his fine form while playing in the IPL -- he ended its inaugural season as the third highest run scorer with 514 runs and hitting 31 sixes -- convinced the selectors to pick him for the upcoming one-day series between Sri Lanka, Bangladesh and Zimbabwe.

"Looking back I could never have thought I would have come this far. Buddhism helped me a lot. It says that you should take the middle path and you will never go wrong," he said.

"But I've done a lot of hard work and everyone, my family and coaches, have given me support. Without that I wouldn't have got here." When he does finally retire you can expect Jayasuriya to keep giving all he can to the game and causes he loves so much.

## M.N. Nambiar

### Legendary 'Villain' of Tamil cinema

Manjeri Narayanan Nambiar, or M.N. Nambiar, as he was generally known, passed away after a prolonged illness at around 1 p.m. at a private nursing home in Chennai on Wednesday, November 19. He was 89.

His remains were taken to his residence at Gopalapuram for fans and members of the film fraternity to pay their respects to the legendary 'villain' of Tamil cinema.

Rare individual

Nambiar was a rare individual who played villainous roles on screen while remaining a virtuous person with saintly qualities off-screen. Contrary to his villainous screen persona, Nambiar was in real life a teetotalter and vegetarian and, above all, a man who upheld ethical values without any scandal or gossip ever being attributed to him.

He was also a great devotee of Sabarimalai Shree Aiyappan and undertook annual pilgrimages to the shrine for over 65 years. He was one of those instrumental in popularising the comparatively unknown deity over the years.

He initiated mountain-trekking pilgrimages at a time when it was not 'fashionable' to worship Shree Aiyappan on the scale it is being done today. As a result, he was hailed not merely as a 'Guruswamy' but a 'Mahaguruswamy' by Aiyappan devotees.

Recently, former film actress and Tamil Nadu Chief Minister Jayalitha Jayaram worshipped at the octogenarian's feet and sought his blessings on her 60th birthday. Tamil superstar and Aiyappan devotee Rajinikanth is another who regularly got himself blessed by the Mahaguruswamy.

Ironically, Nambiar, in spite of his unblemished character, was perceived as a dastardly villain by millions of movie-goers on account of his on-screen image while others guilty of off-screen villainy were hailed as good men due to their screen performances.

In this, Nambiar was like P.S.

Veerappa, another actor who played the villain in Tamil cinema while being of exemplary virtue in real life.

**The 'villain'**

To those Tamil cinema fans like this writer who grew up on a diet of Tamil movies, the demise of Nambiar evokes a sense of deep sorrow. Just as much we relished the great heroes like M.G. Ramachandran, Sivaji Ganesan or Gemini Ganesan, we also appreciated the actors who played villainous roles opposite them.

Without these villains, the heroes could not make their mark. How could the lead actor perform his heroic deeds and win rounds of applause if the villains did not battle it out with guns, swords and fists or abduct the beautiful heroine?

Ramayana without Ravana or Mahabharatha without Duryodhana is unimaginable. Likewise, a Tamil movie without a villain or henchmen cannot be visualised. Villains were an integral part of moviedom.

Their impact was so great that the word 'villain' was adopted as a Tamil word 'villan,' with its amusing feminine equivalent 'villi' for 'vamp.' We jeered the villains and cheered the heroes.

The older generation of villains faded away and a new breed is taking over but then for some of us, 'old is gold' indeed. The villains who faded away or transformed into actors playing character roles have all gone one by one.

P.S. Veerappa, T.S. Baliah, M.R. Radha, S.A. Asokan, R.S. Manohar, O.A.K. Devar and S. Ramadas have all passed away and now it is the turn of Nambiar. He was the last of the great villains of Tamil cinema.

Each actor had a distinctive trait or mannerism. Veerappa was known for his raucous laugh; M.R. Radha for his swift change of voice from squeaky and high-pitched to guttural rasps; and R.S. Manohar would thrust his chest



out and impose his personality.

His speciality

As for Nambiar, his speciality was the way in which he would shake his head from side to side with a scowl and/or grimace. He would arch his eyebrows, expand his nostrils, screw up his mouth in a leering smile or merely purse his lips tightly.

This was enough to project a sense of evil and terror. Sometimes the lighting was dimmed to enhance the ominous threat. Chilling, powerful music in the background added to the fear. At times he would wear false, protruding teeth. When he grinned from ear to ear with those wolfish dentures, the effect was truly menacing.

Recollecting Nambiar's facial expressions revive nostalgic memories in this writer. Imitating actors is a phase many of us have passed through in childhood. Sivaji's dialogue, MGR's action, Veerappa's laughter and Chandrababu's slapstick are but some of these.

One of my favourite acts during childhood was to imitate Nambiar's threatening facial expressions. Upon hearing of his death I could not resist a few attempts before the mirror. Hmmm!

Apart from his facial expressions, Nambiar could also deliver his dialogue with appropriate modulation. He would lower or raise his voice when necessary. Even his hoarse whispers were terrifying.



Unlike many of the present actors, these 'oldies' could speak perfect, fluent Tamil with correct diction and pronunciation.

Nambiar was ethnically a Malayalee but like those of his era could speak other 'Dravidian' languages like Tamil well. Nowadays, even 'Tamil' actors and actresses cannot speak Tamil properly.

Nambiar could also play the 'cool' villain without engaging in melodramatic histrionics. He could also act the womanising playboy who seduces suavely and then ditches the unfortunate damsel.

**A true master**

Like most actors of the older generation he mastered sword-play, wrestling, stick-play, horse-riding, etc. This enabled him to play a realistic, swashbuckling villain on the screen.

It is as villain that Nambiar established himself as an actor. But the great thespian has played other roles like comedian, hero and character artiste on screen. Interestingly, the 'macho' Nambiar has also acted as a woman and girl on the stage during his formative years.

In a stage and screen career

that spanned more than seven decades Nambiar has acted in more than 850 films with different generations of actors. Most of them were in Tamil but some were in Malayalam and Telugu. He has also acted in a Hindi and English film.

It is difficult indeed to single out specific roles from a galaxy of stellar roles played out over several decades. Nevertheless, I shall mention some outstanding ones lingering in memory.

In 'Ambikapathy,' the classical villain was the poet Ottakoothan known for his rivalry with poets Kamban and Pugalenthi. Kamban was played by the veteran M.K. Radha while Nambiar played the crafty maternal uncle villain in 'Uthama Puthiran.' Sivaji played a dual role in this movie based on 'The Man in the Iron Mask' by Alexander Dumas.

Making an impression

Another movie where Nambiar made an impression despite a small role was in A.P. Nagarajan's 'Thillana Mohanambal,' where he played the Maharaja of Madanpoor who was eying the danseuse played by the gorgeous Padmini.

Nambiar also played villain in a historical movie made by Nagarajan starring Sivaji Ganeshan. This was 'Raja Raja Cholan,' where Sivaji essayed the titular role while Nambiar played Baladevar, a cunning counsellor. The clash between both was like an intricate game of chess and the verbal duelling was captivating. It was truly a clash of titans.

Nambiar also played the ambitious Dewan in 'Sivantha Mann,' made by maestro Sridhar. Sivaji was the hero. Nambiar also played villain remarkably in two other Sridhar movies. One was in 'Then Nilavu,' starring Gemini Ganesh and Vyjayanthimala. Nambiar acted as a sophisticated cheat and impersonator.

The other was 'Nenjam Marappathillai,' starring Kalyanakumar and Devika. In this film on the rebirth theme, Nambiar played a villain crazed with the revenge motive who tries to disrupt a union between two souls in two incarnations.

Nambiar has played villain to MGR in a number of films. Some of the notable ones are 'Ulagam Sutrum Vaaliban,' where he plays a karate expert assassin; another one was 'Vettaikaran,' where Nambiar played double as bandit and estate manager.

Nambiar played the bandit chief Kaangyan to MGR's Kathiravan in 'Puthiya Bhoomi.' The names were not so subtle references to the Congress called 'Kaangiras' in Tamil and the DMK with its symbol of Sun also called Kathiravan in Tamil.

Among other noteworthy MGR movies where Nambiar made a strong impact were 'Enga Veetu Pillai,' 'Naan Aanaiyittaal,' 'Theiva Thai,' 'Thirudathe,' 'Raman Thediya Seethai,' 'Pallandu Vaalaha,' 'Aayirathil Oruvan' and 'Arasa Kattalai.'

#### Early days

Nambiar, who was born on March 7, 1919, hailed from Chirakkal in Kannur District in present day Kerala state. The name Nambiar is a caste identity. The Nambiar is a sub-caste of the pre-dominant Nair caste in Kerala.

It is believed that Nambiar are a mixture of the Namboodri (Brahmin) and Nair castes. They are concentrated mainly in North Malabar in the Kannur region. The Manjeris are a Nambiar clan with claims of a martial lineage.

Young Narayanan Nambiar's mother tongue was Malayalam but he opted to join a Tamil drama troupe at the age of 13. He joined the Madurai Devibala Vinodha Sangeetha Sabha run by the famous "Nawab" Rajamanickam Pillai.

This was one of the famous 'Boys Company' drama troupes, so called because all actors were



mainly young boys who played both male and female roles. Young Narayanan Nambiar learnt to speak perfect Tamil and played many roles, including that of women.

His monthly salary then was just Rs. 3, of which he sent Rs. 2 regularly to his mother. Board and lodging was the responsibility of the troupe.

After three years of stage acting, Nambiar got his first screen break. A film company called Parameswar Sound Pictures produced in 1935 a film titled 'Bhaktha Ramadas' at the Ranjit Studio in Mumbai (then Bombay).

All the actors were males and several from 'Boys Company' were recruited. Nambiar, then 16, played two or three roles in the film. He was paid Rs. 75. The director was Murugadas Swamikal.

#### Unexpected boost

Thereafter, Nambiar did not get any more screen roles for many years. Meanwhile, his stage career received an unexpected boost when lead actor K. Sarangan quit Rajamanickam Pillai's troupe.

Now Nambiar began to get better and prominent parts to play. His drama career began taking off. Soon Nambiar passed teenage and sought a place elsewhere in more 'mature' troupes. He joined the 'Shakthi Nataka Sabha' of "Shakthi" Krishnaswamy.

One of the roles played by Nambiar was that of the cruel monarch in 'Kaviyin Kanavu,' a play about the poet Kalidas. S.V. Subbiah played the poet. The play, written by S.D. Sundaram, was a runaway hit. Nambiar's name gathered fame in drama circles.

It was then that Nambiar and Subbiah caught the eye of Producer Somasundaram of Jupiter Films. "Jupiter Somu," as he was known, placed both on a contract for his production company. This was in 1946.

Nambiar's first movie was 'Vidyapathy.' This was based on a detective novel written by Vaduvor Duraiswamy Iyengar and directed by A.T.

Krishnaswamy, who also wrote the screenplay.

Nambiar played an evil Brahmin role. His wife was played by M.S.S. Bhagyam. Subsequently Nambiar and Bhagyam were paired in other light, comedy roles. But the duo was not a hit like N.S. Krishnan-T.K. Mathuram or Kali. N. Ratnam-C.T. Rajakantham.

#### Big break

In 1947, Nambiar got his big break as hero in the film 'Kanjan' (Miser). It failed miserably. He was relegated again to secondary roles. Nambiar played 'friend' to M.G. Ramachandran in 'Rajakumari' (Princess). He also played the scheming uncle Shakuni in 'Abimanyu.'

Then 1949 saw the film 'Velaikkari' being made. The story and dialogue was by DMK founder and ex-Chief Minister C.N. Annadurai. A.S.A. Samy directed it. Nambiar played a dual role acting as the landlord's son and a crafty priest. His Harihara das Swamy role attracted widespread attention.

Nambiar's stock rose and the turning point came when the legendary T.R. Sundaram of Modern Theatres sought him out. He was placed on a contract as was the custom then.

In 1950, Nambiar acted as the conspiring Rajaguru in 'Manthiri Kumari,' for which the dialogues were written by M. Karunanidhi, the present DMK Chief Minister of Tamil Nadu. The movie was a roaring success. Nambiar had arrived.

This was followed by 'Thigambara Samiyar,' another screen version of a Duraiswamy Iyengar detective novel. M.N. Nambiar played the title role and adopted 11 different disguises for the film. It was a novelty then and Nambiar's acting skills were recognised widely.

In 1951, Nambiar played the villainous title role in 'Sarvathigari' (Dictator). It was a re-make of an English movie, 'Gallant Blades.' Nambiar's skill as swordsman was praised.

#### Interesting anecdote

Nambiar was one villain actor who could fence on equal terms

with M.G. Ramachandran. An interesting anecdote relates to this.

When the movie 'Aayirathil Oruvan' was being made in 1965, MGR sustained a cut on his little finger when a sword-fighting scene between both was being shot. MGR bled profusely. Nambiar apologised and MGR graciously accepted it.

One year later the film 'Arasa Kattalai' was being made. Another fencing sequence was being shot. This time it was MGR who nicked Nambiar's little finger.

As Nambiar was being bandaged, the actor wisecracked, "Settan marakkavillai. Mannikkavum illai" (brother has not forgotten or forgiven). MGR, of course, claimed it was an accident.

Meanwhile, Nambiar was also cast as comedian in some movies. Notable among them was 'Marmayogi,' but he did not click in comic roles.

In 1952, an English movie, 'The Jungle,' directed by William Burke, was shot in India. It was a USA-India co-production starring Rod Cameron and Marie Windsor. Nambiar also acted in it, playing the villager Mahaji.

T.R. Sundaram of Modern Theatres also tried out Nambiar as hero in the film 'Kalyani' in 1952 with B.S. Saroja as heroine. It was a disaster. Some years later Sundaram used him as hero in another movie, 'Kavitha.' That too flopped.

#### Road to success

But Nambiar began zooming to success as a villain on screen. He acted in a vast number of roles with different actors playing the hero. He also acted as second hero and also in 'grey' roles where the characters were not clearly black or white.

In some of these roles, Nambiar played the brother to the hero who teams up with the villain and then repents; in others he played the lover or husband to the hero's sister and is antagonistic to him.

Among such roles Nambiar made his mark as MGR's brother-in-law or lover of his sister in films like 'Arasilankumari,' 'Nallavan Vaalvaan,' 'Parisu' and 'En Kadamai.' In these Nambiar played opposite Padmini, E.V. Saroja, Ragini and L. Vijayalakshmi.

A Sivaji film where he played a role in similar vein and shone was as Kannan in 'Makkalai Petra Maharasi.' M.N. Nambiar was paired with M.N. Rajam (no relative).

A highlight of that film was the song 'Ondru Serntha Anbu Maarumaa? Unmai Kaadhal Maari Pohuma?' picturised on Nambiar and Rajam. It was composed by K.V. Mahadevan and sung by P.B. Sreenivas and U. Sarojini.

In some other films Nambiar

was depicted as a bad guy for most of the time, only to be revealed near the finale that he was in reality the good guy. But it was as the archetypal villain that Nambiar excelled. He played them all with consummate ease. He did not identify with any particular actor, director or producer and avoided being categorised as belonging to a certain camp.

Sivaji, MGR, Gemini, SSR, Anandan, Jaishankar, Ravichandran, A.V.M. Rajan, Muthuraman, Kalyanakumar, Muthuraman, Sivakumar, Bhagyaraj, Kamalhasan, Prabhu, Rajnikanth, Vijaykanth, Arjun, Prashanth, Vikram and Manoj - he acted with them all.

#### Renaissance

Nambiar had a filmy renaissance in 1982 when Bhagyaraj cast him in a refreshingly different role in 'Thooral Nindru Pochu.' The wrestling match between Nambiar and Bhagyaraj coupled with the drunken song 'En Soha Kathaiyai Kelu Thaaikulame' were the highlights of this film.

Thereafter, Nambiar played a number of character and comic roles. His last film role was with Vijaykanth in 'Sudeshi,' released in 2006.

He has acted in a number of TV serials. He has also appeared frequently on TV with his reminiscences of Tamil film. He was perhaps one of the oldest and most articulate actors of Tamil cinema.

He also spoke regularly on TV about Sabarimalai Ayappan. He embraced controversy in an uncharacteristic manner by refuting claims made by some actresses about Ayappan temple.

Nambiar did not forget his first love: the stage. He formed the drama troupe Nambiar Nataka Mandram and staged plays. Two such ones were a revival of 'Kaviyin Kanavu' and a comedy, 'Kalyana Supermarket.'

#### In tribute

He was a deeply religious man and led an austere, pious life, despite being in the tinsel world of Kodambakkam. He was admired and respected for this.

Nambiar is survived by two sons and a daughter. One of his sons, Sukumaran Nambiar, is a stalwart of the Bharatiya Janata Party in Tamil Nadu. Nambiar, however, steered clear of politics while being an ardent nationalist.

He was ailing for some time and was hospitalised. Nambiar passed away peacefully on November 19 at the age of 89. The last of yesteryear Tamil screen villains has breathed his last! We, his rasikas, can only think of the past and pay tribute to his memory.




