Eight terrorists were killed and five captured after a gun battle early yesterday with troops near a Catholic Church at Vankalai, in the Mannar district, the Ministry of State said on 6th January.

The Ministry said the soldiers had later found 36 sticks of dynamite, a quantity of spent and live 9 mm ammunition, several spent and live shotgun cartridges, eight hand grenades terrorist leaflets, books, cassettes and tapes.

The official release said that a patrol passing the Church on Saturday night had been fired at.

But a Reuter news agency despatch from Colombo, quoted a government spokesman as saying that the forces had surrounded the church on information that it was being used as a guerilla base.

The agency quoted local residents that the priest attached to the Church was missing after the raid.

Especially the firing at of several and killing postal employees on duty Murunkan Post at the Office on 4th December 1984, as well as causing injuries to, or killing of several other employees in the co-operative, transport and health services.

Enactment of various acts and promulgation of Regulations Emergency from time to time, so as to cause unbearable hardships to the daily life of all sections of the population and prohibiting the means of earning of tens of thousands of fisherfolk and other daily wageearners, thereby driving their families to the brink of starvation, as well evacuating several thousands of families from their residences situated in the so-called "Prohibited zones", especially consequent to the regulations promulgated on 29th November

Continued and increasing presence of the armed forces and the use of them to humiliate, harass, intimidate, terrorise and torture the civilian population as well as in arson rape, looting and destruction of properties.

Mass arrests of several hundreds of ordinary civilians, especially youths, by rounding up areas of resid-

ences and work-places, and the forcible removal to detention camps in the South-merely to find on whether any of them may be so-called terrorists.

Our Trade Unions also denounce the failure of the Government to find a political solution to the National Question, by the complete denial of the recognition of the right of self-determination of the Tamil speaking people in the Northern and Eastern Provinces.

# Stop The Carnage: MIRJE

The Movement for Inter-Racial Justice and Equality (MIRJE), in a Press Release issued under the names of Mr. Charles Abeysekera, President, and Mr. Indika Gunawardene, Secretary, states:

MIRJE has been active during the last five years seeking to provide inter-racial harmony on the basis of justice and equality in this country.

MIRJE has also continued to stress the need for a negotiated just political solution, as it is convinced that the ethnic problem cannot be solved by increasing military action or by repressive laws.

MIRJE therefore welcomed the negotiations that commenced at the end of last year, even though the format of the negotiations did not involve all the political forces of the country whose consensus would have been necessary for an acceptable solution.

MIRJE regrets that the conference has ended with no acceptable solution. The proposals for district councils, provisional councils and a council of state that had emerged out of the conference have been rejected by many organisations and individuals claiming to represent the Sinhalese, by political parties like the SLFP and found to be inadequate by the TULF.

In the absence of the schedules which are referred to in the draft

bills, there is still some doubts about the specific functions of these proposed units.

However, it is obvious that the proposals do not go far enough to satisfy the aspirations of the Tamil people for regional autonomy; neither do they appear strong enough to protect the fundamental rights of the Tamils, including their linguistic rights. In this sense, the proposals were not a solution to the problems which the conference was called upon to deal with.

The proposed laws might have offered a structure of decentralisation and devolution which could, through further honest negotiations, be invested with sufficient powers to be, at least, a solution of transition. It is unfortunate that the Government has now decided not to proceed with further negotiations.

MIRJE is convinced that the results of an abandonment of the search for a political solution will be disastrous for the country. The past few months have seen a tremendous escalation of military activity, on the part of both the State Security Forces and the Tamil militants.

The Security Forces have behaved with great ferocity not only towards militants but also towards the Tamil population at large.

Incidents at Mannar, Vavuniya, Mullaitivu and in numerous parts of Jaffna appear to indicate that the Security Forces conceive of the Tamil population as enemies.

The general Tamil population is also being subjected to new harassments in the form of security zones, prohibited zones, surveillance zones and inordinately long curfews.

As far as MIRJE can gather, economic life in the North is being seriously disrupted by these measures and the people are facing shortages of food.

On the other hand, the incidents on the Kent and Dollar farms and at Naiaru and Kokkilai indicate that the Tamil militants, who had so far confined their attacks to the Security Forces, are also moving against non-combatant civians. Whatever the explanations may be for these specific acts, MIRJE must deplore the fact that increasingly, non-combatants of both sides are becoming unwilling victims.

Any interruption or cessation of the search for a political solution can only make matters worse and result in new levels of brutality and carnage.

MIRJE would therefore strongly urge:-

1) All those Sinhala groups and individuals who have stood out against a political solution to reconsider their positions; any

insistence that devolution should not move beyond the district and the powers given to the DDCs is to ignore the present reality, to ignore the developments of the last two years; any insistence that Tamil militancy must be crushed before political negotiations take place is to ignore the real nature of the militancy and the political causes which have given it birth and sustained it.

- 2) The State and the Tamil militants to descalate the present level of violence and refrain from actions against non-combatants.
- 3) The State to organise its law and order operations so as to cause no more inconvenience to the civilian population.
- 4) The Government, all political forces and mass organisations to reinforce and strengthen the drive towards a negotiated and just political solution.
- 5) The Government to initiate a new stage of political discussions that will involve all the political forces in the country, including the Tamil militants.

MIRJE must sadly point out that the only alternative to a political solution is further carnage further loss of the democratic rights to which we have been accustomed, further brutalisation of our people and the strengthening of the authoritarian trends that are already evident in our society.

## 'HOW ABOUT A LITTLE COURTESY?'

Mr. W. K. Wickremasooriya of Ettambagoda, Panadura, has sent the following letter to the Minister of National Security, Mr. Lalith Athulathmudali:

I have heard enough about the brutality, arrogance and atrocities of the military against the innocent Tamils in the pretext of combatting "terrorism but it was only yesterday that I, as a decent Sinhalese held my head down on seeing for myself just a part of their brutality which in the North and the East can be easily imagined by any average Sinhalese on the face of their observations in Colombo.

On 4th December, in the early morning, I was travelling in a private bus from Panadura to Pettah. the entry point of the Colombo municipal limits near the Dehiwela - Wellawatte bridge, we were stopped by the soldiers at 5 a.m. for checking of identity cards. A soldier who was fully armed pointed his fingers from left to right screamed "Themela Aiya Kavuruth Innawatha?" instead of calling for identity cards decently.

Is this how your soldiers check identity cards of the passengers? Does not it sound that you are branding all the Tamils as Tigers.

Or do your soldiers expect that Tamils should not travel about or rather livamong the Sinhalese? Cannot your soldiers who are among the Sinhalese? Cannot your soldiers who are massacring innocent civilians and camourflaging that they are all terrorists confine their brutality at least to Tamil-speaking areas if at all you have hardly any control over them? At least let there be some decency in Sinhala areas so that whatever they say can be believed by us fools.

For instance, your soldiers can quietly check the identity cards of the passengers and leave them off whatever community they may belong to. Otherwise by such brutal shouting and identifying people as Tamils they are throwing a wrong impression in the minds of other passengers as if the government itself considers all Tamils as terrorists.

Let there be no further aggravation.

Will you please instruct your soldiers to exercise barest the minimum of courtesy if at all they refuse to be decent beings?

# PREPARE SINHALA MASSES FOR POLITICAL SOLUTION

"If the ethnic problem is to be solved, we must recognise the right of self-determination of the Tamils, withdraw the Army from the North and East, repeal the Prevention of Terrorism Act and release all those detained under it, grant a generalamnesty, withdraw the Sixth Amend ment to the Constitution and arrive at a political settlement on the basis of granting regional autonomy to the Northern and Eastern Pro-vinces", states Mr. N. Sanmugathasan, General Secretary of the Ceylon Communist Party in a press statement on the All-Party Conference fiasco,

The statement adds: "The APC was expected to evolve a set of proposals which could be a viable allernative to the demand for a sep-

arate state of Eelam. Whatthe Presidenthasproposed is simply an extension of local government but which is highly centralised and financially tied hand andfoot to the centre. The proposed provincial councils do not have the right even to run a school or hospital or have jurisdiction over a court in their area. The whole point is that the government is not willing to recognise the right of self-determination of the Tamil people.

"The representatives of the Tamil people have declared their willingness to accept any viable alternative to Eclam. They have also indicated that any genuine form of autonomy along the lines of Annexure 'C' to which President Jayewardene gave his assent when

he went to New Delhi in November 1983 for the Commonwealth Leaders' Conference, would be acceptable. Under these proposals, the Tamils can co-exist with the Sinhalese inside a single state but with regional autonomy and the right to run their own affairs in the Northern and Eastern Province. But the autonomy must be real.

"The leaders of the Government and of all Sinhala political parties must prepare the Sinhala people for such a reasonable solution instead of, as is being done now, rouse further communalism.

"In this connection, we must condemn the vicious, communal anti-Tamil hysteria and jingoism that is being generated in the country today. It is almost reminiscent of Hitler's campaign against the Jews. True, the concentration camps and mass deportations are not yet here although the beginnings are discernible.

"Even small children are being encouraged to collect for the National Defence Fund which is nothing but asking the people for money to buy arms and ammunition to kill the Tamil people. That is what it boils down to. One wonders what happened to the first Buddhist precept "I shall not take any form of life". I suppose it is meaningless asking this question at a time when Buddhist monks are dis-robing to join the Army!"

### CHURCH AND SOCIETY

(Extract from speech by Tanzanian President Julius Neyerere)

The purpose of development is man. It is the creation of conditions, both material and spiritual, which enable man the individual and man the species to become his best. This is easy for Christians to understand.

But though the Church—as a consequence of its concentration upon man—avoids the error of identifying development with new factories, increased output or greater national income statistics, experience shows that it all too often makes the opposite error.

For the representatives of the Church and the Church's organisations frequently act as if man's development is a personal and "internal" matter, which can be divorced from the society and the economy in which he lives and earns his daily life. They preach resignation: very often they appear to accept as immutable the social, economic and political framework of the present-day world. They seek to ameliorate intolerable conditions through acts of love and kindness.

When the victims of poverty and oppression begin to behave like men and try to change those conditions the representatives of the Church stand apart.

My purpose today is to suggest to you that the Church should accept the development of peoples means rebellion. At a given and decisive point in history, man decide to act against these conditions which restrict their freedom as men. I am suggesting that, unless we partcipate actively in the rebellion against those social structures and

economic organisations, the Church will become irrelevant to man. Unless the Church, its members and its organisations, express God's love for men by involvement and leadership in constructive protest against the present conditions of man it will be irrelevant totally.

For man lives in society, he becomes meaningful to himself and his fellows only as member of that society. Therefore to talk of the development of man and to work for the development of man must mean the development also of that kind of society which serves man, which enhances his well being, and preserves his dignity.

Thus development of peoples involves economic development, social development and political development and a determination for change. For the present conditions of men must be unacceptable to all who think of an individual person as a unique creation of a living God.

We say man was created in the image of God. I refuse to imagine a God who is poor, ignorant, superstitious, fearful, oppressed, wretched-which is the lot of the majority of those he created in his own image.

Therefore, all this means that kindness is not enough, pity is not enough, and charity is not enough. The men who are suffering from poverty, whether they are in the Third World of in the developed world, need to be helped to stretch themselves; they need to be confidence in their own ability to take control, and to use it themselves for their own purpose"

## WHERE WILL THIS TRAGEDY END?

(This is a translation of a political round-up in the 6th issue of the new Sinhala Weekly Janahanda.)

Mr. Lalith Athulathmudalie, the Minister of national Security addressing Parliment on 28th November 1984, stated that the Government had received information that Tamil militants who had set up camps in India are planning to establish an Eelam State on 14th January and that in order to prevent such a development it has become necessary for him to impose new repressive regulations.

The fact that a number of Sinhalese and Tamils lost their lives is no secret. None of us could be happy about this fact.

If one states that the democratic rights of the people of the North have in reality disappeared, no reasonable person would conclude that it is an exaggeration. Today in Jaffna no one can even ride bicycles without the permission of the police. In order to enter or leave Jaffna one has to obtain a permit. Without police permission no one could keep a guest in ones' house. During the prohibited times, it is not possible to take even a patient, in a serious condition, to the hospital.

Even in a country like Chile, where there is military regime repressive laws such as these have not been enacted.

One section of Mr. Athulathmudali's speech would evoke special attention. His statement to the effect that "people living in the North should leave the area and take a holiday in another part of the country" was flashed in big letters in the front page of the Lake House newspapers. But it did not explain what the National Security Minister was trying to get across by making such a statement. According to the normal tenets of interpretation usually adopted by the man in the street, it appeared to say that "We are going on a rampage of the North, so get the hell out of it and save your soul". If that was what the Minister meant where are we infact heading?

In the present climate that is prevailing in the country, is it possible for tens of thousands of Tamils living in Jaffna to leave their belongings and households and go away to another area with the hope of living there in peace and harmony?

It has become a common attitude to treat every Tamil man or woman as a Tiger or Tigress. How

many Tamils who show no interest in politics and who devote all their energies to their work or their studies have been taken into police custody? Even if they were released after being held in custody for several days and subjected to various forms of harassment, would their experience help to bring about unity and understanding between the communities?

Will these repressive laws affect only the people in the North?

What is the real object of the Media Committee's insane efforts to slander progressive elements of this country? The object of the Media Committee is to silence anyone who seeks to expose or even mildly criticise the antidemocratic measures of the Government in the North and

The newspapers have reported instances in the South where the Army had asked passengers to alight from vehicles and checked their identity cards. Those who did not possess their identity cards have been subjected to threats and harassment.

A statement made by the Chairman of the media Committee coupled with certain posters that had been put in Colombo indicates that we are on the threshold of an even more difficult and repressive period. It is difficult to believe that these posters could have been put up without the permission of persons at the very helm. The posters seek to show that there is a tie up between "the terrorists in the North and the extremists of the South"; the object of the exercise is to brand people with Left leaning ideas as extremists and thereby create a climate for the repression of people with leftist and progressive ideas who dare to criticise government polices.

After the President of the Media Committee said that a statement made by one Uduwarage Henry Perera proves that there is a link between "terrorists in the North and extremists of the South" what reliance could be placed on the communiques issued by this Committee as well as the Government which appointed it?

Janatha Vimukthi Peramuna had stated that Uduwarage Henry Perera was expelled from their party even before 1977. The attempt to lay the blame on the JVP for his actions is, to say the least deceitful. The Government is aware that this person does not belong to any leftist party worth speaking about. They do not know that they should disband their intelligence services.

Would it not be correct to say that Government Communiques which states that "20 terrorists died in a battle with the Security forces" or '30 terrorists were killed when they tried to escape", etc. without mentioning the number of civilians who lost their lives, create wear psychosis amongst people who have been used to lead relatively peaceful lives? Is the Government pursuing a shortsighted policy of obtaining the support for their policies by whipping up war hysteria?

We boast of a great history and a civilisation and therefore it is unworthy for us to endorse these policies of the Government.

The National Question cannot be solved by sticks, swords and guns. If the majority of Sinhala people are not persuaded to understand present-day realities and without seeking to arrive at a practical political solution to the problems of Tamil speaking people, we would find ourselves in an even more tragic situation.

Today millions of rupees are being spent on "defence". Can we afford to squander such colossal sums of money? How many sinhala and Tamil people have lost their lives? How far can this go on?

Ven. Wellawatte Gnanabiwansa, Thero addressing a seminar on the National Question on November 1984, stated that what we should adopt today is not the stance of Dutugemunu but that of Gajaba. That is to say that the Sinhalese who constitute the majority nation has the responsibility to find a political solution to this question. As he stated, there must be an immediate ceasefire, all parties involved in the fighting should immediately begin negotiations and thereby seek a peaceful solution to this problem.

We must abandon the policy of talking about a peaceful solution while at the same time pursuing a military solution.

Although certain Government statements alludes to an imminen Indian invasion the Indian Government has already stated that this is a baseless allegation. In any event, we must all recognise that no one can be happy about an Indian invasion actually taking place, or the continuation of policies that could lead to such a development.

We need not specifically spell out the adverse consequences of such a development. For decades there would be no peace or stability. Therefore all sections of people in this country are duty bound to do whatever in their power to seek a peaceful political solution to this problem.

#### THE Library is for Burning

We reproduce the report of S. Parthasarathy, which appearing in a recent edition of The Hindu

The "security forces" have to their credit a hatrick performance. First it was the Jaffna Public Library destroyed in 1981. Then came the burning of Hartley College Library earlier this year followed by the burning of the collection of 500 odd books belonging to one Nagamani Vijayaratnam in Point Pedro.

He (Principal of Hartley College) wondered whether the Government would with a sense of remorse arrange for assistance to restore and reconstitute the 100 year old library burntdown by security forces on September 1.

This raised the question of what compensation the Government paid for the wanton destruction, again by security forces, of the Jaffna Public Library in 1981 on the eve of the election to the D.D.C. The information that it had not heeded the recommendation of Lionel Fernando committee that Rs. 10 millions be paid by the State for re-building the Library and the President instead had just allotted just Rs.1 million from his relief fund for the purpose.

# MINORITIES MINUS SAFEGUARDS

Reference the news item on "Statutory Minority Rights,.." appearing in the SR of 17th November. Sir Charles Jeffries in his book "Ceylon - The Path to Independence" says: "The Soulbury Constitution had entrenched in it all the protective provisions for minorities that the wit of men could devise".

Subsequently, Lord Soulbury in his forward to the book "Ceylon—a divided Nation" by B. H. Farmer has said: "Nevertheless—in the light of later happenings—I now think it is a pity that the Commission did not also recommend the entrenchment in the Constitution of guarantees of fundamental rights, on the lines enacted in the Constitutions of India, Pakistan, Malaya, Nigeria and elsewhere".

As for the so-called guarantees in the Nigerian and Pakistan Constitutions written in by the departing masters, the little said the better!

As to what protection the Soulbury Constitution provided the minorities and how effective they were is well-illustrated by the "Kodiswaran Case". Mr. Kodiswaran, a Tamil in the Executive Clerical Service, declined to sit the proficiency exam in Sinhala and his increment was stayed in 1962. He thereupon sued the Government on the ground that the Official Language Act of 1956 transgressed the prohibition aganist discrimination provided for in Section 29 of the Constitution. The trial judge upheld the plea. But his judgement was set aside by the Supreme Court on the ground that a public servant cannot sue for his salary.

Mr. Kodiswaran appealed to the Privy Council, which set aside the Supreme Court's decision and directed that the Supreme Court should now rule on the constitutional question The Ceylon Government disposed of the case by abo-

lishing once and for all appeals to the Privy Council—a remnant of colonialism!

The Republican Constitution of 1972, authored by no less a person than Dr. Colvin R de Silva, a champion of the underdog, said goodbye to the so-called safeguards for minorities in the original Section 29 of the Soulbury Constitution, thereby ending a fallacy!

# JR VS MATHEW

For the record, we are publishing the full text of Jayewardene's President letter addressed to former Minister of Industries and Scientific Affairs, Mr.C.Cyril Mathew on 24th December and Mr. Mathew's reply.

Mr. Mathew. A copy of your com-Ministers, munication to Members of Parliament and others dated 18 th December was sent through a messenger and delivered to me on 21st December.

I spoke to you on the telephone on 21st December about a matter concerning Seruwila but you did not mention that you were making your views public and sending this copy to me. If you had I would have invited you to meet

I think that your public criticism of the All-Party Conference proposals now before the Cabinet or decision is a violation of the rules and conventions of Cabinet Government. On previous occasions have pointed out to me and your colleagues in Cabinet these rules, and cited passages from Sir Ivor Jenning's book on Cabinet Government when you thought that were violated.

Since you are familiar with these principles of Cabinet Government and you have deliberately broken them yourself, presume you have decided to cease to be one of my Ministers.

I have, therefore, appointed Mr. Denzil Fernando, M.P., as Minister in your place.

I regret very much that you should have taken this step which I did not expect from you, to whom I have

extended many lattitudes to express your views, though they caused much embarrassment to me, to your colleagues, and to the Party.

Your Excellency

I have to acknowledge receipt of your Excellency's letter of 24th December 1984.

Your Excellency has taken exception to my making public my views on the APC proposals.

The APC proposals were made public by Your Excellency even before they were made available to Cabinet of Ministers. Even up to date these proposals have not been placed before the Cabinet. "Your Excellency will remember that at the Cabinet Meeting of 12th December, Prime Minister categorically that the APC stated proposals were those emanating from the APC and were neither those of the Government nor of the United National Party and Your Excellency and the entire Cabinet agreed with the Prime Minister.

"I have made my views known to the Rev. Priests, Members of Ministers, Parliament and Your Excellency, by my letter of December 18, 1984.

"Your Excellency had explained to two groups of Members of Parliament the APC proposals and also placed these proposals at the APC on 14th December, thereby laying them open to the public to express their views. Accordingly I have expressed my views

in my letter of 18th December and am entitled to do so in the public interest as Your Excellency had already placed the matter for the views of the public. It was no longer a matter for the Cabinet or the party only.

"I was not present at the Cabinet meeting of 19th December due to ill-health. Your Excellency's statement at that Cabinet meeting that the APC proposals were to be placed before the Cabinet reached me only on the evening of 21st December, by which date I had sent my letter to Your Excellency and others.

I am unable to understand how my letter could be considered as a breach of Cabinet convention because I had not said anything against any Cabinet decision or Government policy.

It is regrettable Your Excellency thought it fit to take the action referred to in Your Excellency's letter without calling upon me to explain my conduct. Had such a step been taken, I would have placed the above facts before Your Excellency and thereby would not have given Your Excellency the opportunity to draw the erroneous presumption that I had decided to cease to be one of Your Excellency's Ministers.

Denzil "In appointing Fernando M.P. as Minister in my place, Your Excellency has on the basis of this incorrect presumption decided to remove me from the post of Minister Industries and Scientific Affairs in Your Excellency's Cabinet.

# 'Naked Military Occupation North'

(This is the text of a press statement issued by the Ceylon Teachers Union):

This Government which has been crushing the democratic rights squeezing the standard of living of the people from its very inception has demonstrated that it is now marching towards a naked military occupation in the Northern Peninsula, with the imposing of restrictions on the movements of the civilian population in the Jaffna District.

Putting the most inhuman Pass-Law in South Africa to shame, the government of Junius Richard Jayewardena, has totally banned the use of private vehicles including private buses and curtailed the movements of the civilian population to 2 hours in the morning from 6.00 to 8.00 and 2 hours in the afternoon from 2.00 to 4.00, apart from imposing curfew from 4.30 p.m. to 6.00 a.m. Notwithstanding this, the government has declared a stretch in the sea in the North and the East totally prohibitive.

All these, we are compelled to state have completely jeopardised very existence of the civilian population in the North. The economic life will be brought to a standstill and the civilian population will be pushed to starvation as most will be deprived of their means to earn a living.

Listing of occupants in house-holds and prohibitof ing the right to entertain anyone not listed, virtually breaks up family life and on the other hand, the government in effect, with all the newly imposed restrictions has brought the C. Cyril Mathew entire Tamil population in

the North under housearrest. This is a gross violation of the Human Rights charter adopted by the United Nations to which Sri Lanka is also a signatory.

We therefore wish to lay emphasis on the fact that these schemes of this government are not restricted to the North itself. The Trade Union offices that were sealed off during the 1980 July Strike still remain as they are. There is no necessity to write out the long list of opposition meetings that were broken up by government sponsored goon-squads. There was no shame on the part of the government to employ its goondas in trying to quieten the judiciary. This government that tried to implicate the left organisations with the '83 Tamil pogrom is now trying to make the public believe that the left is now in tow with the "Insurgents", through multi-coloured posters. The Prevention of Terrorism Act that was brought in to force at the expense of the North is now being openly used to repress the left organisations. repression begun in the North will eventually march on to the South.

The son of Mr. Vaithiyampillai Manuelpillai and Mrs. Rasiah Mary Theresa of Ilavalai, Fr. Bastian was born on 11th December 1948.

He was educated at St. Sylvester's Kandy, St. Henry's Ilavalai and St. Patrick's Jaffna.

He spent the minor seminary days at St. Martin's, Jaffna, and studied philosophy at St. Paul's Seminary, Trichinopaly, and theology at St. Paul's, Trichy and the National Seminary, Kandy.

He was ordained at St. Mary's Cathedral, Jaffna on 25th April 1975.

He began as Assistant Pastor at Mannar and later served at Madhu Church. From 1977 to 1981, he was Pastor at Manipay Mission, after which he was appointed to Vankalai.

He had been a very active social worker in Jaffna and Mannar Dioceses and a preferred person to give seminars to Catholic youth groups.

In Mannar Diocese, he was involved in the Human Development Apostolate: rehabilitation of the 1977 and 1983 refugees in various parts of Mannar.

When "men in khaki uniform" ran amok in November 1984 in Uyilankulam-Murunkan area killing about 200, including the Rev. Jeyarajasingam (who was killed near Thallady along with two others), he took the trouble to collect the corpses and made arrangement to bury them.

Statement by the Bishop of Mannar on the Recent Killtings at Vankalai.

We deplore the killing of the Catholic priest, Rev. Fr. Mary Bastian, parish priest of Vankalai, on the early hours of Sunday, 6th at Vankalai Mission House by the security forces. Fr. Bastian, aged 36, a dedicated pastoral worker, was deeply involved in the upliftment of the poor people in the Diocese of Mannar. The Catholics of Mannar and I bemoan this cruel, inhuman and unthinkable act against a man of God, as we hopefully await the release of his body for sacred burial.

We strongly protest against the Sri Lanka Broadcasting Corporation and other government mass media for beaming out false news that arms and ammunition were found in the Catholic Church of Vankalai and that the Church was used as a base to attack the security forces.

We also condemn the killings of innocent civilians in the village of Vankalai:

We strongly object to the unprecedented entry into the Convent of the Holy Family Sisters at Vankalai by the security forces.

The Catholics of Mannar and I, together with my priests, condemn all forms of violencd and earnestly request the Government to protect the lives and properties of the innocent citizens of Mannar. We are afraid that this sort of actions

He was fondly called as 'Basti' by the priests, not only of Jaffna and Mannar Dioceses but also his Sinhalese friends of Kandy Seminary.

He was the brother of Anton and Joe (USA), Anne Fatima (UK), brother-in-law of Mr. P. Ratnasingam (UK), Barbara (USA) and nephew of the late Mr. and Mrs. Sam Alfred of Jaffna.
