NATIONAL LIST NOMINATIONS

The petition filed by Sunanda Deshapriya, Director, CPA, challenging certain National List nominations to Parliament following the April 2004 General Elections was mentioned in the Court of Appeal on 26th of April 2005 and was postponed to 14th July 2005, pending the disposal of the petition filed in the Supreme Court by Mr. Ratnasiri Wickremanayake.

Public Interest Litigation

ON THE 100 METRE BUFFER ZONE

A team of researchers from CPA visited tsunami affected areas in Hambanthota, to ascertain whether people of that area were interested in moving back to their original places of residence located within the 100 meter buffer zone. CPA is considering assisting any interested parties in litigation, but the idea is on hold, considering uncertainty over buffer zone rules and lack of clear will to prosecute on part of affected people interviewed.

Study on Demand Side of Child Trafficking in the Fireworks Industry

Social Indicator was commissioned by ILO to conduct a survey on the demand side of child trafficking in the fireworks industry. This study identifies the factors and the labour market forces that create the demand for children to be exploited. The draft report was completed and submitted to Transparency International (SL) in June.

Women, Land and the Law



This research conducted by the CPA, for CARE international, focuses on the difficulties women face in owning and accessing land and property, legal issues related to the topic, the nature of land disputes, the modalities of their resolution and availability of assistance from governmental and non governmental agencies.

The draft report of this study was presented at workshops in Jaffna, Batticaloa and Colombo in May.

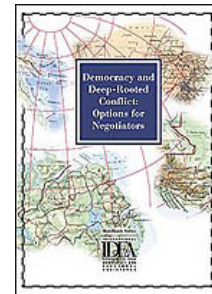

PEACE UNIT

As a part of the Donor Working Group Project, a field visit to Mannar was conducted on May 27th-29th to look into the issue of conflict-related IDPs. The Team consisted of Dr Devanesan Nesiya, Mirak Raheem, (Peace Unit) Bhavani Fonseka, Shehana Gomez, Nikhil Narayan (Legal Unit) and Krishnamurthy (SI). The Team met with a number of stakeholders including the GA and local government officials, the LTTE, NGOs and local community leaders. The principal issues were the situation of Muslim IDPs, Tamil refugees in India and their efforts to return to Sri Lanka.



Social Indicator launched the third wave of its KAPS survey in June 2005. 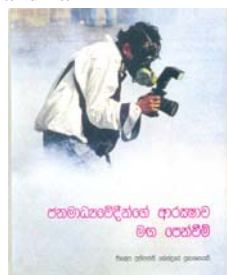

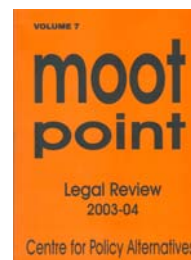

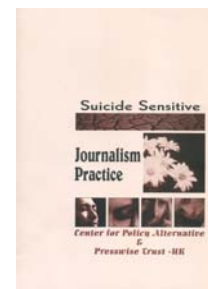
