The Executive Committee of the University Science Teachers' Association, Jaffna, deplores the attempt made by the publishers to present this article as a "University Report' which represents

the views of the academics of the University of Jaffna. The Committee wishes to disassociate itself from the view expressed in the article".

Dr. S. K. Sitrampalam of the Arts Faculty and President of the University Teachers' Association, Jaffna, also denied that the article was written by any member of the University Teachers' Association, Jaffna. He too expressed the disagreement of the University Teachers' Association, Jaffna with the

view expressed in the article. It is further learnt that University Teachers' Association (Human Rights) was formed many years back in Colombo but that Association had ceased to function a long time age after the key officials left the Island.

University Teachers expressed the view that the article does not represent the views of any University Teacher in Jaffna and has not been authored by any University Teacher in Jaffna.

Suicide Tigers Enrich Cricket Parlance

In the test match played last week between the formidable West Indies and the M. C. C. Cricket teams in England when the West Indian Captain and number 2 batsman V, Richards came in to bat and faced the bowler the English Captain Graham Gooch placed a fielder too close to the batsman at a silly mid - of sposition. Kokkatticholai Inquiry Commission Fails to evoke Public Confidence

The appointment of a Commission of Inquiry to inquire into and report on the army atrocities that took place recently at Kokatticholai in the Batticaloa District failed to evoke any public confidence. It is reported that people in the area have expressed their grave doubts in the work of this Commission and have, stated to the BBC correspondent in Colombo that the Commission would only help to suppress the news of atrocities indulged in by the Army in a number of villages action was taken against the in the Kokatticholai area offenders in similar army grave doubts about the

It is further reported that an American priest Rev. Fr. Miller, living in Batticaloa has told the BBC correspondent that so far as he knew 123 Tamils have been killed and 49 have been seriously injured.

One hunderd and forty nine houses have been completely destroyed and 342 houses severely damaged, Rev. Fr. Miller has said that this was a major calamity.

Rev. Fr. Miller has further said that because no legal becoming public. excesses and atrocities at the

same place earlier, the present incidents took place. It is likely that similar incidents will take place in the future

Fr. Miller had told the BBC correspondent that sixty seven dead bodies were found buried and 56 bodies of dead persons were missing. Many dead bodies have been burnt and the identity of the deceased cannot be datemined.

Another person told the BBC correspondent that he saw personally women being dragged out of their homes

The name of our homeland in Roman Script

Eelyom is round the corner. We must settle some preliminaries. To begin with, we must settle on the spelling of the proper noun, the name of our homeland in the Roman Script, which is the International Script. There is only one letter '1' to service for answering the phoenetical shape of w, on, up in the Tamil Script.

At present various spelling patterns are in use. Professor Suntheralingam began with the pattern Eylom. Probably he had not given much thought to it; otherwise he would have made it ee. The TULF used the patern Eelam. Because TULF was the elected parliamentary party many people followed that pattern. It results in forci. gners pronouncing the proper noun of our homeland as in cel. Indra Gandhi and many foreigners also pronounced it as in cel.

Nestor adopted at the start, following Suntheralingam's lead, to write Eelyom. But an Indian friend of his corrected it to EELYOM pointing out that the letter which modifies the sound of I should follow and not precede 1. Thus it will be seen that the correct spelling is EELYOM.

It represents the sound of up and Ih the sound of on while 1 represents the sound

Of course linguists have certain rules for rendering into Roman Script words of other languages. According to this process the spelling would be

EEZHOM.

and would be rather pedantic and confusing to the laymen. It cannot be said that these rules are widely accepted. To try to spell thus would be analagous to the Tamil Pundit who cried, when his mother fell into the well, the alarm 'Enrasy Koopathul. Hope no pedantry invades the spelling of the proper homeland noun of our Eelyom.

Open or Clandestine

It seems that D. M. K. leader Karunanithi does not know the A, B, C of politics. If he accepts responsibility for the Party's almost total failure at the polls, logical sequence is to resign from the Party leadership, or more appropriately, to take steps for a complete change in the party's policy.

Resigning from the seat in the Legislature is a non sequitur. There is no relevance in resigning the seat in the Assembly.

As everyone knows, the

congress and A.I.A D.M.K. accused Karunanithi and his party of giving clandestine support to the liberation tigers. It is now well known that New Delhi did give clandestine support to the militants in the shape of arms, training facilities etc: Since elandestine support is posed as the issue, the proper course for the D. M. K. is to make the Issue open and public. The correct course would be for D. M. K. to pose before the Tamil Nadu electorate the question whether India should support the right for Swaraj for Eelyom Tamils or not. If the issue is posed thus, the opposite issue would be seen to be:- Should India support the Sinhala genocidal Imperial war against the Eelyom Tamils? That is the issue which should be placed before the Tamil Nadu electorate. There should be no question of clandestine support. The issue should be open support for the Eelyom Tamils or for the genocidal Sinhalese. D. M. K. should have brought out the issue openly and frankly in the

above form. Rajiv Gandhi destroyed about seven thousand innocent Tamil civilians and about a thousand Liberation Tigers in addition to enormous damage to property in the process of giving clandestine support to the Sinhalese for purpose of subjugating them to Sinhala Imperium, Let the D.M.K. bring out the issue of Eelyom Tamils into the public inst d of allowing the matter to remain within the clandestine plane.

"Nona Mathaya" Jayalalitha

Nona Mathaya Jayatalitha does not seem to understand International norms or law. If a country accepts refugees from another country as such, it cannot force them back to country from which fled as refugees. It is best to remember that when the question of Eelyom Tamil Refugees being sent back to the Island arose Indra Gandhi posed the question whether they were to be sent back to be butchered. She used the word to be butchered. Let not Nona Mathaya Jayalalitha in her frenzied support to President Ranasinghe Premadasa forget past history.

Such refugees from Lanka cannot be ejected unless they have committed some offence

against the Indian law. It is best to remember that when Rajiv Government proceeded to send Mr. S.C. Chandrakasan out of india and put him on a plane bound to U. S. A to which country he had a multiple visa, he refused to get down from the plane and India had to bring him back. In the meantime Mrs. Chandrakashad filed a writ application in India's courts and the Government India realized that it could not under Indian law eject him from India because he had not committed any offence against Indian law.

Let Nona Mathaya Jayalalitha halt their campaign against Eelyom Tamils following Rajiv Gandhi's policies against the Tamils. The emotional wave played into her hands but when the issues considered dispassionately, she would not gain by identifying herself with Sinhala Sri Lanka.

Jaffna Citizens' Committee Calls for concrete and clear proposals from President

The Jaffna Citizens' Com, mittee has called upon the President Premadasa to put forward concrete and clear proposals for negotiations to solve the ethnic problem.

Much time, resources and invaluable lives have been lost in the party political chessboard",

The Citizens' Committee has, therefore, called upon President Premadasa to put forward concrete and clear proposals which will form as basis for negotiations and invite these concerned to discuss and arrive at a lasting solution which will meet the aspirations of the Tamilspeaking people.

In the field of self-employment projects, the Association has found openings in transiation work, welfare activities in many voluntary welfare organisations and Institutions in the distribution and determination of gifts and donations to displaced persons. building projects, in the re-settlement plans for the displaced and the refugees in several nurseries and indoor and out-door medical and health-care projects in the Jafina District.

A house in the area was also damaged but fortunately no one suffered personal injury.

An Open letter to

President Ranasinghe Premadasa

Dear Mr. President.

You are the eighth politician to head the government in your country. Except for the first prime minister of Ceylon at the time independence in 1948 - Don Stephen Senanayake - who, despite the harm he did to the Tamils, both Indian and indigenous, had a smooth unchallenged 4½ years of Power, and a stop-gap prime Minister in W. Dahanayake for 6 months, all six of you were called upon to solve - repeatedly what has been known in the Sinhala political lexicon as "the Tamil problem."

Thirty - five year old problem

This problem - solving has now gone on for 35 years. and in the process at least 35,000 Tamil lives have been plucked away by the six of you (an average of 1,000 a year), and at least 350,000 Tamils you have made them homeless, virtually Stateless (except the passports), vagrants, wanderers and refugees in their own homelands as well as in the five continents of the world. Between the six of you, you represent Oxford, Cambridge, the Upcountry and Lowcountry Sinhala aristocracies, and in your humble your case beginnings. And certainly. all of you were Sinhalese, and significantly, Buddhists, (even it some of you were converts from Christianity) representing a fairyland of rolling

charge something that you cannot posibly deny - that between the six of you, over a period of 35 years. you have failed to find a solution to your own problem. Not the problem that afflicts the Tamils themselves, because we Tamils have found a solution for it. At least we know what the solution is. But you Don't Know the Solution to Your Own Problem! Does not make you, as the surviving President, representing the Sinhala Buddhist people and the Sri Lankan State, if not ashamed, at least inadeq-

What did you do with a glorious patrimony?

The island of Ceylon. Mr. President, has long been eulogised by foreign travellers, and in tourist brochures, as a Paradise on Earth, as a Garden of Eden. That was Nature's blessing, certainly you Sinhala peliticians had no hand in Your country at the time of independence had a flourishing export economy Rubber Tea, in Coconut, which of was the inheritance derived from British colonial entreprenurial skill and the sweat of the oppressed Tamil labuorers. You had a readymade infrastructure for a flourishing tourist industry, a fine network of roads and railways, sun--swept marble beaches, a

We are a nation -We have found a solution for our problems

religion that stands Ahimsa, Tolerance and the Middle Path.

What have you to declare after 35 years? For your Sihala manhood and Buddhist plety? Your leadership incompetence? Your political bankruptcy? Your racial inbred intolerance? Your chauvinism? Your hypocrisy in parading your religion? Your pretence as democrats? Even if we are kind to you and say that you are not guilty of any of these (all six of you including the three living ones), you have to plead guilty to the bottom-line verdant valleys, rivers and water - falls. You had no share in that either. To what you exhibit to tourists as historical ruins of an ancient civilisation, you have now added more ruins in the North and through bombing shelling - not as examples of civilisation, but of the lack of it. You were presented with a multi - ethnic, multi - lingual, multi-religious mosaic of peaceful human presence with which you could have raised a model, secular democracy that would have been a showpiece to show the world. What have you done with it?

Mr. President within these fifty years of independence, what have you politicians done, with all this glorious patrimony? What was once known as a land of milk and honey, you have made it into one of blood and poison. Instead of progress, you have only made your country slide into regress. Instead of touching the Highest Common Denominator in the collective Sinhala psyche, you kept on reaching for the lowest. But as the one Sinhala politician who we still believe is probably more sensitive to the terrain and temper of the people outside the insensitive seat of power in the pretentious wealth -flaunting metropolis Colombo, you should realise that the country over which you think you preside, is not the same as the one in which you and we are born. Or the one which you took charge.

No Challenge

Talking not in the nature of a challenge, but in plain, realistic valuation, neither your government, nor any government to follow, could possibly exercise any more that kind of "sovereignty" over the north and east that you have in mind (as reflected in your recent Communique dated 3 January 1991 -Page 12); which "sovereigmeans something totally different to the Tamils and Tamil-speaking Muslim people who live there. To them, it makes no sense, other than subjugation. We are not blaming you alone for that. After all, you are not only a pillar of the Sinhala-Buddhist Establishment; you are also a prisoner

The Sri Lankan State itself has been founded on a bedrock of mythology, harking back to the Mahavamsa and Dutta Gamani, and nourished on the concept of Sinhala-Buddhist exclusiveness. After 50 years of damage to the mind-both Sinhala and Tamilit is now too late to put the clock back. How can we Mr. President when your Sinhala primers and history books have been telling once unspoilt little Sinhala children that the Tamils are aliens, they are enemies, they are descendants of South Indian invaders, they desecrated

your ancient Sinhala civilisation and that it was your Sinhala Buddhist hero Dutta Gamani who rescued your land, language and religioa from the clutches of the Tamil marauders? Many of those children who were taught all these at their tender age thirty, forty years ago. are the very ones who are today's grown - ups, deciding policy, wearing yellow robes and dictating the course of your history.

"Afraid? why, I'm only too willing". There ARE some Tamils, Mr. President, who may view the world like that shepherdess. By all means, assimilate them and keep them within your fold. But that is no excuse for you to assume that they represent Tamil thinking (you assume so in your communique), or represent Tamil pride, Tamil feeling or the collective Tamil consciousness.

Every Island is not a nation -Nordoes an Island have only a nation

If you want to sustain a Sri Lankan State that is Sinhala and Buddhist, in which others of differing ethnic or religious persuasions cannot expect consideration as equal partners (on the basis that they are numerically smaller) you are welcome to that kind of State, blessed by the Buddha. Where you and your predecessors in office have erred, is in trying to assimilate peopel who are neither Sinhala nor Buddhist and annex territory where neither Sinhala is spoken nor Buddhism is practised; where the people have their own language, their own religions, own traditions, own culture, own ethos, own ways of life and own territory, all of which are legally and morally sufficient to constitute them into a nation - a separate Tamil nation. Perhaps you are confused into thinking that a chance geographical formation that happens to be an island makes it one nation like many external observers who suffer from that metaphysical illusion. In which case, imagine the number of nations that we have around Ceylon - Delft, for example. Or Kachchativu or Analativu: or Eluvaitivu... Or think of the neighbouring Maldives, with its 1000-odd island nations! No. Mr. President, there is no Godgiven law nor man - made rule that says that every island is one nation or that one island cannot contain two nations of peoples.

No Rhetoric

There was a character in one of Marlowe's plays - a shepherdess who when asked whether she was not afraid of being raped, tossed her head in defiance and said:

Please do not think we have been indulging in any rhetoric in saying all these. We certainly appreciate the fact that on your part some rhetoric, some face - saving, are unavoidable: when an established government is called upon to respond to a unilateral ceasefire announced (rather impudently we think) by a group of armed men described variously as 'guerrillas", "separatists", "tercorists", "fascists", "murderes" and so on. As for rhetoric you have in your Defence Minister Ranjan Wijeratne a regular practitioner, an accomplished master of the spoken word, a man who in looks can pass off as a benign Bishop but in words sounds most of the time like a cross between Attila the Hun and Bob Hope.

But should we not mix the rhetoric with some bold thinking, some tangible action at this point of time when the country is fast reaching the cross-roads. We are afraid Mr. President that whatever steps you take now and in the near future, or the steps that you don't take, may determine the future course of history for all time. And That Mr. President is not rhetoric either.

After a 35-year period of subjection to physical violence and humiliation (beginning with that day at Galle Face Green in 1956) what hurts the Tamils Mr. President is, more then the corporeal injury, the fact that the guilt of the ethnic crime has yet to seep into the collective sinhala consciousness. We do not expect from you therefore or from

International Organizations must Continue Service

Citizens' Committee tells President

The Jaffna Citizens' Committee has condemned the aerial attack on UNHCR and MSF vehicles and has told President Premadasa that the services of International organizations are very much needed amongst the affected people and requests the President to ensure the working of these organizations unhindered by the armed forces of government.

The Citizens' Committees' letter reads as follows:-

We have time and again complained to your Excellency the indiscriminate bombing, shelling and straffing from helicopters on civilian targets,

Despite our cries the forces have always been claiming that their attacks had been very accurate on LTTE targets. The number of civilian deaths and destruction caused to temple, churches, schools, houses and refugee camps have proved our claims beyond any doubt.

Recent attacks on the UNH CR and MSF vehicles injuring foreign personnel who have come into our country to do humanitarian services cannot be justified or condoned under any pretext.

It is our suspicion that the attacks were wilful and, by no means, accidental as all the vehicles concerned were flying internationally accepted

flags for protection which no airman could have failed to see. Besides the movement of these vehicles in the area concerned were - according to reports - made known to the forces in advance.

We are concerned very much in this matter and it is our carnest desire that these International organizations must continue their services in these areas among the people who are suffering beyond description.

Please therefore take all steps to ensure that incidents of this nature do not take place in the future and make it possible for the foreign personnel to continue their invaluable services to the suffering people.

Mr. Premadasa has named a three man Commission to sit in judgement over the Kokati. cholai carnage in which innocent civilians Comprised of men, women and children were killed mutilated and raped by the Sri Lankan forces as a retaliation against the loss of three of their men in an operation against the L. T. T. E.

The purpose of a Commisslon is to convince the common man the real cause behind the commission of an offence, be it against a State or its subjects and where the laws of the land have turned a Nelsonian eye. The three Commissioners have been issued with the terms of the Commission and based on those terms they have to enquire and report. Therefore the mission of the L.T. T. E., in their struggle to liberate the Tamil community from Sinhala Chauvinists remains self explanatory.

cation to protest against the daily increasing killings of innocent civilians and widespread damage to private houses and Public buildings by purposeless Artillery Shellings and shellings by gunboats.

It has become a regular practice on the part of the Government Security Forces to engage in indiscriminate

Artillery Shellings fired into thickly populated areas lying 15 to 20 Kilometers away. These vicious attacks take place throughout the day and more at nights. There were hundreds ot cases where civilian lives and houses were destroyed by these shells.

Recently an artillery shell fired from the Palaly Camp fell on a house with a large; family at Naranthanai in Kayts killing seven of its inmates - a husband and wife (65 & 60 years respectively) and five children ranging 4 to 14 years.

These poor victims were reported to be having their dinner at that time.

Confusion worse Confounded

Sometimes back we had news that President Premadasa gave an ultimatum to the members of the All Party Conference (APC) He told the APC to give its own proposals for the solution of what is described in Sinhala quarters as the 'national problem' by a certain date and proceeded to say that should the APC fail to do so the government would come out with its own

The deadline has come and gone but neither the APC nor President Premadasa has come forward with any proposals.

In the meantime President Premadasa got the Ambassadors of three European countries to enlighten the members of the APC in regard to ideas for the solution of the 'national problem'. And we have it that the Ambassadors also did say something to the members of the APC to enlighten them in regard to finding ways and means of solving the 'national question'. Still the APC is so sterile that it cannot conceive or bring forth anything.

It is not only the APC but all Sinbala politicians are in that pathetic position and unfortunately so because of deliberate choice on their own part.

Week before last, on Thursday, when parliament met and the question of the extension of emergency came up for discussion several parliamentarians started speaking on the 'national question' and every one appeared to speak for the sake of speaking without being 'caught' in any position. We had SLFP speakers offering co-operation to the Government all the time without themselves indicating in any way the extent to which they would co-operate but betraying all the time their hidden intent to make the 'national question, an election issue to defeat their opponents.

Minister Ranil Wickramasinghe asked - let it he noted that he never suggested - whether a federal form of Government would not be an appropriate solution.

The SLFP rose immediately to the occasion. One M. P. frem the SLFP charged that the Government was attempting to introduce a federal form of Government and declared that the 'people of this country' would never permit such a move.

Prompt came the denial from the benches and Minister Wimal Wickremasinghe stated that the Government would not introduce a form of Government which is contrary to the Constitution - the Jayawardrene constitution fof course.

And State Minister M. S. Sellasamy was heard to appeal most pathetically and equally idiotically to the Opposition to discuss the matter amongst themselves and come to some agreed conclusions and then speak to the Government. And so ended the debate without anyone putting forward any concrete proposal but every one wanting the other to bell the cat - not of course to solve the problem but to get an advantage over his opponent to weild a weapon at the bustings!

But President Premadasa's confusion seems worse confounded. He originally wanted three European Ambaasadors to enlighten the members of the APC but now has made a right about turn and seems to be content with the insular wisdom of the Baudha Sinhala fundamentalism. He has declared at Kamburupitiya that no foreign advice or assistance is needed to solve the 'national question'. One does not know whether the word 'foreiga' in Mr. Premadasa's terminology has to be given a restrictive meaning as referring to India only or its ordinary meaning One does not see any reason why he should have bothered the Amb assadors of the three European countries referred to. to lecture to the members of the APC, if he thinks that no foreign, advice or assistance is necessary.

Despite challenges from the Opposition, Mr. Premadasa himself keeps mam as to what his own solution is to the 'national question'. Everyone not excluding Mr, Premadasa keeps on rambling general sentiments which take no one anywhere.

They are all not merely confused but confounded. They do not have any solution to meet the Tamil demand.

Then why not agree to the only sensible alternative now available? Leave the Tamils severely alone as they demand and be rid of your headache for all time.

UNDERGRADS PROTEST-

to President

Undergraduate attached to the University of Jaffna took out a protest demonstration on Monday June 24th, 1991 against the Sri Lankan Government's recent genocidal attack against the Tamils of Kokatticholai in the Batticaloa District and against the attack on University students by the armed forces of the Sri Lankan government.

The Jaffna University students marched out from the University premises in procession carrying placards and banners. The procession went through the important roads and reached Jaffna Secretariat where they handed over a memorandum to the Additional Government Agent, Jaffna to be forwarded to President Premadasa. Later the students went in procession to the office of the

students ICRC Team at Jaffna and handed over a memorandum to the ICRC Team leader

> The memorandum presented by the University students states that the Tamils are being continued to be rendered refugees by the actions of the armed forces and Tamil women being subjected to sexual assault by Muslim thugs. The genocidal attack against the Tamils started in June last year and is continuing to date.

> The memorandum refers to the large scale arrests of Tamil youths and refers specifically to the case of a final year Jaffna University student named Jayascelan being arrested by Muslim thugs and army personnel at Vavuniya on June 8th, 991. Nothing is known of

this student to date. The memorandum also refers to the killing of some students of the University after the war broke out last June. Arumainayakam of Kattaiparichchan, Kirupakaran of Akkaraipattu, Thayalan of Thuraineelavanai and Joseph Jeyarai of Kayts are some of the students who have been killed by the Sri Lankan Army. Another final year student, Mukunthan, had been seriously wounded, when the Army shot at him at Vavuniya.

The memorandum also states that a number of University students from the occupied areas are unable to continue their studies because of army action. The memorandum calls upon President Premadasa to stop forthwith the military operations in the Northeast.
