



Chairman's Message

Dear Collegues, and Members of TWAN

I have great pleasure in wishing you a Happy and Prosperous Tamil New Year on behalf of TWAN. As you no doubt would have gathered by now, TWAN was formed in 1986 principally for the purpose of helping Tamil



refugees and also to unite Tamil Community. Prior to the formation of TWAN, regretfully the Tamil Community unlike other minority communities, was represented by various splinter groups. We are extremely glad to report that we are atlast able to bring everyone together under one banner and that is 'TWAN'.

We have faced many difficulties in the past but have been able to withstand it because of the united force of our members. This is a voluntary organisation which was formed for the public out of the funds of the public and hence we recognize the importance of spending what little income we have for the best purpose possible. But because of the financial stress unfortunately we have not been able to undertake some important activities. Our sole aim is to cross all hurdles with your help. This organisation recognizes the difficulties which are to be faced by the Tamil Refugees during the year to come. We will be failing in our duties if we do not help these poor souls when they need us most. We would therefore appreciate your co-operation and guidance in this matter.

We are also aware that the next financial year is important for all of you because of the recent legislation regarding poll tax. We aim to study this matter at great length and advise you, as we have been doing in other matters. Our aims are numerous but what we could achieve is limited because of the financial stress but we have done all we could to pin point the most important matters and allocate our time and energy for it. During the past financial year we spent a great deal of time in studying the recent DHSS regulations and advising you upon it. Many of you have gained by it but we appreciate that there are still some of you who have not made use of the resources available to them. Although many of our members volunteer their services free of charge, this organization needs funding to survive. We hope that you would keep on encouraging us by donating freely and also by helping us physically.

I would be failing in my duties if I do not thank those who have been helping us in the past. The local Borough Councillors and other well wishers have been extremely helpful in providing us with the funds in the past. But these funds are insufficient. We propose to employ three full time workers to advise at our offices but this requires funds and hence we would invite your assistance in this regard.

1. Election of Chair for AGM

Mrs Jeya Vivekanandan's name was proposed for chair by Mr. Loganathan and seconded by Mr. J. Asokan. She was elected unanimously.

2. Apologies

Apologies were received from Mr. Sivakumar, Mr. P. Sivasubramanian and Mr. Sivagnanam for their inability to attend the meeting due to unforeseeable circumstances.

3. Last Year's Report/Minutes

Last year's minutes of the meeting were read by the Secretary Mr P. Chandradas and agreed.

4. Activities 88/89

Because of the volume of work involved in dealing with the problems faced by the Tamils living in Newham, TWAN decided to employ a full time employee and Mr Jeevahan was appointed as a full time employee to work for TWAN from its office at 33 Station Road, Manor Park, London E12. TWAN helped the public at large dealing mainly with the following:

- a. Immigration
- b. Nationality
- c. Legal Matters
- d. DHSS & Welfare Rights
- e. Education
- f. Housing
- g. Racial / Police harassment
- h. Translation / Interpretation
- i. Employee / Employer's Problems

Immigration

Once again we had to liaise with Airport Immigration officials regarding refugees asking for refugee status. Mr Jeevahan undertook individual casework to release refugees from Airports. A good rapport was established with those officials and they called upon Mr. Jeevahan in turn to act as an interprter to those who couldn't speak English.

TWAN also dealt with a number of cases where refugees arrived here with false documents and held in detention centres and

prisons.

Case work was also undertaken for local people who needed help in preparing their immigration cases such as filling the necessary forms for the renewal of visas and also directing people to U.K. IAS for advice who then referred their cases to appeal tribunal and Home Office.

Nationality

Case work here covered Indians, Malaysians, Singaporeans as well as Sri Lakans. The work involved preparing people for interviews with the Home Office.

Legal Matters

Legal advice was given to people by our Chair, Mr. Thiru, on Housing, Immigration, Insurance and Motoring Offences.

DHSS & Welfare

The advice involved mainly on Welfare Rights. Many people do not know what their rights are and the main handicap was the language problem and they were unable to read the leaflets from the DHSS and gather informafion and seek help.

We had to put special effort into the following areas:

- a. Income Support
- b. National Insurance numbers
- c. Rates / Rents Rebates / Poll tax
- d. Educational problems
- e. Marriage / Registration
- f. Educational Grants

Many people sought our guidance to understand the present law concerning Social Security which ordinary people find difficult to understand. We are extremely glad to report that because of the guidance given by this organisation, many people have benefitted.

Educational Problems

In most cases students who haven't received refugee status faced problems in finding places at colleges. Although London Borough of Newham's policy is that anybody who has applied for refugee status should be treated as refugee, Newham Community College at EastHam and WestHam refused to enroll anybody who had not been given refugee status. They demanded passports from the refugees for enrolment which the refugees could not produce because either they did not have one or it was still held in the Home Office. Because of these two different stands by the Newham Borough and Newham Education Authority a lot of applications were turned down.

So TWAN contacted the Education Authority of Newham and highlighted the Council policy on education for refugees which paved way for all refugees to get enrolled in Colleges and continue their studies. TWAN also applied for grants for these students and succeeded in some and has lodged appeals on the ones which have been turned down.

Work also had to be carried out in getting places for children in infant and junior schools. TWAN is aware of the financial strain the London Borough of Newham faces. Unfortunately some important schools are going to be closed and the parents whose children are going to be affected approached us and we gave them guidance wherever possible.

Housing

A number of refugees who came to this Country as refugees neither have any family ties nor friends and when people in this category are released from the Airports and detention centres the first and the foremost problem for them is to find accommodation. As an organisation, TWAN was able to provide them with accommodation in its members houses temporarily. Then when the problem grew bigger & bigger TWAN liaised with HOMELESS REASONS UNIT and got people registered on the Council waiting list. Because of the long waiting list rehousing through this process was almost an impossibility.

Therefore TWAN decided to find them alternate accommodation. We set up a Housing Coop through which we were able to get some run down houses. We renovated them and provided accomodations to the homeless refugees. Herein we wish to stress that TWAN believes in self help. Many of our members spent valuable time in helping to renovate the premises for this purpose.

Racial & Police Harassment

Last year's report detailed several police harassments to the Tamil refugees and the action TWAN took against it. After the delegation from TWAN met the Home Secretary Mr. Douglas Hurd a circular was sent to the police departments from his office outlining methods and procedures on passport checks. Since then police harassment and passport checks ceased in Newham.

But we still get reports that people are harassed especially in places like Canning Town, Silver Town and North Woolwich areas. These are being dealt jointly by both Newham Monitoring Project and TWAN.

Translation & Interpretation

Many approached TWAN for translation or interpreting the Tamils when they go to offices such as DHSS for their needs. Our help was also sought by the immigration offices at the Airports, official at U.K. IAS and many voluntary organisations.

Employment

The main problem faced by the refugees was in obtaining the National Insurance number. In cases where jobs were offered applicants had to give the national insurance numbers. To obtain national insurance number certain DHSS offices demanded the passports from the refugees and turned down their applications on the grounds that they couldn't produce their passports as they were being held at the Home Office pending decision.

TWAN had to meet the officers concerned in the respective offices and argued for the applicants and persuaded the officials to issue the national insurance cards.

It was also brought to TWAN's attention that certain employers tried to use this situation and either underpaid the employees or in some cases not paid at all. TWAN met those opportunists on behalf of these people and negotiated with them and sorted out the problems. In certain cases we took legal action against the so-called employers.

Housing Coop Report

This Coop was found in 1987 out of desperate need to house refugees who had no ties in U.K. 1987 was the international year for the unsheltered and Homeless. In this year a steering Group was formed with TWAN, Community links, Housing Offices and HARAG to look into the Housing provisions for homeless refugees. Out of this came an agreement from the HOMELESS REASONS UNIT registered by Newham Community Housing that a Coop for Sri Lankan refugees to be established. The Coop was set up in late '87. It is run by collective residents of Newham.

The refugees released from Airport, detention Centres and prisons are placed in the Coop for a short period until a permanant accommodation is found. Through this system we were given four properties last year. They were given to us unfinished undecorated and in a bad state needing repairs.

They are being repaired now. One of these houses was burnt down and that particular property is being returned to NCH.

Recent developments regarding this housing pro ject look bleak. Private establishments have been trying to negotiate a take over of the Coop. TWAN had an emergency meeting with the housing department and expressed our feellings on this. We discussed the possibillity of the Coop applying for Housing Association Status.

At the moment we are having talks with London and Quadrant Housing association to explore this possibility further. We are hoping at present to build some houses in Naville Road, Forest Gate, in conjuction with London and Quadrant Housing Association.

The latest good news is that NUT has agreed to give us more houses in the future. If anyone would like to gather more information about this you are welcome to Contact Newham Tamil Community Housing Coop management Committee.

Women Association Report

The association which had been functioning as WOMEN UNIT OF NEWHAM WELFARE ASSOCIATION during the period of 86-87 has started functioning as NEWHAM TAMIL WOMEN ASSOCIATION from March 1988 after it had been decided at 1988 AGM to let it function as an independent group.

The new Committee has started functioning under the Chair of Mrs Y. Loganathan with seven Committee members:

- 1. Secretary Miss N. Thambiah

During the last summer they had SUMMER HOLIDAY PROJECT for five weeks in two places one at East Ham and the other at Manor Park respectively. During this period they had total of 36 children who were taught workshop and cultural practise by four teachers and a supervisor.

During the period the children were taken on two outings to South End on Sea and the other to a circus in West Ham park. On the last day of the project they celebrated Children's day in which a number of people took part. It was a two hour programme in which there were dances, dramas and music staged by the children. Mrs Anjala who is the RACIAL EQUALITY OFFICER at L.B.N. was the Chief guest for the event and gave away prizes to the children who took part in the events.

Besides this they cellebrated a cultural event in

which more than 300 people were present. There was veena programme by Mrs Suthamathi Balasingam, dance by the students of BHARATIYA VIDYA BHAVAN presented by Mrs Chitra Viswanathan while there was vocal by Mr Yogcswaran. It was an admission – free event.

The WOMEN ASSOCIATION also arranged a pilgrimage to Skandavel in Wales in which 60 people took part. These were the major contributions last year and they are looking forward to do many more social activities in the forthcoming year. It involves some financial burden but still they hope that they will succeed in their aim with the help and support of the public.

They also run a Women Advisory Service giving advice to women in solving the problems which they face in their every day life. Any one who needs this help can contact Mrs Loganathan who is always at your disposal.

Finance Report

As far as finance is concerned we faced a very bad year. As we are working within the Newham Borough we are more or less dependent on the council for our survival as far as finance is concerned. We applied for grants for some of our projects. While some of them have been accepted by the council rest of them have been turned down. Even for the ones which have been accepted money has not been released. A chart has been appended from which you can see the situation.

Last year we signed a contract with the BRITISH REFUGEE COUNCIL to provide our organisation with three workers to look after the needs of our Community in Newham. Unfortunatley we haven't received their services yet. This is why we were unable to carry out our services and projects sucessfully last year, as planned. Even though we never gave up we employed Mr. Jeevahan as full time employee and he worked from our office at 33 Station Road, Manor Park, London E12, looking after the needs of the people who approched him. He was paid by the members of TWAN and it is very very unfortunate that we couldn't get his service after September 1988 because of lack of financial resources. Still we are making arrangements to employ a full time employee there. We hope that our financial situation will get better soon and we will have somebody there within two months.

The financial report has been attached and we hope that you will accept the report. At this juncture may we take this opportunity to thank the people who have contributed to our cause and request others to subscribe for membership in the organisation as finance is the vital back bone of organisation for its survival. This is the only organisation formed

by the refugees themselves who suffered in the detention camps and prison and underwent all the agonies. Therefore we always make sure that every penny we collect goes to the right cause.

8. Newham Tamil Community Council (N.T.C.C.)

It had been formed in 1986 and is functioning as Tamil Community of Newham which was an umbrella organisation of Newham Tamils. In 1987 AGM it was changed to Newham Tamil Community Council. Five organisations are affiliated to this group. It comprises of London Tamil Sangam, London Sri Murugan Temple, Tamil Welfare Association of Newham, Tamil Community Housing Coop. and Newham Tamil Women Association. The only organisation which is out of the council is Thamilar Munnetra Kazhagam and we appeal to them to come and affiliate with us to work as a United force in dealing with the problems faced by Tamils.

Last year a lot of organisations applied for grant to the Newham Borough regarding projects to help Tamils and the council was unable to make any decision because of the multiplicity of organisations involved in this. So the council decided to investigate this matter and after a long investigation it has been decided that the council will only consider the applications which are recommended by NTCC for grants and NTCC will be consulted before authorising grants.

Office Administration

33 Station Road Manor Park London E12 has been the office for TWAN, WOMEN'S ASSOCIATION and HOUSING COOP since May 1987. Last year we have been given planning permission by the Council and it has been decided to name it TWAN COMMUNITY CENTRE. Already it is being used for children's projects and in future we are planning to make it a focal point to meet all Tamils there and share their views and opinions on the current affairs concerning Tamils.

10. Constitutional Amendments

In the AGM there had been five amendments to the constitution.

a. Name of the Association

The name TWAN will be changed to TWA (Newham) U.K. Ltd

b. All these days beneficiaries and members of the organisations are only from the London Borough of Newham. But the amendment makes anybody from any part of the U.K. to become its member and beneficiary.

c. All these days the organisation has ben registered with only L.B. of Newham. But from 1989, we will take steps to register the organisation as a Charitable Limited Company

d. In the past we never mentioned in our constitution whether we have a right to employ anybody for the organisation, but the fourth amendment gives powers to the organisation to employ anybody.

e.It has been decided to adopt the Newham Borough equal opportunity policy to our organisation.

It was proposed at our last committee meeting that a questionnaire should be prepared and sent to each refugee and help him/her to face his/her case as it comes along.

Elderly people's needs should be met and attention should be paid especially to Health and

We are all aware that dance, music and cultural classes are held in a number of places by a number of groups in and around London and we should coordinate with all these groups and set up standards among them by having some sort of tests and competition. We also must have musical programmes like ISAI VIZHA to encourage the artists who keep the culture alive.

To put these efforts into action we need your physical, moral and financial help. We were able to do something to our Community with your help last year and we are stepping into this new year with more determination and courage to do better service to the community because we know that you are there to give us a hand and we will march forward towards the dawn for our people.

THE Tamii Welfare Association is to run a study on the welfare of Tamii refugees in Newham aided by a possible council grant of £1,500.

THE Tamil Welfare Association of Newham, Station Road, Manor Park is getting £300 towards the cost of hiring a hall for the Tamil New Year celebrations.

TAMILS NET NEW BASE

A FORMER fish and chip shop in Manor Park is to be "home" for a number of community-based services for Newham's Tamil population, Under plans agreed by Newham councillors last week, 33 Station Road will be converted into offices for the Tamil Welfare and Women's Associations, and a building contractors co-operative.

DOUBLE TAKE' ON

NEWHAM Council have called on Tamil leaders to vet grant applications from their community groups

after allegations of fraud.

In future. Newham Tamil Community Council will meet council officers to ensure there is no duplication of grants and that applicant groups have a record of good standing in the community.

The move comes after the council received seven applications for funding from Tamil groups in the

One organisation had applied for a total of £3,466 * by claiming twice. Two others, who have so far not demonstrated that they are working for the Tamil community, applied for more than £1,500.

A council report said: "It is important that any voluntary organisation seeking funding is a bona-fide voluntary organisation which is representative of the olocal community and accountable to its members.

"Some applications have sought identical equipment or sought to address identical needs.

The report went on: "The extent to which some groups represent the interests of local Tamils is far from clear"

The council have now agreed to a grant of only £800 to be divided among three Tamil groups in the coming financial year.

'Double Take' on Tamils Bid for Grants

We are concerned about this report. Part of it read, "One organisation had applied for a total of £3,466 by claiming twice. Two others, who have so far not demonstrated that they are working for the Tamil Community, applied for more than £1.500".

This is a sheer misunderstanding by the Recorder. The person reported this should have investigated the facts thoroughly before he made such an allegation. The truth is that, there are two Tamil Women's Associations in Newham and incidently both organisations function under the name of "Tamil Women's Association of Newham". One organisation has its base at 33 Station Road, Manor Park, London E12 and the other at 720 Romford Road, Manor Park, London E12. SO, THERE WAS NO DOU-BLE TAKE AS ALLEGED BY THE RECORDER:

As for the second part of the news report, Recorder should understand that

Newham Council not only provide grant to well established organisations, but also provide fundings and support to ethnic minority voluntary groups for their initial startings.

It may be true for groups who have very recently moved in to Newham to have applied for fundings. Even in such cases it wound not be a crime for such organisations to submit applications for grant aid. Recorder should understand that not all applications submitted are honoured

However it calls for concern on all Tamil organisations in Newham.

There needs to be greater a co-operation among all Tamil organisations in the Borough. It also calls for the Newham Tamil Community Council to advise, process and scrutinize and prioritise future grant applications so that the Tamil Community is not embarrased by such allegations. It also calls ALL bonafide for organisations in Newham Tamil Community Councils to stand together not only for grant aid purposes but also for common goals and demonstrate Tamil Unity.





WHAT YOU CAN DO

- Inform us of any racist attack (including graffiti, abuse, damage or other incidents) you know of or any attack you think has a racist motive -by doing this we will be better able to monitor such attacks more accurately.
- Inform us of anyone you feel has been harassed by police on racial grounds, have had their rights abused, or unnecessarily detained without charge. If charged, ask them to come to see us. Let us know of any policing tactic in the borough that you feel needs drawing attention to. We will then place pressure on the police to account for their action.
- Bring to our attention anyone who feels that the police have acted improperly in any way and wish to make a complaint. We will assist people in making their complaint.
- Advertise our 24-hour Emergency Service. We need more volunteers to join the service and encourage others to participate. You are generally required for at least one evening a month. Not too much to ask in the struggle!
- Invite us to talk about our work at a meeting of your trade union branch or any community group/political party you may belong to. This should stimulate discussion and debate, which is one of the opening shots for effective anti-racist work.
- Affiliate to Newham Monitoring Project, come to our meetings (details from the Project), and publicise our activities in whatever way you can.
 Keep an eye out for our activities, meetings and demonstrations, and help us to support you.
- If you have been the victim of any form of racism, and have any contact with the police, always keep a note of the names and numbers of any officers you speak to, even on the phone. The greater the number of participants, the more reflective we are of those we represent.


