

The Minister of Health and Local Government,—Housing and Town Improvement (Hanwella area),—That this House resolves under the provisions of section 3 (b) of the Housing and Town Improvement Ordinance (Chapter 199), as modified by proclamation under section 88 (1) of the Ceylon (Constitution) Order in Council, 1946, published in Gazette Extraordinary No. 9,773 of September 24, 1947, that from the 1st day of February, 1948, the aforesaid Ordinance shall be in force within the area defined in the Schedule hereto.

Schedule.

All that area of land representing the former Sanitary Board Town of Hanwella situated in Meda Pattuwa of Hewagam Korale in Colombo District of the Western Province and bounded as follows:—

North: By a line drawn from a point at the centre of the Kelani Ganga due north of the north-western corner of the cemetery bordering the Low Level Colombo-Avissawella Road eastwards along the centre line of the said river to a point due north of culvert No. 19/1 on the Low Level Colombo-Avissawella Road over the Kuppiawatta Ela.
